Notes to Financial Statements

December 31, 2024

1. Description of Plan

The following description of Maxcess International Corporation 401(k) Savings Plan (the Plan) provides only general information. Participants should refer to the Plan document and summary plan document for a more complete description of the Plan's provisions, copies of which may be obtained from the Company.

General

The Plan is a defined contribution plan covering all eligible employees of Maxcess International Corporation and Roto-Die Company, Inc. (collectively, the Company). The Plan excludes from participation nonresident aliens who receive no U.S. source income, leased employees, residents of Puerto Rico and employees of an affiliated employer that did not adopt this Plan. Employees are eligible to participate in the Plan immediately upon their date of hire and are automatically enrolled at a deferral rate of 5% with an automatic escalation every April thereafter of 1% to a maximum deferral rate of 12%, unless they affirmatively elect not to participate in the Plan or change the rate of deferral.

The Benefits Committee is responsible for the general administration of the Plan. Vanguard Fiduciary Trust Company is the trustee and The Vanguard Group, Inc. is the record-keeper for the Plan (collectively, Vanguard).

The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (ERISA).

Contributions

Participants may contribute up to 80% of their eligible compensation, as defined in the Plan. Contributions may be in the form of pre-tax elective deferrals or after-tax Roth contributions. Participants may also contribute amounts representing distributions from other qualified plans. Participants aged 50 and older may make catch-up contributions. The Company makes safe harbor matching contributions each payroll period equal to 100% of a participant's contributions that do not exceed 3% of eligible compensation, plus 50% of a participant's contributions up to the next 2% of eligible compensation. The Company also makes a true-up safe harbor matching contribution. Additionally, nonelective contributions (Nonelective Contributions) may be contributed at the discretion of the Company. An employee must complete one year of eligible service, as defined, and be employed on the last day of the plan year to be eligible to receive Nonelective Contributions. The Company did not make Nonelective Contributions for 2024.

Notes to Financial Statements (continued)

1. Description of Plan (continued)

All contributions are subject to certain Internal Revenue Code (the Code) limitations.

Participants direct their elective contributions into various investment options offered by the Plan and can change their investment options daily. Participants who are automatically enrolled have their contributions invested in the applicable Vanguard target retirement trust based on their age until they change their election. The Company's contributions are invested in the same manner as that of the participant's elective contributions.

Participant Accounts

Each participant's account is credited with the participant's contributions, the Company's contributions and allocations of plan earnings and is charged with an allocation of administrative expenses. Plan earnings are allocated based on the participant's share of net earnings or losses of his or her respective elected investment options. Allocations of administrative expenses are based on the participant's account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are immediately vested in their own contributions and actual earnings thereon. In addition, participants are immediately vested in the Company's matching and Nonelective Contributions plus actual earnings thereon, except for certain participants merged into the Plan whose former company discretionary contributions continue to vest according to the predecessor plan's vesting provisions.

Participant Loans

Participants may borrow from their participant accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. Loan terms range from 1–5 years or up to 10 years for the purchase of a principal residence. A participant may not have more than one loan of each type outstanding at any point in time. The loans are secured by the balance in the participant's account and bear interest at a rate similar to the rate charged for a loan made under similar circumstances by persons in the business of lending money plus 1%. Principal and interest are paid ratably through payroll deductions.

Notes to Financial Statements (continued)

1. Description of Plan (continued)

Payment of Benefits

On termination of service, death, disability, or retirement, a participant may elect to receive the value of the participant's vested account balance, in the form of a full or partial lump sum payment, installment payments or an annuity.

In-service withdrawals are available in certain limited circumstances, as defined by the Plan. Hardship withdrawals are allowed for participants incurring an immediate and heavy financial need, as defined by the Plan. Participants are limited to two hardship withdrawals per calendar year and the minimum hardship withdrawal amount is \$500.

Administrative Expenses

The Plan's administrative expenses are paid by either the Plan or the Company, as provided by the Plan's provisions. The Company pays the majority of the administrative expenses incident to the management of the Plan; however, certain costs may be paid from the assets of the Plan. Expenses that are paid by the Company are excluded from these financial statements.

Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA.

2. Summary of Significant Accounting Policies

Basis of Accounting

The accompanying financial statements have been prepared on the accrual basis of accounting.

Payment of Benefits

Benefits are recorded when paid.

2. Summary of Significant Accounting Policies (continued)

Notes Receivable from Participants

Notes receivable from participants represent participant loans that are recorded at their unpaid principal balance, plus any accrued but unpaid interest. Interest income on notes receivable from participants is recorded when it is earned. Related fees are recorded as administrative expenses and are expensed when they are incurred. If a participant ceases to make loan repayments and the plan administrator deems the participant loan to be a distribution, the participant loan balance is reduced and a benefit payment is recorded.

Use of Estimates

The preparation of financial statements in conformity with generally accepted accounting principles in the United States (U.S. GAAP) requires management to make estimates that affect the amounts reported in the financial statements and accompanying notes and supplemental schedule. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

Investments held by the Plan are stated at fair value. Fair value is defined as the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date (an exit price). See Note 4 for further discussion and disclosures related to fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Dividends are recorded on the ex-dividend date. Interest income is recorded as earned. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold, as well as held, during the year.

3. Investments

All investment information disclosed in the accompanying financial statements and supplemental schedule, including investments held and notes receivable from participants at December 31, 2024 and 2023, and net appreciation in fair value of investments, interest income on notes receivable from participants, and interest and dividends for the year ended December 31, 2024, was obtained or derived from information supplied to the plan administrator and certified as complete and accurate by Vanguard.

4. Fair Value Measurements

Fair value is defined under Accounting Standards Codification 820, *Fair Value Measurement*, as the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date (i.e., an exit price). The fair value hierarchy prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets and liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy are described below:

- Level 1 – Unadjusted quoted prices in active markets that are accessible to the reporting entity at the measurement date for identical assets and liabilities.
- Level 2 – Inputs other than quoted prices in active markets for identical assets and liabilities that are observable either directly or indirectly for substantially the full term of the asset or liability. Level 2 inputs include the following:
 - quoted prices for similar assets and liabilities in active markets
 - quoted prices for identical or similar assets or liabilities in markets that are not active
 - observable inputs other than quoted prices that are used in the valuation of the assets or liabilities (e.g., interest rate and yield curve quotes at commonly quoted intervals)
 - inputs that are derived principally from or corroborated by observable market data by correlation or other means
- Level 3 – Unobservable inputs for the asset or liability (i.e., supported by little or no market activity). Level 3 inputs include management’s own assumption about the assumptions that market participants would use in pricing the asset or liability (including assumptions about risk).

The level in the fair value hierarchy within which the fair value measurement is classified is determined based on the lowest level input that is significant to the fair value measurement in its entirety.

4. Fair Value Measurements (continued)

Following is a description of the valuation techniques and inputs used for each major class of assets measured at fair value by the Plan. There have been no changes in the valuation techniques and inputs used at December 31, 2024 and 2023.

Registered investment companies: Valued at quoted market prices, which represent the net asset value (NAV) of shares held by the Plan at year-end.

Common/collective trusts: Valued at the published NAV of shares held by the Plan at year-end. Participant transactions (purchases and sales) may occur daily without restrictions.

5. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market volatility and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported on the statements of net assets available for benefits.

Notes to Financial Statements (continued)

6. Tax Status

The underlying pre-approved plan has received an opinion letter from the Internal Revenue Service (IRS) dated June 30, 2020, stating that the written form of the underlying pre-approved document is qualified under Section 401 of the Code. Any employer adopting this form of the plan will be considered to have a plan qualified under Section 401 of the Code, and, therefore, the related trust is tax-exempt. Once qualified, the Plan is required to operate in conformity with the Code to maintain its qualified status. The plan administrator believes the Plan is being operated in compliance with the Code.

U.S. GAAP requires plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. Plan management has analyzed the tax positions taken by the Plan and has concluded that there are no uncertain positions taken or expected to be taken. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

7. Party-in-Interest Transactions

The Plan invests in shares of registered investment companies managed by an affiliate of Vanguard. The Plan also holds units of common/collective trusts managed by Vanguard. These transactions qualify as party-in-interest transactions; however, they are exempt from the prohibited transactions rules under ERISA.

8. Subsequent Events

Management evaluated subsequent events for the Plan through September 3, 2025, the date the financial statements were available to be issued. Based on this evaluation, no additional disclosures or adjustments were required to be made to the financial statements as of December 31, 2024.
