## Independent Auditors' Report

### Scope and Nature of the ERISA 103(a)(3)(c) Audit

We have performed audits of the accompanying financial statements of the Morrison Center 403(b) Retirement Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Morrison Center 403(b) Retirement Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note C to the financial statements, is complete and accurate.

### Opinion

### **Basis for Opinion**

### **Responsibilities of Management for the Financial Statements**

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

## **Notes to Financial Statements**

### **Morrison Center 403(b) Retirement Plan**

#### **Note A - Description of Plan**

The following description of the Morrison Center 403(b) Retirement Plan (the “Plan”) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan’s provisions.

#### **General**

The Plan is a 403(b) Volume Submitter Plan sponsored by the Morrison Center (the “Center”, the “Company” or the “Employer”) covering all eligible employees of the Center. The Plan was established with an original effective date of August 1, 2017. The Plan was restated effective on January 1, 2020 and March 28, 2024 and is subject to the provisions of the Employee Retirement Income Security Act of 1974 as amended (“ERISA”).

#### **Eligibility**

All Center employees are eligible to participate in the Plan upon the first day of hire. Elective deferral contributions begin as soon as administratively feasible following this entry date. The Plan provides for an automatic election to have pre-tax elective deferral contributions made for each participant of 2% of pay, and shall apply to participants at the time they enter or reenter the Plan. The Participant will be given a reasonable period to affirmatively elect a different percentage, to elect not to make elective deferral contributions, or to elect to designate all or any portion as Roth elective deferral contributions. Employees are eligible to receive discretionary employer matching contributions starting the first day of the month following the completion of thirty days of service.

#### **Contributions**

In addition to a percentage or dollar amount of pre-tax annual compensation, as defined in the Plan, participants may make Roth contributions. Both are subject to certain limitations set forth by the Internal Revenue Code. Participants who have attained age fifty before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute rollover amounts, representing distributions from other qualified contribution plans. Participants direct the investment of their contributions into various mutual fund investment options offered by the Plan.

Participant contributions may be matched by the Company at a percentage of the participants’ contributions, as determined by the Company. For the plan year ended December 31, 2024, the Company matched 50% of each participant’s deferral contributions up to 4% for a maximum match of 2%. Employee deferrals and employer matching contributions are funded on a payroll basis. All contributions are subject to applicable Internal Revenue code limitations.

The plan provides for an additional discretionary contribution to be made for each Plan Year in an amount determined by the Center. No such contribution was made for the year ended December 31, 2024.

## **Notes to Financial Statements**

### **Morrison Center 403(b) Retirement Plan**

#### **Note A - Description of Plan - Continued**

##### **Participant Accounts**

Each participant's account is credited with the participant's contribution, Company contributions, Plan earnings, and is charged with an allocation of administrative expenses. The allocation of administrative expenses is based upon specific participant transactions and account balances. The benefit to which a participant is entitled is the benefit that can be provided from each participant's vested account.

##### **Investment Options**

Participants direct the investment of their contributions into various investment options offered by the Plan.

##### **Vesting and Withdrawals**

Participants are vested immediately in their contributions plus actual earnings thereon. Vesting in the Company's discretionary matching contribution is based on years of continuous service. A participant is 100% vested in company matching contributions after five years of credited service. In the event of death or disability, or upon reaching normal retirement age, a participant becomes 100% vested in employer matching contributions.

Withdrawals are permitted from a participant's account prior to termination of employment in the case of death, disability, or financial hardship (as defined by the IRC). Participants who have reached age 59 ½ may receive an in-service distribution of all or part of their elective account, including Roth deferrals.

##### **Notes Receivable from Participants**

Participants may borrow from their account balances a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balances. The maximum number of loans a participant may have outstanding at any time is one, and only one loan may be taken out in any 12-month period. The repayment period will not be longer than five years. Upon termination, the balance of any outstanding loan is due within sixty days, unless all plan vendors permit the loan to be accepted as part of a direct rollover to a new employer's plan. Loans are secured by the balance in the participant's account and bear a fixed rate of interest based on current lending rates at the time the loan is originated. Payment due dates and length will be set out in the promissory note. Principal and interest is paid bi-weekly through a payroll deduction.

## Notes to Financial Statements

### Morrison Center 403(b) Retirement Plan

#### Note A - Description of Plan - Continued

##### **Payment of Benefits**

Participants are entitled to receive a distribution upon termination of employment due to death, retirement, and specific situations of financial hardship. In addition, participants who continue to work after normal retirement age may elect to begin the distribution at any time after reaching their normal retirement age of 65. Participants must begin receiving benefits by the required beginning date, which is generally 73. After termination of employment, if the vested amount of the participant account is \$5,000 or less, it will be paid to the former employee in a single sum; if greater than \$5,000 the participant is entitled to the distribution of their account as a lump sum payment or in installments.

If the vested balance exceeds \$5,000, the participant must consent to any distribution of their account prior to the time payments begin under applicable federal law.

##### **Forfeited Accounts**

When certain terminations of participation in the Plan occurs, the nonvested portion of the participant's account, as defined by the Plan, represents forfeitures. Forfeitures may be used to reduce company contributions or to pay plan expenses. During the year ended December 31, 2024, the Company used \$65,098 to fund employer contributions. As of December 31, 2024 and 2023, the balance in the forfeiture account was \$4,111 and \$58,323, respectively.

#### Note B - Summary of Significant Accounting Policies

##### **Basis of Accounting**

The financial statements of the Plan are prepared in accordance with accounting principles generally accepted in the United States of America.

##### **Estimates**

The preparation of financial statements in conformity with United States generally accepted accounting principles requires the Plan Administrator to make estimates and assumptions that affect the reported amounts of assets, liabilities, and changes therein, and disclosure of contingent assets and liabilities. Accordingly, actual results may differ from those estimates.

##### **Notes Receivable from Participants**

Notes receivable are measured at their unpaid principal balance plus accrued but unpaid interest. Interest income is recorded when it is earned on an accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 and 2023, respectively. If a participant ceases to make loan repayments and the Plan Administrator deems the participant loan to be a distribution, the outstanding loan balance will be included in participants' gross income for federal income tax purposes as if it were distributed to him or her.

## Notes to Financial Statements

#### Note B - Summary of Significant Accounting Policies - Continued

##### Administrative Expenses

Professional and administrative expenses of the Plan, at the Company's election, may be paid out of the Plan or directly by the Company. Certain fees are assessed by the custodians and recordkeepers for the processing of participant loans and participant withdrawals, and are charged directly to the participant's account. In addition, personnel and facilities of the Company are used by the Plan for its accounting and other activities at no charge to the Plan.

##### Payment of Benefits

Benefits are recorded when paid.

##### Investment Valuation and Income Recognition

The Plan's investments are stated at fair value (except for fully benefit-responsive investment contracts, which are reported at contract value). Fair value of a financial instrument is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note D for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold, as well as held during the year.

#### Note C - Information Certified by the Plan's Custodian and Recordkeeper (Unaudited)

The Plan Administrator has elected the method of compliance permitted by 29 CFR 2520 103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, as permitted under such election, the Plan Administrator instructed the Plan's independent auditors not to perform, and they did not perform any auditing procedures with respect to information certified by Delaware Charger Guarantee and Trust Company d/b/a Principal Trust Company (Principal) and Empower Annuity Insurance Company and Empower Trust Company, LLC (Empower), as custodians and recordkeepers of the Plan, except for comparing information certified by Principal and Empower to information included in the Plan's financial statements and supplemental schedule. The Plan Administrator has obtained certifications from Principal Trust Company from January 1, 2024 through April 9, 2024 and as of and for the year ended December 31, 2023, and from Empower Annuity Insurance Company and Empower Trust Company, LLC for 2024 that such information is complete and accurate.

#### Note D - Fair Value of Investments (Unaudited)

Financial Accounting Standards Board (FASB) Accounting Standards Codification (ASC) 820, *Fair Value Measurements and Disclosures*, provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

- Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the plan has the ability to access.

- Level 2 Inputs to the valuation methodology include:  
quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
  - inputs other than quoted prices that are observable for the asset or liability;
  - inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

- Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

- *Mutual Funds*: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

#### **Note E - Guaranteed Option Contract**

The Plan provides for a traditional fully benefit responsive guaranteed income contract, with contributions maintained in the general account. The account is credited for earnings on the underlying investments and charged for participant withdrawals. The Empower Investments Fixed Account guarantees principal and pays a guaranteed minimum interest rate of 0%.

#### **Note F - Party-in-Interest Transactions**

Principal Trust Company and Empower Annuity Insurance Company and Empower Trust Company, LLC are the recordkeepers and custodians, as well as the managers of certain plan investments. Therefore, transactions with these institutions qualify as party-in-interest transactions.

The Plan paid certain direct custodian and recordkeeping fees totaling \$19,280 for the year ended December 31, 2024.

#### **Note G - Plan Termination**

Although it has not expressed any intent to do so, the Center has the right under the plan to discontinue its contributions at any time and to terminate the plan subject to the provisions of ERISA. In the event of plan termination, participants would become 100% vested in their employer contributions.

#### **Note H - Tax Status**

The Company, as the Plan's sponsor, adopted a pre-approved Code section 403(b) prototype plan, which received an Internal Revenue Service opinion letter dated March 31, 2017, which states that the plan satisfies the applicable sections of the Internal Revenue Code. The Plan itself has not received a determination letter from the IRS. The Plan has subsequently been restated; however, the Plan's management believes that the Plan, other than the issues described in the below Note J, is currently designed and is being operated in compliance with the applicable requirements of the IRC, and that the Plan continues to be tax exempt. Therefore, no provision for income taxes has been included in the Plan's financial statements.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and to recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by a government authority. The Plan administrator has analyzed the tax positions taken by the Plan, and has concluded that, as of December 31, 2024, there are no uncertain positions taken, or expected to be taken, that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions. However, there are currently no audits for years/periods in progress.

#### **Note I - Risks and Uncertainties**

The Plan provides for various investment options which in turn invest in various investment securities. Investment securities are exposed to various risks, such as interest rate, market volatility and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits and statement of changes in net assets available for benefits.

#### **Note J - Compliance and Contingencies**

The Plan has not yet completed its annual testing requirements for 2019, 2023 and 2024. Management is currently working with its custodian and trustee to complete all required testing as soon as possible.

#### **Note K - Subsequent Events**

Effective July 1, 2025, the Plan was amended to remove the eligibility requirements for the employer matching contributions and nonelective contributions. Employees deferring to the Plan will now be eligible to receive employer matching contributions and nonelective contributions upon the first date of employment.

Effective September 11, 2025, a program of the Center was sold to an unrelated for-profit entity along with the employees that worked under that segment. Approximately forty employees have been effectively terminated from the Center and transferred to the purchasing company. Certain participant balances will be rolled out of the Plan in accordance with the Plan document.

Management has made an evaluation of subsequent events to and including October 6, 2025, which was the date the financial statements were available to be issued and determined that any subsequent events that would require recognition or disclosure have been considered in the preparation of the financial statements.
