## Notes to Financial Statements December 31, 2024 and 2023

---

### Note 1: Description of the Plan

The following description of Oglethorpe University (the University) 403(b) Retirement Program (the Plan) provides only general information. Participants should refer to the Plan Document for a more complete description of the Plan's provisions.

#### General

The Plan is a defined contribution plan, covering all employees of the University except FICA Exempt student employees and nonresident aliens who received no compensation from the University which constitutes United States source income. There are no age or service requirements for eligibility to participate in the Plan. Eligible employees may enter the Plan on the first day of each payroll period. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

#### Contributions

Participants may make pre-tax and/or Roth contributions through payroll deductions in any amount up to 100% of the participant's compensation, as defined in the Plan Document, subject to statutory limitations under the Internal Revenue Code (IRC). The statutory limit for 2024 was \$23,000. Participants who have attained age 50 are eligible to defer additional amounts (catch-up contributions). The maximum catch-up contribution in 2024 was \$7,500. Participants may also contribute amounts representing distributions from other qualified plans (rollover contributions).

The Plan has elected an automatic contribution arrangement (ACA). Under the ACA, upon becoming eligible to participate in the Plan, participants will be automatically enrolled with a 5% pre-tax elective deferral contribution percentage, unless the participant makes a contrary election. The ACA applies to new participants hired on or after July 1, 2019, excluding adjunct professors, part-time seasonal coaches, and those employees scheduled to work less than 20 hours per week.

The University may make discretionary employer contributions and/or discretionary employer matching contributions, as determined by the University, to those eligible participants who have completed one year of service. Discretionary contributions are allocated based on a uniform percentage of compensation. During 2024, eligible participants received employer matching contributions equal to 7% of eligible compensation after contributing 5% of compensation. Salary deferral contributions of less than 5% of compensation were not matched. There were no other discretionary employer contributions in 2024.

#### Administration

The University has engaged Lincoln Financial Group Trust Company, Inc., Lincoln National Life Insurance Company, and TIAA-CREF (the Custodians) to serve as the Custodians of the Plan. The Custodians receive all contributions made under the Plan, holds Plan assets and pay benefits to participants as directed by the Plan Administrator (Note 3).

The University serves as the Plan Administrator. The Plan Administrator has the responsibility to administer the Plan for the exclusive benefit of the participants and their beneficiaries. These duties include, but are not limited to, establishing procedures, maintaining records, interpreting provisions of the Plan, and making determinations regarding questions which may affect eligibility for benefits.

## **Participant Accounts**

Participants direct the investment of their contributions and any employer contributions into various investment options offered by the Plan. Each participant's account is credited with the participant's contributions, discretionary employer matching contributions, and an allocation of discretionary employer contributions, and actual Plan earnings thereon. Participant accounts are charged with withdrawals and an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

## **Vesting**

Participants are immediately vested in their voluntary contributions, as well as the University's discretionary employer contributions plus actual earnings thereon.

## **Investment Options**

Participants are required to make participant-directed allocations of their accounts in increments totaling 100% among various investment options, selected by the Plan Administrator, including certain options for which the Custodians or their affiliates serve as investment advisors (Note 6). Participants can make changes to their investment options daily.

## **Notes Receivable from Participants**

Participants may borrow from their accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. Loans are repayable in periods not to exceed five years, unless the loan is for the purchase of a primary residence, in which the loan repayment period may not exceed fifteen years. The loans are secured by the balance in the participant's account and bear interest at the Prime Rate (7.50% at December 31, 2024) plus 1%. The interest rates on participant loans range from 4.25% to 9.50% per annum at December 31, 2024. Principal and interest are repaid through payroll deductions, unless directly repaid to the Plan by the participant.

## **Payment of Benefits**

Withdrawals from participant accounts may be made for the following reasons: hardship, attainment of age 59 ½, qualified reservist, normal retirement at age 65, death, total disability or termination of employment. In addition, a participant may withdraw all or any portion of their vested account balance held in an annuity contract provided that they are at least age 50 at the time of the in-service distribution and have completed two years of service.

Hardship withdrawals are permitted if certain criteria are met, as defined by the Plan Document, and are subject to taxes in the year received.

Upon reaching the age of 59 ½, a participant is eligible to receive distributions without termination of employment and without penalty.

Participants withdrawing from the Plan due to termination of employment, retirement, death or disability, may receive the value of their vested account through a lump sum distribution or rollover, or in installment payments over a specified period not to exceed the life or life expectancy of the participant or designated beneficiary. The individual agreements governing the investment options selected may further restrict payout options.

In general, if a participant's vested account balance exceeds \$5,000, the account may not be distributed without the participant's consent. If no alternative election has been made and the benefit is \$5,000 or less (the involuntary cash-out amount), the Plan may, upon termination of service of a participant for any reason, pay the benefits owed in a lump sum distribution.

## **Forfeited Accounts**

At December 31, 2024 and 2023, forfeited accounts totaled \$13,148 and \$7,018, respectively. These accounts shall be used to reduce future employer contributions. During the year ended December 31, 2024, \$625 from forfeited accounts were used to reduce employer contributions.

## **Note 2: Summary of Accounting Policies**

### **Basis of Accounting**

The financial statements of the Plan are prepared using the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP).

### **Use of Estimates**

The preparation of financial statements in conformity with U.S. GAAP requires the Plan Administrator to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Accordingly, actual results may differ from those estimates.

### **Investment Valuation and Income Recognition**

The Plan's investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date (Note 4).

Purchases and sales of investments, including gains or losses, are recorded on a trade-date basis. Interest income is recorded when earned, and dividend income is recorded on the ex-dividend date. Net appreciation/depreciation in the fair value of investments represents the change in fair value during the year, including realized and unrealized gains and losses.

### **Risks and Uncertainties**

Investments are exposed to various risks, such as interest rate risk, market risk and credit risk. Due to the level of risk associated with certain investments and the level of uncertainty related to changes in the value of investments, it is at least reasonably possible that changes in risks in the near term would materially affect participants' account balances and the amounts reported in the accompanying statements of net assets available for benefits and the statement of changes in net assets available for benefits.

### **Notes Receivable from Participants**

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded when earned. Related fees are recorded as administrative expenses and are expensed when incurred. No allowance for credit losses has been recorded as of December 31, 2024 and 2023. If a participant ceases to make loan repayments and the Plan Administrator deems the participant loan to be in default, the participant loan balance is reduced, and a benefit payment is recorded.

### **Payment of Benefits**

Benefit payments are recorded when paid by the Plan.

## Administrative Expenses

Certain expenses of maintaining the Plan are paid directly by the University and are excluded from these financial statements. These expenses include, but are not limited to, legal, accounting and recordkeeping fees. However, individual transaction fees for participant directed transactions including, but not limited to, distributions and notes receivable from participants are charged to the participant's account and included in administrative expenses. Investment related expenses are included in administrative expenses and net appreciation in fair value of investments.

## Note 3: Investment Information Certified by Custodians

The Plan Administrator has elected the method of annual reporting compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, as permitted under such election, the Plan Administrator instructed the Plan's independent auditors not to perform any auditing procedures with respect to the following information certified by the Custodians, except for comparing such information to information included in the Plan's financial statements:

## Note 4: Fair Value Measurements

The accounting standard for fair value measurements provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements).

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability; and
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

*Mutual Funds:* Valued at the net asset value (NAV) of shares held by the Plan at year end.

*Fixed Annuity Contracts:* Reported at contract value. The contract value equals the accumulated cash contributions and interest credited to the Plan's contracts, less any withdrawals. Transactions in similar investment instruments are not observable. Certain contract types contain liquidity restrictions on the redemption of annuity accumulations, which could impact the value realized upon exiting the contract. The contract value approximates fair value.

*Money Market Fund:* Valued at NAV of shares held by the Plan at year end.

*Pooled Separate Accounts:* Valued at the NAV of units of the pooled separate account. The NAV, as provided by the custodian, is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund less its liabilities. The practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV. Withdrawals can be executed any time but are generally limited to one per calendar quarter. Were the Plan to initiate a full redemption of a pooled separate account, the investment adviser reserves the right to temporarily delay withdrawal from the account in order to ensure that the securities liquidations will be carried out in an orderly business manner. There are no unfunded commitments related to the pooled separate account.

**Note 5: Income Tax Status**

The Plan has been designed to qualify under Section 403(b) of the Internal Revenue Code (Code). The terms of the Plan have been prepared to conform with the sample language provided by the IRS in Revenue Procedure 2007-71. The Plan Administrator intends to apply for a determination letter on the Plan once the IRS opens such a program. The Plan is required to operate in conformity with the Code to maintain the tax-exempt status for plan participants under Section 403(b).

GAAP requires plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan Administrator has analyzed the tax positions taken by the Plan and has concluded that as of December 31, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan Administrator believes it is no longer subject to income tax examinations for years prior to 2021.

**Note 6: Related-Party and Party-In-Interest Transactions**

The Custodians perform services for, sell products to, and manage and maintain certain investments of the Plan for which fees are charged to the Plan. While the University pays a portion of the fees, a portion is paid by the Plan (Note 2). Transactions with these providers qualify as party-in-interest transactions. Fees paid by the Plan for these services totaled \$47,564 for the year ended December 31, 2024, which is included as administrative expenses in the accompanying statement of changes in net assets available for benefits. Party-in-interest transactions also include notes receivable from participants.

Such transactions, while considered party-in-interest transactions under ERISA regulations, are permitted under the provisions of the Plan and are specifically exempt from the prohibition of party-in-interest transactions under ERISA.

**Note 7: Plan Termination**

Although it has not expressed any intent to do so, the University has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, assets of the Plan will be distributed to the participants in accordance with the Plan provisions.

**Note 8: Subsequent Events**

The University has evaluated for subsequent events between the statement of net assets available for benefits date of December 31, 2024 and the report date, the date these financial statements were made available for issuance, and has concluded that all subsequent events requiring disclosure have been incorporated in these financial statements.
