Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Tetra Pak Retirement Savings Plan, an employee benefit plan subject to the *Employee Retirement Income Security Act of 1974* (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Tetra Pak Retirement Savings Plan financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the years then ended stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report:

Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about Tetra Pak Retirement Savings Plan's ability to continue as a going concern within one year after the date that these financial statements are available to be issued.

Note 1. Description of the Plan

The following description of the Tetra Pak Retirement Savings Plan (Plan) provides only general information. Participants should refer to the plan document for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan established on October 1, 1997, covering substantially all employees of Tetra Pak Inc. and its participating subsidiaries (collectively, the Company). Employees are eligible to participate upon completion of one hour of service. The Plan is subject to the provisions of the *Employee Retirement Income Security Act of 1974* (ERISA), as amended by subsequent legislation. The Plan was amended and restated effective January 1, 2022.

Charles Schwab Trust Bank is the trustee of the Plan under a contractual agreement with the Company. Charles Schwab Trust Bank holds and manages the assets, maintains records of the Plan and assumes responsibility for proper allocation of income among participants' accounts in the Plan.

Contributions

Each participant may elect to make pre-tax contributions of any whole percentage or flat dollar amount up to 100% of the participant's compensation for the period as permitted under the Internal Revenue Code (IRC). Participants may also make after-tax contributions. Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans. Combined pre-tax and after-tax contributions may not exceed 100% of eligible compensation. Participants direct the investment of all contributions into various investment options offered by the Plan.

The Company may make a matching contribution, basic contribution or a supplemental contribution. These contributions to participants are computed in accordance with the terms of the Plan and are based on the agreements made with the participating subsidiary.

Participant Accounts

Each participant's account is credited with the participant's contributions and allocations of: (a) the Company's contributions and (b) plan earnings, and is charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's account.

Vesting and Forfeitures

Participant contributions and related earnings are 100% vested at all times. Vesting in the Company's contributions, plus actual earnings, is based on years of continuous service. Vested interests are computed in accordance with the terms of the Plan and are based on agreements made with the participating subsidiary. Forfeitures are used to reduce future Company contributions or to pay the Plan's expenses.

Forfeitures totaling \$156,331 and \$127,720 were used in 2024 and 2023, respectively, to pay the Plan's expenses. For the years ended December 31, 2024 and 2023, \$23,197 and \$551,666, respectively, of forfeitures were applied against Company contributions. Forfeitures available for future use at December 31, 2024 and 2023, are \$507,000 and \$39,383, respectively.

Notes Receivable From Participants

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their account balance. The loans are secured by the balance in the participant's account and bear interest at rates that range from 5.25% to 10.50% at December 31, 2024.

Payment of Benefits

The Plan requires, upon termination of employment, retirement, disability or death, that the value of the participant's account, which is \$1,000 or less, be distributed in a lump-sum payment. Participant accounts between \$1,001 and \$5,000 will be automatically rolled over into an IRA. Participants with accounts in excess of \$5,000 may elect a distribution in the form of a rollover or lump-sum payment. Participants may also request in-service withdrawals, subject to certain limitations.

Note 2. Summary of Significant Accounting Policies

Basis of Accounting

The accompanying financial statements have been prepared using the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of net assets, changes in net assets and the disclosure of contingent assets and liabilities at the date of the financial statements. Actual results could differ from those estimates.

Valuation of Investments and Income Recognition

The Plan's investments are stated at fair value. The Plan's investments in shares of registered investment companies are valued based on quoted market prices which represent the net asset value of shares held by the Plan. The common or collective trust fund is valued at net asset value (NAV) of units held. The NAV is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund less its liability. The Plan's group annuity contract with Lincoln Financial Group is valued at fair value by discounting the related cash flows based on current yields of similar instruments with comparable durations considering the creditworthiness of the issuer.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded as earned. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable From Participants

Notes receivable from participants are reported at their unpaid principal balance plus any accrued but unpaid interest, with no allowance for credit losses, as repayments of principal and interest are received through payroll deductions.

Payment of Benefits

Benefits are recorded when paid.

Administrative Expenses

Participant loan fees are charged to the respective participants' accounts. Fees incurred by the Plan for the investment management services are included in net appreciation in fair value of investments. Other administrative expenses of the Plan are paid by the Company.

Note 3. Information Certified by the Trustee

The plan administrator has elected the method of annual reporting compliance permitted by ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.1033-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Charles Schwab Trust Bank, a qualified institution, has certified the following information in the accompanying financial statements and ERISA-required supplemental schedule is complete and accurate:

- Investments and notes receivable from participants as shown in the statements of net assets available for benefits as of December 31, 2024 and 2023
- Investment income components and interest income from notes receivable from participants as shown in the statements of changes in net assets available for benefits for the years ended December 31, 2024 and 2023
- Investment information and notes receivable from participants included in the accompanying supplemental schedule of assets (held at end of year) as of December 31, 2024

The Plan's independent auditors did not perform auditing procedures with respect to this information, except for comparing such information to the related information included in the financial statements and ERISA-required supplemental schedule.

Note 4. Fair Value Measurements

Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Fair value measurements must maximize the use of observable inputs and minimize the use of unobservable inputs. There is a hierarchy of three levels of inputs that may be used to measure fair value:

- Level 1** Quoted prices in active markets for identical assets or liabilities
- Level 2** Observable inputs other than Level 1 prices, such as quoted prices for similar assets or liabilities, quoted market prices in markets that are not active; or other inputs that are observable or can be corroborated by observable market data for substantially the full term of the assets or liabilities
- Level 3** Unobservable inputs supported by little or no market activity and are significant to the fair value of the assets or liabilities

The asset's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. There have been no changes in the methodologies used at December 31, 2024 and 2023.

The Plan's group annuity contract with Lincoln Financial Group is valued at fair value by discounting the related cash flows based on current yields of similar instruments with comparable durations considering the creditworthiness of the issuer.

Registered investment companies' values are determined by obtaining quoted market prices on nationally recognized securities exchanges (Level 1).

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Group Annuity Contract

The Plan entered into an investment contract with Lincoln Financial Group. Lincoln Financial Group maintains the contributions in an unallocated fund to which it adds interest on a daily basis and has no set maturity. The effective interest rate is set semi-annually and is effective on January 1 and July 1. When changed, the new rate applies only to funds deposited from the date of change. Purchased annuities are contracts under which Lincoln Financial Group is obligated to pay benefits to named employees or their beneficiaries. The premium rates for each annuity to be purchased in the future and maximum administrative expense charges against the fund are also guaranteed by Lincoln Financial Group.

The following table summarizes investments for which fair value is measured using the net asset value per share practical expedient as of December 31, 2024. There are no participant redemption restrictions for these investments; the redemption notice period is applicable only to the Plan.

Note 5. Party-in-Interest Transactions

Certain plan investments are shares of registered investment companies managed by Charles Schwab Trust Bank, the trustee of the Plan. These transactions, therefore, qualify as party-in-interest transactions.

Fees of \$408,040 and \$375,305 were paid by the Plan during 2024 and 2023, respectively, for professional services rendered by parties-in-interest. The Company provides certain administrative services at no cost to the Plan.

Note 6. Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants will become 100% vested in their accounts.

Note 7. Income Tax Status

The Plan operates under a non-standardized pre-approved profit sharing/money purchase/CODA adoption agreement sponsored by Schwab Retirement Plan Services. The non-standardized plan document has been filed by the appropriate agency and the sponsor has obtained an opinion letter dated June 30, 2020, from the Internal Revenue Service stating that the non-standardized plan, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code. Although the Plan has been amended since receiving the opinion letter, the plan administrator believes that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believes that the Plan is qualified, and the related trust is tax exempt as of the financial statement date.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Note 8. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

Note 9. Subsequent Events

Subsequent events have been evaluated through October 13, 2025, which is the date the financial statements were available to be issued.
