Independent Auditor's Report

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed an audit of the financial statements of Zephyr Products, Inc. Profit Sharing and 401(k) Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

Note 1: Description of the Plan

The following description of the Zephyr Products, Inc. Profit Sharing and 401(k) Plan (the Plan), provides only general information. Refer to the Plan agreement for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution Plan covering employees of Zephyr Products, Inc. (the Company). Employees are eligible to begin deferring contributions once they reach 500 hours of service during their first six months of employment. Employees are eligible for company matching contributions when they achieve one year of service. Employees are eligible for any discretionary contributions if employed on the last day of the Plan year and obtained 1,000 hours of service in the Plan year. There is no age requirement to participate. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Employee Contributions

Participating employees may elect to contribute a fixed percentage or dollar amount of their annual compensation, as defined in the Plan document, to the Plan on a tax-deferred or after-tax basis. Participants who have attained age 50 before the end of the Plan year, are eligible to make catch-up contributions. Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan currently offers several mutual funds to Plan participants. Participants are also allowed to make rollover contributions of amounts received from other tax-qualified retirement plans. Such contributions are deposited in the appropriate investment funds in accordance with the participant's direction and the Plan's provisions. Contributions are subject to certain IRS limitations.

Employer Contributions

The Company contributes a discretionary match of 50 percent of the participant's contribution up to two percent of the employee's eligible compensation. Participants direct the investment of the Company match into the investment options offered by the Plan.

At the end of the Plan year, the Company, at the discretion of the Company's Board of Directors, also may make profit-sharing contributions, as defined in the Plan document. Profit-sharing contributions are allocated to eligible participants based upon the percentage of the participant's compensation to the total compensation of all eligible participants. Company contributions, both matching and profit-sharing, are invested in the participant directed accounts in the same manner as the employee deferrals. The Company has provided a discretionary contribution of \$402,856 and \$327,375 for 2024 or 2023, respectively.

Participant Accounts

Each participant's account is credited with the participant's voluntary contribution and allocations of the employer's matching contribution, any employer discretionary profit-sharing contribution and Plan earnings, which are allocated proportionately among all participants based on participant earnings or account balances, as defined. Participants' accounts are charged with an allocation of administrative expenses. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are immediately fully vested in their own deferral contributions and rollover contributions. Company matching and profit sharing contributions, and any earnings attributable to these contributions, will be come vested in employer profit sharing contributions on modified vesting schedule as follows; 0% for 0-2 years, 50% after 2 years, and 100% after 3 years of service.

Participant Loans

Under the terms of the Plan, participants may borrow from their accounts a minimum of \$1,000 up to a maximum of \$50,000 and cannot exceed 50% of their nonforfeitable account balance. Loans are permitted only for purposes outlined in the loan policy. The loans are secured by the balance in the participants' accounts and bear interest at a rate of Prime plus 1%. Loan repayments are made ratably through payroll deductions. Generally, the loan term may not exceed five years. However, if the loan is for the purchase of a principal residence, the Plan Administrator may permit a longer repayment term.

For the year ended December 31, 2024 and 2023, none of the loan balances were deemed to be in default.

Payment of Benefits

Distributions are made upon death, disability, retirement, or termination of employment. In-service distributions are permitted upon attaining age 59 1/2. The participant may receive a lump-sum amount equal to the value of the participant's vested interest in his or her account. Distributions are made in a lump sum, substantially equal payments or a partial withdrawal to the participant and designated beneficiaries. Mandatory distributions may be made following severance from employment when the participant's account balance is \$5,000 or less without written consent.

Forfeitures

Forfeitures represent the non-vested portion of participant account balances upon termination. Participants forfeit the non-vested portion of employer contributions made on their behalf upon the earlier of the date they withdraw from the Plan or upon Plan-specified number of breaks in service. The amount forfeited totaled \$9,259 for the year ending December 31, 2024. Forfeited amounts are used to pay administrative expenses or reduce any employer contribution. Forfeitures used to reduce employer contribution was \$398 in 2024. At December 31, 2024 and 2023, forfeited nonvested accounts totaled \$9,407 and \$398, respectively.

Note 2: Summary of Accounting Policies

Basis of Accounting

The financial statements of the Plan are prepared under the accrual method of accounting in accordance with accounting principles generally accepted in the United States of America. Contributions from the Company are accrued in the period in which they become an obligation of the employer by declaration of the Board of Directors. Contributions from employees are accrued when withholding is made from employees' payroll.

Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan Administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

Payment of Benefits

Benefits are recorded when paid. As of December 31, 2024 and 2023 the Plan had no pending distributions of a participant requesting distribution but not receiving it until the subsequent year.

Investment Valuation and Income Recognition

The Plan's investments are presented as determined and certified by Charles Schwab Trust Bank (the Custodian) as of the Plan's year end. Shares of mutual funds and common collective trust funds are valued at the net asset value of shares held by the Plan at year end. Purchases and sales of securities are recorded on a trade-date basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Administrative Fees

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Plan Sponsor. Expenses that are paid by the Plan Sponsor are excluded from these financial statements. Fees related to the administration of distributions from participants accounts are charged directly to the participants account. Investment fees and other expenses are included in administrative expenses.

Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include quoted prices for similar assets or liabilities in active markets; quoted prices for identical or similar assets or liabilities in inactive markets; inputs other than quoted prices that are observable for the asset or liability; and inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

See Note 3 for further documentation on fair value measurements.

The asset's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs. The valuation methods may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine fair value of certain financial instruments could result in a different fair value measurement at the reporting date. There have been no changes in the methodologies used at December 31, 2024 and 2023. Following is a description of the valuation methodologies used for assets measured at fair value.

Mutual Funds

Valued at the daily closing price as reported by the fund. Mutual funds and money market accounts held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds and money market accounts held by the Plan are deemed to be actively traded.

Common Collective Trust

The Plan holds investments in Common Collective Trusts (CCT). The CCT is valued at net asset value (NAV) per unit, which is based on the fair value of the underlying assets in the trust. The NAV is calculated daily and reflects the market value of the underlying securities. The CCT is not publically traded, and redemption is restricted to qualified plans.

Note 4: Related Party and Party in Interest Transactions

The Company absorbs the cost of audit fees related to the Plan, some administrative fees and the cost of fidelity bonds. The Company provides administrative services on behalf of the Plan. As the Plan does not reimburse the Company for the cost of such services, they are not included in these financial statements.

Administrative functions are performed by officers or employees of the Company. Additional party-in-interest transactions include audit fees paid to Varney & Associates, CPAs, LLC, custodian fees paid to Charles Schwab Trust Bank, investment advisor fees paid to Creative Planning, and third-party administration fees paid to EPIC Retirement Plan Services. These transactions qualify as exempt party-in-interest transactions.

Note 5: Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts.

Note 6: Tax Status

The Company adopted a non-standardized prototype Plan document. The Internal Revenue Service issued an opinion letter, dated June 30, 2020, on the prototype Plan document, indicating the basic plan document is acceptable under Code Section 401 of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the letter, the Plan Administrator believes the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC. Therefore, no provision for income taxes has been included in the Plan's financial statements.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service or the Department of Labor. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan Administrator believes it is no longer subject to income tax examinations for the years prior to 2021.

Note 7: Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.
