As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan ("investment information") by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA ("qualified institution").

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

### *Opinion*

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

#### Note 1 - Description of Plan

The following description of Max Hospitality 401(k) Profit Sharing Plan (the "Plan") provides only general information. Participants should refer to the Plan document, and any amendments thereto, for a more complete description of the Plan's provisions.

##### General

The Plan was organized effective January 1, 1998 as a defined contribution retirement savings plan covering all eligible employees of Max Hospitality, LLC and its participating affiliates: Max Downtown, LLC, Max Trumbull, LLC, Max's Grill, LLC, Max's Oyster Bar, LLC, MaxFish, LLC, Max's Burger Bar, LLC, Max Burger Longmeadow, LLC, Maxamia, Inc., LLC, Stone Pie Kitchen, LLC, Max's Catering, LLC, and Max Goodwin, LLC, (collectively referred to as the "Company"). Eligible employees age 21 or older may begin participating in the Plan following the completion of one year of service with a minimum of 1,000 hours. Eligible employees enter the Plan on the first day of the Plan year quarter coinciding with or next following the date requirements are met. Union employees whose employment is governed by a collective bargaining agreement are excluded from participating in the Plan. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA"). The Plan administrator is responsible for oversight of the Plan, including determining the appropriateness of the Plan's investment offerings and monitoring investment performance.

##### Contributions

Participants may make salary deferral contributions to the Plan equal to a specific percentage or dollar amount of their pre-tax annual compensation, as defined by the Plan. Participants may designate all or a portion of their salary deferral contributions as Roth deferral contributions. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined contribution or defined benefit plans (rollover). Participants direct the investment of their contributions into various investment options offered by the Plan.

The Company has elected to make safe harbor matching contributions to the Plan equal to 100% of the first 3% of participant salary deferral contributions, plus an additional 50% of participant salary deferral contributions between 3% and 5%. For the year ended December 31, 2024, the Company's safe harbor matching contributions totaled \$314,140. Highly compensated employees, as defined, are not entitled to receive any safe harbor matching contributions. The Company may, at its discretion, make additional discretionary matching contributions to the Plan; however, there were no discretionary matching contributions declared for the year ended December 31, 2024.

The Company may, at its discretion, also make profit sharing contributions to the Plan. Participants must have completed one year of service with a minimum of 1,000 hours and be actively employed on the last day of the Plan year to share in an allocation of any discretionary profit sharing contributions. For the year ended December 31, 2024, the Company elected not to make any discretionary profit sharing contributions to the Plan. Participants also direct the investment of all Company contributions. All contributions are subject to certain Internal Revenue Code ("IRC") limitations.

##### Participant accounts

Each participant's account is credited with the participant's salary deferral contributions, any rollover contributions, safe harbor matching contributions and any discretionary matching contributions, as well as allocations of any discretionary profit sharing contributions and Plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions,

as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

#### **Vesting**

Participants are vested immediately in their salary deferral contributions, safe harbor matching contributions and any rollover contributions, plus actual earnings thereon. In the event of termination due to death, disability or normal retirement, participants shall become 100% vested in the Company's discretionary matching and profit sharing contribution portions of their account. For all other participants, vesting in the Company's discretionary matching and profit sharing contribution portions of their account is based on credited years of service, as defined by the Plan, according to the following schedule:

#### **Payment of benefits**

On termination of service for any reason, participants will receive benefits in a lump-sum amount equal to the value of the participant's vested interest in his or her account. Participants with a vested account balance less than \$1,000 will receive a mandatory distribution. For terminated participants with a vested account balance greater than \$1,000 but less than \$5,000, the Plan administrator will make a direct rollover of the participant's account to an individual retirement account designated by the Plan administrator. Participants with a vested account balance greater than \$5,000 may defer payment of benefits until a later date.

Withdrawals from the salary deferral portion of a participant's account may be made in the event of a financial hardship, in accordance with the provisions specified by the Plan. Participants who are at least 59½ years of age may withdraw all or a portion of the vested balance in his or her account prior to termination. Withdrawals from a participant's rollover account may be made at any time, in accordance with the provisions specified by the Plan.

#### **Forfeited accounts**

At December 31, 2024 and 2023, forfeited nonvested accounts totaled \$50,760 and \$26,226, respectively. These accounts will be used to reduce future employer contributions or to pay Plan expenses. For the year ended December 31, 2024, forfeited nonvested accounts of \$23,124 were utilized to pay Plan expenses.

### **Note 2 - Summary of accounting policies**

#### **Basis of accounting**

The financial statements of the Plan are prepared on the accrual basis of accounting.

#### **Investment valuation and income recognition**

The Plan's investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan administrator determines the Plan's valuation policies through consultation with and information provided by the trustee and the Plan's investment adviser. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold, as well as held during the year.

#### **Contributions**

Contributions from Plan participants and the safe harbor matching contributions from the Company are recorded in the year in which the employee contributions are withheld from compensation. Any profit sharing contributions from the Company are recorded in the year in which the contributions are earned.

#### **Payment of benefits**

Benefits are recorded when paid.

#### **Expenses**

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the processing of distributions and a quarterly asset-based investment advisory and recordkeeping fee are charged directly to the participant's account and are included in administrative expenses. Plan expenses also include direct payments to the Plan's third-party administrator. Other indirect investment related expenses are included in the net appreciation in fair value of investments.

#### **Use of estimates**

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America ("GAAP") requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

#### **Subsequent events**

The Plan has evaluated subsequent events through October 10, 2025, the date the financial statements were available to be issued.

#### **Note 3 - Certified investments**

The Plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Investments held at December 31, 2024 and 2023, and investment income for the year ended December 31, 2024, that are disclosed in the accompanying financial statements and supplemental Schedule of Assets (Held at End of Year) (Schedule H, Line 4i), were obtained or derived from information supplied to the Plan administrator and certified as complete and accurate by Capital Bank and Trust Company, the trustee of the Plan.

#### Note 4 - Fair value measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities ("Level 1") and the lowest priority to unobservable inputs ("Level 3"). The three levels of the fair value hierarchy under Financial Accounting Standards Board issued Accounting Standards Codification 820, *Fair Value Measurement*, are described as follows:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability; and
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodology used for assets measured at fair value. There have been no changes in the methodology used at December 31, 2024 and 2023.

*Mutual funds and money market fund:* Valued at the daily closing price as reported by the funds. The mutual funds and money market fund held by the Plan are open-end funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value and to transact at that price. The mutual funds and money market fund held by the Plan are deemed to be actively traded.

#### Note 5 - Related party transactions and party-in-interest transactions

Plan investments include shares of mutual funds and a money market fund managed by American Funds, an affiliate of Capital Bank and Trust Company. Capital Bank and Trust Company is the trustee as defined by the Plan; therefore, these transactions qualify as party-in-interest transactions. Indirect fees incurred by the Plan for investment management services are included in the net appreciation in fair value of investments. Direct fees paid by the Plan to the trustee for administrative expenses totaled \$24,449 for the year ended December 31, 2024. The Plan also made direct payments of \$17,536 to the Plan's third-party administrator and investment advisor, also considered parties-in-interest, for the year ended December 31, 2024. The Plan sponsor pays directly any other fees related to the Plan's operations.

#### Note 6 - Plan termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their employer contributions.

#### Note 7 - Tax status

The Plan has been designed using a non-standardized pre-approved defined contribution plan document sponsored by FIS Business Systems, LLC. FIS Business Systems, LLC received an opinion letter dated June 30, 2020 in which the Internal Revenue Service ("IRS") stated that the non-standardized pre-approved defined contribution plan document, as then designed, was in compliance with the applicable requirements of the IRC. Although the Plan itself has not received a determination letter from the IRS, the Plan administrator believes that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believes that the Plan is qualified and the related trust is tax-exempt.

GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

#### Note 8 - Risks and uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participant account balances and the amounts reported in the statements of net assets available for benefits.

#### **Note 9 - Nonexempt transactions**

As reported on the supplemental Schedule of Delinquent Participant Contributions (Schedule H, Line 4a), certain salary deferral contributions were not remitted to the Plan within the time frame specified by DOL Regulation 29 CFR2510.3-102, thus constituting nonexempt transactions between the Plan and the Company for the year ended December 31, 2024. The supplemental schedule includes delinquent participant contributions of \$125,075 pertaining to payroll periods during the year ended December 31, 2023. The Company is currently working with its third-party administrator to correct these delinquent participant contributions through a corrective contribution of lost earnings that will be deposited into the Plan and allocated to the affected participants as soon as administratively feasible.
