Scope and nature of the ERISA Section 103(a)(3)(C) audit

We have performed audits of the financial statements of Conway Medical Center 401(k) Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

Basis for opinion

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the plan, and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditor's responsibilities for the audit of the financial statements

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

Other matter - supplemental schedule required by ERISA

These additional procedures included comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with US GAAS. For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

NOTE 1 - DESCRIPTION OF PLAN

The following description of the Conway Medical Center 401(k) Plan (the "Plan") is provided for general information purposes only. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan that covers all full-time employees of Conway Hospital, Inc. and Conway Hospital Community Services, Inc. (collectively, the "Sponsor" or "Employer"), who are age 18 or older. The Plan was formed on March 1, 2009, and is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended ("ERISA").

Contributions and Eligibility

Participants may contribute a portion of their salary to the Plan. Participants are limited to \$23,000 for the year ended December 31, 2024 (\$30,500 for participants over 50 years of age) as prescribed by the Internal Revenue Code ("IRC"). The Plan also accepts Roth contributions and Roth rollover contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans. Certain highly compensated employees are limited further as to contributions to the Plan.

The Plan provides for Employer matching and discretionary contributions. Participants that contribute a portion of their salary to the Plan are eligible to receive Employer matching contributions equal to 100% of the amount contributed to the Plan for each payroll period up to the first 3% of eligible compensation plus 50% of the next 2% of eligible compensation.

There were no Employer discretionary contributions made during the year ended December 31, 2024.

Participant Accounts

Each participant's account is credited with the participant's contributions, Employer contributions and an allocation of Plan earnings, and is charged with withdrawals, as applicable, an allocation of Plan losses and certain Plan expenses. The allocation of Plan investment results is based on participant earnings on account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from such participant's vested account.

Vesting

Participants are immediately vested in their contributions plus the actual earnings thereon. Employer matching contributions, which are considered safe harbor contributions to the Plan, are always 100% vested. Vesting of Employer discretionary contributions is based on a participant's years of credited service. Employer discretionary contributions vest at the rate of 20% per year (beginning after two years of service) until they are fully vested after six years. Upon normal retirement, disability or death, all contributions become fully vested.

Investment Options

Upon enrollment in the Plan, participants may direct their elective deferrals and Employer matching and discretionary contributions in a variety of investment options offered by the Plan.

Notes Receivable from Participants

Participants may borrow from their vested fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The loans are secured by the balance in the participant's account. The loans bear interest at rates that are commensurate with local prevailing rates at the date of issuance, as determined quarterly by the Plan administrator. Loan repayments of principal and interest are made by participants directly to the Plan trustee in accordance with the terms of each participant loan. Participants are limited to a maximum of one outstanding loan.

Payment of Benefits

Upon termination of service, a participant may elect to receive the value of the vested interest in their account in the form of a lump-sum distribution, installment payments, annuity payments, or rollover the balance into an IRA or other qualified plan.

Also, the Plan considers the normal retirement age to be 65. Upon obtaining the normal retirement age, the Plan participant will be entitled to 100% of their account balance. While employed, participants generally may not receive a distribution from their account; however, a participant may request a distribution of all or a portion of their voluntary contributions if they can demonstrate financial hardship. In addition, participants who have attained age 59½ are entitled to receive distributions from all contribution accounts. Minimum required distributions for participants who have reached age 73 also apply per IRC regulations.

Forfeited Accounts

Forfeitures of terminated participants' nonvested accounts are used to reduce future Employer contributions or pay Plan expenses. During the year ended December 31, 2024, \$119,576 of forfeitures were used to reduce Employer contributions to the Plan. As of December 31, 2024 and 2023, the forfeiture balance was \$2,208 and \$0, respectively.

NOTE 2 - SUMMARY OF ACCOUNTING POLICIES

Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America ("US GAAP").

Use of Estimates

The preparation of financial statements in conformity with US GAAP requires management to make estimates and assumptions that affect the reported amounts of net assets available for benefits and changes therein. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

The Plan's mutual funds, collective trusts, group variable annuity and stable value separate account investments are stated at fair value. The net appreciation in fair value of investments includes realized and unrealized gains and losses from investment activity. Purchases and sales of securities are recorded on a trade-date basis. Dividends are recorded on the ex-dividend date. Interest income is recorded on the accrual basis.

Risks and Uncertainties

The Plan provides for various investment securities. Investment securities are exposed to various risks, such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities and the level of uncertainty related to changes in the value of investment securities, it is at least reasonably possible that changes in risks in the near term would materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits and the statement of changes in net assets available for benefits.

Payment of Benefits

Benefits are recorded when paid.

Administrative Expenses

The Employer may pay Plan administration expenses with its own assets rather than using Plan assets. To the extent the Employer does not pay Plan expenses with its own assets, the Plan will pay the expenses of Plan administration and will assess the expenses paid against the accounts of all participants in the Plan. Additionally, administrative expenses include certain participant-initiated transaction fees that are assessed against the individual participant's account, such as loan origination fees.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid balance plus any accrued but unpaid interest. Delinquent loans considered in default are reclassified as distributions based upon the terms of the Plan document.

NOTE 3 - CERTIFIED INFORMATION

The Plan Administrator has elected the method of annual reporting compliance permitted by 29 CFR 2520.103-8 of the Department of Labor Rules and Regulations for Reporting Disclosures under ERISA. Accordingly, as of December 31, 2024 and 2023 and for the year ended December 31, 2024, Lincoln Financial Group Trust Company, Inc. (the "Trustee") has certified that the following data included in the accompanying financial statements and supplemental schedule is complete and accurate:

- Investments, at fair value and notes receivable from participants, as shown in the statements of net assets available for benefits as of December 31, 2024 and 2023.
- Investment income and interest income on notes receivable from participants, as shown in the statement of changes in net assets available for the year ended December 31, 2024.
- Schedule H, line 4(i) - schedule of assets (held at end of year) as of December 31, 2024.

NOTE 4 - FAIR VALUE MEASUREMENTS

Accounting Standards Codification ("ASC") 820, *Fair Value Measurements and Disclosures*, establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest

priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under ASC 820 are described below:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability; and
- Inputs that are derived principally from or corroborated by observable market data by correlation, or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full-term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The valuation methods described below may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date. There were no changes in valuation methodology between December 31, 2023 and December 31, 2024.

Mutual funds - A portion of the Plan's assets are invested in actively traded mutual funds, which are valued at the net asset value ("NAV") of shares as of the reporting date as quoted on nationally recognized securities exchanges.

Stable value separate account - Valued at NAV of units held based on fair value of underlying investments, less liabilities. The NAV is used as the practical expedient to estimate fair value. The Lincoln Stable Value Separate Account is a fixed annuity contract issued by The Lincoln National Life Insurance Company. Assets backing this contract are held in a separate account that's segregated from the general assets of the issuing company. Assets in the Lincoln Stable Value Separate Account are held for the exclusive benefit of contract owners and aren't subject to the claims of insurance company creditors or other general account contract owners. The primary objective of the stable value separate account is to maximize investment income with long-term preservation of capital. If the Plan decides to terminate the contract, pay out of the balance is in six installments over five years by paying 20% immediately, 20% in year 1, 25% in year 2, 33% in year 3, 50% in year 4, and 100% in the final year. There are no additional redemption restrictions. During the payout period, interest will continue to be credited to the balance. There are no unfunded commitments.

Collective trusts - Valued at NAV of units held based on fair value of underlying investments, less liabilities. The NAV is used as the practical expedient to estimate fair value. The Plan's collective trust investments include the MFS Mid Cap Growth Fund Collective Trust, the MFS Mid Cap Value Fund

Collective Trust, and the Great Gray Trust EuroPacific Growth Class Collective Trust. The primary objective of the MFS Mid Cap Growth Fund Collective Trust is to invest in the MFS Mid Cap Growth Fund, which is the underlying fund. The investment strategy of the MFS Mid Cap Growth Fund is to invest primarily in equity securities of issuers with medium market capitalization with a focus on investments in companies its manager believes to have above average earnings growth potential compared to other companies. The primary objective of the MFS Mid Cap Value Fund Collective Trust is to invest in the MFS Mid Cap Value Fund, which is the underlying fund. The investment strategy of the MFS Mid Cap Value Fund is to invest primarily in equity securities of issuers with medium market capitalization that its manager believes are undervalued compared to their perceived worth. There are no unfunded commitments or redemption restrictions. The primary investment objective of the Great Gray Trust EuroPacific Growth Class Collective Trust is to invest in the Capital Group EuroPacific Growth Trust, which is the underlying investment fund, a collective investment trust maintained by the Capital Bank and Trust Company. The investment strategy of the Capital Group EuroPacific Growth Trust is to seek long-term capital growth by investing in international equity investments.

Group variable annuity - The Plan's Lincoln Pathbuilder Income investment option is a group variable annuity contract. Amounts contributed to the annuity contract are invested in the Lincoln Variable Insurance Products Trust (LVIP) American Global Balanced Allocation Managed Risk Fund, a fund of funds with a balanced allocation. The guarantee is provided by a contract between the Plan sponsor and The Lincoln National Life Insurance Company that provides a plan participant with guaranteed annual retirement income.

NOTE 5 - PLAN TERMINATION

Although it has not expressed any intent to do so, the Sponsor has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts.

NOTE 6 - TAX STATUS

The Plan is operating under a non-standardized pre-approved plan document issued by Lincoln Retirement Services Company LLC. Plan management has obtained an opinion letter dated June 30, 2020, from the Internal Revenue Service ("IRS") specifying the form of the Plan adoption agreement and the basic Plan document is acceptable under IRS Section 401 as of the date of the opinion letter. The Plan has been amended since receiving the opinion letter. However, the Plan administrator believes the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC and, therefore, believes the Plan is qualified and is tax exempt.

US GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken uncertain positions that more-likely-than-not would not be sustained upon examination by the IRS. The Plan administrator has analyzed the tax positions taken by the Plan and has concluded that as of December 31, 2024 and 2023, there are no uncertain positions taken, or expected to be taken, that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

NOTE 7 - TRANSACTIONS WITH PARTIES-IN-INTEREST

Certain plan investments are managed by The Lincoln National Life Insurance Company (“LNLIC”), an affiliate of the Plan’s Trustee. Therefore, transactions with LNLIC qualify as exempt party-in-interest transactions. Notes receivable from participants are also considered party-in-interest transactions. The majority of the Plan’s administrative fees are paid by the Sponsor, who is also considered to be a party-in-interest of the Plan.

NOTE 8 - SUBSEQUENT EVENTS

The Plan evaluated subsequent events and transactions for potential recognition or disclosure in the financial statements through October 13, 2025, the date the financial statements were available to be issued. Effective January 1, 2025, the Plan was amended to remove the minimum service requirement for participation in the Plan, and to allow for in-plan Roth conversions.
