Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of the Alacriant, Inc. 401(k) Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

1. Description of the Plan

The following description of the Alacriant, Inc. 401(k) Plan provides only general information. Participants should refer to the Plan agreement and the summary plan description for a more complete description of the Plan's provisions.

General

Alacriant, Inc. (the Plan Sponsor) established the Plan effective March 1, 2001. The Plan is a defined contribution plan that covers substantially all employees of the Plan Sponsor who have completed two months of service and have attained the age of eighteen. The Plan is subject to the provisions of ERISA.

Contributions

Each year participants may contribute up to 100% of their annual pre-tax compensation into the Plan, subject to the maximum amount allowed by the Internal Revenue Code (IRC). The Company also offers a Roth 401(k) option. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans.

The Plan provides for an automatic enrollment deferral percentage of 2% of compensation for newly eligible participants. The new participant may affirmatively elect a different percentage or elect not to make an elective deferral contribution.

The Plan Sponsor may contribute a discretionary matching percentage of each participant's eligible deferral contribution. The Plan Sponsor matched 100% of the participants' voluntary contributions up to 2% of compensation, which resulted in a matching contributions of \$102,643 for the year ended December 31, 2024.

The Plan Sponsor may also make other contributions to the Plan which are referred to as qualified matching contributions and qualified non-elective contributions. These contributions are totally discretionary, including the discretion to forego the contribution for one or more Plan years. The Plan Sponsor made no qualified matching contributions or non-elective contributions for the year ended December 31, 2024. All contributions are limited to the maximum allowed as a deduction under the IRC.

Vesting

A participant is fully vested immediately in elective wage deferrals and amounts rolled over from other qualified plans. Vesting for discretionary employer matching contributions are as follows:

Participant Accounts

Each participant's account is credited with the participant's contribution including elective deferrals and rollover contributions and an allocation of the Plan Sponsor's contribution and plan earnings. The benefit

to which a participant is entitled is the benefit that can be provided from the participant's vested account. All investments of the Plan are fully participant-directed.

Notes Receivable from Participants

Participants are permitted to borrow from their vested interest of their individual account a maximum of \$50,000 or the greater of 50% of their vested account balance, whichever is less. The notes are secured by the participant's vested account balance and are considered a direct investment from their account under the Plan and bear interest at rates ranging from 3.25% to 8.50% at December 31, 2024. These notes are generally payable in equal installments through payroll deductions and carry a reasonable interest rate based on a bank or other professional lender's rate charged for a loan under similar circumstances.

Payment of Benefits

Upon termination of service, a participant may elect to receive either a lump-sum distribution, a direct rollover distribution, or partial installment distributions to satisfy the required minimum distribution rules, equal to the value of the participants' vested interest in his or her account. The Plan Sponsor automatically cashes out participants who leave the company after the date of termination if the participants' account balance is \$5,000 or less. A participant having a balance between \$1,000 and \$5,000 must elect to receive either a lump-sum distribution or a direct rollover distribution. A participant having less than a \$1,000 balance must take a lump-sum distribution. Non-terminated employees who have reached age 59 ½ may make withdrawals of up to 100% of their vested account balance. Non-terminated employees may make withdrawals from their vested account balance as a hardship withdrawal. Hardship withdrawals are subject to additional rules and conditions as outlined in the Plan agreement.

Forfeited Accounts

Forfeitures which occur pursuant to the Plan may be used to restore amounts previously forfeited, reduce employer contributions, or to reduce administrative expenses. During the year ended December 31, 2024, \$26,528 was transferred into the forfeiture account, \$75 was earned on investments, and \$26,596 was used to offset a portion of employer contributions. As of December 31, 2024 and 2023, the Plan had no forfeitures available.

2. **Summary of Significant Accounting Policies**

Basis of Accounting

The Plan's financial statements have been prepared on the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan Sponsor to make estimates that affect reported amounts in the financial statements and accompanying notes. Accordingly, actual results may differ from these estimates.

Investment Valuation and Income Recognition

Investments are required to be reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's trustee determines the Plan's valuation policies utilizing information

provided by the investment advisers, custodians, and insurance company. See Note 4 for a discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments purchased and sold, as well as held, during the year.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are charged directly to the borrowing participant's account and are included in administrative expenses when incurred. If a participant does not make note repayments and the plan administrator considers the participant note to be in default, the note balance is reduced, and the delinquent participant note receivable is recorded as a benefit payment based on the terms of the Plan agreement.

Payment of Benefits

Benefits are recorded when paid.

Administrative Expenses

Certain expenses of maintaining the Plan are paid directly by the Plan Sponsor and are excluded from these financial statements. Certain investment management and other fees are paid directly by the Plan. Investment related expenses are included in appreciation (depreciation) of fair value of investments.

Subsequent Events

The Plan Sponsor has evaluated subsequent events through October 14, 2025, which is the date the financial statements were available to be issued.

3. Information Provided by the Custodians

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and supplemental schedule, including investments and notes receivable from participants held at December 31, 2024 and 2023, and investment income (loss) and benefit payments for the year ended December 31, 2024, was obtained or derived from information supplied to the plan administrator and certified as complete and accurate by Principal Trust Company and Principal Life Insurance Company, the custodians.

4. Fair Value Measurements

The authoritative accounting guidance establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy under the authoritative accounting guidance are described as follows:

Notes to Financial Statements

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the plan has the ability to access.

Level 2 - Inputs include quoted prices that are observable for the asset or liability and inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 or 2023.

Registered investment companies: Valued at the closing price reported on the active market on which the individual securities are traded.

Pooled separate accounts: Valued at the net asset value (NAV) of shares held by the Plan at year end. The NAV, as provided by the custodians, is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund less its liabilities. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV.

Common/collective trusts: Valued at the daily NAV of units of a collective trust. The NAV, as provided by the custodians, is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund less its liabilities. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation method is appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

5. Plan Termination

Although it has not expressed any intent to do so, the Plan Sponsor has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants will become 100% vested in their accounts.

6. Tax Status

The Internal Revenue Service (IRS) has determined and informed the Plan Sponsor by a letter dated June 30, 2020, that the Plan and related trust are designed in accordance with applicable sections of the IRC. Although the Plan has been amended since receiving the determination letter, the Plan administrator and the Plan's tax counsel believe that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believe that the Plan is qualified, and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require the Plan Sponsor to evaluate tax positions taken by the plan and recognize a tax liability if the plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

7. Transactions with Parties in Interest

Principal Trust Company and Principal Life Insurance Company are the custodians of the Plan and hold all of the Plan's investments. Principal Trust Company and Principal Life Insurance Company are parties in interest of the Plan as defined by ERISA Section 3(14), and accordingly investment transactions in the funds are parties in interest transactions. Certain legal and accounting fees and certain administrative expenses relating to the maintenance of participant eligibility records are absorbed by the Plan Sponsor. Other than as described above or pursuant to a trust agreement, the Plan has no agreements or transactions with any parties in interest.

8. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.
