Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of Tasis Dorado Retirement Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) audit. The financial statements comprise the statements of net assets available for benefits as of December 31, 2024, and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of Tasis Dorado Retirement Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of and for the years ended December 31, 2024, and 2023, stating that the certified investment information, as described in Note C and D to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section:

- The amounts and disclosures in the financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- The information in the financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America. Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of Tasis Dorado Retirement Plan and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about Tasis Dorado Retirement Plan's ability to continue as a going concern for one year after the date the financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the plan, and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditor's Responsibilities for the Audit of the Financial Statements

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with generally accepted auditing standards will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedules, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audits of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with generally accepted auditing standards. DECEMBER 31, 2024, AND 2023

NOTE A - DESCRIPTION OF THE PLAN

The following description of the Tasis Dorado Retirement Plan (hereinafter referred to as the Plan) provides only general information. Participants should refer to the Plan Adoption Agreement for a complete description of the Plan's provisions.

General

The Plan is a defined contribution plan covering all employees of Tasis Dorado Education Foundation, Inc. (hereinafter referred to as the Sponsor), who have complied with the required minimum age of 21 to become a participant. No service requirement is needed to allow employees enter to the Plan. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Contributions

Participants can make pre-tax contributions and after-tax contributions, up to the limitations prescribed under applicable law, as defined in the Plan. Participants are allowed to modify or suspend their contributions on a quarterly basis.

The Employer may match pre-tax contributions equal to \$1 for each dollar contributed by the participant up to 2% of compensation. The Plan allows an additional employer contribution of 1% contribution to their account, whether they choose to contribute or not.

Rollover contributions

The Plan's Trustee shall be authorized to receive rollover contributions only if the employee has met the participation requirement of the Plan as of the date of the contributions.

Profit sharing contributions

The Employer will make no Profit-Sharing Contributions.

Participants' accounts

Each participant's account is credited with the participant's contribution and an allocation of (a) the Sponsor's contribution, if eligible and (b) Plan earnings. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

NOTE A - DESCRIPTION OF THE PLAN - CONTINUED

Vesting

Participant's pre-tax and after-tax contributions are always 100% vested.

For matching contribution, participants are vested according to the following schedule:

- 25% after one year of service
- 50% after two years of service
- 75% after three years of service
- 100% after four years of service

For the additional employer contribution, participants are vested according to the following schedule:

- 20% after two years of service
- 40% after three years of service
- 60% after four years of service
- 80% after five years of service
- 100% after six years of service

Investment option

Upon enrollment in the Plan, a participant directs the investment of his or her contributions into Mutual Funds. If no investment instructions are provided, participants' accounts will be invested in a qualified default investment alternative selected by the Plan Sponsor. The participants are allowed to change their investment options on a daily basis.

Distribution of benefits

Distribution of benefits that are less than \$5,000 shall be made to participants in a single lump sum payment. If the amount exceeds \$5,000, the participant shall have the option to decide how to receive the distribution.

The Plan shall permit distributions attributable to Sponsor contributions only upon the occurrence of one of the following events:

- a. a financial hardship
- b. retirement of the employee or attainment of normal retirement age.
- c. separation from service (for any reason, including death).
- d. permanent disability of the employee.
- e. termination of the Plan.

Loans

Loans to participants from the Plan are not permitted.

Forfeitures

Forfeitures under the Plan will be used to reduce related Plan costs and expenses or to allocate to participant's accounts. Forfeitures will be maintained in a single suspense account and invested in the default investment option selected by the Plan Sponsor.

NOTE B - ORGANIZATION, BASIS OF PRESENTATION, AND ACCOUNTING POLICIES

Organization

The Plan was organized on August 1, 2017, and commenced operations on September 1, 2017. Plan was amended effective on August 1, 2019.

Accounting policies

Basis of presentation

The financial statements of the Plan are prepared on the accrual basis of accounting. The Plan sponsor is Tasis Dorado Educational Foundation, Inc. Banco Popular de Puerto Rico (BPPR) is the trust and recordkeeper of the Plan.

Investment valuation and income recognition

The Plan's investments are participant-directed and are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note D for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis.

Fair value measurements

The Plan's investments are reported at fair value in the accompanying statements of net assets available for benefits. The fair value measurement accounting literature (ASC 820) establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value and describes inputs as either observable or unobservable. Observable inputs can be seen in the market whereas unobservable inputs are assumptions made by the valuer based upon the best available information. ASC 820 requires the observable inputs to be used wherever possible, resulting in the classification of the hierarchy.

The Plan categorizes its fair value measurements into a three broad levels hierarchy based on the priority of the inputs to the valuation technique. The fair value hierarchy gives the highest priority to quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). If the inputs used to measure fair value fall within different levels of the hierarchy, the category level is based on the lowest priority level input that is significant to the fair value measurement of the instrument in its entirety.

The Plan categorizes assets and liabilities carried at fair value in the accompanying statements of net assets available for benefits as follows:

- Level 1 - Unadjusted quoted prices accessible in active markets for identical assets or liabilities at the measurement date and mutual funds where the value per share (unit) is determined and published daily and is the basis for current transactions. Level 1 inputs are considered "observable" inputs.
- Level 2 - Unadjusted quoted prices for similar assets or liabilities in active markets or inputs (other than quoted prices) that are observable or that are derived principally from or corroborated by observable market data through correlation or other means. Primary inputs to this valuation technique may include comparative trades, bid/asks, interest rate movements, U.S. Treasury rates, Secured Overnight Financing Rate ("SOFR"), prime rates, cash flows, maturity dates, call ability, estimated prepayments, and/or underlying collateral values.

Fair value measurements-continued

- Level 3 - Prices or valuation techniques that require inputs that are both unobservable and significant to the overall fair value measurement. Inputs reflect management's best estimate about the assumptions market participants would use at the measurement date in pricing the asset or liability. Consideration is given to the risk inherent in both the method of valuation and the valuation inputs. Primary inputs to this valuation technique include broker quotes and comparative trades.

Changes in observability of significant valuation inputs identified during these reviews may trigger reclassifications. Reclassifications are reported as transfers at the beginning of the period in which the change occurs.

Use of estimates

The preparation of financial statements in conformity with generally accepted accounting principles requires the plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

Payments of benefits

Benefits are recorded when paid.

Administration expenses

All expenses for maintaining the Plan are accounted for as they are incurred and paid or contributed by the Plan Sponsor. Administrative expenses for the year ended December 31, 2024 and 2023, amounted to approximately \$10,000 and \$8,000 respectively.

NOTE E - TRANSACTIONS WITH PARTIES-IN-INTEREST

The trustee of the assets and the Plan's auditors are parties-in-interest to the Plan. The Sponsor is not aware of any prohibited transactions with parties-in-interest. Auditing fees and administrative expenses are paid by the Sponsor, which amounted to approximately \$25,000 and \$21,000 during 2024 and 2023, respectively. Fees paid to the trustee of investments appear to be reasonable for the years ended December 31, 2024, and 2023.

NOTE F - INCOME TAX STATUS

The Department of the Treasury of the Commonwealth of Puerto Rico has ruled that the Plan qualifies under Section 1081.01 (e) of the Income Tax Act of 2011 (the Act) and is, therefore, not subject to income tax under the present income tax law. The Plan is required to operate in conformity with the Act to maintain its qualification.

NOTE G - RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risks associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances, and the amount reported in the statement of net assets available for benefits.

NOTE H - PLAN TERMINATION

Although it has not expressed any intent to do so, the Sponsor has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their employer contributions and the Trust shall continue until all Participants' accounts have been completely distributed.

NOTE I - DATE OF MANAGEMENT'S REVIEW

Subsequent events were evaluated through October 1, 2025, which is the date the financial statements were available to be issued.
