Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the plan, and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

### ***Auditor's Responsibilities for the Audit of the Financial Statements***

Our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

In performing an audit in accordance with GAAS, we:

- Exercise professional judgment and maintain professional skepticism throughout the audit.
- Identify and assess the risks of material misstatement of the financial statements, whether due to fraud or error, and design and perform audit procedures responsive to those risks. Such procedures include examining, on a test basis, evidence regarding the amounts and disclosures in the financial statements.
- Obtain an understanding of internal control relevant to the audit in order to design audit procedures that are appropriate in the circumstances, but not for the purpose of expressing an opinion on the effectiveness of Leggett & Platt, Incorporated Employee Benefit Fund's internal control. Accordingly, no such opinion is expressed.
- Evaluate the appropriateness of accounting policies used and the reasonableness of significant accounting estimates made by management, as well as evaluate the overall presentation of the financial statements.
- Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about Leggett & Platt, Incorporated Employee Benefit Fund's ability to continue as a going concern for a reasonable period of time.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control related matters that we identified during the audit.

NOTE A – DESCRIPTION OF PLAN

The following description of the Leggett & Platt, Incorporated (L&P or the Company) Employee Benefit Fund (Plan) provides only general information. Prior to December 31, 2024, substantially all of the benefits of the Plan were funded through a Voluntary Employee Beneficiary Association trust (VEBA). On December 31, 2024, as more fully described below, the VEBA was terminated. Participants should refer to the Plan document and annual enrollment materials for a more complete description of the Plan's provisions.

Plan Termination

The Plan may be terminated or amended at any time by action of the Board of Directors of L&P, or its designees, subject to the provisions set forth in ERISA. Should the Plan be terminated, the Company shall complete the processing of all requests for benefit payments for which participants were entitled prior to such termination.

Termination of Trust

On December 31, 2024, L&P terminated the VEBA trust. The Plan will continue to provide medical benefits as discussed below, however, all future claim payments, including the Plan's currently payable benefit obligations and postemployment benefit obligations, will be made from the general assets of the Company. In addition, the Plan will no longer undergo a financial statement audit.

General

The Plan provides medical benefits for eligible employees of L&P and certain subsidiaries and affiliates. In addition, retired or terminated employees may purchase continued coverage for a specified period of time as required by the Consolidated Omnibus Budget Reconciliation Act of 1985, as amended (COBRA). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

Administrative Expenses

Both L&P and the Plan pay administrative services. Expenses paid by L&P at no cost to the Plan include accounting and other administrative services. Remaining expenses are paid by and reflected in the financial statements of the Plan.

Eligibility and Benefits

After a specified waiting period, the Plan provides medical benefits for employees (including spouses and dependents) of L&P locations participating in the Plan with 30 hours or more of service each week. Most medical benefits are underwritten by the Plan; however, the Plan carries reinsurance coverage for claims that exceed certain limits.

Contributions

Employees are required to contribute to the Plan, generally based on the number of adults and children covered, at rates determined by L&P. L&P will make contributions as needed for the difference between participant contributions, reinsurance payments, medical claims, insurance premiums and administrative expenses paid by the Plan. Any deficiency of the Plan's net assets over benefit obligations is funded by the Company on a pay-as-you-go basis.

NOTE B – SUMMARY OF ACCOUNTING POLICIES

Basis of Accounting

The accompanying financial statements have been prepared on the cash basis, which is a basis of accounting other than accounting principles generally accepted in the United States of America and is permitted by the Department of Labor Rules and Regulations for Reporting and Disclosure. Under the cash basis, additions and deductions are not recorded by the Plan until cash is received and payments are made.

NOTE B – SUMMARY OF ACCOUNTING POLICIES – CONTINUED

Use of Estimates

The preparation of financial statements in conformity with the Plan's cash basis of accounting requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities, benefit obligations and changes therein and disclosure of contingent assets and liabilities at the date of the financial statements. Actual results could differ from those estimates.

Income Taxes

The VEBA received an exemption letter from the IRS dated April 17, 1989, stating that the VEBA is tax-exempt under the provisions of Section 501(a) of the Internal Revenue Code (IRC). However, as a result of the Plan's funding policy, from time to time the VEBA may be subject to income tax.

In addition, the Plan and the VEBA are required to operate in conformity with the IRC to maintain the tax-exempt status of the Plan and the VEBA. L&P believes that the Plan and the VEBA are being operated in compliance with the applicable requirements of the IRC and, therefore, believes that the Plan and the VEBA are tax-exempt.

With a few exceptions, the Plan and the VEBA are no longer subject to federal, state and local income tax examinations by tax authorities for years before 2021.

Benefit Obligations

Plan benefit obligations for amounts currently payable, including medical claims payable and claims incurred but not reported, at December 31, 2024 and 2023 and the changes in the benefit obligations for the years then ended are estimated based upon historic claims experience, timing of the payment of claims, and actual claims reported after year end. The Plan's benefit obligations at December 31, 2024 will be paid from the general assets of the Company in 2025.

Postemployment Benefit Obligation (PEBO)

The Plan has estimated PEBO for health care benefits attributable to terminated employees covered under the provisions of the COBRA and under the Plan's specific provisions relating to spouses and dependents of deceased employees and employees who become temporarily totally disabled. This estimate was developed using participant status, coverage periods and historical claims data. The Plan's PEBO at December 31, 2024 will be paid from the general assets of the Company in 2025.

Payment of Benefits

Claim payments are recorded when paid by the Plan as medical claims paid in the accompanying Statements of Changes in Net Assets Available for Benefits.

Reinsurance Coverage

Premiums for reinsurance coverage are included in the accompanying Statements of Changes in Net Assets Available for Benefits. The Plan's reinsurance coverage has a per participant deductible limit of \$1,000,000. The Plan had no claims that exceeded our per participant deductible limits during the year ended December 31, 2023. During the year ended December 31, 2024, reinsurance coverage reimbursements of \$1,923,678 were received and netted with medical claims paid in the accompanying Statement of Changes in Net Assets Available for Benefits.

NOTE C – PARTIES-IN-INTEREST TRANSACTIONS

Party-in-interest transactions include those with fiduciaries, any person who provides services to the Plan, an employer whose employees are covered by the Plan, a person who owns 50% or more of such an employer, or relatives of such persons.

The Company provides accounting and other administrative services at no cost to the Plan. These transactions are allowable party-in-interest transactions under Section 408(b) of ERISA and the regulations promulgated thereunder.

NOTE D – SUBSEQUENT EVENTS

Subsequent events have been evaluated through October 14, 2025, which is the date the financial statements were available to be issued.
