**NOTE 1: DESCRIPTION OF PLAN**

The following description of the Jako Enterprises, LLC 401(k) Profit Sharing Plan (Plan) provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan's provisions.

**General** - The Plan is a defined contribution plan established and effective January 1, 2011, to provide employees of Jako Enterprises, LLC (Company) the opportunity to accumulate savings that provide benefits in the event of retirement, disability, or death. The Plan is structured to comply with the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended. Participation in the Plan is voluntary.

**Eligibility** - An employee becomes eligible to participate in the Plan after completing six months of service and attaining age 18 and may enter the Plan immediately following the date of eligibility.

**Contributions** - Each year, participants are eligible to contribute up to 85 percent of annual compensation up to the maximum permitted by law on a pretax basis, a Roth after-tax basis or a combination of both. Participants who are at least age 50 before the end of a plan year are eligible to make catch-up contributions during the plan year. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover). Participants direct the investment of their contributions into a diversified menu of investment options offered by the Plan. The Company contributes a 100% safe harbor matching contribution limited to 4% of a participant's compensation. The Company may also elect to make discretionary additional matching contributions and/or profit-sharing contributions each year. There were no discretionary matching or profit-sharing contributions made for the plan years ended December 31, 2024 and 2023. Contributions are subject to certain statutory limitation.

**Participant Accounts** - Each participant's account is credited with the participant's contributions and Company matching contributions, as well as an allocation of plan earnings, and charged with an allocation of any administrative expenses paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

**Vesting** - Participants are immediately vested in their contributions and the safe harbor matching contribution plus actual earnings thereon. Vesting in the Company's discretionary profit-sharing contribution portion of their accounts is based on years of continuous service after the effective date of the Plan. A participant is 20% vested after two years of service. The vesting percentage increases 20% each subsequent year until a participant becomes 100% vested after six years of credited service. Participants become 100% vested upon death or disability while employed by the Company.

**NOTE 1: DESCRIPTION OF PLAN - CONTINUED**

**Contributions** - Contributions from plan participants and the related employer-matching contributions, if any, are recorded in the year in which the participant contributions are withheld from compensation.

**Notes Receivable from Participants** - Participants may borrow from their accounts a minimum of \$500 up to a maximum equal to the lesser of \$50,000 or 50% of their account balance. Participants may only have two outstanding loans at one time. The notes are secured by the balance in the participant's account. All loans pay a rate of interest based on the prime rate on the date the loan is requested. All loans are repaid through payroll deductions within a five-year period, unless used for the purchase of a primary residence. The plan administrator shall treat a loan as being in default upon termination of employment or upon the failure to make any payment when due. Upon termination, the entire outstanding principal and accrued interest shall be immediately due and payable, and the participant will be deemed to have received a taxable distribution from the Plan. The loan offset occurs no later than the first date the participant may receive a distribution under the terms of the Plan.

**Payment of Benefits** - Upon termination of service due to death, disability, retirement (normal age 65 and early age 62), or separation from service, or attainment of age 59½ without terminating employment, a participant may elect to receive a lump-sum amount, substantially equal payments, or partial withdrawals equal to the value of the participant's vested interest in certain accounts. Balances of terminated participants that do not exceed \$5,000 will be automatically distributed in a direct rollover to an individual retirement account designated by the Company. Upon the death of a participant, the participant's beneficiary is entitled to the balance of the participant's account.

As required under Section 401(a)(9) of the Internal Revenue Code (IRC), a participant must begin receiving required minimum distributions from the Plan by April 1 of the calendar year following the later of (i) the year in which the participant reaches age 73, or (ii) the year in which the participant retires if not a 5% owner.

**Hardship Withdrawals** - Participants can withdraw their employee pretax and/or Roth contributions in the form of a hardship withdrawal to satisfy an immediate and heavy financial need as defined by the Plan.

**Forfeitures** - As of December 31, 2024 and 2023, forfeited nonvested accounts totaled \$42 and \$359, respectively. Forfeited amounts, to the extent they are not used to pay plan expenses, are to be used to reduce any employer contributions. During 2024, no forfeitures were used to reduce employer contributions or pay plan expenses.

**NOTE 2: SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

**Basis of Accounting** - The financial statements of the Plan are prepared on the accrual basis of accounting, in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP).

**NOTE 2: SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES - CONTINUED**

*Use of Estimates* - The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

*Investment Valuation and Income Recognition* - Investments are reported at fair value. Fair value is the price that would be received for the sale of an asset or paid for the transfer of a liability in an orderly transaction between market participants at the measurement date. See Note 3 for discussion of fair value measurements.

Purchases and sales of investments are recorded on a trade-date basis. Interest income is accrued when earned. Dividend income is recorded on the ex-dividend date. Net appreciation/depreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

*Notes Receivable from Participants* - Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are charged directly to the borrowing participant's account and are included in administrative expenses when incurred. As of December 31, 2024 and 2023, no allowance for credit losses has been recorded. If a participant does not make loan repayments and the plan administrator considers the participant loan to be in default, the loan balance is reduced, and the delinquent participant note receivable is recorded as a benefit payment based on the terms of the plan document.

*Payment of Benefits* - Benefits are recorded when paid.

*Administrative Expenses* - Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses paid by the Company are excluded from these financial statements. Costs associated with participant-initiated transactions are paid by the respective participants' accounts. Some administrative expenses are paid from the annual operating expenses of the Plan's designated investment alternatives, which are netted against the investment earnings for the relevant participant-directed investments.

*Subsequent Events* - The Plan's policy is to evaluate events and transactions subsequent to its year end for potential recognition in the financial statements or disclosure in the notes to the financial statements. Management has evaluated events and transactions through the date of the independent auditor's report, which is the date the financial statements were available to be issued.

**NOTE 3: FAIR VALUE MEASUREMENTS**

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of fair value hierarchy are described as follows:

*Level 1* - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

*Level 2* - Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability; and
- Inputs that are derived principally from, or corroborated by, observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

*Level 3* - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

Following are descriptions of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used as of December 31, 2024 and 2023.

**Registered Investment Companies (Mutual Funds)** - Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

**NOTE 3: FAIR VALUE MEASUREMENTS - CONTINUED**

*Collective Trust* - Valued at the NAV of units of the trust. The NAV, as provided by the trust, is used as a practical expedient to estimate fair value. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV. Participant transactions may occur daily. Were the plan to initiate a full redemption of the collective trust, the investment advisor reserves the right to temporarily delay withdrawal from the trust in order to ensure that securities liquidation will be carried out in an orderly business manner.

**NOTE 5: RELATED-PARTY AND PARTY-IN-INTEREST TRANSACTIONS**

The Plan has not considered normal plan operations such as participant and employer contributions or benefits accrued or paid by the Plan for participants as party-in-interest transactions that require separate disclosure. Participant loan origination fees and distribution fees are paid out of the relevant participants' accounts. The Company pays directly any other fees related to plan operations. These transactions qualify as party-in-interest transactions that are exempt from the prohibited transaction rule.

**NOTE 6: PLAN TERMINATION**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants would become 100 percent vested in their employer contributions.

**NOTE 7: TAX STATUS**

The underlying prototype standardized profit-sharing plan with Cash or Deferred Arrangement (CODA) has received an opinion letter from the Internal Revenue Service (IRS) dated June 30, 2020, stating that the form of the Plan is qualified under the IRC and, therefore, the related trust is tax exempt. Once qualified, the Plan is required to operate in conformity with the IRC to maintain its qualification.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would be sustained upon examination by the IRS or DOL. The plan administrator has analyzed the tax positions taken by the Plan and has concluded that as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in process. The Plan's federal Form 5500 is subject to examination from regulatory authorities generally for the three years after it was filed.

**NOTE 8: RISKS AND UNCERTAINTIES**

The Plan invests in various registered investment companies and collective trusts, which are exposed to various risks such as interest rate, market, and credit risk. Due to the level of risk associated with certain investments, it is at least reasonably possible that changes in the values of investments will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

**NOTE 9: COMMITMENTS AND CONTINGENCIES**

In the normal course of business, there may be various commitments and contingencies outstanding which are not reflected in these financial statements. In the opinion of plan management, the outcome of such events, if any, would not have a material effect on the Plan's financial position or operations.

**NOTE 10: PLAN RESTATEMENT**

Effective April 1, 2024, the plan was restated, and Fidelity became the custodian. All assets were transferred to Fidelity on March 28, 2024. Additionally, added an age requirement for eligibility of 18 years, the entry date was changed to immediate, and discretionary additional matching contributions were added to the Plan.
