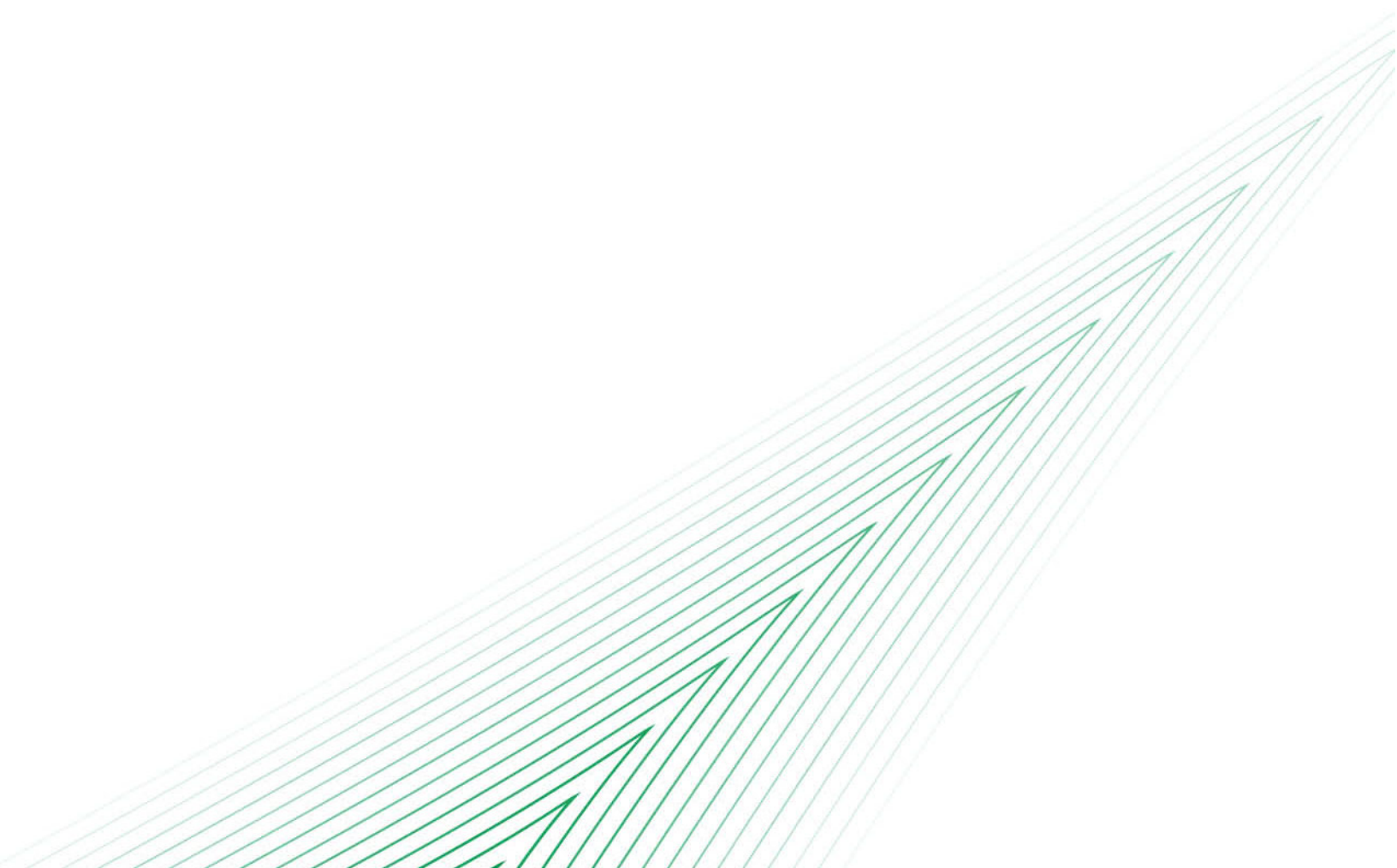

## INDEPENDENT AUDITORS' REPORT

To the Trustees and Plan Administrator of  
**Stavola Management Company, Inc. 401(k) Plan**

### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Stavola Management Company, Inc. 401(k) Plan ("the Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan ("investment information") by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA ("qualified institution").

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023 and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

### Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditors' Responsibilities for the Audit of the Financial Statements section:

- The amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- The information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

## **Basis for Opinion**

We conducted our audits in accordance with auditing standards generally accepted in the United States of America ("GAAS"). Our responsibilities under those standards are further described in the Auditors' Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

## **Responsibilities of Management for the Financial Statements**

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern within one year after the date that the financial statements are issued or available to be issued.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

### NOTES TO FINANCIAL STATEMENTS

#### (1) Description of plan

The following description of the Stavola Management Company, Inc. 401(k) Plan (the "Plan") provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions, which is available from the plan administrator.

**General** - The Plan is a defined contribution plan covering all nonunion employees of Stavola Management Company, Inc., Stavola Contracting Company, Inc., Stavola Construction Materials, Inc., Stavola Asphalt Company, Inc., Stavola Beaver Run Quarry, LLC, Stavola Flemington Asphalt, LLC, Summit Anthracite, Inc., and Stavola Realty Company (collectively, the "Companies" or "plan sponsors"). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA").

On October 1, 2024, Stavola Contracting Company, Inc., Stavola Construction Materials, Inc., Stavola Asphalt Company, Inc., Stavola Beaver Run Quarry, LLC, Stavola Flemington Asphalt, LLC, and Summit Anthracite, Inc. were acquired by an unrelated party. As of October 1, 2024, the Plan was amended to exclude these plan sponsors who are no longer participating in the Plan due to the transaction. As a result, all affected participants of the acquired plan sponsors were made fully vested in their participant accounts.

**Change in recordkeeper and custodian** - Effective April 1, 2022, Empower Annuity Insurance Company of America ("Empower") acquired the full-service retirement business of Prudential Financial, Inc. In connection with the transaction, Empower acquired all shares of Prudential Bank & Trust, FSB ("PBT"), the former custodian of the Plan, and Prudential Retirement Insurance and Annuity Company, the former provider and certifier of the insurance investment contract, which are no longer affiliated with Prudential Financial, Inc. The custodial account was transferred from PBT to Empower on February 2, 2024.

**Contributions** - Each year, participants may contribute up to 100% of pre-tax annual compensation, as defined by the Plan. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans (rollover). Participants may also elect to make post-tax (Roth) contributions.

The Plan includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan. Automatically enrolled participants have their deferral rate set at 3% of eligible compensation, which is subject to an annual increase of 1% of compensation up to a maximum of 10% of compensation. Contributions resulting from the automatic enrollment are invested in a designated balanced fund until changed by the participant. Annual deferral rate increases are applied on July 1<sup>st</sup> of each year following the anniversary of the initial deferral withheld.

The Plan allows for the Companies to contribute safe harbor employer contributions of 100% of a participant's contribution to the Plan up to a maximum of 4% of his or her compensation. In addition, the Companies may elect to make discretionary matching contributions and/or profit-sharing contributions. For the year ended December 31, 2024, there were no discretionary matching contributions or profit-sharing contributions made.

Contributions are subject to certain Internal Revenue Code ("IRC") limitations.

**(1) Description of plan (continued)**

**Participant investment account options** - Participants direct the investment of all contributions into various options offered by the Plan. The Plan currently offers several mutual funds, a money market fund, a guaranteed income fund, and a pooled separate account.

**Participant accounts** - Each participant's account is credited with the participant's contribution and allocations of the Companies' contributions and the Plan's earnings and is charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested interest in his or her account.

**Vesting** - Participants are immediately vested in their contributions plus actual earnings thereon. The Companies' safe harbor employer contributions are fully vested when contributed.

Vesting in the Companies' discretionary and profit-sharing contribution portion of their accounts is based on years of continuous service. A participant is 100% vested in the Companies' discretionary contribution portion of his or her account after six years of credited service, as follows:

Less than 2	0
2 but less than 3	20
3 but less than 4	40
4 but less than 5	60
5 but less than 6	80
6 or more	100

**Notes receivable from participants** - Participants may borrow from their accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balances. Loan transactions are treated as transfers between the investment fund and the participants' loan receivable accounts. Loans range from 1 to 5 years, with a longer term for the purchase of a primary residence. The loans are secured at their inception by the balances in the participants' accounts and bear interest at rates commensurate with local prevailing rates as determined quarterly by the plan administrator. Principal and interest are paid ratably through payroll deductions.

**Payment of benefits** - On termination of service due to death, disability, or retirement, a participant or his or her beneficiary(ies) may elect to receive either a lump sum amount equal to the value of the participant's vested interest in his or her account or annual installments over a fixed number of years. A lump sum will be distributed if the participant's balance is less than \$7,000. For termination of service due to other reasons, a participant may receive the value of the vested interest in his or her account as a lump sum distribution.

**Forfeited accounts** - As of December 31, 2024 and 2023, forfeited nonvested accounts totaled \$0 and \$8,315, respectively. These forfeited nonvested accounts can be used to reduce future employer contributions. During the year ended December 31, 2024, \$7,563 forfeited nonvested accounts were used to reduce employer contributions.

#### (2) Summary of significant accounting policies

**Basis of accounting** - The financial statements of the Plan are prepared on the accrual basis of accounting.

**Use of estimates** - The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the plan administrator to make estimates and assumptions that affect certain reported amounts of assets and liabilities and changes therein, and disclosures of contingent assets and liabilities. Accordingly, actual results may differ from those estimates.

**Investment valuation and income recognition** - The Plan has investments in mutual funds, a pooled separate account, and a money market fund, which are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements.

The Plan also has an investment contract with an insurance company that allows participants to invest in a guaranteed income fund. Contract value is the relevant measurement attribute for that portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants would receive if they were to initiate permitted transactions under the terms of the Plan. The statements of net assets available for benefits present the investment contract at contract value, which approximates its fair value. See Note 5 for discussion of the guaranteed income fund.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net depreciation/appreciation in fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

**Contributions** - Contributions from Plan participants and the matching contributions from the Companies are recorded in the year in which the employee contributions are withheld from compensation.

**Notes receivable from participants** - Notes receivable from participants are measured at their unpaid principal balance plus accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 and 2023. If a participant ceases to make loan repayments and the plan administrator deems the participant's loan in default, the participant's loan balance is reduced, and a benefit payment is recorded.

**Payment of benefits** - Benefits are recorded when paid.

**Administrative expenses** - Certain expenses of the Plan are paid by the Companies and are not included in the statement of changes in net assets available for benefits.

#### (3) Information prepared and certified by a custodian

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including investments and notes receivable from participants held as of December 31, 2024 and 2023, and net appreciation in fair value of investments, interest and dividends, and interest income on notes receivables from participants for the year ended December 31, 2024, was obtained by management and derived from information certified as complete and accurate by Empower, a custodian of the Plan. As of December 31, 2024 and 2023, approximately \$29,500,000 and \$29,400,000, respectively, of investments and notes receivable from participants were certified by Empower. During the year ended December 31, 2024, approximately \$3,650,000 of net appreciation in fair value of investments, interest and dividends, and interest income from participants in total was certified by Empower.

#### (4) Fair value measurements

Financial Accounting Standards Board Accounting Standards Codification (“FASB ASC”) Topic 820, “Fair Value Measurements and Disclosures,” provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under FASB ASC Topic 820 are described below:

Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 Inputs to the valuation methodology include: quoted prices for similar assets and liabilities in active markets; quoted prices for identical assets and liabilities in active markets; inputs other than quoted prices that are observable for the asset or liability; and inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the financial instrument.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset’s or liability’s fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques are used to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following are descriptions of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used as of December 31, 2024 and 2023.

**(4) Fair value measurements (continued)**

*Mutual funds and money market fund:* Valued at the daily closing price as reported by the fund. The mutual funds and the money market fund held by the Plan are open-ended mutual funds and a money market fund, respectively, that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (“NAV”) and to transact at that price. The mutual funds and the money market fund held by the Plan are deemed to be actively traded.

*Pooled separate account:* Valued at the NAV of units of the separate account. The NAV, as provided by a custodian of the Plan, is used as a practical expedient to estimate fair value. Were the Plan to initiate a full redemption of the separate account, the custodian reserves the right to temporarily delay withdrawal from the account in order to ensure that securities’ liquidations will be carried out in an orderly business manner. There are no unfunded commitments for the pooled separate account, the redemption frequency is daily, and the redemption notice period is daily.

#### (5) Investment contract with an insurance company

The Plan has a group annuity contract, which is a fully benefit-responsive investment contract with Empower as of December 31, 2024. Empower maintains the contributions in a general account. The investment is valued at contract value, which was \$7,122,197 and \$8,579,938 as of December 31, 2024 and 2023, respectively, as determined by the custodian based on the value of the underlying assets in the general account. The account is credited with earnings and losses on the underlying investments and charged with participant withdrawals and administrative expenses. The investment contract issuer is contractually obligated to repay the principal and the specified interest rate that is guaranteed to the Plan.

Because the investment contract is fully benefit-responsive, the contract value is the relevant measurement attribute for that portion of the net assets available for benefits attributable to the investment contract. In the event the Plan discontinues this investment, the contract value at that time would be due to the Plan. The underlying investments of Empower's general account consist primarily of public and private fixed-maturity securities and commercial mortgage loans. No specific investment or group of investments in Empower's general account backs this investment contract. Contract value, as reported to the Plan by the custodian, represents contributions made under the contract, plus earnings, less participant withdrawals, and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

There are no reserves against contract value for credit risk of the contract issuer or otherwise.

Certain events limit the ability of the Plan to transact at contract value with the issuer. Such events include the following: (1) amendments to the Plan document (including complete or partial plan termination or merger with another plan); (2) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions; (3) bankruptcy of one of the plan sponsors or other plan sponsors' events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan; or (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA. The plan administrator does not believe that any events that would limit the Plan's ability to transact at contract value with participants are probable to occur.

The investment contract may be terminated by the Plan at any time but can only be terminated by Empower if the Plan does not meet certain operational obligations or fails to pay certain expenses as defined by the contract or if Empower abandons this class of investment.

#### (6) Plan termination

Although it has not expressed any intent to do so, the Companies have the right under the Plan to discontinue their contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their employer contribution accounts.

**(7) Tax status**

The Internal Revenue Service (“IRS”) has determined that the prototype 401(k) profit-sharing plan, sponsored by Empower, is designed in accordance with applicable sections of the IRC and informed Empower in a letter dated June 30, 2020. The plan administrator has adopted the prototype plan and believes that the Plan is currently being operated in compliance with the applicable requirements of the IRC. The plan administrator and trustees believe that the Plan and related trust are currently designed and being operated in compliance with the applicable requirements of the IRC.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain tax position that “more likely than not” would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**(8) Risks and uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term, and such changes could materially affect participants’ account balances and the amounts reported in the statements of net assets available for benefits.

**(9) Related-party transactions and party-in-interest transactions**

Certain Plan investments are managed by Empower and Putnam Investments; therefore, transactions related to these investments qualify as party-in-interest transactions. Fees paid by the Plan for recordkeeping services amounted to \$125,111 for the year ended December 31, 2024. Fees paid by the Plan for the investment management services are included in net depreciation/appreciation in fair value of investments. The Companies pay directly certain other fees related to the Plan’s operation.

**(10) Delinquent participant contributions**

For the year ended December 31, 2023, the Companies did not remit certain participant contributions to the Plan on a timely basis as defined by the Department of Labor’s Rules and Regulations for Reporting and Disclosure under ERISA. For the year ended December 31, 2023, untimely remittances identified on the Schedule of Delinquent Participant Contributions totaled \$78,535, which were corrected by funding the lost earnings related to these untimely employee contributions in 2024.

**(11) Subsequent events**

In 2025, there have been approximately \$6,830,000 of benefits paid to participants as of the date that these financial statements were available to be issued.

The Plan has evaluated subsequent events through October 13, 2025, which is the date the financial statements were available to be issued.
