#### 1. Plan Description

The following description of Frontier Dermatology 401(k) Profit Sharing Plan, formerly Silver Falls MSO, LLC 401(k) Profit Sharing Plan, (the "Plan") provides only general information. Participants should refer to the plan document for a more complete description of the Plan's provisions.

##### **General**

The Plan was established to provide a retirement savings program for eligible employees of Silver Falls MSO, LLC (the "Company" or "employer") and certain adopting affiliated entities. The Plan is a defined contribution plan subject to the provisions of the Employee Retirement Income Security Act of 1974 as amended ("ERISA"). The Company is the plan administrator; accordingly, certain members of its management have been appointed to be responsible for overseeing the Plan's operations including determining the appropriateness of the Plan's investment offerings and monitoring investment performance.

##### **Eligibility**

All employees who have reached the age of 21 are eligible to participate in the elective deferral portion of the Plan. All employees who have reached the age of 21 and completed three months of service are eligible to any employer contributions. Upon satisfaction of the respective eligibility requirements, participants may enter the Plan.

##### **Contributions**

Each year participants may contribute a percentage or fixed amount of their annual compensation, as defined. Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. The Plan permits after-tax elective deferrals ("Roth Elective Deferrals"). Participants may also contribute amounts representing distributions from certain other qualified plans. Under the terms of the plan document, the employer is permitted to make discretionary matching, safe harbor matching, and profit sharing contributions to the Plan. For the year ended December 31, 2024, the employer elected to remit safe harbor matching contributions equal to 100 percent of the first 3 percent, plus 50 percent of the next 2 percent, of employee compensation deferred. Participants direct the investment of all contributions credited to their accounts into the various investment options offered by the Plan. Contributions are subject to certain IRS limitations.

##### **Participant Accounts**

Each participant's account is credited with the participant's contributions, employer matching contributions, and allocations of plan earnings and administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

##### **Vesting**

Participants are immediately vested in their own contributions, including any rollover contributions from other qualified plans, plus actual earnings thereon. Vesting in the Company's contributions to participants' accounts is based on years of credited service. Participants become vested in employer discretionary matching and profit-sharing contributions according to a six-year graded schedule. Employer safe harbor matching contributions are immediately 100 percent vested.

##### **Notes Receivable from Participants**

Participants may borrow from their accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50 percent of their vested account balance reduced by the highest outstanding

loan balance in their account during the prior twelve-month period. Participants are permitted to have only one loan outstanding. Participant loans are collateralized by the balance in the respective participant's account. Each loan's interest rate is determined by management at the issuance date based on prevailing rates for similar instruments and remains fixed throughout the duration of the note. Interest paid by a participant is credited to the participant's individual account. Principal and interest are paid ratably through monthly payroll deductions with payment terms up to five years for general purpose loans or for a longer repayment term if the loan is used to acquire a principal residence.

#### **Payment of Benefits**

On termination of service due to death, disability, resignation, discharge, retirement or proven hardship, a participant is eligible to receive a payment or payments in aggregate amounts up to the total value of the participant's vested interest in his or her account. Hardship withdrawals are permitted from the employee deferrals and employer matching portions of participant accounts.

#### **Forfeited Accounts**

At December 31, 2024 and 2023, forfeited nonvested accounts held by the Plan totaled \$20,930 and \$39,303, respectively. Forfeitures may be used to reduce future employer contributions or to pay the Plan's administrative expenses. During the year ended December 31, 2024, employer contributions were reduced by \$22,279 from forfeited nonvested accounts.

## **2. Summary of Significant Accounting Policies**

#### **Basis of Accounting**

The accompanying financial statements have been prepared on the accrual basis of accounting.

#### **Use of Estimates**

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

#### **Investment Valuation and Income Recognition**

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Management determines the Plan's valuation policies utilizing information provided by the Plan's investment advisers, trustees, and custodians. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

#### **Notes Receivable from Participants**

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024. If a participant ceases to make loan repayments and the plan administrator deems the participant loan to be in default, the participant loan balance is reduced and a corresponding benefit payment is recorded.

#### **Excess Contributions Payable**

Amounts payable to participants for contributions in excess of amounts allowed by the IRS are recorded as a liability with a corresponding reduction to contributions.

#### **Payment of Benefits**

Benefits are recorded when paid.

#### **Expenses**

Certain expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation of fair value of investments.

#### **Subsequent Events**

In preparing these financial statements, management has evaluated subsequent events through October 9, 2025, the date the financial statements were available to be issued.

### **3. Certified Investments**

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and supplemental schedules, including investments and notes receivable from participants held at December 31, 2024 and 2023, and net appreciation in fair value of investments, interest and dividends, and interest income on notes receivable from participants for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Empower Trust Company, LLC and Empower Annuity Insurance Company of America.

### **4. Fair Value Measurements**

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under Financial Accounting Standards Board ("FASB") Accounting Standards Codification ("ASC") 820 are described as follows:

**Level 1.** Level 1 inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

**Level 2.** Level 2 inputs to the valuation methodology include (a) quoted prices for similar assets or liabilities in active markets, (b) quoted prices for identical or similar assets or liabilities in inactive markets, (c) inputs other than quoted prices that are observable for the asset or liability, and (d) inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

**Level 3.** Level 3 inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023. Fair values are provided by the trustee for all of the Plan's assets as follows:

- Registered investment companies: Registered investment companies, including money market accounts and other mutual funds, are valued at the daily closing price as reported by the fund. Registered investment company investments held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.
- Insurance company general accounts: The fair value of unallocated insurance contracts, consisting of assets allocated to EI Fixed Account - Series Class I through an Empower Annuity Insurance Company of America group annuity contract, is calculated based on contributions made, less withdrawals and administrative expenses, plus interest credited. The Plan's investments in unallocated contracts and the related interest rate guarantees are subject to the credit risk of Empower Annuity Insurance Company of America and are solely funded by the assets held in its general account. There are no reserves against contract value for credit risk of the contract issuer or otherwise. The crediting rate for the contract is reset quarterly. The average yield earned by the Plan and crediting rate were 1.41 percent for the year ended December 31, 2024. Certain events may limit the ability of the Plan to transact at contract value. Such events include premature termination of the contracts by the Plan, plant closings, layoffs, termination of the Plan, bankruptcy, mergers, and early retirement incentives. Upon occurrence of any of these events, a market value adjustment or other withdrawal restrictions may apply. The unallocated contracts are not considered to be fully benefit responsive. Accordingly, unallocated contracts are presented at fair value and are classified in Level 2 of the fair value hierarchy.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while management believes the Plan's valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

**5. Related Party and Party-In-Interest Transactions**

Certain of the Plan's investments are managed by Empower Annuity Insurance Company of America. Empower Annuity Insurance Company of America, and its affiliate Empower Trust Company, LLC, serve as investment custodian and recordkeeper for the Plan; therefore, these transactions qualify as party-in-interest transactions. Fees incurred by the Plan for certain investment expenses are included in net appreciation in the fair value of investments, as they are paid through fees charged at the investment level rather than direct payments by the Plan. Administrative expenses paid by the Plan to certain parties-in-interest to the Plan amounted to \$148,174 for the year ended December 31, 2024. The Company pays directly certain expenses related to the Plan's operations.

**6. Plan Termination**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants would become 100 percent vested in the employer contributions portion of their accounts.

**7. Plan Tax Status**

The Plan has adopted a volume submitter agreement as the plan document. The volume submitter agreement obtained an opinion letter, dated June 30, 2020, in which the Internal Revenue Service stated that the prototype plan, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code ("IRC"). The Plan has been amended since receiving the opinion letter; however, the plan administrator believes that the Plan is designed, and currently being operated, in compliance with the applicable requirements of the IRC and, therefore, is qualified and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits in progress for any tax periods.

**8. Risks and Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Market risks include global events, such as pandemics or international conflicts, which could impact the value of investment securities. Due to

the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

#### **9. Delinquent Participant Contributions and Loan Payments**

As reported on the supplemental schedule of (II) Schedule H, Line 4a - Schedule of Delinquent Participant Contributions, certain employee contributions and loan payments were not remitted to the Plan within the timeframe specified by the Department of Labor, therefore constituting nonexempt transactions between the Plan and the Company for the year ended December 31, 2024. The related lost earnings remittances required under applicable regulations to correct the delinquent participant contributions were pending payment as of December 31, 2024.
