Report on the Audit of the Financial Statements

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of Spooner Health System 403(b) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

NOTE 1 DESCRIPTION OF PLAN

The following description of Spooner Health System (Employer) 403(b) Plan (the Plan) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan originally effective November 1, 1965. The Plan has been amended throughout the years to comply with tax legislation. The Plan was last restated in 2018 with a retroactive effective date of January 1, 2010 as part of the remedial amendment period to adopt a volume submitter 403(b) plan document. As part of the restatement, certain provisions are effective January 1, 2019. The Plan excludes leased employees. Employees are eligible to participate in the employee elective deferral portion of the Plan upon their date of hire. Employees are eligible to participate in Employer contributions after completion of one year of service in which at least one hour is worked. The employee enters the Plan for Employer contribution purposes on the day the one year of service requirement is met. The Plan is subject to ERISA, as amended. The Retirement Plan Committee and Senior Leaders are responsible for the oversight of the Plan.

Contributions

Eligible participants are permitted to elect to have a portion, limited by Plan provisions, of their compensation contributed as pre-tax or after-tax Roth contributions to the Plan. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. The Plan also allows for special 15-year 403(b) catch-up contributions to the Plan.

The Employer will make a matching contribution on behalf of each participant who has made employee elective deferrals. The Employer matching contribution is 100% of employee deferrals up to 5% of compensation deferred.

Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans or conduit IRAs. Participants direct the investment of contributions into various investment options offered by the Plan. Contributions are subject to certain limitations.

Participant Accounts

Each participant's account is credited with the participant's deferral contributions, the Employer's matching contributions, and an allocation of Plan earnings or losses and certain Plan expenses. Allocations are based on participant earnings or account balances, as defined. Income is allocated daily based on the shares in the participant's account. The benefit to which a participant is entitled is the benefit that can be provided by the participant's account.

Vesting

Participants are immediately vested in all sources of contributions plus actual earnings thereon.

NOTE 1 DESCRIPTION OF PLAN (CONTINUED)

Notes Receivable from Participants

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. Two notes may be outstanding at one time. Principal and interest is paid ratably through a home-bill loan system. Note terms range up to five years or up to 15 years for the purchase of a principal residence. The notes are secured by the balance in the participant's account and bear interest equal to the prime rate plus 1%.

Plan Loans

Participants may borrow amounts directly from Lincoln Financial Group. There may be only two outstanding Plan loans at any time. The minimum loan amount is \$1,000. The maximum loan amount is 50% of a participant's vested annuity account value, not to exceed \$50,000 on all retirement accounts and contracts for the Employer's Plan maintained at Lincoln Financial Group and other vendors. General-purpose loans must be repaid within five years and loans for the purchase of a principal residence may be repaid over a term between 10 to 20 years. For loans repaid over a period of 15 to 20 years, the loan amount must be at least \$10,000. The funds backing the loan must be in the Fixed Account at Lincoln Financial Group. If there are insufficient funds in the participant's Fixed Account, Lincoln Financial Group will transfer the amount necessary to satisfy the loan request from all vested subaccounts to the fixed account on a prorata basis. During the term of the loan, a portion of the participant's tax deferred annuity account equal to the outstanding principal of the loan, plus any interest that has accumulated on that amount is set aside in a loan reserve account. The loan reserve balance may consist of both salary deferral and Employer funds and the participant does not have access to the amounts in the loan reserve account. The loan reserve account is credited with interest at a rate equal to the interest rate on the loan minus 2.50% on the date of loan issuance. During the existence of a contract loan, the amount of the contract loan principal will continue to earn interest at an annual rate of 4.50%. The loan rate of interest will be an annual rate of 7.00%. Loan payments of principal and interest must be in level, amortized payments either monthly or quarterly. Loan payments are allocated to the same subaccounts in the same proportion as the participant's current pre-tax contributions. All interest earnings are allocated 100% to the fixed account. The amount of outstanding loans with Lincoln Financial Group was \$-0- and \$351 at December 31, 2024 and 2023, respectively.

Benefit Payments

Upon termination of service, death, disability, retirement (age 65), or early retirement (age 55) the participant may elect to receive the value of the vested interest in their account in the form of a lump sum distribution, or installments. The Plan allows for in-service distributions at age 59½ and hardship distributions subject to Plan provisions. If a participant terminates employment and the participant's account balance does not exceed \$1,000, the Plan administrator will authorize the benefit payment without the participant's consent.

NOTE 2 SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan administrator to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements. Estimates also affect the reported amounts of income and expense during the reporting period. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

The Plan's investments are valued at fair value (except for fully benefit-responsive investment contracts, which are reported at contract value). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date.

Purchases and sales of securities are recorded on a trade-date basis. Investment income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 and 2023. Delinquent notes receivable are reclassified as distributions based upon the terms of the Plan document.

Benefit Payments

Benefits are recorded when paid.

Administrative Expenses

Certain expenses of maintaining the Plan are paid directly by the Employer and are excluded from these financial statements. Fees related to the administration of notes receivable from participants and benefit payments are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation of fair value of investments.

Subsequent Events

In preparing these financial statements, the Plan has evaluated events and transactions for potential recognition or disclosure through October 13, 2025, the date the financial statements were available to be issued.

NOTE 3 CERTIFICATION OF INVESTMENT INFORMATION

Lincoln Financial Group Trust Company, Inc., and Lincoln National Life Insurance Company, the qualified institutions, have supplied the Plan administrator with certifications as to the completeness and accuracy of the notes receivable from participants and all investment information reflected on the accompanying statements of net assets available for benefits as of December 31, 2024 and 2023, the statements of changes in net assets available for benefits for the years then ended, and the supplemental schedule of assets (held at end of year) as of December 31, 2024.

NOTE 4 FAIR VALUE OF INVESTMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy are described as follows:

Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 – Inputs other than quoted prices included within Level 1 that are observable for the asset or liability, either directly or indirectly, such as:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair market value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

NOTE 4 FAIR VALUE OF INVESTMENTS (CONTINUED)

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the valuation methodologies used at December 31, 2024 and 2023.

Mutual Funds – Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Separate Account – Valued at the NAV of units as determined by the insurance company. NAV is a readily determinable fair value and is the basis for current transactions.

NOTE 5 GENERAL ACCOUNTS WITH INSURANCE COMPANY

The Plan entered into traditional fully benefit-responsive guaranteed investment contracts with Lincoln National Life Insurance Company. Lincoln National Life Insurance Company maintains the contributions in general accounts. The accounts are credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The investment contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan. The crediting rate is based on a formula established by the contract issuer but may not be less than 1.75%. The crediting rate is reviewed on a quarterly basis for resetting. The guaranteed investment contracts do not permit the insurance company to terminate the agreement prior to the scheduled maturity date.

NOTE 5 GENERAL ACCOUNTS WITH INSURANCE COMPANY (CONTINUED)

The contracts meet the fully benefit-responsive investment contract criteria and therefore, are reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value, as reported to the Plan by Lincoln National Life Insurance Company, represents contributions made under the contracts, plus earnings, less participant withdrawals, and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

The Plan's ability to receive amounts due is dependent on the issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments.

Certain events might limit the ability of the Plan to transact at contract value with the issuer. Such events include (1) amendments to the Plan documents (including complete or partial Plan termination or merger with another plan), (2) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the Plan Sponsor or other Plan Sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan, or (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA, or (5) premature termination of the contract. No events are probable of occurring that might limit the ability of the Plan to transact at contract value with the contract issuer and that also would limit the ability of the Plan to transact at contract value with the participants. The Plan administrator believes that any events that would limit the Plan's ability to transact at contract value with participants are probable of not occurring.

In addition, certain events allow the issuer to terminate the contracts with the Plan and settle at an amount different from contract value. Such events include (1) an uncured violation of the Plan's investment guidelines, (2) a breach of material obligation under the contract, (3) a material misrepresentation, and (4) a material amendment to the agreement without the consent of the issuer.

NOTE 6 PLAN TAX STATUS

The Plan is placing reliance on an opinion letter received from the Internal Revenue Service (IRS) on the volume submitter 403(b) plan indicating that the volume submitter plan is qualified under Section 403(b) of the Internal Revenue Code (IRC) and is therefore, not subject to tax under current income tax law. The volume submitter plan has been amended since receiving the opinion letter. However, the Plan administrator believes that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believes that the Plan is qualified, and the related trust is tax-exempt.

NOTE 6 PLAN TAX STATUS (CONTINUED)

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

NOTE 7 PLAN TERMINATION

Although it has not expressed any intent to do so, the Employer has the right under the Plan to discontinue contributions at any time and to terminate the Plan subject to the provisions of ERISA.

NOTE 8 RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of the investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

NOTE 9 PARTY-IN-INTEREST TRANSACTIONS

The investments are managed by Lincoln Financial Group Trust Company, Inc., and Lincoln National Life Insurance Company, the qualified institutions. Therefore, the investment transactions qualify as party-in-interest transactions. Lincoln National Life Insurance Company is the issuer of the general accounts held by the Plan and, therefore, these transactions qualify as party-in-interest transactions.

NOTE 10 RECONCILIATION OF FINANCIAL STATEMENTS TO FORM 5500

Certain Plan assets are invested in the Lincoln National Life Insurance Company Multi-Fund Pooled Separate Account Q. The separate account invests in shares of mutual funds. Lincoln has chosen not to complete and submit an Annual Report (Form 5500) reporting the separate account as a "direct filing entity" with the Department of Labor. Therefore, the Plan's interest is reported as mutual funds in the Plan's Annual Return/Reports (Form 5500) prepared and submitted for the subject audit year. However, the financial statements of the Plan reflect its representative value in the pooled separate account.
