#### 1. Plan Description and Summary of Significant Accounting Policies

---

The following description of Donatelle Plastics, Inc. 401(k) Salary Reduction Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

##### General Information

The Plan is a 401(k) salary reduction plan which was established on April 1, 1990. The Plan was last restated and amended effective January 1, 2023. The Plan covers substantially all employees of Donatelle Plastics, Inc. (the Company) who have two months of service and have attained age 18. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

In June 2024, the Company was acquired under an equity purchase agreement. Effective July 27, 2024, the plan was terminated and all participants became fully vested in their entire account balance. Participants who continued to be employed by the acquiring company after the termination date were able to roll their balances (including loans) into the acquiring company's plan.

##### Basis of Accounting

The accompanying financial statements have been prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America.

##### Contributions

Each year, participants may contribute from 1% to 100% of pretax compensation (or post-tax compensation for the Roth portion of the 401(k) plan) not to exceed the limits of the Internal Revenue Code (IRC), as defined in the Plan. Participants may also contribute amounts representing distributions from other qualified plans. Participants direct the investment of their contributions into various investment options offered by the Plan.

The Company may contribute to the Plan discretionary matching and/or nonelective contributions. Matching contributions, if any, are determined annually and may be a percentage of compensation or a fixed dollar amount. In addition, each year the Company may contribute a nonelective contribution to the Plan. The Company's nonelective contribution, if any, is allocated to participants eligible to share in the contribution based upon a percentage calculated by dividing the participant's eligible plan compensation by the total eligible plan compensation of all eligible participants. Participants direct the investment of their matching and/or nonelective contributions into various investment options offered by the Plan. The Company's contributions do not exceed the maximum amount deductible by the Company under the regulation of the IRC.

##### Participant Accounts

Each participant's account is credited with the participant deferrals, employer profit sharing and matching contributions and an allocation of Plan earnings. Allocations of plan earnings are based on the valuation of the investments (participant-directed) held in each participant's account. Participant's accounts are value on a daily basis. The benefit the participant is entitled to is the benefit that can be provided from the participant's account.

##### Notes Receivable from Participants

Generally, participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their account balance. Loan terms range from one to five years for general purpose loans or five to fifteen years for loans for the purchase of a primary residence. The loans are secured by the vested balance in the participant's account and bear interest at a fixed rate of 1% over the Wall Street Journal Prime Rate of interest at the time of the loan. Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent participant loans are reclassified as distributions based upon the terms of the plan document. There were no loans outstanding as of December 31, 2024.

##### Vesting

Participants are immediately vested in their contributions plus actual earnings thereon. Vesting in the Company's profit sharing and matching contribution portion of their accounts plus actual earnings thereon is based on years of continuous service. A participant is fully vested in their account after 6 years of service, upon reaching age 65, upon death or upon permanent disability. Prior to plan termination, termination of employment before any of the above occurred activated the following vesting schedule for the profit sharing and matching portions of their accounts:

##### Forfeited Accounts

Terminated participants forfeit their non-vested balance upon the earlier of the receipt of their vested benefits or after incurring five consecutive one-year breaks in service. Forfeitures are used by the employer to reduce employer contributions or administrative expenses of the Plan. For the years ended December 31, 2024 and 2023, forfeited non-vested accounts totaled \$5,319 and \$20,261, respectively. Forfeitures in the amount of \$15,939 and \$14,697 were used to reduce employer contributions in 2024 and 2023, respectively. Forfeitures in the amount of \$995 were used to reduce administrative expenses of the Plan during the year ended December 31, 2024. There were no forfeitures used to reduce administrative expenses during the year ended December 31, 2023.

There were no forfeited non-vested amounts as of December 31, 2024. As of December 31, 2023, forfeited non-vested amounts totaling \$11,522, were available to reduce future employer contributions or administrative expenses of the Plan.

##### Payment of Benefits

Upon termination of employment, death, disability or retirement, participants may receive the value of the participant's vested interest in the form of a lump sum payment or if the balance exceeds \$1,000, elect to defer the benefit payment in accordance with Plan guidelines. If the participants' vested account balance is less than \$1,000, the Plan will distribute their vested account balance in a lump-sum payment.

The Plan allows for early retirement distributions at the age of 59 ½. The plan also allows for hardship withdrawals from participants' elective deferral accounts (not including Roth deferral accounts). Benefit payments are recorded upon distribution to participants.

##### Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the amount that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 for discussion on fair value measurements.

All purchases and sales of securities have been recorded on a trade-date basis. Income is recorded as earned. The increase or decrease in the fair value of investments represents the net difference between the current value of securities held at the beginning of the year or cost of securities purchased during the year and the current value of securities held at the end of the year.

##### Administrative Expenses

The Company pays certain administrative expenses on behalf of the Plan. Administrative expenses paid by the Plan during the years ended December 31, 2024 and 2023 were for management of certain Plan investments. These expenses are included on the statement of changes in net assets available for benefits.

##### Use of Estimates

The preparation of financial statements in conformity with U.S. generally accepted accounting principles requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosures of contingent assets and liabilities at the date of the financial statements and the reported amounts of revenues and expenses during the reporting period. Actual results could differ from those estimates.

##### Subsequent Events

In preparing these financial statements, Plan management has evaluated events and transactions for potential recognition or disclosure through September 26, 2025, the date the financial statements were available to be issued.

#### 2. Certification of Investments

---

The Board of Directors has appointed Great West Life & Annuity Insurance Company (Great West) as trustee. The Plan Sponsor has elected to invest the assets of the Plan by means of an investment program offered by Great West Life & Annuity Insurance Company, and has appointed them as a recordkeeper to the Plan under a separate plan services agreement and to provide brokerage services to the Plan. Great West has supplied the plan administrator with certifications as to the completeness and accuracy of total assets of the Plan invested by the trustee aggregating \$0 and \$28,028,216 as of December 31, 2024 and 2023, respectively, and the related investment income of \$3,920,587 and \$4,735,924 for the years then ended, respectively, which includes interest on notes receivable from participants. Such amounts and all related financial data are included in the accompanying financial statements and supplemental schedule of the Plan based on such certifications from the trustee.

#### 3. Fair Value Measurements

---

Accounting standards establish a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy are described below:

**Level 1:** Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

**Level 2:** Observable market-based inputs or unobservable inputs that are corroborated by market data. Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets
- Quoted prices for identical or similar assets or liabilities in inactive markets
- Inputs other than quoted prices that are observable for the asset or liability
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means

If the asset or liability has a specific (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

**Level 3:** Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

**General Account investment:** Fair value represents the value the Plan would receive if the various contracts were terminated, which is book value less any early withdrawal charges.

**Mutual funds:** Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the SEC. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

**3. Fair Value Measurements (Continued)**

The methods described on the previous page may produce fair values that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

#### 5. Plan Termination

---

As noted in Note 1, the Company terminated the Plan in 2024 and all participants became 100% vested in their accounts. All balances were paid out to employees prior to December 31, 2024.

---

#### 6. Plan Tax Status

---

The Plan has adopted a prototype plan document, which has received an opinion letter from the Internal Revenue Service stating that the plan document and related trust are designed in accordance with applicable sections of the Internal Revenue Code (IRC). The Plan has been amended since receiving the opinion letter. However, the Plan Administrator and the Plan's tax counsel believe that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC.

Plan management evaluates all significant tax positions as required by generally accepted accounting principles in the United States. As of December 31, 2024, Plan management does not believe that it has taken any tax positions that would require the recording of any additional tax liability nor does it believe that there are any unrealized tax benefits that would either increase or decrease within the next twelve months. The Plan's income tax returns are subject to examination by the appropriate regulatory authorities as of December 31, 2024, and the Plan's federal tax returns generally remain open for the last three years.

#### **7. Risk and Uncertainties**

---

The Plan provides for investment in a variety of investment funds. In general, investments are exposed to various risks, such as interest rate, credit and overall market volatility risk. Due to the level of risk associated with certain investments, it is reasonably possible that changes in the values of the investments will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

---

#### **8. Party-In-Interest Transactions**

---

Transactions resulting in Plan assets being transferred to or used by a related party are considered prohibited transactions under ERISA unless a specific exemption exists. Great West is the trustee of a portion of the Plan's assets and manages certain Plan investment transactions; therefore, the transactions qualify as party-in-interest transactions. However, the transactions are not considered prohibited transactions as ERISA regulations provide for a specific exemption for such transactions. The Plan also issues loans to participants, which are secured by the participant account balances. These qualify as party-in-interest transactions but are permitted under ERISA regulations. Additionally, certain employees of the Company provide certain accounting and administrative services to the Plan for which no fee is charged. These transactions are also permitted under ERISA regulations.
