The following description of the Medical Services Group - Department of Medicine Profit Sharing Plan (Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

(a) General

All Medical Services Group - Department of Medicine (Plan Sponsor) employees are eligible to participate in the Plan when they have completed one month of service and have attained age 21. The Plan is subject to provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Trustee Group is responsible for oversight of the Plan. The Benefits Committee determines the appropriateness of the Plan's investment offerings, monitors investment performance and reports to the Trustee Group.

(b) Contributions

The Plan Sponsor may make discretionary contributions to the Plan. Contributions are subject to limitations determined by the Internal Revenue Service (IRS) and are allocated among the participants as set forth in the Plan document. Discretionary contributions of \$4,836,548 and \$4,330,486 were recognized by the Plan in 2024 and 2023, respectively.

Upon enrollment in the Plan, participants must direct discretionary contributions among the investment options made available by the Plan. Participants may change their investment options at any time throughout the Plan year.

(c) Participant Accounts

Each participant's account is credited with an allocation of discretionary contributions and Plan earnings and charged with an allocation of Plan losses. The allocation of discretionary contributions is based on a percentage of a participant's compensation. Plan earnings and losses are allocated based on account balances. The benefit to which a participant is entitled is the benefit that can be provided from a participant's vested account.

(d) Vesting

Participants are fully vested in their account balances at all times.

(e) Notes Receivable from Participants

Participants may borrow from their vested accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. Terms of the loans require repayment over a period not extending beyond five years from the date of the loan. Loans for the purchase of a residence have a thirty year term.

Loans are secured by the balance in the participant's account and bear interest at the prime rate plus 1%. Participants are permitted to have only one loan outstanding at a time. Principal and interest are paid ratably through payroll deductions.

(f) Payment of Benefits

Upon termination of service due to normal retirement, death, or disability, a participant may elect to receive an amount equal to the participant's account balance in either a lump-sum amount or installments if the participant is subject to lifetime minimum required distributions. If the participant's account balance is \$5,000 or less, the account balance may only be distributed in a single lump sum amount. In the event of the termination of a participant's employment for any reason other than normal retirement, death or disability, the participant's vested account balance will become due and payable in a single lump-sum payment. If a participant's account balance exceeds \$1,000, they must consent to the distribution before it may be made. If a participant's account balance is \$1,000 or less, participant consent to the distribution is not required.

(2) Summary of Accounting Policies

(a) Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting.

(b) Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

(c) Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Benefits Committee determines the Plan's valuation policies utilizing information provided by the investment advisors and custodian. See note 3 for discussion on fair value measurements. Purchases and sales of shares held in registered investment companies are recorded on a trade-date basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

(d) Notes Receivables from Participants

Notes receivables from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred.

If a participant ceases to make loan repayments and the Plan administrator deems the participant loan to be in default, the participant loan balance is reduced and a benefit payment is recorded.

(e) Payment of Benefits

Benefits are recorded when paid.

(f) Administrative Expenses and Other Plan Operating Expenses

Certain operating expenses incurred in maintaining the Plan are paid directly by the Plan Sponsor and are excluded from these financial statements. Expenses related to the administration of receivables--notes from participants and benefit payments are charged directly to the participant's account and are included in administrative expenses and benefits paid to participants, respectively. Investment related expenses which reflect certain fees paid by the various investment funds to their affiliated investment advisors, transfer agents, and others as described in each fund's prospectus or other published documents are included in net appreciation of fair value of investments in the statements of changes in net assets available for benefits for the years ended December 31, 2024 and 2023.

(g) Subsequent Events

The Plan has evaluated subsequent events through October 13, 2025, the date the financial statements were available to be issued.

(3) Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 Inputs to the valuation methodology include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability; and
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

(3) Fair Value Measurements, Continued

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Mutual funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-ended that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value and transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

(4) Certified Information

Certified information disclosed in the accompanying financial statements and ERISA - required supplementary schedule, including investments and notes receivable from participants held at December 31, 2024, and net appreciation in fair value of investments, and dividends, and interest income on notes receivable from participants for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Newport Trust Company, LLC (the custodian of the Plan).

(5) Related Party and Party-in-Interest Transactions

The Plan does not consider discretionary contributions made to the Plan or benefits paid by the Plan to be party-in-interest transactions. Transactions with the custodian, qualify as party-in-interest transactions. Recordkeeping, audit and administrative services provided to the Plan are paid directly by the Plan Sponsor. In addition, the Plan issues notes receivable to participants, which are secured by the balances in the participant's accounts. Therefore, related transactions qualify as party-in-interest transactions.

(6) Plan Termination

Although it has not expressed any intent to do so, the Plan Sponsor has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA.

(7) Tax Status

The Plan adopted a Volume Submitter Profit Sharing Plan sponsored by Newport Group, Inc. (Newport Group), formerly Verisight, Inc. The Newport Group has received an advisory letter from the IRS dated June 30, 2020, as to the Volume Submitter Profit Sharing Plan's qualified status. The Volume Submitter Profit Sharing Plan advisory letter has been relied upon by this Plan. The Plan has been amended since adopting the Volume Submitter Profit Sharing Plan. However, the Plan administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC and the related trust continues to be tax-exempt at December 31, 2024.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the organization has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan administrator believes it is no longer subject to income tax examination for years prior to 2021.

(8) Risk and Uncertainties

The Plan invests in various investment securities. The investments are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with these investments, it is at least reasonably possible that changes in the values of investments will occur in the near term and that such changes could materially affect participant account balances and the amounts reported in the statements of net assets available for benefits.
