December 31, 2024 and 2023

1) Description of Plan

The following description of the SENMCAC 401(k) Plan (the “Plan”) provides only general information. The Plan is a defined contribution plan covering substantially all employees of Southeast New Mexico Community Action Corporation (the “Organization”) and is subject to provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Plan started in January 2024. Participants should refer to the Plan agreement for a more complete description of the Plan’s provisions.

- A. *General* – The Plan is a defined contribution plan covering all full-time employees of the Organization who are age 18 or older. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).
- B. *Contributions* – Each year, participants may contribute up to the lesser of a) 100% of eligible pre-tax compensation or b) \$23,000 (the maximum annual amount that can be contributed to a 401(k) arrangement per the Internal Revenue Code for 2024). Participants who have attained age 50 or over at the end of the calendar year are permitted to make additional “catch-up” elective deferral contributions up to \$7,500. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans. Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan currently offers various mutual fund investment options for participants. The Organization contributes to the Plan as follows:
- Eligible employees receive an employer matching contribution of 7%, upon the attainment of age 18, and completion of 12 months of service.

Participants may also transfer or rollover amounts to the Plan from other qualified retirement plans. Rollovers into the Plan for the year ended December 31, 2024 were \$18,359 and are included in the statement of changes in net assets available for benefits.

- C. *Participant Accounts* – Each participant’s account is credited with the participant’s contributions and allocations of (a) the Organization’s contribution and (b) the Plan’s earnings and is charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

1) Description of Plan — continued

D. *Vesting* – Participants are 100% vested immediately in their contributions, actual earnings (losses) thereon, and in the Organization’s contribution portion of their accounts.

E. *Payment of Benefits* – On termination of service due to death, disability or retirement, a participant may elect to receive either a lump-sum amount equal to the value of the participant’s vested interest in his or her account. For termination of service for other reasons, a participant may receive the value of the vested interest in his or her account as a lump-sum distribution.

2) **Summary of Significant Accounting Policies**

Basis of Accounting

The accompanying financial statements have been prepared in accordance with accounting principles generally accepted in the United States of America.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the plan administrator to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of revenues and expenses during the reporting period. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

Investments are recorded at fair value. Management determines the Plan’s valuation policies utilizing information provided by the custodian. See note 4.

Payments of Benefits

Upon termination of services, the achievement of early retirement age, or normal retirement age (age 59 ½), a participant may request distribution of their retirement account. Participants may receive the value of his or her account in a lump-sum amount, in installment payments over a specified period of time, or in various life annuities as defined in the Plan document. Participants may also withdraw amounts from their retirement account by reason of financial hardship under specific guidelines set forth in the Plan document.

Operating Expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Organization. Expenses that are paid by the Organization are excluded from these financial statements. Investment related expenses are included in net appreciation of fair value investments.

Subsequent Events

Management has evaluated subsequent events through October 13, 2025, which is the date the financial statements were available to be issued.

3) Information Certified by the Plan Custodian

In accordance with the provisions of 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for reporting and Disclosure under ERISA, Capital Bank and Trust Company, the Plan custodian, has provided and certified that the following information included in the financial statements and supplemental schedule is complete and accurate at December 31, 2024 and 2023, and for the year ended December 31, 2024:

4) Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority unobservable inputs (Level 3). The three levels of the fair value hierarchy under FASB ASC 82 are described as follows:

Level 1 Fair Value Measurements – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 Fair Value Measurements – Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability; and
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Fair Value Measurements – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in methodologies used at December 31, 2024 and 2023.

Mutual Funds – Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-ended mutual funds that are registered with the SEC. These funds are required to publish their daily net asset value (NAV) and to transact at the price. The mutual funds held by the Plan are deemed to be actively traded.

5) **Related Party Transactions**

American Funds provides various contract administration services and certain Plan investments are shares of mutual funds managed by American Funds. American Funds is part of Capital Group, the custodian as defined by the Plan, and, therefore, these transactions qualify as party-in-interest transactions. Fees paid by the Plan for administrative expenses totaled \$1,880 for the year ended December 31, 2024. These party-in-interest transactions are exempt for the prohibited transaction rules of ERISA.

6) **Plan Termination**

Although it has not expressed any intent to do so, the Organization has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in the employer contributions.

7) Tax Status

The Internal Revenue Service (IRS) has determined and informed the Organization that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code (IRC). The Plan administrator believes that the Plan is designed and is currently operated in compliance with the applicable requirements of the IRC and, therefore, believe that the Plan is qualified and the related trust is tax-exempt.

U.S. generally accepted accounting principles require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

8) Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the value of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.
