### SCOPE AND NATURE OF THE ERISA SECTION 103(A)(3)(C) AUDIT

We have performed audits of the accompanying financial statements of The Perdue Savings Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of The Perdue Savings Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of and for the years ended December 31, 2024 and 2023 stating that the certified investment information, as described in Note D to the financial statements, is complete and accurate.

### OPINION

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section—

- the amounts and disclosures in the financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- the information in the financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

### BASIS FOR OPINION

We conducted our audits in accordance with auditing standards generally accepted in the United States of America. Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of The Perdue Savings Plan and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

## **RESPONSIBILITIES OF MANAGEMENT FOR THE FINANCIAL STATEMENTS**

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about The Perdue Savings Plan's ability to continue as a going concern for one year after the date the financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments; administering the plan; and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

NOTE A – DESCRIPTION OF PLAN

The following description of The Perdue Savings Plan provides only general information. Participants should refer to the Summary Plan Description for a more complete description of the Plan's provisions. The Plan is a defined contribution plan and is administered by the Perdue Investment Committee.

The Plan's trustee and recordkeeper is Principal Financial Group (Principal).

Plan Eligibility

All salary and hourly employees of Perdue Farms, Inc. and its subsidiaries (the Company) who are age 21 or older, except employees covered by a collective bargaining agreement, are eligible to participate in the Plan after 30 days. Employees covered by a collective bargaining agreement are eligible for the Plan based on the contract in place for the Plan year, including contribution limits for both employee and employer match.

Contributions

Participants may contribute between 1-75% of their pre-tax annual compensation to the Plan, subject to annual individual deferral limitations as determined by the Internal Revenue Service (IRS). Participants who are 50 years old before the end of the Plan year are eligible to make catch-up contributions. Participants can elect to contribute on a pretax basis, an after-tax basis, or a combination of the two. Participants may also contribute amounts representing distributions from other tax-qualified plans.

For participants with one year or more of service, the Company matches up to 5% of base compensation that the participant contributes, subject to a maximum salary limitation. Entry dates for the Company match are January 1, April 1, July 1, or October 1.

The Company may make discretionary contributions. Employees need not be contributing to the Plan to receive these contributions.

Participant Accounts

Each participant's account is credited with the participant's contribution, the Company's matching contribution, any additional Company contributions, and an allocation of Plan earnings. Investment earnings are allocated based on participant account balances. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. Participants direct the investment of their accounts from available investment options offered by the Plan. If a participant does not make an investment election, the participant's account is automatically invested in a qualified default investment fund.

Vesting

For elective and Company match, participants are 100% vested immediately. For additional Company contributions, participants vest after 3 years of service.

Forfeited Accounts

Upon a participant's termination, the unvested portion of the participant's account is forfeited. Forfeitures are used to reduce future employer contributions or pay Plan administrative expenses. Unallocated forfeited non-vested accounts were nominal in 2024 and 2023.

NOTE A – DESCRIPTION OF PLAN – CONTINUED

Payment Of Benefits

Upon termination of employment, Plan participants are entitled to receive the full value of their non-forfeitable account. Benefits are distributed in the form of a lump-sum payment. Participants with vested account balances less than \$5,000 are immediately distributed as a lump-sum under the terms of the Plan unless the participant has made a timely rollover election. In-service withdrawals are permitted for hardships or when a participant attains age 59 ½.

Normal Retirement

The date on which the participant attains age 65.

Termination Of Benefits

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan, subject to the provisions of ERISA. In the event of a Plan termination, participants will become 100% vested in their accounts.

Notes Receivable From Participants

The Plan allows participants to borrow from their accounts a minimum of \$1,000 up to a maximum equal to the lesser of 50% of the participant's vested account value or \$50,000, reduced by the highest outstanding loan balance in the previous 12-month period. The notes are secured by the balance in the participant's account and bear interest at a rate commensurate with financial institution rates for similar loans as determined by the Plan administrator. All notes must have a defined repayment schedule, which provides for principal and interest payments to be made ratably through payroll deductions over a period not to exceed 5 years.

Tax Status

The Plan obtained its latest determination letter on October 15, 2014, in which the Internal Revenue Service stated that the Plan, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code. The Plan has been amended since receiving the determination letter. However, the Plan administrator and the Plan's tax counsel believe that the Plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code and has no income subject to unrelated business income tax.

NOTE B – SIGNIFICANT ACCOUNTING POLICIES

Basis Of Accounting

The financial statements of the Plan are prepared using the accrual method of accounting.

Use Of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America (GAAP) requires management to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results could differ from those estimates.

Investment Valuation And Income Recognition

Investments are reported at fair value. Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year. See Note F – Fair Value Measurement for further discussion.

NOTE B – SIGNIFICANT ACCOUNTING POLICIES – CONTINUED

Notes Receivable From Participants

Notes receivable from participants are valued at unpaid principal balance plus any accrued but unpaid interest. Delinquent notes receivables are reclassified as distributions based upon the terms of the Plan document. No allowance for credit loss has been recorded as of December 31, 2024 and 2023. If a participant ceases to make loan repayments and the Plan Administrator deems the participant loans to be a distribution, the participant loan is reduced, and a benefit payment is recorded. At December 31, 2024, outstanding notes bore interest rates ranging from 4.25% to 10.25%, depending on the inception date of the note.

Contributions

Contributions from Plan participants and the matching contributions from the Company are recorded in the year in which the participant contributions are withheld from amounts paid. Non-elective contributions are recognized upon authorization and in the year the underlying compensation is recognized under the Plan. All participant, matching, and additional Company contributions are participant directed. Participant contributions in excess of amounts allowed by the IRS are recorded as a liability with a corresponding reduction in contributions.

Benefit Payments

Benefits are recorded when paid.

Plan Expenses

Certain expenses of maintaining the Plan are paid directly by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants and distributions from the Plan are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation of fair value of investments.

NOTE C – RISK AND UNCERTAINTIES

The Plan invests in registered investment companies and common/collective trusts. These securities are exposed to various risk such as interest rates, market and credit. Due to the level of risk associated with these securities and the level of uncertainty related to changes in the value, it is at least reasonably possible that changes in the various risk factors will occur in the near term that could materially affect the amounts reported in the accompanying financial statements.

The Plan maintains a cash account which may, at any point in time, have an amount on deposit in excess of Federally insured limits.

NOTE D – CERTIFIED ASSETS

All investment information and notes receivable from participants included in the accompanying financial statements and schedules were obtained or derived from information certified as complete and accurate by the trustee, Delaware Charter Guarantee and Trust Company d/b/a Principal Trust Company (Principal), for the period January 1, 2023 through December 31, 2024.

NOTE E – RELATED PARTY TRANSACTIONS

Plan assets are invested in funds managed by Principal Trust Company. Principal is the trustee as defined by the Plan and, therefore, qualifies as a party-in-interest. Fees incurred by the plan to Principal Trust, were approximately \$596,000 in 2024 and \$351,000 in 2023.

Certain participants of the Plan have outstanding loans with the plan at December 31, 2024 and 2023. These loans are considered party-in-interest transactions according to the Department of Labor guidelines. Total outstanding loans as of December 31, 2024 and 2023 were \$15,990,916 and \$14,701,943, respectively.

NOTE F – FAIR VALUE MEASUREMENTS

The Plan applies generally accepted accounting principles to establish a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy under generally accepted accounting principles are described as follows:

**Level 1** – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the plan has the ability to access.

**Level 2** – Inputs to the valuation methodology include quoted prices for identical or similar assets and liabilities in active or inactive markets; inputs that are observable for the asset or liability, and inputs that are derived principally from or corroborated by observable market data by correlation or other means.

**Level 3** – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

A financial instrument's categorization within the hierarchy is based upon the lowest level of input that is significant to the fair value measurement.

A description of the valuation methodologies used for instruments measured at fair value, including the general classification of such instruments pursuant to the valuation hierarchy, is as follows:

**Registered Investment Companies (Mutual Funds)** – Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily NAV and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

**Common/Collective Trust Funds** - Valued at the NAV of units of a collective investment trust. The NAV is based on the fair value of the underlying investments held by the fund less its liabilities. Participant transactions (purchased and sales) may occur daily. Were the Plan to initiate a full redemption of the collective trust, the investment adviser reserves the right to temporarily delay withdrawal from the trust in order to ensure that securities liquidations will be carried out in an orderly business manner. There are no unfunded commitments.
