### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed an audit of the financial statements of Nystrom & Associates 401k Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audit of Nystrom & Associates 401k Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. **Note 1. Plan Description**

Nystrom & Associates, Ltd. (the Company) established the Nystrom & Associates, Ltd. Plan (the Plan), a defined contribution plan adopted under section 401(k) of the Internal Revenue Code, to provide retirement income and other benefits to qualified employees. The following is not a comprehensive description of the Plan, and therefore, does not include all situations and limitations covered by the Plan. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

**Plan Operations**

The Company is the sponsor and administrator of the Plan, Trust Point, Inc. is the custodian of the Plan and is responsible for holding the assets of the Plan, executing investment transactions and making disbursements. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

**Eligibility**

Employees who have completed 30 days of service and have reached the age of 18 become eligible to participate in the Plan on the first day of the month following eligibility. Employees are eligible to participate in employer contributions to the plan if they have reached age 18 and have completed twelve months of service.

**Contributions**

Each year, participants may contribute up to 100 percent of annual compensation, as defined in the Plan. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans. For 2024, the Company contributed an amount equal to 15.25% of the amount that a participant contributes to the Plan. Additional profit-sharing amounts may be contributed at the Company's option. Contributions are subject to certain limitations. Participants may direct the investment of the contributions into various investment options under the Plan. Participants may change their investment options at any time.

**Participant Accounts**

Participant's accounts are credited with employee salary deferrals and with an allocation of the employer's contribution, Plan earnings, and forfeiture of participants' nonvested accounts, if applicable. Allocations are based on participant earnings or account balances as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. The participant accounts are valued on a daily basis.

**Vesting**

Participants are immediately vested in their voluntary contributions plus actual earnings thereon. Vesting in the Company's matching and discretionary contributions portion of their accounts plus actual earnings thereon is based on years of continuous service. A participant's account vests at the rate of 20% per year after one year of credited service and is 100% vested after five years of credited service.

**Distribution of Benefits**

Upon termination of service, death, disability or retirement, a participant (or the participant's beneficiary in the case of death) will receive the vested portion of his or her account either as a lump-sum payment or an annuity. Hardship distributions during employment are available to participants for medical expenses described in Section 213(d) of the IRC, the purchase of a principal residence, or the payment of tuition and related educational fees for the next 12 months of postsecondary education.

**Investment Options**

Upon enrollment in the Plan, a participant may direct contributions to a variety of mutual fund investments maintained by Trust Point. The funds range from low risk cash reserve funds to high risk international growth funds.

**Forfeitures**

At December 31, 2024 and 2023, forfeited nonvested accounts totaled \$6,405 and \$6,405, respectively. These forfeitures can be used to reduce future employer contributions to the Plan or pay Plan expenses. During 2024, \$0 in forfeitures was used to reduce employer contributions.

**Administrative Expenses**

The Company pays certain administrative expenses, including consulting, audit and administrative fees, on behalf of the Plan.

**Note 2. Significant Accounting Policies**

**Basis of Accounting**

The financial statements of the Plan are prepared under the accrual method of accounting.

**Use of Estimates**

The preparation of financial statements in conformity with generally accepted accounting principles requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosures of contingent assets and liabilities at the date of the financial statements. Estimates also affect the reported amounts of revenue and expense during the reporting period. Actual results could differ from those estimates.

**Investment Valuation and Income Recognition**

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Trustees determine the Plan's valuation policies utilizing information provided by the investment advisers, custodians and insurance company. See Note 6 for a discussion of fair value measurements.

Purchases and sales of securities are recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net gain from investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

**Benefit Payments**

Benefits are recorded upon distribution.

**Risks and Uncertainties**

The Plan provides for various investment options in various combinations of investment securities. Investment securities are exposed to various risk factors including, but not limited to, interest rates, market conditions and credit risks. Due to the level of risk associated with certain investment securities and the level of uncertainty related to changes in the value of investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the participants' account balances and the amounts reported in the Statement of Assets Available for Plan Benefits in future periods.

**Subsequent Events**

The Plan has evaluated all subsequent events through **October 13, 2025**, which is the date the financial statements were available to be issued.

**Note 3. Information Certified by the Custodian**

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and supplemental schedule, including investments and notes receivable from participants held at December 31, 2024 and 2023, and net appreciation in fair value of investments, interest and dividends for the year ended December 31, 2024, was obtained or derived from information supplied to the plan administrator and certified as complete and accurate by Trust Point, Inc. (TrustPoint) and State Street Bank & Trust, the custodians of the Plan.

**Note 4. Tax Status**

The Internal Revenue Service issued a favorable determination letter dated September 18, 2001, stating that the Prototype Plan adopted by the Plan sponsor is designed in compliance with the IRC and is exempt from federal income taxes. The Plan sponsor is committed to taking all action necessary, if any, to maintain the Plan's qualified status. The Plan has been amended since receiving the determination letter. However, the Plan administrator believes that the plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code. Therefore, no provision for income taxes has been included in the plan's financial statements.

The Plan administrator has analyzed the tax positions taken by the Plan, and has concluded that, as of December 31, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax period in progress. The Plan administrator believes it is no longer subject to income tax examinations for years prior to 2021.

**Note 5. Termination of Plan**

Although the Company has not expressed any intent to do so, it has the right under the Plan to discontinue contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts. Any unallocated assets of the plan shall be allocated to participant accounts and distributed in such a manner as the Company may determine.

**Note 6. Fair Value Measurements**

The fair value measurement accounting literature establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority. Level 2 inputs consist of observable inputs other than quoted prices for identical assets (Level 1). Level 3 inputs are unobservable and have the lowest priority. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value. Level 2 inputs are used for investments for which Level 1 inputs were not available. Level 3 inputs would only be used if Level 1 or Level 2 inputs

were not available. There are no plan assets requiring the use of Level 3 inputs for the periods presented.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes to the methodologies used at December 31, 2024 and 2023.

*Level 1 Fair Value Measurements*

*Mutual Funds:* Valued at the net asset value (NAV) of shares held by the Plan at year end.

*Pooled Separate Account:* The net asset value ("NAV") of a separate account is not publicly quoted but is available to current investors via the Employer website or when plan participants access their account values. The NAV is the basis for current transactions and the PSA can be redeemed at NAV as of the measurement date. The NAV is calculated in a manner consistent with GAAP for investment companies.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.
