Notes to Financial Statements

December 31, 2024

1. Description of Plan

The following description of the New Hampshire Oncology-Hematology Professional Association 401(k) Profit Sharing Plan and Trust (the Plan) provides only general information. Participants should refer to the Summary Plan Description and the Plan document for a more complete description of the Plan's provisions.

General

The Plan, established October 1, 1977, and most recently amended June 1, 2025, is a defined contribution plan covering all eligible employees of New Hampshire Oncology-Hematology Professional Association (Company) who have attained the age of twenty-one.

Employees age 21 and older are eligible to participate in the deferral portion of the Plan, effective January 1, 2024, upon their date of hire (Prior to January 1, 2024, there was a six-month waiting period).

Employees are eligible to participate in the safe harbor matching contribution the first day of the month following the completion of six consecutive full calendar months of employment (500 hours). Effective June 1, 2025, eligible employees are required to complete 1,000 hours of service to be eligible for the safe harbor matching contribution and enter month after completion of 1,000 hours of service.

Employees are eligible for the discretionary employer contribution after one year of service (1,000 hours). Participants enter the Plan for discretionary employer contributions on the first day of January and July of each year.

The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Contributions

Each year, participants may contribute from 1% to 100% of their respective pretax annual compensation, subject to limitations established by the Plan and the Internal Revenue Service. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions.

1. Description of Plan (continued)

Contributions (continued)

The Plan permits Roth elective deferrals. Roth elective deferrals are treated in the same manner as participant elective deferrals, except that Roth elective deferrals are not “pre-tax” deferrals as defined in the Code.

The Plan includes an automatic contribution arrangement. Individuals hired by the Company who, upon becoming eligible to make a salary deferral, who do not affirmatively elect not to participate in the Plan are automatically enrolled in the Plan and will have their compensation reduced by 3% per pay period and invested in the Qualified Default Investment Alternative fund.

The Company provides a safe harbor matching contribution equal to 100% of the first 3% of compensation deferred and 50% of the next 2% of compensation deferred.

The Company discretionary employer contribution, if any, is allocated to all eligible participants with one year of service and employed on the last day of the plan year. For the year ended December 31, 2024, the Company contributed \$535,561, less forfeitures used of \$25,233 for a net contribution of \$510,328. For the year ended December 31, 2023, the Company contributed \$436,555, less forfeitures used of \$5,349, for a net contribution of \$431,206.

Participants Accounts

Each participant’s account is credited with the participant’s contribution, Company contributions, if any, and a pro rata allocation of the Fund’s investment gains or losses. The benefit to which a participant is entitled is the vested portion from the participant’s account.

Forfeited Accounts

Participants who leave the employment of the Company forfeit the non-vested portion of their accounts. Forfeitures are used to offset future Company contributions to the Plan. At December 31, 2024 and 2023, forfeitures available totaled \$19,883 and \$5,702, respectively. Forfeitures used to reduce employer contributions during the year ended December 31, 2024 and 2023 amounted to \$26,428 and \$5,349 respectively.

1. Description of Plan (continued)

Vesting

Participants are vested 100% in their 401(k) deferral contributions, Company safe harbor matching contributions, and earnings thereon at all times.

Participants become vested in the employer contribution, if any, according to a vesting schedule as follows: 20% vested after two years of service and an additional 20% for each additional year of service up to 100% after six years.

Notes Receivable from Participants

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. Loan terms must not exceed five years unless for the purchase of a primary residence for which the loan period can be extended. Participants can only have one loan outstanding at a time. The loans are secured by the balance in the participants' account and bear interest at the prime rate plus 2%. Principal and interest are paid ratably through payroll deductions.

Payment of Benefits

Upon separation of employment due to termination, death, disability or retirement, a participant may receive the value of the vested interest in his or her account as a lump-sum amount. Prior to termination of employment, a participant can withdraw their deferred compensation balance in the event of certain hardship circumstances or upon reaching 59 1/2 years of age.

Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA.

2. Summary of Accounting Policies

Basis of Accounting

The financial statements have been prepared on the accrual basis of accounting.

2. Summary of Accounting Policies (continued)

Investment Valuation and Income Recognition

The Plan's investments are stated at fair value. Fair value is defined as the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date (an exit price). See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Management fees and operating expenses charged to the Plan for the management of investments are deducted from income earned on a daily basis and are not separately reflected. Consequently, certain management fees and operating expenses are reflected as a reduction of investment return for such investments.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income on notes receivable from participants is recorded when it is earned. Delinquent participant loans are reclassified as distributions based upon the terms of the plan document.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan's management to make estimates and assumptions that affect the amounts reported in the financial statements and accompanying notes. Actual results could differ from those estimates.

Payment of Benefits

Benefits are recorded when paid.

2. Summary of Accounting Policies (continued)

Administrative Expenses

The Plan's expenses are paid either by the Plan or the Company, as provided by the Plan document. Expenses that are paid directly by the Company are excluded from these financial statements. Certain expenses incurred in connection with the general administration of the Plan that are paid directly by the Plan are recorded as deductions in the accompanying statements of changes in net assets available for benefits.

3. Certified Investments

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required supplemental schedule including investments and notes receivable from participants held at December 31, 2024 and 2023, and net appreciation (depreciation) in fair value of mutual funds, dividend and interest income, and interest income on notes receivable from participants for the years then ended, was obtained by management and agreed to or derived from information certified as complete and accurate by Ascensus, LLC, an affiliate and agent for Ascensus Trust Company, the custodian.

4. Fair Value Measurements

The fair value framework establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The fair value hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets and liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy are described below.

Level 1 – Unadjusted quoted prices in active markets that are accessible to the reporting entity at the measurement date for identical assets and liabilities.

Level 2 – Inputs other than quoted prices in active markets for identical assets and liabilities that are observable either directly or indirectly for substantially the full term of the asset or liability. Level 2 inputs include the following:

- Quoted prices for similar assets and liabilities in active markets
- Quoted prices for identical or similar assets or liabilities in markets that are not active

- Observable inputs other than quoted prices that are used in the valuation of the asset or liabilities (e.g., interest rate and yield curve quotes at commonly quoted intervals)
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 – Unobservable inputs for the asset or liability (i.e., supported by little or no market activity). Level 3 inputs include management’s own assumption about the assumptions that market participants would use in pricing the asset or liability (including assumptions about risk).

The level in the fair value hierarchy within which the fair value measurement is classified is determined based on the lowest level input that is significant to the fair value measure in its entirety.

The following is a description of the valuation methodologies used by the Plan. There have been no changes in the valuation methodologies at December 31, 2024 and 2023.

Mutual funds are valued daily at the closing price per share, as reported by the fund. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

All mutual fund investments held December 31, 2024 and 2023 are Level 1 within the fair value hierarchy.

5. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Market risks include global events which could impact the value of investment securities, such as a pandemic or international conflict. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants’ account balances and the amounts reported in the statements of net assets available for benefits.

6. Income Tax Status

The Plan adopted the Epic Advisors, Inc. non standardized profit sharing plan and it has received an advisory letter from the Internal Revenue Service (IRS) dated June 30, 2020, in which the Internal Revenue Service stated that the form of the volume submitter profit sharing plan was in compliance with the applicable requirements of the Internal Revenue Code (Code). Once qualified, the Plan is required to operate in conformity with the Code to maintain its qualification. Although the Plan has been amended since receiving the advisory letter, the plan administrator believes the Plan is being operated in compliance with the applicable requirements of the Code and, therefore, believes that the Plan is qualified, and the related trust is tax exempt.

Accounting standards require recording uncertain income tax positions that exist in the Plan's financial statements. Plan management has determined there are no uncertain tax positions and believes there is no adjustment or disclosure required in the Plan's financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

7. Parties-In-Interest

Section 3(14) of ERISA defines a party-in-interest to include, among others, fiduciaries or employees of the Plan, any person who provides services to the Plan or an employer whose employees are covered by the Plan. Accordingly, notes receivable from participants and the management of investments held by the custodian are considered party-in-interest transactions.
