Note 1 - Plan Description

The following brief description of the Fidelis Realty Partners, Ltd. 401(k) Plan (the Plan) is provided for general information only. Participants should refer to the plan document for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan covering eligible employees of Fidelis Realty Partners, Ltd. and participating employers (collectively, the Partnership) and is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (ERISA). The Plan was adopted by the Partnership on April 1, 2003 and has since been amended and restated.

The Partnership has appointed an employee to serve as the plan administrator. Ascensus Trust Company serves as the Plan's trustee. Ascensus, LLC is an authorized representative for the trustee and serves as the Plan's recordkeeper.

Eligibility

Participation in the Plan is available for all eligible employees, as defined, who are at least 21 years of age. The Plan includes a savings feature designed to permit the employees and the Partnership to contribute to the Plan at amounts allowable under Section 401(k) of the Internal Revenue Code (IRC).

Contributions

Employee pre-tax and Roth contributions are made to the Plan by electing to contribute up to 100% of the employee's compensation, as defined, subject to the maximum limits allowed by law. Participants who have attained age 50 before the end of the year are eligible to make catch-up contributions. Participants may also make rollover contributions from other qualified plans and certain other qualified sources as defined in the plan document.

Eligible employees automatically begin deferring at 3% of their compensation for each payroll period, unless an affirmative election not to contribute or to contribute at a different percentage is made by the employee. The contributions are made on a pre-tax basis unless the employee affirmatively designates that any portion or all of the contributions be treated as Roth contributions.

The Partnership makes safe harbor matching contributions to all eligible participants in an amount equal to 100% of the first 3% of an employee's deferrals and 50% of the next 2% of the employee's deferrals. The Partnership may also make discretionary profit-sharing contributions. There were no discretionary profit-sharing contributions made for the year ended December 31, 2024.

Participant Accounts

Participants direct the investment of their accounts into various investment options offered by the Plan. Under the Plan, earnings and losses are allocated to the participants' accounts daily according to an allocation formula provided in the plan document.

Vesting and Forfeitures

Participants are immediately vested in their contributions, the safe harbor matching contributions made by the Partnership and actual earnings thereon. Vesting in profit-sharing contributions is based on years of service. A participant is 33% vested after one year of service, with an additional 33% vested after each additional year of service, with 100% vesting being reached after three years of service. Regardless of the vesting schedule, participants become fully vested upon reaching normal retirement age, death, disability or termination of the Plan.

There were \$2,355 and \$2,284 of forfeitures available at December 31, 2024 and 2023, respectively. Forfeitures may be used to pay plan expenses or reduce future contributions made by the Partnership. For the year ended December 31, 2024, no forfeitures were utilized to pay plan expenses or to offset contributions made by the Partnership.

Benefit Payments

Distributions may be made to participants upon termination of employment, death, disability or retirement. Under certain circumstances, participants may withdraw a portion of their account while still employed for reasons of financial hardship, upon the attainment of age 59½ and for other such reasons, as defined. Distributions from the Plan may be paid in the form of a lump sum distribution or partial payments at the discretion of the participant. Upon withdrawal from the Plan or termination of employment, participants with an account balance of \$1,000 or less receive an automatic lump sum distribution from the Plan. For participants with an account balance greater than \$1,000 but less than \$7,000, the plan administrator makes a direct rollover into an individual retirement account. Withdrawals from the Plan may be subject to income tax on contributions and income earned.

Notes Receivable from Participants

Notes receivables from participants are loans to participants secured by the vested portion of their accounts. Participants may borrow from their participant account a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000, reduced by the highest outstanding loan balance during the preceding twelve months, or 50% of their account balances. Interest rates are based on the prime rate at the time of issuance. Principal and interest are generally repaid through payroll deductions. Loan terms are limited to five years unless for the purchase of a principal residence, which could then be extended up to 30 years. A participant may not have more than two loans outstanding at one time.

Note 2 - Accounting Policies

Basis of Accounting

The accompanying financial statements have been prepared using the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America (GAAP).

Investment Valuation and Income Recognition

Investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. The net appreciation or depreciation in the fair value of investments includes realized gains and losses on investments sold during the year as well as unrealized appreciation and depreciation of investments held at the end of the year.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest is recorded on the accrual basis. No allowance for credit losses was recorded as of December 31, 2024 or 2023, as the notes are collateralized by the participants' account balances. In general, notes receivable from participants are placed into default in the calendar quarter following the quarter in which no payment on the note is made and such defaults are recognized as distributions when a distributable event has occurred.

Excess Contributions Payable

Amounts payable to participants for contributions in excess of amounts allowed by the Internal Revenue Service (IRS) are recorded as a liability with a corresponding reduction to contributions.

Benefit Payments

Benefit payments are recorded when paid.

Administrative Expenses

Certain transactional charges are paid by the participants. All other administrative costs are paid by the Plan unless paid by the Partnership, at its discretion. Investment-related expenses are included in the net appreciation or depreciation in the fair value of investments.

Use of Estimates

The preparation of financial statements in conformity with GAAP requires the plan administrator to make estimates and assumptions that affect the reported amounts of assets, liabilities and changes therein and the disclosure of contingent assets and liabilities at the date of the financial statements. Actual results could differ from those estimates.

Risks and Uncertainties

The Plan invests in various investment securities. Investment securities, in general, are exposed to various risks, such as interest rate, credit and overall market volatility. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the value of investments will occur in the near term and may impact participants' account balances, and the amounts reported in the financial statements.

Subsequent Events

Management of the Plan evaluates events occurring subsequent to the date of the financial statements in determining the accounting for and disclosure of transactions and events that affect the financial statements. Subsequent events have been evaluated through October 14, 2025, which is the date the financial statements were available to be issued.

Note 3 - Certified Information

The plan administrator has elected the method of annual reporting compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, as permitted under such election, the plan administrator has obtained certifications from Ascensus, LLC, as an authorized representative of Ascensus Trust Company, as of December 31, 2024 and 2023, and for the year ended December 31, 2024, that all of the information provided is complete and accurate. Information included in the financial statements and accompanying notes to the financial statements as to investments, notes receivable from participants, investment income, interest income on notes receivable from participants, and all of the related information in the supplemental schedule, is presented solely in reliance upon these certifications.

The Plan's independent auditor did not perform auditing procedures with respect to this information except for comparing such information to the related information included in the financial statements, the accompanying notes to the financial statements and the supplemental schedule.

Note 4 - Fair Value Measurements

GAAP provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy are described as follows:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets
- Quoted prices for identical or similar assets or liabilities in inactive markets
- Inputs other than quoted prices that are observable for the asset or liability
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

An asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used should maximize the use of observable inputs and minimize the use of unobservable inputs.

The following are descriptions of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Mutual Funds: These funds are valued daily at their quoted market prices.

Common/Collective Trust Fund: This fund is valued at its net asset value (NAV) as determined by the issuer, based on the value of each of the underlying investments, less applicable fees charged by the issuer. The NAV is used as a practical expedient to estimate fair value. The practical expedient is not used when it is determined to be probable that the investment will be sold for an amount different than the reported NAV.

Note 5 - Federal Income Tax

The pre-approved plan received an opinion letter from the IRS dated June 30, 2020, stating that it was in compliance with the applicable requirements of the IRC. The pre-approved plan has been amended since receiving their IRS letters; however, the plan administrator believes that the Plan continues to be designed and operated in compliance with the applicable requirements of the IRC. Therefore, no provision for income taxes has been included in the Plan's financial statements.

GAAP requires plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain tax position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Note 6 - Plan Termination

Although it has not expressed any intent to do so, the Partnership has the right under the plan document to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. If the Plan is terminated, all participants become 100% vested.

Note 7 - Party-in-Interest Transactions

The Plan maintains a recordkeeping agreement with Vanguard Group, Inc. (VGI), whereby VGI has subcontracted with Ascensus, LLC to provide the recordkeeping for the Plan. Certain mutual funds offered by the Plan are issued by VGI, a party-in-interest with respect to the Plan. Transactions involving these mutual funds are covered by an exemption from the “prohibited transactions” provisions of ERISA and the IRC.
