## INDEPENDENT AUDITORS' REPORT

To the Plan Administrator of  
American Credit Acceptance LLC 401k Plan

### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed an audit of the financial statements of American Credit Acceptance LLC 401k Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statement of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year then ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of American Credit Acceptance LLC 401k Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained a certification from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note C to the financial statements, is complete and accurate.

### Opinion

In our opinion, based on our audit and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section

- the amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, on the modified cash basis of accounting, which is a basis of accounting other than accounting principles generally accepted in the United States of America.
- the information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

## **Basis for Opinion**

We conducted our audit in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of American Credit Acceptance LLC 401k Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. ## **Responsibilities of Management for the Financial Statements**

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about American Credit Acceptance LLC 401k Plan's ability to continue as a going concern for one year after the date that the financial statements are available to be issued.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with modified cash basis of accounting, which is a basis of accounting other than accounting principles generally accepted in the United States of America.

**A. Description of Plan**

The following description of the American Credit Acceptance LLC 401k Plan provides only general information. Participants should refer to the plan document for a more complete description of the Plan's provisions.

1. **General.** The Plan is a defined contribution plan subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Plan covers employees of American Credit Acceptance, LLC (the Company) who have met certain eligibility requirements as defined by the Plan. Employees must complete two consecutive months of service and be age 18 or older to be eligible. The Plan Sponsor determines the appropriateness of the Plan's investment options and monitors investment performance.
2. **Contributions.** Each year, participants may contribute to the Plan through pretax deferrals and/or (post tax) Roth deferrals. Participants are allowed to defer from annual compensation, as defined in the Plan up to the maximum amount allowed by IRS Code sections 402(g) and 415. Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. The Company makes safe harbor matching contributions equal to the participant's deferral to the Plan up to 5% of compensation. Additional profit-sharing amounts may be contributed at the discretion of the Company's management. Contributions are subject to certain limitations.
3. **Investment Options.** Participants direct the investment of their accounts into various investment options offered by the Plan. The Plan currently offers mutual funds and a stable value fund as investment options for participants.
4. **Participant Accounts.** Each participant's account is credited with the participant's contributions, allocations of the Company's contribution, and plan earnings (losses) and is charged with benefit payments, transaction fees related to notes receivable from participants and distributions, and allocations of administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

5. Vesting. Participants are immediately vested in their contributions, the Company’s safe harbor contribution, and actual earnings thereon. Vesting in the Company’s discretionary contribution portion of their accounts plus actual earnings thereon is based on years of service. A participant is 100 percent vested after six years of service.

For vesting in the Company’s discretionary contributions, the following vesting schedule is followed:

<u>Years of Vesting Service</u>	<u>Vesting Percentage</u>
Less than two years	0
Two years but less than three years	20
Three years but less than four years	40
Four years but less than five years	60
Five years but less than six years	80
Six or more years	100

Vesting in the Company’s discretionary profit-sharing contribution plus actual earnings thereon is based on year of service during which 1,000 hours are worked.

6. Notes Receivable from Participants. Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of 50% of their vested account balance or \$50,000, in accordance with the provisions of the Plan. The notes are secured by the balance in the participant’s account and bear interest at rates that range from 4.25% to 9.50%. Principal and interest are paid ratably through payroll deductions.
7. Payment of Benefits. Upon termination of service due to death or disability, a participant’s account shall be fully vested and nonforfeitable and the surviving spouse or participant may elect to receive the value of the participant’s account in a lump-sum payment. Upon termination of service due to retirement, a participant may elect to receive a lump-sum amount equal to the value of the participant’s vested interest in his or her account.

In-service withdrawals are available in certain limited circumstances, as defined by the Plan. Hardship withdrawals are allowed for participants incurring an immediate and heavy financial need, as defined by the Plan document. Hardship withdrawals are strictly regulated by the Internal Revenue Service (IRS).

8. **Forfeitures.** At December 31, 2024 and 2023, forfeited nonvested accounts totaled \$49 and \$26, respectively. These accounts will be used to reduce future Company contributions or pay administrative expenses. During 2024, forfeited amounts of \$335 were used to pay Plan expenses of \$312.

**B. Summary of Accounting Policies**

1. **Basis of Accounting.** The financial statements of the Plan are prepared accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America (“GAAP”)
2. **Estimates.** The preparation of financial statements in conformity with GAAP requires management to make estimates and assumptions that affect certain reported amounts of assets, liabilities, and changes therein, and disclosure of contingent assets and liabilities. Accordingly, actual results could differ from those estimates.
3. **Investment valuation and income recognition.** Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Plan management determines the Plan’s valuation policies utilizing information provided by the trustee. See Note F for discussion of fair value measurements.  
Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation or depreciation includes the Plan’s gains and losses on investments bought and sold as well as held during the year.
4. **Notes receivable from participants.** Notes receivable from participants are measured at their unpaid principal balance. Interest income is recorded when received. Delinquent participant loans are reclassified as distributions based upon the terms of the plan document. No allowances for credit losses have been recorded as of December 31, 2024 and 2023.
5. **Payment of Benefits.** Benefits are recorded upon distribution.
6. **Administrative expenses.** The Plan’s administrative expenses are paid by either the Plan or the Company, as provided by the plan document. Certain administrative functions are performed by employees of the Company. No such employee receives compensation from the Plan. Expenses relating to specific participant transactions (notes receivable from participants and distributions) are charged directly to the participant’s account.
7. **Subsequent events.** The Plan has evaluated subsequent events through October 15, 2025, the date the financial statements were available to be issued.

- C. **Information certified by the Trustee.** Ascensus is the trustee for the plan. The trustee holds the Plan’s investment assets and executes investment transactions. Management has determined that Ascensus is a qualified institution, and the information prepared and certified by them meets the requirements of ERISA Section 103(a)(3)(C). Certain information related to investments disclosed in the accompanying financial statements and supplemental schedules, including investments held at December 31, 2024 and 2023, and net appreciation in fair value of investments for the year ended December 31, 2024, was obtained from information supplied to the Plan administrator by the trustee. Accordingly, as permitted under such election, the Plan administrator instructed the Plan’s independent auditor not to perform any auditing procedures with respect to the following information certified by the trustee, except for comparing such information certified by the trustee to information included in the Plan’s financial statements and supplemental schedules.

- D. **Plan Termination.** Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan Termination, participants will become 100 percent vested.
- E. **Tax Status.** The Plan has adopted a prototype plan document, which has obtained an opinion letter dated June 30, 2020 from the Internal Revenue Service which states that prototype document satisfies the applicable provisions of the Internal Revenue Code section 401(a). The Plan has not received a determination letter specific to the Plan itself; however, the Plan administrator believes the Plan was designed and is operating in compliance with the applicable requirements of the Internal Revenue Code. Therefore, no provision for income taxes has been included in the Plan’s financial statements.

GAAP requires plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not

be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

- F. **Risks and Uncertainties.** The Plan invests in various investment securities. Investment securities, in general, are exposed to various risks, such as interest rate, credit, and overall market volatility. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances, and the amounts reported in the statements of net assets available for benefits.

G. **Fair Value Measurements**

Fair value as defined under GAAP is an exit price, representing the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. GAAP establishes a three-tier fair value hierarchy, which prioritizes the inputs used in measuring fair value. These tiers include:

**Level 1:** Observable inputs such as quoted prices in active markets.

**Level 2:** Inputs other than quoted prices in active markets that are either directly or indirectly observable.

**Level 3:** Unobservable inputs about which little or no market data exists, therefore requiring an entity to develop its own assumptions.

Assets and liabilities are classified in their entirety based on the lowest level of input that is significant to the fair value measurement. The Plan's assessment of the significance of a particular input to the fair value measurement requires judgment, and may affect the valuation of fair value assets and liabilities and their placement within the fair value hierarchy levels.

There have been no changes in the methodologies used at December 31, 2024 and 2023. The following is a description of the valuation methodologies used for assets measured at fair value:

***Mutual Funds***

Mutual funds are publicly traded investments and are valued daily at the closing price reported on the active market on which the funds are traded.

***Stable Value Fund***

The Plan invests in a stable value collective trust fund for which quoted prices are not available in active markets for identical instruments. The Plan utilizes the net asset value ("NAV") per share provided by the trustee as a practical expedient to estimate fair value. This practical expedient would not be used if it is determined to be probable that the fund will sell the investment for an amount different from the reported NAV. Participant transactions (purchases and sales) may occur daily. If the Plan initiates a full redemption of the stable value collective trust fund, the issuer reserves the right to require 12 months' notification in order to ensure that securities liquidations will be carried out in an orderly

business manner. The stable value collective trust fund is not required to be classified within a level on the fair value hierarchy.
