NOTE 1 - DESCRIPTION OF PLAN

The following description of the Conway Medical Center 403(b) Plan (the "Plan") is provided for general information purposes only. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan that covers substantially all employees of Conway Hospital, Inc. (the "Company" or the "Sponsor"). The Retirement Committee controls and manages the operation and administration of the Plan. Lincoln Retirement Services Company, LLC and Empower Retirement, LLC ("Empower") maintained the Plan's investments as of December 31, 2024 and 2023. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended ("ERISA").

Plan Termination

The Plan Sponsor elected to terminate the Plan effective July 15, 2023. The Company plans to liquidate the assets of the Plan as soon as administratively possible. As of December 31, 2024, assets remained in the Plan. Plan management plans to liquidate all Plan assets by December 31, 2025. Effective December 31, 2022, the Plan was frozen, and participant contributions were no longer permitted to be made to the Plan.

The following paragraphs described the policies of the Plan prior to its termination.

Participant Accounts

Each participant's account is credited with the participant's contributions and an allocation of Plan earnings, and is charged with withdrawals, as applicable, an allocation of Plan losses and certain Plan expenses. The allocation of Plan investment results is based on participant earnings on account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from such participant's vested account.

Vesting

Participants are immediately 100% vested in their contributions plus the actual earnings thereon.

Investment Options

Participants may direct the investment of their accounts into a variety of investment options offered by the Plan.

Notes Receivable from Participants

Participants may borrow from their vested fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The loans are secured by the balance in the participant's account. The loans bear interest at rates that are commensurate with local prevailing rates at the date of issuance, as determined by the Plan administrator. Loan repayments of principal and interest are made by participants directly to the Plan trustees in accordance with the terms of each participant loan. Participants are limited to a maximum of one outstanding loan.

Payment of Benefits

Upon termination of service, a participant may elect to receive the value of the vested interest in their account in the form of a lump sum distribution or various installment options as provided by the Plan. Also,

the Plan considers the normal retirement age to be 65. Upon obtaining the normal retirement age, the Plan participant will be entitled to 100% of their account balance. While employed, participants generally may not withdraw amounts contributed on a pre-tax basis; however, a participant may request a distribution of all or a portion of their voluntary contributions if they can demonstrate financial hardship. In addition, participants who have attained age 59½ are entitled to receive distributions from all contribution accounts. Minimum required distributions for participants who have reached age 73 also apply per Internal Revenue Code ("IRC") regulations.

NOTE 2 - SUMMARY OF ACCOUNTING POLICIES

Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America ("U.S. GAAP").

Investment contracts held by a defined contribution plan are required to be reported at fair value, except for fully benefit-responsive investment contracts. Contract value is the relevant measure for that portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants would receive if they were to initiate permitted transactions under the terms of the Plan.

As further discussed in Note 1 to the financial statements, the Plan Sponsor approved termination of the Plan, effective July 15, 2023. In accordance with U.S. GAAP, the financial statements of the Plan have been prepared on the liquidation basis of accounting as of December 31, 2024 and 2023 and for the plan year ended December 31, 2024.

Use of Estimates

The preparation of financial statements in conformity with U.S. GAAP requires management to make estimates and assumptions that affect the reported amounts of net assets available for benefits and changes therein. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

The Plan's mutual funds and stable value separate account investments are stated at fair value and the guaranteed investment contract is stated at contract value. The net appreciation in fair value of investments includes realized and unrealized gains and losses from investment activity. Purchases and sales of securities are recorded on a trade-date basis. Dividends are recorded on the ex-dividend date. Interest income is recorded on the accrual basis.

Risks and Uncertainties

The Plan provides for various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit. Due to the level of risk associated with certain investment securities and the level of uncertainty related to changes in the value of investment securities, it is at least reasonably possible that changes in risks in the near term would materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits and the statement of changes in net assets available for benefits.

Payment of Benefits

Benefits are recorded when paid.

Administrative Expenses

The Plan's administrative expenses are paid by either the Plan or the Company, as provided by the Plan document. Certain administrative functions are performed by employees of the Company. No such employee receives compensation from the Plan. Expenses relating to specific participant transactions (notes receivable from participants and distributions) are charged directly to the participant's account.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid balance plus any accrued but unpaid interest. Delinquent loans considered in default are reclassified as distributions based upon the terms of the Plan document. For the year ended December 31, 2024, there were no deemed distributions included within benefits paid to participants in the statement of changes in net assets available for benefits (in liquidation).

NOTE 3 - CERTIFIED INFORMATION

The Plan Administrator has elected the method of annual reporting compliance permitted by 29 CFR 2520.103-8 of the Department of Labor Rules and Regulations for Reporting Disclosures under ERISA. Accordingly, as of December 31, 2024 and 2023 and for the year ended December 31, 2024, Lincoln Financial Group Trust Company, Inc. and Empower Trust Company, LLC have certified that the following data included in the accompanying financial statements and supplemental schedule is complete and accurate:

- Investments, at fair value and contract value, as shown in the statements of net assets available for benefits as of December 31, 2024 (in liquidation), and investments, at fair value and contract value and notes receivable from participants as of December 31, 2023.
- Investment income and interest income on notes receivable from participants, as shown in the statement of changes in net assets available for the year ended December 31, 2024 (in liquidation).
- Schedule H, line 4(i) - schedule of assets (held at end of year) as of December 31, 2024.

NOTE 4 - FAIR VALUE MEASUREMENTS

Accounting Standards Codification ("ASC") 820, *Fair Value Measurements and Disclosures*, establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under ASC 820 are described below:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability; and

- Inputs that are derived principally from or corroborated by observable market data by correlation, or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The valuation methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date. There were no changes in valuation methodology between December 31, 2023 and 2024.

Mutual funds - A portion of the Plan's assets are invested in actively traded mutual funds, which are valued at net asset value ("NAV") of shares as of the reporting date as quoted active market prices are reported on national exchanges.

Stable value separate account - Valued at NAV of units held based on fair value of underlying investments, less liabilities. The NAV is used as the practical expedient to estimate fair value. The Lincoln Stable Value Separate Account is a fixed annuity contract issued by The Lincoln National Life Insurance Company. Assets backing this contract are held in a separate account that's segregated from the general assets of the issuing company. Assets in the Lincoln Stable Value Separate Account are held for the exclusive benefit of contract owners and aren't subject to the claims of insurance company creditors or other general account contract owners. The primary objective of the stable value separate account is to maximize investment income with long-term preservation of capital. If the Plan decides to terminate the contract, pay out of the balance is in six installments over five years by paying 20% immediately, 20% in year 1, 25% in year 2, 33% in year 3, 50% in year 4, and 100% in the final year. There are no additional redemption restrictions. During the payout period, interest will continue to be credited to the balance. There are no unfunded commitments.

NOTE 5 - INVESTMENT AT CONTRACT VALUE

The Plan also includes a guaranteed investment contract with Talcott Resolution Life Insurance Company ("Talcott"), formerly named Hartford Life Insurance Company. Talcott maintains the contributions in a general account. When establishing interest crediting rates for this product, Talcott considers many factors, including current economic and market conditions, the general interest rate environment and both the expected and actual experience of a reference portfolio within the issuer's general account. The crediting interest rate is based on a formula agreed upon with the issuers, but it may not be less than 1%. Such interest rates are reviewed on a quarterly basis for resetting.

This guaranteed investment contract meets the fully benefit-responsive investment contract criteria and therefore is reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value represents contributions made under each contract, plus earnings, less participant withdrawals, and administrative expenses. The contract value of the Talcott investment contract held by the Plan was \$584,609 at December 31, 2024, and \$567,820 at December 31, 2023.

The Plan's ability to receive amounts due in accordance with fully benefit-responsive investment contracts is dependent on the third-party issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments.

Certain events limit the ability of the Plan to transact at contract value with the issuers. Such events include the following: (1) amendments to the Plan document (including complete or partial plan termination or merger with another plan); (2) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions; (3) premature termination of the contracts; (4) bankruptcy of the Plan sponsor or other plan sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan; or (5) the failure of the Plan to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA. The Plan administrator does not believe that the occurrence of any such value event, which would limit the Plan's ability to transact at contract value with participants, is probable, with the exception of the termination of the Plan. As of December 31, 2024, the guaranteed investment contract with Talcott has not yet been terminated.

In addition, certain events allow the issuer to terminate the contracts with the Plan and settle at an amount different from contract value. Those events may be different under each contract. Examples of such events include the following: (1) an uncured violation of the Plan's investment guidelines; (2) a breach of material obligation under the contract; (3) a material representation; or (4) a material amendment to the agreements without the consent of the issuer.

NOTE 6 - TAX STATUS

The Plan is operating under a volume submitter 403(b) plan issued by Lincoln Retirement Services Company, LLC. The volume submitter 403(b) plan has obtained an advisory letter dated March 31, 2017, from the Internal Revenue Service ("IRS") specifying the form of the Plan adoption agreement and the basic Plan document are acceptable under IRS Section 403(b) of the IRC. The Plan has been amended since receiving the advisory letter. However, the Plan administrator believes the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC and, therefore, believes the Plan is qualified and is tax exempt.

U.S. GAAP requires plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan administrator has analyzed the tax positions taken by the Plan and has concluded that as of December 31, 2024 and 2023, there are no uncertain positions taken, or expected to be taken, that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

NOTE 7 - TRANSACTIONS WITH PARTIES-IN-INTEREST

Certain plan investments are managed by The Lincoln National Life Insurance Company, an affiliate of Lincoln Financial Group Trust Company, Inc., and Empower. Therefore, transactions with these entities qualify as exempt party-in-interest transactions. Fees paid by the Plan for investment management services were included as a reduction of the return earned on each fund. Notes receivable from participants are also considered party-in-interest transactions.

NOTE 8 - SUBSEQUENT EVENTS

The Plan evaluated subsequent events and transactions for potential recognition or disclosure in the financial statements through October 13, 2025, the date the financial statements were available to be issued. As of October 13, 2025, assets remained in the Plan. Plan management intends to fully liquidate the Plan by December 31, 2025. There were no other subsequent events identified that require adjustment or disclosure.
