## INDEPENDENT AUDITORS' REPORT

To the Retirement Plan Committee of  
Joseph Phelps Vineyards 401(k) Profit Sharing Plan

### Scope and Nature of the ERISA Section 103(a)(3)(C) Audits

We have performed audits of the financial statements of Joseph Phelps Vineyards 401(k) Profit Sharing Plan (the "Plan"), an employee's benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's ("DOL's") Rules and Regulations for Reporting and Disclosure under ERISA. Management has obtained a certification from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 4 to the financial statements, is complete and accurate.

### Opinion

### 1. Description of Plan

The following description of Joseph Phelps Vineyards 401(k) Profit Sharing Plan (the “Plan”) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan’s provisions.

#### **General**

The Plan was adopted by Stone Bridge Cellars, Inc. on June 1, 1981. Stone Bridge Cellars, Inc. was acquired by Joseph Phelps Vineyards, Inc., in 2022 and is the (the “Company” and “Plan Sponsor”). The Plan document was most recently amended effective January 1, 2023. The Plan is defined as a contribution retirement plan of the profit-sharing type subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”) and certain provisions of the Internal Revenue Code (“IRC”). All full-time employees of the Company who are at least 18 years of age are eligible to participate in the Plan, except union employees and non-resident aliens, after completing three months of service. Part-time employees are eligible to participate for purposes of salary deferrals after completion of one year and 1,000 hours of service. The Retirement Plan Committee is responsible for oversight of the Plan. The Investment Advisory Committee determines the appropriateness of the Plan’s investment offerings, monitors investment performance and reports to the Plan’s Board of Directors.

#### **Plan Administration**

The Company is the administrator of the Plan. As administrator, the Company has exclusive authority and responsibility for all matters in connection with the operation and administration of the Plan. Empower Trust Company, LLC (“Empower”) was the appointed trustee for the Plan in 2024 and 2023, and acted at the direction of the Plan’s administrator.

#### **Contributions**

The Plan includes automatic enrollment for all employees, which starts at 6% and increases annually by 1% to a maximum deferral contribution of 10%, which commences on the first day of the month following eligibility. Participants may elect to defer up to 100% of eligible pre-tax compensation to the Plan. Participant contributions are made through payroll deductions and are subject to the limits imposed by Section 402(g) of the IRC. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may elect to make Roth 401(k) contributions to the Plan. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans. Effective January 1, 2023, the Plan document was amended to change the allocation for non-elective contribution classes, whereby each participant constitutes a separate classification.

The Company makes matching contributions based on employee elective deferrals funded annually. Generally, the employer matching contributions will be 25% of the employee elective deferral up to 6% of eligible compensation. The Company approved and made an employer matching contribution of \$153,916, net of forfeitures, for the year ended December 31, 2024, which was funded in 2025.

Additionally, the Plan allows for qualified non-elective contributions at the discretion of the Company. The Company approved and made a qualified non-elective contribution of \$655,930 for the year ended December 31, 2024, which was funded in 2025.

#### **Contributions**, continued

Employees must be employed on the last day of the Plan year and be credited with one year of service (1,000 hours) in order to receive discretionary non-elective contributions.

The Plan Sponsor also offers a non-qualified deferred compensation (“NQDC”) plan to certain employees. Participants in the NQDC plan are not eligible for discretionary non-elective contributions.

#### **Participant Accounts**

Each participant’s account is credited with the participant’s contributions, employer contributions, Plan earnings or losses, expenses, and rollovers from other qualified plans. Plan earnings or losses are allocated based upon each participant’s account balance. Certain fees are charged to the fund investments and are offset against Plan investment income and loss as presented on the statement of changes in net assets available for benefits. Participants should refer to the prospectuses of these funds for details on the various types and amounts of investment fees charged to the Plan and their individual accounts.

#### **Vesting**

Participant contributions, rollovers, and net earnings on these contributions, are fully vested when made or earned.

Matching contributions and discretionary non-elective employer contributions, if any, as well as all earnings on these contributions, vest according to the following schedule:

Participants are fully vested upon retirement, death, disability, or Plan termination.

#### **Notes Receivable from Participants**

Participants are allowed one note receivable at any time and may borrow from their fund accounts a minimum of \$1,000 up to 50% of the value of their account balance, or \$50,000, whichever is less. Note receivable terms range from one to five years, except for notes receivable used to purchase a primary residence, which may have a maximum term of ten years. The notes receivable are secured by no more than 50% of the balance in the participant’s account and bear interest at a rate commensurate with local prevailing rates at the time the note receivable originates. As of December 31, 2024, the interest rates on notes receivable from participants ranged from 4.25% to 9.50% per annum. Principal and interest are paid in equal installments through biweekly payroll deductions, personal checks from employees on leave, or cashier’s checks for the full payoff of the notes receivable.

#### ***Payments of Benefits***

When participants leave the Company, upon retirement (age 60, or early retirement at age 55 with six years of service) or for any other reason, those participants (or their beneficiaries) may receive the vested value of their account in a single lump-sum payment or in installments. The Plan also allows for in-service withdrawals upon a participant attaining the age of 59½, or having a hardship. In-service withdrawals may be taken from the pre-tax elective deferral account, matching contributions, and discretionary non-elective contributions as long as they are vested, with the exception of hardships that may not be taken from matching contributions or discretionary non-elective contributions. In addition, the Plan allows for withdrawals of any rollover contributions at any time.

In order to receive distributions, participants (or their beneficiaries) are required to file the appropriate forms with Empower. Account values will be determined as of the day the distribution is made.

Distributions under the Plan shall generally be made as soon as possible after the date of retirement, date of death, or termination of employment. Mandatory distributions of account balances under \$5,000 will be made as soon as possible. In the event of a mandatory distribution greater than \$1,000, if the participant does not elect to have such distribution paid directly to an eligible retirement plan specified by the participant in a direct rollover or to receive the distribution directly, then the Plan's administrator will pay the distribution in a direct rollover to an individual retirement account designated by the Plan's administrator.

#### ***Investment Options***

Upon enrollment in the Plan, a participant may direct their contributions in percentage increments into a series of mutual funds and a fixed annuity fund offered by the Plan. Participants may change their investment options at any time.

#### ***Forfeitures***

Forfeitures that occur during a Plan year may be used to pay reasonable Plan expenses or to reduce employer contributions. Forfeited non-vested accounts totaled \$33,206 and \$23,265 as of December 31, 2024 and 2023, respectively. Forfeited funds in the amount of \$30,047 and \$40,168 were used to reduce employer contributions and pay Plan expenses for the years ended December 31, 2024 and 2023, respectively.

#### ***Secure Act. 2.0***

On December 23, 2022, Congress passed the Consolidated Appropriations Act of 2023, which included SECURE Act 2.0. SECURE Act 2.0 contains over 90 new retirement provisions, with varying effective dates through 2027. Since the provisions of SECURE Act 2.0 include both required and optional elements, applicable provisions will be evaluated and implemented in accordance with accompanying regulations and guidance, and the Plan will be amended as required. Certain provisions became effective for 2024, these changes had no material impact to the Plan's financial statements as of December 31, 2024 and 2023, and for the year ended December 31, 2024.

### 2. Summary of Significant Accounting Policies

#### ***Basis of Accounting***

The accompanying financial statements have been prepared on the accrual basis of accounting, in accordance with accounting principles generally accepted in the United States of America (“U.S. GAAP”).

#### ***Use of Estimates***

The preparation of financial statements in conformity with U.S. GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities, and changes therein, disclosure of contingent assets and liabilities and changes in net assets available for benefits. Actual results may differ from those estimates.

#### ***Investment Valuation and Income Recognition***

Investments in mutual funds are reported at fair value and investments in the guaranteed income fund are reported at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan’s Retirement Committee determines the Plan’s valuation policies utilizing information provided by the investment advisor and custodian. See Note 3, “Fair Value Measurements,” for discussion of fair value measurements.

Purchases and sales of securities are reflected on a trade date basis. Interest is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation in fair value of investments includes the Plan’s gains and losses on investments bought and sold, as well as held during the year.

#### ***Notes Receivable from Participants***

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 and 2023.

#### ***Payment of Benefits***

Benefits are recorded when paid.

#### ***Expenses***

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant’s account and are included in administrative expenses. Investment related expenses are included in net appreciation in fair value of investments.

#### ***Information Certified by the Custodian***

Empower has prepared and certified as complete and accurate the Plan’s schedule of investment assets, transactions, net realized and unrealized gains and losses on investments, and dividends and interest, which was used to prepare the accompanying financial statements and supplemental schedule.

### 3. Fair Value Measurements

Accounting standards for fair value measurements establish a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under these accounting standards are described below:

*Level 1* – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

*Level 2* – Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets.
- Quoted prices for identical or similar assets or liabilities in inactive markets.
- Inputs other than quoted prices that are observable for the asset or liability.
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

*Level 3* – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value:

*Mutual funds:* Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the U.S. Securities and Exchange Commission. These funds are required to publish their daily net asset value ("NAV") and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

There have been no changes in the methodologies used as of December 31, 2024 and 2023.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

### 5. Investment Contract with Empower

The Plan entered into a fully benefit-responsive investment contract with Empower. Empower maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The guaranteed investment contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan. The crediting rate is based on a formula established by the contract issuer but may not be less than 0%. The crediting interest rate is reviewed for resetting on an annual basis. For the year ended December 31, 2024, the effective rate was 1.41%.

### 5. Investment Contract with Empower, continued

Because the guaranteed investment contract is fully benefit-responsive, contract value is the relevant measurement for the guaranteed investment contract. Contract value, as reported to the Plan by Empower, represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value. As of December 31, 2024, the contract value of the guaranteed investment contract with Empower was \$393,272.

The Plan's ability to receive amounts due is dependent on the issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments.

Certain events might limit the ability of the Plan to transact at contract value with the issuer. Such events include the following: (1) amendment to the Plan document (including complete or partial termination or merger with another plan.), (2) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the Plan Sponsor or other Plan Sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan, or (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA. No events are probable of occurring that might limit the ability of the Plan to transact at contract value with the contract issuers and that would limit the ability of the Plan to transact at contract value with the participants.

### 6. Related-Party Transactions and Party-in-Interest Transactions

Certain Plan investments are shares of mutual funds and a guaranteed income fund managed by the custodian of the Plan. Any purchases and sales of mutual funds are performed in the open market at fair value. Any purchase and sales of fixed annuities are performed at contract value as reported by Empower, the contract holder. Such transactions, while considered party-in-interest transactions under ERISA regulations, are permitted under the provisions of the Plan, and are specifically exempt from the prohibition of party-in-interest transactions under ERISA.

Fees incurred by the Plan for the investment management services are included in net appreciation in fair value of investments, as they are paid through the ERISA spending account, which is a revenue sharing account rather than a direct payment. For the year ended December 31, 2024, approximately \$40,014 was paid out of the ERISA spending account for Plan advisor related fees.

### 7. Tax Status

The Plan uses a prototype plan document sponsored by Empower. Empower received an opinion letter from the Internal Revenue Service ("IRS") dated November 11, 2022, which states that the prototype document satisfies the applicable provisions of the IRC. The Plan itself has not received a determination letter from the IRS and has been amended since receiving the opinion letter. However, the Plan's management believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC. Therefore, no provision for income tax has been included in the Plan's financial statements.

### 8. Plan Termination

The Company has established the Plan with the intention and expectation that the Plan will continue indefinitely. However, the Company reserves the right at any time to terminate the Plan subject to the provisions of ERISA. In the event of termination of the Plan, distributions will be made to participants as described in the Plan agreement, and participants would become 100% vested in their employer contributions.

### 9. Risks and Uncertainties

The Plan provides for various investment options in any combination of mutual funds and guaranteed income fund offered by the Plan. Investment securities are exposed to various risks, such as interest rate, market fluctuations, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in risks will occur in the near term that could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits and the statement of changes in net assets available for benefits.

The Plan held investments in three funds that represented 20%, 13%, and 12% of net assets as of December 31, 2024.

The Plan held investments in three funds that represented 21%, 15%, and 11% of net assets as of December 31, 2023.
