DESCRIPTION OF PLAN

The following description of the George, Miles & Buhr, LLC (the Company) 401(k) and Profit Sharing Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan covering all full-time employees of the Company. Full time permanent employees are eligible immediately upon hire. Temporary full time employees are eligible after completing one year of service. There is no age requirement. Eligible employees may enter the plan on the first day of January or July following the date eligibility requirements are met. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Contributions

Each year, participants may contribute a portion of their pretax and after-tax annual compensation, as defined in the Plan. Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover).

The Plan adopted an auto-enrollment provision on September 22, 2021. Under this provision all eligible employees of the Plan Sponsor hired after the adoption date are automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan. Automatically enrolled participants have their deferral rate set at 3% of eligible compensation and there is no escalation clause.

Employer matching contributions are discretionary, there were no employer matching contributions in the current year. The employer may also make a discretionary profit sharing contribution. Profit sharing contributions are based off of a percentage of the participant's eligible compensation. Profit-sharing contributions for the year ended December 31, 2024 totaled \$356,758. All employer contributions are invested in the same funds in which the participants invest their own contributions.

Contributions are subject to certain IRS limitations.

Investment options

Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan currently offers various registered investment companies and a common collective trust as investment options for participants. Participants may direct contributions in investment options in percent increments or fixed dollar amounts. All employer contributions are invested in the same funds in which the participants invest their own contributions.

DESCRIPTION OF PLAN (Continued)

Participant accounts

Each participant's account is credited with the participant's elective contributions and the Company's matching contributions and profit sharing contribution, as well as allocations of Plan earnings. Participant accounts are charged with an allocation of administrative expenses. Allocations are based on participant earnings, accounts balances, and specific participants transaction, as defined by the Plan. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are immediately vested with respect to any elective deferrals, rollover contributions, plus the actual earnings thereon. Vesting in the company's discretionary matching contribution and nonelective profit-sharing contributions plus actual earnings thereon are based on years of service. A participant is 100 percent vested after 3 years of credited service.

Participant loans

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance, reduced by the aggregate dollar amount of loans outstanding. Loan terms range from 1 to 5 years or longer if the loan is for the purchase of a primary residence provided documentation as to the purpose of the loan is made available. The loans are secured by the balance in the participant's account. The loan must bear a reasonable rate of interest. Principal and interest are paid ratably through payroll deductions or by direct payments to the plan's trustee.

Payment of benefits

On termination of service due to death, disability or retirement, a participant may elect to receive a lump-sum amount equal to the value of the participant's interest in his or her account. For termination of service due to other reasons, the plan administrator is required to distribute to the participant his or her interest in a single lump-sum payment as soon as administratively feasible. Participants with vested balances in excess of \$5,000 may elect to maintain their investments in the Plan, rollover their investments to another qualified plan, or receive their interest as a lump-sum distribution.

Plan termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its' contributions at any time and terminate the Plan subject to the provisions of ERISA. Any unallocated assets of the Plan shall be allocated to participant accounts and distributed in such a manner as the Company may determine.

Forfeited accounts

Forfeitures are used to reduce future employer contributions or pay plan expenses. As of December 31, 2024 there was a balance of \$0 in the forfeiture account. For the year ended December 31, 2024 \$82 was used to pay plan expenses.

Administration of Plan assets

The Plan's assets are held by the Ascensus Trust Company. As a prototype sponsor of the Plan, they provide recordkeeping third-party administration, and investment services for the Plan. Financial Solutions Advisory Group provides investment advisory services to the Plan. Newport Group, Inc. both provide recordkeeping services to the Plan. Administrative expenses are paid first by the Plan's earnings, prior to being allocated to the participant accounts. During the year ending December 30, 2024 \$52,952 was paid out in administrative expenses.

SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of accounting

The financial statements of the Plan are prepared under the accrual method of accounting.

Use of estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan Administrator to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Accordingly, actual results may differ from those estimates.

Investment valuation and income recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Management determines the Plan's valuation policy utilizing information provided by the investment advisors and custodians. See the **FAIR VALUE MEASUREMENTS** note for discussion of fair value measurements. .

Purchases and sales of funds in the Plan are recorded on a trade date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Payment of benefits

Benefits are recorded when paid.

Participant Loans

Participant loans are measured at their unpaid principal balance plus any accrued and unpaid interest. Interest income is recorded on the accrual basis. Related fees are charged directly to the borrowing participant's account and are included in administrative expenses when incurred.

No allowance for credit loss has been recorded as of December 31, 2024. If a participant ceases to make loan repayments and the plan administrator deems the participant loan to be in default, the participant loan balance is reduced and a benefit payment is recorded.

Expenses

The Plan's expenses are paid either by the Plan or the Company, as provided by the plan document. Expenses that are paid directly by the Company are excluded from these financial statements. Certain expenses incurred in connection with the general administration of the Plan that are paid by the Plan are recorded as deductions in the accompanying statement of changes in net assets available for benefits. In addition, certain investment related expenses are included in net appreciation of fair value of investments presented in the accompanying statements of changes in net assets available for benefits.

Subsequent events

The Plan has evaluated subsequent events through October 13, 2025, the date which the financial statements were available to be issued.

FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The fair value hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 Inputs other than quoted prices included within Level 1, to the valuation methodology include

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used during December 31, 2024.

Mutual Funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the SEC. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Money market accounts: These are listed as registered investments on the form 5500. Due to their short maturities, the fair value of the investments approximates their carrying value.

Synthetic cash accounts: These are listed as other investments on the form 5500. Due to their short maturities, the fair value of the investments approximates their carrying value.

The methods used above may product a fair value calculation that is not indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

PARTICIPANT LOANS

As indicated in the Description of the Plan footnote, the Plan permits participants to borrow from their vested fund accounts. For purposes of the Statement of Net Assets Available for Benefits, participant loans are presented at the amount of their outstanding principal balances, plus accrued interest. The loans were secured by the participant's accounts to the extent of their loan balance which approximate fair market values. The loans bear interest at 4.25-9.50%, which were commensurate with local prevailing rates at the inception of the loans as determined by the plan administrators.

RELATED PARTY TRANSACTIONS AND PARTIES-IN-INTEREST

Certain plan investments are shares of registered investment companies managed by Ascensus. Ascensus Trust Company is the trustee as defined by the Plan and, therefore, these transactions qualify as party in interest transactions. Fees incurred by the Plan for the investment management services are included in net appreciation in fair value of investments because they are paid through revenue sharing rather than a direct payment.

TAX STATUS

The volume submitter document, upon which the Plan was designed received a favorable opinion letter from the Internal Revenue Service (“IRS”) stating that the Plan is qualified under Section 401(a) of the Code and therefore, is exempt from taxation dated November 30, 2020. Once qualified, the Plan is required to operate in conformity with the Code to maintain its qualification. The Plan was amended subsequent to receiving the opinion letter, however, the Plan Administrator believes the Plan is being operated in compliance with the applicable requirements of the Code. Therefore, no provision for income tax has been included in the Plan’s financial statements.

Accounting principles generally accepted in the United States require plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain tax position that more likely than not would not be sustained upon examination by the applicable authorities. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

RISKS AND UNCERTAINTIES

The Plan provides for various investment options in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants’ account balances and the amounts reported in the statement of net assets available for benefits.
