**NOTE 1: DESCRIPTION OF THE PLAN**

**General**

The following description of Simmons First National Corporation 401(k) Plan (the “Plan”) provides only general information. For a more complete description of the Plan’s provisions, participants should refer to the Plan Document.

The Plan is a defined contribution plan sponsored by Simmons First National Corporation (the “Company”) for the benefit of employees of the Company and employees of its participating related employers, who have at least one hour of service and are age 18 or older. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”). State Street Bank and Trust Company is the trustee of the Plan and serves as Plan custodian.

**Contributions**

A safe harbor matching contribution of 100% of employees’ deferral contributions not exceeding 3% of employees’ compensation plus 50% of employees’ deferral contributions in excess of 3% of employees’ compensation but not in excess of 5% of compensation was made in 2024 and 2023 for all participants. A discretionary contribution of 2.56% and 1.32% of employees’ compensation was made as of December 31, 2024 and 2023, respectively, for all participants. Additional discretionary amounts may be contributed by the Company. Participants may also contribute additional amounts to the Plan. Participant contributions are limited to 85% of their compensation. Participant rollover and participant Roth contributions are also permitted. Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions.

**Participant Investment Account Options**

Participants direct the investment of their contributions as well as the Company’s safe harbor matching contributions and discretionary profit sharing contributions into various investment options offered by the Plan. Each participant has the option of directing his contributions into any of the separate investment accounts and may change the allocation daily.

**Participant Accounts**

Each participant’s account is credited with the participant’s contribution, the Company’s contributions and plan earnings. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

## **Vesting**

Participants are immediately vested in their voluntary contributions plus earnings thereon and are immediately vested in the Company's safe harbor matching contributions and discretionary profit sharing contributions. In addition, vesting in the Company's contributions plus earnings thereon, transferred from the ESOP, is based on years of service. A participant is fully vested after six years of service.

## **Forfeited Accounts**

At December 31, 2024 and 2023, forfeited nonvested accounts totaled \$25,623 and \$23,459, respectively. These accounts will be used to reduce future employer contributions. In 2024 and 2023, employer contributions were reduced by \$24,565 and \$2,649, respectively, from forfeited nonvested accounts.

## **Payment of Benefits**

On termination of service due to death, disability or retirement, a participant may elect to receive either a lump-sum amount equal to the value of the participant's vested interest in his or her account or annual installments over a 10-year period. For termination of service for other reasons, a participant may receive the value of the vested interest in his or her account as a lump-sum distribution.

Distributions of participant's investment in Company common stock are made in stock unless a participant holds less than 250 shares, in which case the participant is given the option of a stock or cash distribution.

## **Notes Receivable from Participants**

The Plan Document includes provisions authorizing loans from the Plan to active participants. The minimum amount of a loan shall be \$1,000. The maximum amount of a participant's loan is determined by the available loan balance restricted to the lesser of \$50,000 or 50% of the participant's vested account balance. All loans are collateralized by the balance in the participant's account and are repayable over a period not to exceed five years, except for the purchase of a principal residence, which should not exceed 15 years. Loans will bear a fixed rate of interest based on the fixed interest rates currently being charged by commercial lenders for loans of similar circumstances as determined by the plan administrator.

## **Voting Rights**

Each participant is entitled to exercise voting rights attributable to the shares of the Company's common stock allocated to his or her account and is notified by the trustee prior to the time that such rights are to be exercised. The trustee is not permitted to vote any share for which a participant has not given instructions.

## **Plan Termination**

Although it has not expressed an intention to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan, subject to the provisions of ERISA. In the event of plan termination, participants will become 100% vested in their employer contributions.

## **NOTE 2: SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

### **Basis of Accounting**

The accompanying financial statements are prepared on the accrual basis of accounting.

### **Use of Estimates**

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of net assets and changes in net assets, and disclosure of contingent assets and liabilities at the date of the financial statements. Actual results could differ from those estimates.

### **Investment Valuation and Income Recognition**

Quoted market prices, if available, are used to value investments. The Company's common stock is valued at fair value as determined by quoted market prices. Mutual funds and collective trust funds are valued at the net asset value ("NAV") of shares held by the Plan at year-end. Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

### **Notes Receivable from Participants**

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent participant loans are reclassified as distributions based upon the terms of the Plan Document.

### **Payment of Benefits**

Benefit payments to participants are recorded upon distribution.

### **Administrative Expenses**

Administrative expenses may be paid by the Company or the Plan, at the Company's discretion.

### **NOTE 3: CERTIFICATION OF CUSTODIAN**

The plan administrator has elected the method of annual reporting compliance permitted by ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, State Street Bank and Trust Company, a qualified institution, has certified the following investment information included in the accompanying financial statements and ERISA-required supplemental schedule is complete and accurate to the best of their knowledge and belief:

- Investments and notes receivable from participants as shown in the statements of net assets available for benefits and related disclosures as of December 31, 2024 and 2023.
- Investment income and interest income from notes receivable from participants as shown in the statements of changes in net assets available for benefits for the years ended December 31, 2024 and 2023.
- Investment information and notes receivable from participants included in the accompanying schedule of assets (held at end of year) as of December 31, 2024.

The Plan's independent auditor did not perform auditing procedures with respect to this certified investment information, except for comparing such certified investment information to the related investment information included in the financial statements and ERISA-required supplemental schedule.

### **NOTE 4: PARTY-IN-INTEREST TRANSACTIONS**

Party-in-interest transactions include those with fiduciaries or employees of the Plan, any person who provides services to the Plan, an employer whose employees are covered by the Plan, an employee organization whose members are covered by the Plan, a person who owns 50% or more of such an employer or employee association or relatives of such persons.

The Plan had investments in company stock and company investment portfolios. Plan expenses paid to Transamerica Retirement Solutions, record keeper, totaled \$282,760 and \$291,758 for the years ended December 31, 2024 and 2023, respectively.

The Plan incurs expenses related to general administration and record keeping. The Company pays certain accounting, auditing and legal fees relating to the Plan and provides certain administrative services at no cost to the Plan.

## NOTE 5: FAIR VALUE MEASUREMENTS

Fair value is the price that would be received to sell an asset in an orderly transaction between market participants at the measurement date. Fair value measurements must maximize the use of observable inputs and minimize the use of unobservable inputs. There is a hierarchy of three level of inputs that may be used to measure fair value:

- *Level 1* - Quoted prices in active markets for identical assets.
- *Level 2* - Observable inputs other than Level 1 prices, such as quoted prices for similar assets; quoted prices in markets that are not active; or other inputs that are observable or can be corroborated by observable market data for substantially the full term of the assets.
- *Level 3* - Unobservable inputs supported by little or no market activity and are significant to the fair value of the assets.

### Recurring Measurements

Following is a description of the valuation methodologies and inputs used for assets measured at fair value on a recurring basis and recognized in the accompanying statements of net assets available for benefits, as well as the general classification of such assets pursuant to the valuation hierarchy. There have been no significant changes in the valuation techniques during the years ended December 31, 2024 and 2023. The Plan had no liabilities measured at fair value on a recurring basis. In addition, the Plan had no assets or liabilities measured at fair value on a nonrecurring basis.

## Investments

Where quoted market prices are available in an active market, securities are classified within Level 1 of the valuation hierarchy. Level 1 securities include Company common stock and mutual funds. Mutual funds are valued at the NAV of shares held by the Plan at year-end. If quoted market prices are not available, then fair values are estimated by using quoted prices of securities with similar characteristics or independent asset pricing services and pricing models, the inputs of which are market-based or independently sourced market parameters, including, but not limited to, yield curves, interest rates, volatilities, prepayments, defaults, cumulative loss projections and cash flows. Such securities are classified in Level 2 of the valuation hierarchy. In certain cases where Level 1 or Level 2 inputs are not available, securities are classified within Level 3 of the hierarchy.

Certain investments, such as collective trust funds, measured at NAV per share have not been classified in the fair value hierarchy. The fair value of the collective trust fund is based on the NAV of the underlying investments, as reported to the Plan by the contract issuer, and is used as a practical expedient to estimate fair value. The following table summarizes the investments for which fair value is measured using the NAV per share practical expedient as of December 31, 2024 and 2023. There are no participant redemption restrictions for these investments; the redemption notice period is applicable only to the Plan.

## NOTE 6: TAX STATUS

The IRS has determined and informed the Company by a letter dated July 5, 2018, that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code (“IRC”). Although the plan has been amended since receiving the determination letter, the Plan Administrator and the Plan’s tax counsel believe that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believe that the Plan is qualified, and the related trust is tax exempt.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

## NOTE 7: RISKS AND UNCERTAINTIES

The Plan invests in company common stock and various investment securities, which are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with such investments and the level of uncertainty related to changes in the value of such investments, it is at least reasonably possible that changes in risk in the near term could materially affect the participants' account balances and the amounts reported in the statements of net assets available for benefits and the statements of changes in net assets available for benefits.
