Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed an audit of the accompanying financial statements of Lassonde 401(k) Plan for the Benefit of US Employees (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the Statements of Net Assets Available for Benefits - Modified Cash Basis as of December 31, 2024 and 2023, and the related Statement of Changes in Net Assets Available for Benefits - Modified Cash Basis for the year ended December 31, 2024, and the related Notes to the Financial Statements.

Management, having determined it is permissible in the circumstances, has elected to have the audit of Lassonde 401(k) Plan for the Benefit of US Employees' financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audit need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained a certification from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 4 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audit and on the procedures performed as described in the Auditors' Responsibilities for the Audit of the Financial Statements section -

- the amounts and disclosures in the financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with the modified cash basis of accounting.

- the information in the financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America. Our responsibilities under those standards are further described in the Auditors' Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of Lassonde 401(k) Plan for the Benefit of US Employees and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audit. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Basis of Accounting

We draw attention to Note 3 of the financial statements, which describes the basis of accounting. The financial statements and Supplemental Schedule are prepared on the modified cash basis of accounting, which is a basis of accounting other than accounting principles generally accepted in the United States of America. Our opinion is not modified with respect to this matter.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of these financial statements in accordance with the modified cash basis of accounting, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

Notes to the Financial Statements**

Note 1 - Plan summary

Description of plan

The following description of the Lassonde 401(k) Plan for the Benefit of US Employees (the Plan) provides only general information. Participants should refer to the Plan documents for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan covering substantially all salaried employees and some union employees represented by the bargaining unit of the United Food and Commercial Workers Union, Local 56, AFL-CIO of Lassonde Pappas and Company, Inc. (the Company). Employees become eligible to participate in the Plan upon employment. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Contributions

Participants are permitted to make elective deferrals from 1% to 50% of their pre-tax annual compensation, subject to maximum amounts allowed by the Internal Revenue (Code).

The Company makes matching contributions in an amount equal to 100% of the first 3% of compensation and 50% of the next 2% of compensation. The employer match begins after two months of service. In addition to the 401(k)-matching contribution, the Company's Board of Directors, at its discretion, may also make a profit-sharing contribution for each plan year. No such contribution was made to the Plan during the years ended December 31, 2024 and 2023.

The Plan also accepts, on behalf of employees, rollover contributions representing distributions from other employer-sponsored, tax qualified pension or profit-sharing plans. Such contributions are subject to certain conditions to be eligible for rollover into the Plan.

Participant accounts

Each participant's account is self-directed and credited with the participant's and Company's contributions and earnings on investments. Allocations are based on participant earnings as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Participant loans

Participants may borrow from their accounts within limits prescribed by the Plan and the Code. Participant loans are valued at unpaid principal plus accrued interest.

Note 1 - Plan summary (continued)

Vesting

An employee is 100% vested at all times in their pre-tax contributions and the 401(k)-matching contribution plus actual earnings thereon. An employee becomes vested in employer profit-sharing contributions at the rate of 20% per year beginning after the second year of service, with the employee being fully vested after the completion of six years of service.

Investment options

Upon enrollment in the Plan, a participant may direct the investment of their contributions into a variety of investments. The Plan currently offers fifteen mutual funds and one savings account as investment options for participants. Participants may change their investments daily.

Payment of benefits

On termination of service due to death, disability or retirement, a participant may elect to receive a lump-sum amount equal to the value of the participant's vested interest in his or her account. For termination of service due to other reasons, a participant may receive the value of the vested interest in his or her account as a lump-sum distribution. Benefits are recorded when paid.

Forfeited accounts

Forfeited non-vested accounts will be used to reduce future employer contributions. At December 31, 2024 and 2023, there were no forfeited non-vested amounts. In 2024, employer contributions were reduced by \$6,180 from forfeited non-vested accounts.

Note 2 - Concentration of credit risk

The Plan maintained its cash in bank deposit accounts which were in excess of the insurance limits provided by the Federal Deposit Insurance Corporation (FDIC). At December 31, 2024 and 2023, there was no uninsured cash.

Note 3 - Summary of significant accounting policies

Basis of accounting

The financial statements and supplemental schedule of the Plan are presented on the modified cash basis of accounting. Under this method, contributions, interest, and dividend income are recorded as received. Benefits and expenses are recorded when paid. The Plan's investments are stated at fair value, determined by either quoted market prices or estimates provided by the Plan Trustee. Purchases and sales of securities are recorded on a trade-date basis.

Note 3 - Summary of significant accounting policies (continued)

Use of estimates

The preparation of financial statements in conformity with the modified cash basis of accounting requires the Plan Administrator to make estimates and assumptions that affect certain reported amounts of assets and liabilities and disclosures of contingent assets and liabilities at the date of the financial statements and the reported amounts of revenue and expenses during the reporting period. Accordingly, actual results may differ from those estimates.

Investment valuation and income recognition

The Plan's investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date.

Purchases and sales of securities are recorded on a trade date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Mutual fund fees

Investments in mutual funds are subject to sales charges in the form of front-end loads, back-end loads or 12b-1 fees. The 12b-1 fees, which are ongoing fees allowable under Section 12b-1 of the Investment Company Act of 1940, are annual fees deducted to pay for marketing and distribution costs of the funds. These fees are deducted prior to the allocation of the Plan's investment earnings activity and thus not separately identifiable as an expense.

Administrative expenses

Certain expenses of maintaining the Plan are paid by the Company and are therefore excluded from these financial statements. Fees for the administration and maintenance of a participant account balances are included in administrative expenses and charged directly to the participant's account. Investment related expenses are included in net appreciation of fair value of investments.

Note 5 - Fair value

Financial Accounting Standards Board (FASB) in its Accounting Standards Codification (ASC) Topic 820, *Fair Value Measurement*, establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy are described below:

Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 inputs must be observable for substantially the full term of the asset or liability.

Note 5 - Fair value (continued)

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

The cash and money market account is valued at the cost of the amount held in the deposit account. The mutual funds are valued based on the daily closing price reported by the fund.

While the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Note 6 - Plan termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts.

Note 7 - Risks and uncertainties

The Plan provides for various investment options in registered investment companies. Investment securities are exposed to various risks, such as interest rate, market and credit.

Due to the level of risk associated with certain investment securities and the level of uncertainty related to changes in the value of investment securities, it is at least reasonably possible that changes in risks in the near-term would materially affect participants' account balances and the amounts reported in the Statements of Net Assets Available for Benefits - Modified Cash Basis and the Statement of Changes in Net Assets Available for Benefits - Modified Cash Basis.

Note 8 - Party-in-interest and related party transactions

Certain plan investments are shares of mutual funds and units or participation in common/collective trusts held with Charles Schwab Bank. Charles Schwab Bank is the Trustee as defined by the Plan and, therefore, transactions related to these investments qualify as party-in-interest transactions.

Note 9 - Tax status

The Plan uses a prototype non-standardized profit-sharing plan document sponsored by the Trustee. The Trustee received an opinion letter from the Internal Revenue Service (IRS) dated June 19, 2014, which states that the prototype document satisfies the applicable provisions of the IRC. The prototype plan has been amended since receiving the determination letter. The Plan itself has not received a determination letter from the IRS. However, the Plan's management believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC as of the financial statement date.
