### DESCRIPTION OF PLAN

The following description of the Peninsula Orthopedic Associates, P.A. ("Company") Profit Sharing Plan ("Plan") provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

#### General

The Plan is a defined contribution plan covering all employees who are twenty-one or older and not represented by a collective bargaining unit who are residents or resident aliens of the United States. The plan specifically excludes per diem employees from participating. Employees must accumulate 90 days of service prior to entry. Eligible employees may enter the Plan on the first day of the subsequent month once they have met all eligibility requirements. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

#### Contributions

Each year, participants may contribute a portion of their pretax or after tax annual compensation, as defined in the Plan. Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover). Participants direct the investment of their contributions into various investment options offered by the Plan.

The Company makes a non-elective Safe Harbor contribution equal to three percent (3%) of employee compensation. Employer profit sharing contributions are discretionary for each employee based on employee compensation.

The Company makes a discretionary profit sharing contributions equal to a percentage of employees pay that is evaluated and adjusted each year.

For the years ended December 31, 2024 and 2023, employer safe harbor contributions totaled \$393,050 and \$307,703, while profit sharing contributions totaled \$655,991 and \$505,451, respectively.

Contributions are subject to certain IRS limitations.

#### Investment options

Participants direct investment of their contributions into various investment options offered by the Plan. The Plan currently offers various mutual funds and insurance company general accounts as investment options for participants. Participants may direct contributions in investment options in percent increments or fixed dollar amounts. All employer contributions are invested in the same funds in which the participants invest their own contributions.

### DESCRIPTION OF PLAN (Continued)

#### Participant accounts

Each participant's account is credited with the participant's contribution, company safe harbor contributions and profit sharing contributions, as well as Plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on the nature of the expense, proportionally on the value of the account balance, or as an equal dollar amount based on the number of Participants in the Plan, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

#### Vesting

Participants are immediately vested in their contributions, safe harbor contributions & "rollover" contributions plus actual earnings thereon. Vesting in the Company's discretionary contributions is based upon years of continuous service. Participants earn 20% vesting after completion of two covered year of service, 40% vesting after completion of three covered years of service, 60% after completion of four years of covered service, and 80% after completion of five years of covered service. A participant is 100 percent vested after six years of credited service.

#### Notes receivable from participants

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of 50% of their vested account balance or \$50,000, reduced by the aggregate dollar amount of loans outstanding. A participant can only have three (3) loans currently outstanding from the Plan. Loan terms range from 1-5 years or longer if the loan is for the purchase of primary residence provided documentation as to the purpose of the loan is made available. The loans are secured by the balance in the participant's account. The loan interest rate, determined quarterly, is set at one percent above the prime rate, as defined. Principal and interest are paid ratably through payroll deductions or by direct payment to the plan's custodian. Delinquent participant loans are reclassified as withdraws based upon the terms of the plan document.

#### Payment of benefits

On termination of service due to death, disability, or retirement, a participant will receive lump sum amount equal to the value of the participant's vested interest in his or her account if the balance does not exceed \$5,000, or if the vested balance is over \$5,000 a participant can receive lump sum distribution or partial withdrawals of at least \$1,000. For termination of service for other reasons, a participant may receive the value of the vested interest in his or her account as a lump sum distribution.

#### Forfeited accounts

Forfeitures other than matching contributions are used to reduce future employer contributions and pay plan expenses. As of December 31, 2024 and 2023 there is a balance of \$3,863 and \$2,546 in the forfeiture account, respectively. During the year ended December 31, 2024 and 2023, \$16,099 and \$35,821 of forfeitures were applied toward administrative expenses, respectively.

#### Administration of Plan assets

The Plan assets are currently held by Ascensus, LLC, they provide custodial, investment services, and record-keeping for the Plan. They are also the third-party administrator and provide administrative services including preparation of all required annual filings. A small number of employees contribute to brokerages outside of Ascensus; however, they are included in the plan's total assets and Ascensus provides record keeping services and third party administrator services for these assets. During the years ending December 31, 2024 and 2023, \$24,971 and \$19,217 respectively, were paid out in administrative expenses. The Plan made direct payments totaling \$19,565 to other service providers for the year ended December 31, 2024. No direct payments to other service providers were made by the Plan for the year ended December 31, 2023.

### SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

#### Basis of accounting

The financial statements of the Plan are prepared under the accrual method of accounting.

#### Use of estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the plan administrator to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results may differ from those estimates.

#### Investment valuation and income recognition

Investments are reported at fair value, except for fully benefit responsive investment contracts, which are reported at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Company's owners and CEO jointly determine the Plan's valuation policies utilizing information provided by the investment advisers, custodians and third party administrator. See the "FAIR VALUE MEASUREMENTS" note for discussion of fair value measurements.

Investments in fully-benefit responsive investment contracts are reported at contract value. Contract value is the relevant measure for the portion of the net assets available for benefits of a defined contribution plan attributed to fully benefit-responsive investment contracts because contract value is the amount participants would receive if they were to initiate permitted transactions under the Plan.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (decline) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

#### Notes receivable from participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred.

No allowance for credit losses has been recorded as of December 31, 2024 or 2023. If a participant ceases to make loan repayments and the plan administrator deems the participant loan to be in default, the participant loan balance is reduced and a benefit payment is recorded.

#### Payment of benefits

Benefits are recorded when paid.

#### Expenses

The Plan's expenses are paid either by the Plan or the Company, as provided by the plan document. Expenses that are paid directly by the Company are excluded from these financial statements. Certain expenses incurred in connection with the general administration of the Plan that are paid by the Plan are recorded as deductions in the accompanying statement of changes in net assets available for benefits. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. In addition, certain investment related expenses are included in net appreciation of fair value of investments presented in the accompanying statements of changes in net assets available for benefits.

### SELF-DIRECTED ACCOUNTS

The Plan allows participants to invest contributions in self-directed accounts with custodians of the participant's choosing. During 2024 and 2023 six participants elected to invest in self-directed accounts. All self-directed accounts invested in open-end mutual funds and interest and non-interest bearing cash registered with the Securities Exchange Commission ("SEC"). The self-directed accounts were certified by the Plan trustee, Ascensus LLC.

### FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The fair value hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 – Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

---

Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

*Mutual funds:* Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the SEC. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

*Interest bearing cash:* Invested with brokerages other than Ascensus Trust Company, these accounts are listed as other investments on the form 5500. Due to their short maturities, the fair value of these instruments approximates their carrying value.

*Self-directed mutual funds:* Invested with brokerages other than Ascensus Trust Company, these accounts are listed as other investments on the form 5500. Other investments are valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the SEC. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

The methods used above may produce a fair value calculation that is not indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

**FULLY BENEFIT-RESPONSIVE INVESTMENT CONTRACT**

The Plan holds an investment contract that comprises a traditional investment contract with Federated Capital Preservation Fund totaling \$3,863 and \$2,453 at December 31, 2024 and 2023, respectively. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The guaranteed investment contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan. The guaranteed investment contract does not permit the insurance company to terminate the agreement prior to the scheduled maturity date.

The contract meets the fully benefit-responsive investment contract criteria and therefore is reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value, as reported to the Plan by Ascensus Trust Company, represents contributions made under the contract, plus earnings, less participant withdrawals, and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

The Plan's ability to receive amounts due is dependent on the issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments.

Certain events might limit the ability of the Plan to transact at contract value with the issuer. Such events include (1) amendments to the Plan documents (including complete or partial Plan termination or merger with another plan), (2) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the Plan sponsor or other Plan sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan, or (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA (5) premature termination of the contract. No events are probable of occurring that might limit the ability of the Plan to transact at contract value with the contract issuers and that also would limit the ability of the plan to transact at contract value with the participants.

In addition, certain events allow the issuer to terminate the contract with the Plan and settle at an amount different from contract value. Such events include (1) an uncured violation of the Plan's investment guidelines, (2) a breach of material obligation under the contract, (3) a material misrepresentation, (4) a material amendment to the agreement without the consent of the issuer.

### **RELATED PARTY TRANSACTIONS AND PARTIES-IN-INTEREST**

Ascensus Trust Company was the custodian as defined by the Plan and, therefore, these transactions qualify as party in interest transactions. Certain Plan investments are shares of mutual funds which were managed by Ascensus Trust Company during the plan year. Fees incurred by the Plan for the investment management services are included in net appreciation in fair value of investments because they are paid through revenue sharing rather than a direct payment.

As described in the Summary of Accounting Policies, the Plan made direct payments to Ascensus Trust Company totaling \$24,971 during the Plan year ended December 31, 2024 not covered by revenue sharing. During the Plan year ended December 31, 2023 the Plan made direct payments to Ascensus Trust Company totaling \$19,216 not covered by revenue sharing. The Plan made direct payments to other service providers totaling \$19,565. The Company pays directly any other fees related to the Plan's operations.

### **PLAN TERMINATION**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100 percent vested in their employer contributions.

### **TAX STATUS**

The volume submitter document, upon which the Plan was designed received a favorable opinion letter from the Internal Revenue Service (“IRS”) dated June 30, 2020, stating that the Plan is qualified under Section 401(a) of the Code and therefore, is exempt from taxation. Once qualified, the Plan is required to operate in conformity with the Code to maintain its qualification. The Plan was amended subsequent to receiving the opinion letter, however, the Plan Administrator believes the Plan is being operated in compliance with the applicable requirements of the Code. Therefore, no provision for income taxes has been included in the Plan’s financial statements.

Accounting principles generally accepted in the United States require plan management to evaluate uncertain tax positions taken by the Plan and recognize a tax liability if the organization has taken an uncertain tax position that more likely than not would not be sustained upon examination. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

### **RISKS AND UNCERTAINTIES**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants’ account balances and the amounts reported in the statement of net assets available for benefits.
