## **INDEPENDENT AUDITORS' REPORT**

### **To the Trustees and Management of Pawling/Tafur McDonalds 401(k) Plan**

#### **Scope and Nature of the ERISA Section 103(a)(3)(C) Audit**

We have performed the audits of the accompanying financial statements of Pawling/Tafur McDonalds 401(k) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained a certification from a qualified institution as of December 31, 2024 and 2023 and for the years then ended, stating that the certified investment information, as described in Note F to the financial statements, is complete and accurate.

#### **Opinion**

In our opinion, based on our audits and on the procedures performed as described in the Auditors' Responsibilities for the Audit of the Financial Statements section—

- the amounts and disclosures in the financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- the information in the financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).



## **Basis for Opinion**

We conducted our audits in accordance with auditing standards generally accepted in the United States of America. Our responsibilities under those standards are further described in the Auditors' Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of Pawling/Tafur McDonalds 401(k) Plan and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

## **Responsibilities of Management for the Financial Statements**

Management is responsible for the preparation and fair presentation of these financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about Pawling/Tafur McDonalds 401(k) Plan's ability to continue as a going concern for one year after the date the financial statements are available to be issued.

**NOTE A - DESCRIPTION OF PLAN**

The following description of the Pawling/Tafur McDonalds 401(k) Plan (the “Plan”) for 3<sup>rd</sup> GEN MOJO, LLC and KP Paws, LLC (the Companies) provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan’s provisions.

**1. General**

The Plan is a “Safe Harbor” plan covering all employees of the Companies who are 21 years of age or older and who have completed one year of service. The Plan covers employees of 3<sup>rd</sup> GEN MOJO, LLC and KP Paws, LLC. Each employee who has met the eligibility requirements can be a participant on the first entry date which occurs after satisfying the requirements. The plan entry dates are January 1 and July 1 of each year. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Trustees oversee governance of the Plan, determine the appropriateness of the Plan’s investment offerings, and monitor investment performance.

**2. Contributions**

Each year, participants may contribute up to 100% of pretax annual compensation and/or participants may contribute after-tax Roth contributions, as defined in the Plan document, subject to Internal Revenue Code (IRC) limits. Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans (rollover). Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan currently offers various mutual funds and an insurance investment contract as investment options for participants. Contributions are subject to certain statutory limitations.

The Companies will make a contribution in an amount equal to 100% of the participant’s elective deferral, up to 3% of their contribution. In addition, the Companies match 50% of the next 2% of the participant’s elective deferral. Contributions of the Companies are 100% vested at all times. The matching contributions were \$137,025 and \$132,488 for December 31, 2024 and 2023, respectively.

**3. Participant Accounts**

Each participant’s account is credited with the participant’s contribution, the Companies’ matching contributions, allocations of plan earnings (losses), and then charged with an allocation of any administrative expenses paid by the Plan. Allocations are based on participant earnings or account balances, as defined in the Plan. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account balance.

**4. Vesting**

Participants are immediately vested in their contributions, employer matching contributions, rollovers, plus actual earnings thereon.

**NOTE A - DESCRIPTION OF PLAN (Continued)**

**5. Payment of Benefits**

Upon termination of service due to death, disability, retirement, or termination of employment, a participant may elect to receive a distribution in an amount equal to the participant's vested interest in his or her account. The plan administrator may transfer the vested account to an IRA in the participant's name for account balances between \$1,000 and \$5,000, if election forms are not returned timely. Vested account balances less than \$1,000 can be automatically distributed to participants upon termination. In conditions of financial hardship, a participant may apply to the plan administrator for approval to withdraw that portion of their elective deferrals necessary to meet the financial hardship, subject to the limitations of the Plan and Code.

**6. Forfeited Accounts**

In accordance with the plan document, forfeitures are first applied to the restoration of forfeitures, and then, at the discretion of the Companies, can be added to or used as employer contributions or can be used to pay administrative expenses of the Plan. At December 31, 2024 and 2023, forfeited nonvested and/or unallocated accounts totaled \$14,315 and \$15,595, respectively. The Companies used \$1,759 and \$3,359 to reduce employer contributions during 2024 and 2023, respectively.

**NOTE B - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

**1. Basis of Accounting**

The financial statements of the Plan are prepared on the accrual basis of accounting.

**2. Investment Valuation and Income Recognition**

Investments are reported at fair value, except for fully benefit-responsive investment contracts, which are reported at contract value (see Note H). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Trustees determine the Plan's valuation policies. See Note G for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) in fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year. Gains and losses included in changes in net assets available for benefits for the years ended December 31, 2024 and 2023, are reported in net appreciation (depreciation) in fair value of investments.

**3. Use of Estimates**

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America ("GAAP") requires the plan administrator to make estimates and assumptions that affect certain reported amounts of assets and liabilities and changes therein, and disclosures of contingent assets and liabilities. Accordingly, actual results may differ from those estimates.

**4. Payment of Benefits**

Benefits are recorded when paid.

**5. Expenses**

Certain expenses of maintaining the Plan are paid by the Companies and are therefore, excluded from these financial statements. All costs and expenses of administering the Plan are payable by the Plan if not paid by the Companies. Distribution fees are charged directly to the participants' accounts. Investment related expenses are included in net appreciation (depreciation) of fair value of investments. Rebates received from investment providers are allocated pro-rata among all participants based on their account value. These rebates are included in net appreciation (depreciation) in fair value of investments.

**NOTE C - PLAN TERMINATION**

Although they have not expressed any intent to do so, the Companies have the right under the Plan to discontinue their contributions at any time and to terminate the Plan subject to the provisions of ERISA.

**NOTE D - RISKS AND UNCERTAINTIES**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

**NOTE E - TAX STATUS**

The Companies have adopted the Standard Retirement Services, Inc. Defined Contribution Pre-Approved Plan under Adoption Agreement dated January 1, 2022. The prototype plan sponsor has obtained an opinion letter dated June 30, 2020, in which the Internal Revenue Service (IRS) stated that the prototype non-standardized profit-sharing plan document was in compliance with applicable requirements of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the opinion letter, the Plan administrator believes that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believes that the Plan is qualified, and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require the plan administrator to evaluate tax positions taken by the Plan and to recognize a tax liability for any uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by tax authorities; however, there are currently no audits in progress for any open tax periods.

**NOTE F - INFORMATION PREPARED AND CERTIFIED BY THE CUSTODIAN**

Certain information disclosed in the accompanying financial statements and supplemental schedule, which include investments held at December 31, 2024 and 2023, dividends and interest, and net appreciation (depreciation) in fair value of investments for the years ended December 31, 2024 and 2023, was obtained or derived from information supplied to the plan administrator and certified as complete and accurate by Charles Schwab Trust Bank, the Custodian of the Plan.

**NOTE G - FAIR VALUE MEASUREMENTS**

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The three levels of the fair value hierarchy under FASB ASC 820 consists of three broad levels: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority; Level 2 inputs consist of observable inputs other than quoted prices for identical assets; and Level 3 inputs are unobservable and have the lowest priority. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value. Level 2 and 3 inputs would only be used when Level 1 inputs are not available. There are no plan assets requiring the use of Level 2 or Level 3 inputs for the years presented.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

**Registered investment companies (mutual funds)** - The fair value of registered investment companies (mutual funds) is based on quoted net asset values of the shares as reported by the fund. The funds held by the Plan are open-end mutual funds registered with the U.S. Securities and Exchange Commission. The funds must publish their daily net asset value and transact at that price. The funds held by the Plan are considered to be actively traded.

**NOTE H - FULLY BENEFIT-RESPONSIVE GUARANTEED INVESTMENT CONTRACT**

The Plan has a fully benefit-responsive guaranteed investment contract with Standard Insurance Company ("Standard") with contract values of \$80,332 and \$71,071 for the years ended December 31, 2024 and 2023, respectively. Standard maintained the contributions in a general account. The account was credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The guaranteed investment contract issuer was contractually obligated to repay the principal and a specified interest rate that was guaranteed to the Plan.

Because the guaranteed investment contract is fully benefit-responsive, contract value is the relevant measurement attribute for that portion of the net assets available for benefits attributable to the guaranteed investment contract. The guaranteed investment contract is presented on the face of the statements of net assets available for benefits at contract value. Contract value, as reported to the Plan by the Standard Insurance Company, represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value. There are no reserves against contract value for credit risk of the contract issuer or otherwise.

Certain events limit the Plan's ability to transact at contract value with the Standard Insurance Company. Such events include the following: termination of the contract, spin-offs, divestitures, layoffs, corporate relocation, partial or total plan termination, retirement incentive programs, and the liberalization of plan withdrawal or transfer rules. Furthermore, certain events would allow the issuer to terminate the contract with the Plan and settle at an amount different from contract value. Examples of such events include the contract owner's failure to abide by state or federal law, failure to render performance necessary to comply with the terms of the contract, failure to maintain assets of at least \$25,000, plan disqualification, and failure to adopt the Plan in a reasonable period of time. The plan administrator does not believe that any events which would limit the Plan's ability to transact at contract value with the plan participants or the issuer are probable of occurring.

**NOTE I - RELATED PARTY AND PARTY-IN-INTEREST TRANSACTIONS**

Standard Insurance Company is the third-party administrator as defined by the Plan, and therefore, payments for services qualify as party-in-interest transactions. As described in Note B-5, the Plan made direct payments to the third-party administrators for distribution and plan services which amounted to \$2,395 and \$1,720 for the years ended December 31, 2024 and 2023, respectively. Additionally, the Plan invests in a guaranteed investment contract with Standard Insurance Company. These party-in-interest transactions are exempt from the prohibited transaction rules of ERISA.

**NOTE J - PLAN AMENDMENTS**

Effective March 23, 2023, the Plan was amended to add an additional Plan Trustee.

**NOTE K - DATE OF MANAGEMENT'S REVIEW & SUBSEQUENT EVENTS**

Subsequent events have been evaluated through October 14, 2025, which is the date on which the financial statements were available to be issued.

No subsequent events were identified that would require an adjustment to or disclosure in the accompanying financial statements.
