### **Scope and Nature of the ERISA Section 103(a)(3)(C) Audit**

We have performed audits of the financial statements of Citizens Medical Center, Inc. 401(k) and Pension Trust (the Plan), an employee benefit plan subject to the *Employee Retirement Income Security Act of 1974* (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. ## **Note 1. Description of the Plan**

### ***General***

The following description of the Citizens Medical Center, Inc. 401(k) and Pension Trust (Plan) provides only general information. Participants should refer to the Plan Document for a more complete description of the Plan's provisions.

The Plan is a defined contribution plan sponsored by Citizens Medical Center, Inc. (Company) for the benefit of its employees who are age 21 and older. In addition, participants are eligible to receive employer contributions after reaching age 21 and completing twelve months of service. A year of service is defined by the Plan as a twelve-month period during which the employee completes at least 1,000 hours of service. Various members of the Company's management are the trustees of the Plan. Principal Life Insurance Company serves as the recordkeeper. Principal Life Insurance Company and Delaware Charter Guarantee and Trust Company d/b/a Principal Trust Company serve as the plan custodians. Principal Global Investors Trust Company serves as trustee of the collective investment trusts.

### ***Contributions***

The Plan permits eligible employees through a salary deferral election to have the Company make annual pre-tax, Roth, and after-tax contributions of up to the maximum allowable by the Internal Revenue Service. Employee rollover contributions are also permitted. Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions.

The Company makes matching contributions of 50% of employees' salary deferral amounts up to 6% of employees' compensation. The Company also makes additional contributions of 2% of eligible employees' compensation. The Company may also make discretionary contributions to participants employed on the last day of the year. Contributions are subject to certain limitations.

### ***Participant Investment Account Options***

Each participant has the option of directing contributions into any of the various investment options offered by the Plan and may change the allocation daily.

The Plan Document also includes an automatic deferral feature whereby a participant is treated as electing to defer a certain percentage of eligible compensation unless the participant made an affirmative election otherwise.

### ***Participant Accounts***

Each participant's account is credited with the participant's contribution, the Company's contribution and plan earnings and is charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefits to which a participant is entitled is the benefit that can be provided from the participant's vested account.

### ***Vesting***

Participants are immediately vested in their voluntary contributions plus earnings thereon. Vesting in the Company's contribution portion of their accounts plus earnings thereon is based on years of continuous service. A participant is 20% vested after one year of credited service. Vesting increases by 20% each year after that until 100% is reached after five years. The nonvested balance is forfeited upon termination of service.

***Notes Receivable from Participants***

Participants may borrow from their fund accounts a minimum amount of \$500 up to a maximum amount equal to the lesser of \$50,000 or 50% of the participant's vested account balance. All loans are covered by demand notes and are repayable over a period not to exceed five years through payroll withholdings unless the participant is paying the loan in full. Interest on the loans is based on local prevailing rates as determined by the plan administrator.

***Payment of Benefits***

On termination of service, death, disability or retirement, a participant may elect to receive either a lump-sum amount equal to the value of his account, annuity or annual installments over a fixed reasonable period of time. Participants may also make in-service withdrawals, including for financial hardships.

***Forfeited Accounts***

At December 31, 2024 and 2023, forfeited nonvested accounts totaled \$397 and \$28,913, respectively. These accounts will be used to reduce future employer contributions or pay administrative expenses. Also, in 2024 and 2023, employer contributions remitted were reduced by \$55,724 and \$38,731, respectively, from forfeited nonvested accounts. The contribution receivable was reduced by \$27,284 at December 31, 2023.

**Note 2. Summary of Significant Accounting Policies**

***Basis of Accounting***

The accompanying financial statements are prepared on the accrual basis of accounting.

***Use of Estimates***

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of net assets, changes in net assets, and the disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

***Investment Valuation and Income Recognition***

Investments are reported at fair value. Quoted market prices, if available, are used to value investments. Mutual funds are valued at the net asset value (NAV) of shares held by the Plan at year end.

Pooled separate accounts are valued at estimated fair value as provided by Principal Life Insurance Company.

The fair value of guaranteed investment contracts are calculated by discounting the related cash flows based on current yields of similar instruments with comparable durations considering the creditworthiness of the issuer.

The Plan's interest in the collective investment trusts are valued based on information reported by the investment advisor using the audited financial statements of the collective investment trusts at year-end.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation in the fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

***Contributions***

Contributions from Plan participants and the matching contributions from the Company are recorded in the year in which the employee contributions are withheld from compensation.

***Notes Receivable from Participants***

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent participant loans are reclassified as distributions based upon the terms of the Plan Document.

***Payment of Benefits***

Benefit payments to participants are recorded upon distribution.

***Administrative Expenses***

Administrative expenses may be paid by the Company or the Plan, at the Company's discretion.

**Note 3. Certification of Plan Custodians**

The Plan Administrator has elected the method of annual reporting compliance permitted by ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Principal Life Insurance Company (PLIC), Delaware Charter Guarantee and Trust Company d/b/a Principal Trust Company and PLIC on behalf of Principal Global Investor's Trust Company, collectively, qualified institutions, have certified the following investment information included in the accompanying financial statements and ERISA-required supplemental schedules are complete and accurate:

- Investments as shown in the statements of net assets available for benefits and related disclosures as December 31, 2024 and 2023
- Investment income as shown in the statements of changes in net assets available for benefits for the years ended December 31, 2024 and 2023
- Investment information included in the accompanying schedule of assets (held at year-end) as of December 31, 2024

The Plan's independent auditors did not perform auditing procedures with respect to this certified investment information, except for comparing such certified investment information to the related investment information included in the financial statements and ERISA-required supplemental schedules.

#### **Note 4. Party-in-Interest Transactions**

Party-in-interest transactions include those with fiduciaries or employees of the Plan, any person who provides services to the Plan, an employer whose employees are covered by the Plan, an employee organization whose members are covered by the Plan, a person who owns 50 percent or more of such an employer or employee association, or relatives of such persons.

The Plan invests in certain funds of the plan custodians as defined by the Plan and, therefore, these transactions qualify as party-in-interest transactions.

The Plan paid \$55,320 and \$47,569 of contract administration fees to Principal during 2024 and 2023, respectively. Individually nonmaterial expenses paid to parties in interest aggregated \$24,978 and \$24,693 during the years ended December 31, 2024 and 2023, respectively. The Company provides certain administrative services at no cost to the Plan.

#### **Note 5. Disclosure About Fair Value of Plan Assets**

Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Fair value measurements must maximize the use of observable inputs and minimize the use of unobservable inputs. There is a hierarchy of three levels of inputs that may be used to measure fair value:

- Level 1** Quoted prices in active markets for identical assets or liabilities
- Level 2** Observable inputs other than Level 1 prices, such as quoted prices for similar assets or liabilities; quoted prices in markets that are not active; or other inputs that are observable or can be corroborated by observable market data for substantially the full term of the assets or liabilities
- Level 3** Unobservable inputs supported by little or no market activity and are significant to the fair value of the assets or liabilities

The Plan's investment in the Principal U.S. Property Separate Account is subject to certain restrictions including delaying the payment of most withdrawal or transfer requests, but for no more than three years from the effective date. In accordance with the terms of the plan's group annuity contract, delayed payment requests will be honored proportionately. This means transactions may be processed in a series of payments until enough cash is available to pay obligations. As of December 31, 2024, participant distribution requests totaling \$5,099 were pending due to withdrawal limitation.

Following is a description of the valuation methodologies and inputs used for assets measured at fair value on a recurring basis and recognized in the accompanying statements of net assets available for benefits, as well as the general classification of such assets pursuant to the valuation hierarchy. There have been no significant changes in the valuation techniques during the years ended December 31, 2024 and 2023. The Plan had no liabilities measured at fair value on a recurring basis. In addition, the Plan had no assets or liabilities measured at fair value on a nonrecurring basis. For assets classified within Level 3 of the fair value hierarchy, the process used to develop the reported fair value is described below.

**Investments**

Where quoted market prices are available in an active market, securities are classified within Level 1 of the valuation hierarchy. If quoted market prices are not available, then fair values are estimated by using quoted prices of securities with similar characteristics or independent asset pricing services and pricing models, the inputs of which are market-based or independently sourced market parameters, including, but not limited to, yield curves, interest rates, volatilities, prepayments, defaults, cumulative loss projections and cash flows. Such securities are classified in Level 2 of the valuation hierarchy. In certain cases where Level 1 or Level 2 inputs are not available, securities are classified within Level 3 of the hierarchy. See the table below for inputs and valuation techniques used for Level 3 securities.

**Note 7. Tax Status**

The Plan operates under a nonstandardized pre-approved profit-sharing plan document sponsored by Principal Life Insurance Company. This pre-approved plan document received an opinion letter from the Internal Revenue Services (IRS) stating the form of the plan is acceptable under the appropriate section of the Internal Revenue Code (IRC). The Plan itself has not obtained or requested a determination letter. However, the plan administrator believes the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC and the Plan was qualified and the related trust was tax exempt as of the financial statement date.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**Note 8. Nonexempt Transactions**

Defined contribution plans are required to remit employee contributions to the Plan as soon as they can be reasonably segregated from the employer's general assets, but no later than the 15th business day of the month following the month in which the participant contributions are withheld by the employer. Contributions of \$155,424 were not remitted within the required time period and lost earnings have not been remitted to the Plan as of December 31, 2024.

**Note 9. Risks and Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the participants' account balances and the amounts reported in the statements of net assets available for benefits.

**Note 10. Subsequent Events**

Subsequent events have been evaluated through October 13, 2025, which is the date the financial statements were available to be issued.
