### ***Scope and Nature of the ERISA Section 103(a)(3)(C) Audits***

We have performed the audits of the accompanying financial statements of Riverside Refreshments, Inc. 401(k) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statement of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of Riverside Refreshments, Inc. 401(k) Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Management has obtained certifications from Empower Trust Company, LLC, as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

### ***Opinion***

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section:

- the amounts and disclosures in the financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

- the information in the financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

### ***Basis for Opinion***

We conducted our audits in accordance with auditing standards generally accepted in the United States of America. NOTES TO FINANCIAL STATEMENTS

NOTE 1 - DESCRIPTION OF PLAN

The following description of the Riverside Refreshments, Inc. 401(k) Plan is provided for general information purposes only. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

1. General - The Plan is a defined contribution plan covering all employees of Riverside Refreshments, Inc. (the "Company"). Employees must be 21 years of age or older and complete one year of service to participate in the Plan. It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).
2. Contributions - Each year, participants may contribute up to the IRS maximum percentage of pretax annual compensation, as defined in the Plan. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans. Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan currently offers various pooled separate accounts with an insurance company and a guaranteed investment contract as investment options for participants. Both matching contributions and profit sharing amounts may be contributed at the option of the Company's board of directors and are invested in a portfolio of investments as directed by the participant.
3. Participant Accounts - Each participant's account is credited with the participant's contribution and allocation of (a) any optional Company contribution, and b) Plan earnings, and charged with an allocation of administrative expenses. Allocations of Plan earnings are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. Each participant directs the investment of their account to any of the investment options available under the Plan.
4. Vesting - Participants are immediately vested in their contributions plus actual earnings thereon. The value of the participant's account attributable to matching and profit sharing contributions vests as follows:

Less than 3	0%
3 or more years	100%
5. Payment of Benefits - On termination of service due to death, disability, retirement or other reasons, a participant or named beneficiary will receive the value of the participant's vested interest in his or her account as either a lump-sum distribution or installment payments.
6. Administrative Expenses - Certain costs incurred in the administration of the Plan are paid from plan assets. Certain administrative functions are performed by employees of the Company. No such employee receives compensation from the Plan.

NOTE 1 - DESCRIPTION OF PLAN (continued)

7. Forfeited Accounts - At December 31, 2024 and 2023, the forfeited, nonvested account balance was \$25,760 and \$17,078, respectively. Forfeitures result when compliance testing requires refunds of excess contributions. In the event excess contributions are refunded, the match portion of the contributions becomes a forfeiture at the distribution date and is used to pay administrative expenses or reduce the employer's matching contribution. For the year ended December 31, 2024, \$7,470 was used to reduce employer contributions.

NOTE 2 - SUMMARY OF ACCOUNTING POLICIES

The policies and principles that significantly affect the determination of net assets and changes in the net assets are summarized below:

Basis of Accounting

The financial statements of the Plan are prepared using the accrual method of accounting.

Investment Valuation and Income Recognition

The Plan's investments are stated at fair value with the exception of the fully benefit-responsive investment contract, which is stated at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Contract value is the relevant measure for the portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants would receive if they were to initiate permitted transactions under the Plan. Valuation methodologies are disclosed in Notes 4 and 5.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date.

The Plan presents in its statement of changes in net assets available for benefits the net appreciation/depreciation in the fair value of investments, which consists of realized gains or losses and unrealized appreciation/depreciation on those investments.

Payment of Benefits

Benefit payments to participants are recorded upon distribution.

Estimates

The preparation of financial statements in conformity with generally accepted accounting principles requires the plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

Subsequent Events

The Plan has evaluated subsequent events through October 9, 2025, the date the financial statements were available to be issued.

NOTE 4 - FAIR VALUE MEASUREMENTS

Accounting principles generally accepted in the United States of America establish a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. Fair value measurements must be classified and disclosed in one of the three levels of the fair value hierarchy are described as follows:

Level 1 - Financial instruments with unadjusted, quoted prices listed on active market exchanges.

Level 2 - Financial instruments valued using inputs that include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability; and
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Financial instruments that are not actively traded on a market exchange and require using significant unobservable inputs in determining fair value.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

*Pooled separate accounts:* Pooled separate accounts are reported at net asset value (NAV). The NAV is calculated by the fund manager. Each pooled separate account is divided into investment divisions called Sub-Accounts. The value of each pooled separate account is equal to the sum of the values of the Sub-Accounts it holds. Each Sub-Account invests in shares of an underlying mutual fund (“Fund”). Sub-Account values are measured in terms of Accumulation Units. The Accumulation Units of a Sub-Account are assigned a unit value on a daily basis, at the end of each day the New York Stock Exchange (“NYSE”) is open for trading, as of the close of the NYSE on that day (“Valuation Day”).

To determine the current Accumulation Unit Value for a Sub-Account, the prior Valuation Day’s Accumulation Unit Value is multiplied by the Net Investment Factor. The Net Investment Factor is used to measure the investment performance of a Sub-Account from one Valuation Day to the next. The Net Investment Factor for each Sub-Account equals the NAV per share of the underlying Fund held in the Sub-Account at the end of the current Valuation Day, divided by the NAV per share of the underlying Fund held in the Sub-Account at the end of each prior Valuation Day, minus any applicable daily mortality and expense risk and administration charges. The shares of the underlying Fund are valued at NAV on a daily basis.

- (i) World Small/Mid Stock funds seek capital appreciation through investment in equities securities of issuers in the U.S. and foreign countries. A substantial portion of assets are invested in small and mid-sized companies.
- (j) Mid cap funds will invest at least 80% of its net assets in securities of “mid-cap” companies, and in derivatives and other instruments that have economic characteristics similar to such securities.

(k) Small blend funds seek to maximize total return through investment primarily in small capitalization equity securities.

\*Any transfer or withdrawal from a separate account may be delayed for a period of up to 30 days if there is a negative cash flow into a separate account considering all contracts with funds in the separate account on the Valuation Date for such transfer or withdrawal. In the event of contract discontinuance, transfers or payments may be deferred for up to a maximum of 90 days.

NOTE 5 - TRADITIONAL INVESTMENT CONTRACT

The Plan holds a traditional investment contract. This contract meets the fully benefit-responsive investment contract criteria and therefore is reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses.

The traditional investment contract held by the Plan provides a guarantee that the credit rate will not fall below one percent. Cash flow volatility (for example, timing of benefit payments) as well as asset underperformance can be passed through to the Plan through adjustments to future contract crediting rates. Formulas are provided in the contract that adjusts renewal crediting rates to recognize the difference between the fair value and the book value of the underlying assets. Crediting rates are reviewed annually for resetting.

The Plan's ability to receive amounts due in accordance with this fully benefit-responsive investment contract is dependent on the third-party issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments.

Certain events might limit the ability of the Plan to transact at contract value with the contract issuer. These events may be different under each contract. Examples of such events include the following:

1. The Plan's failure to qualify under Section 401(a) of the Internal Revenue Code or the failure of the trust to be tax-exempt under Section 501(a) of the Internal Revenue Code;
2. Premature termination of the contract;
3. Plan termination or merger;
4. Changes to the Plan's prohibition on competing investment options;
5. Bankruptcy of the plan sponsor or other plan sponsor events (for example, divestitures or spinoffs of a subsidiary) that significantly affect the Plan's normal operations.

No events are probable of occurring that might limit the ability of the Plan to transact at contract value with the contract issuer and that also would limit the ability of the Plan to transact at contract value with the participants.

The insurance company investment contract does not permit the insurance company to terminate the agreement prior to the scheduled maturity date.

NOTE 6 - RIGHTS UPON PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants would become 100% vested in their employer contributions and earnings thereon.

NOTE 7 - TAX STATUS

The Plan is a prototype plan sponsored by Empower Trust Company, LLC. The prototype plan has received a favorable determination letter from the Internal Revenue Service dated March 31, 2014. The Plan has been amended since its determination letter was received in order to comply with changes in tax laws. Riverside Refreshments, Inc. 401(k) Plan has not obtained a separate determination letter from the Internal Revenue Service. The Plan Sponsor believes the Plan to be acceptable under Section 401 of the Internal Revenue Code and that it has been operated in compliance with the applicable requirements of the Internal Revenue Code. Accordingly, no provision for income taxes has been provided in the accompanying financial statements.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the plan and recognize a tax liability (or asset) if the plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Employee Benefit Securities Administration or the Internal Revenue Service. The plan sponsor has analyzed the tax positions taken by the plan, and has concluded that as of December 31, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements.

NOTE 8 - PARTY-IN-INTEREST TRANSACTIONS

The Plan's investments include pooled separate accounts and a guaranteed investment account managed by Empower and its affiliates. Empower and its affiliates earn fees for managing its pooled separate accounts and guaranteed investment account, and these fees are deducted from the earnings reported by the pooled separate accounts and guaranteed investment account. Certain fees associated with administering the Plan are also paid to Empower. Empower is the Plan trustee, and, therefore, these transactions qualify as party-in-interest transactions.

NOTE 9 - RISKS AND UNCERTAINTIES

The Plan provides for various investment options including any combination of pooled separate accounts. The underlying investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities and the level of uncertainty related to changes in the value of investment securities, it is at least reasonably possible that changes in the values of the investment securities will occur in the near term and that such changes could materially affect the amounts reported in the statement of net assets available for benefits and participants' individual account balances.

NOTE 10 - RECONCILIATION OF FINANCIAL STATEMENTS TO 5500

The Annual Return/Report of Employee Benefit Plan (the "Form 5500") is prepared on the modified cash basis. Accordingly, certain balances included on Schedule H (Part I and II) of the Form 5500 differ from those included in these financial statements.
