Note 1. Description of the Plan

The following description of the SBG Employee 401(k) Plan and Trust (Plan) provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan covering all eligible employees of Sudler and Company, Inc. (Company) and provides for retirement benefits to all participants. During 2019, the Company became a 100% owned entity of PMG Holdings, Inc.; however, the Company is treated as a separate legal entity for 401(k) and testing purposes. Upon satisfying the requirement of attaining the age of 21 and completing one year and 1,000 hours of service with the Company, employees become eligible to participate in the Plan on the first day of each plan year and the first day of the seventh month of each plan year. The Plan is subject to the provisions of the *Employee Retirement Income Security Act of 1974* (ERISA), as amended by subsequent legislation. The Plan was adopted on June 30, 1992, and restated July 1, 2014, and April 1, 2021.

On December 1, 2022, the retirement plan business of Securian Financial, recordkeeper, was acquired by The Standard. This did not result in any changes to plan provisions.

Contributions

Participants may elect to contribute the lesser of 1% to 100% of their eligible compensation or the maximum amount allowed in accordance with the Internal Revenue Code, as defined (\$23,000 in 2024). If a participant has attained age 50 by year-end, the participant may make a catch-up contribution of up to \$7,500 in 2024. The Company may make discretionary matching contributions of a percentage, if any, to be determined annually but subject to a maximum of 4% of the eligible compensation contributed by a participant to the Plan. Matching contributions were equal to 25% of the amount contributed by the employee up to the first 4% of compensation for the plan year. The Company may also, at their discretion, make a profit-sharing contribution to the Plan. There were no profit-sharing contributions made in 2024. A participant's account may include contributions made to another plan and transferred to the Plan as part of a rollover contribution.

Participant Accounts

Each participant's account is credited with the participant's contributions and an allocation of: (a) the Company's contributions and (b) plan earnings (losses) including increases or decreases in fair value of investments and charged with an allocation of administrative expenses. Allocations are based on participant earnings (losses) or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Each participant has a nonforfeitable right to the entire value of their salary reduction contribution account and rollover contribution account. A participant shall have a vested interest in their Company contribution account according to the following vesting schedule:

Years of Service	Vested Interest
Less than 2	0%
2 less than 3	20%
3 less than 4	40%
4 less than 5	60%
5 less than 6	80%
6	100%

A participant or their beneficiary shall be fully vested in the entire value of the participant’s account upon the participant’s attainment of his normal retirement age, early retirement age, or upon such participant’s disability or death.

Notes Receivable From Participants

Participants may borrow from their accounts up to the lesser of \$50,000 or 50% of their nonforfeitable account balances. The loans are secured by the remaining nonforfeitable balance in the participant’s account and bear interest at rates that range from 5.00% to 8.50% at December 31, 2024. Loan terms are not to exceed five years except for those loans utilized for the purpose of purchasing a primary residence. Generally, loan repayments (principal and interest) are repaid through payroll deductions.

Forfeited Accounts

At December 31, 2024 and 2023, forfeited nonvested accounts totaled \$2,467 and \$2,366, respectively. These accounts will first be used to pay administrative expenses. Any remaining amounts will be used to reduce future Company contributions payable under the Plan. During 2024, \$4,818 of forfeitures were used to reduce Company contributions to the Plan.

Payment of Benefits

If a participant retires, the balance of the participant’s account is payable at their option in a lump-sum distribution, cash distribution, or a rollover into a qualified plan or IRA unless the participant’s balance in the Plan is less than \$1,000, in which case the participant will receive a lump-sum distribution. Upon death or termination of a participant, the trustee of the Plan advises the beneficiary or participant of the various methods of distribution of the participant’s account available to the participant or their beneficiary. Beneficiaries are entitled to 100% of the participant’s account balance upon death or disability, as defined.

Participants are allowed to make in-service withdrawals from their fully vested interest in the Plan prior to age 59½ for reasons of financial hardship, as defined in the plan document. In 2020, the Company adopted the SECURE Act provision permitting eligible participants who are giving birth or adopting a child to withdraw up to \$5,000 without incurring the 10% penalty tax on early distributions.

Investment Options

Participants in the Plan have the right to direct the investment of their account balances in one or more investment funds made available by the plan committee of the Plan. The Plan currently offers investment options in pooled separate accounts and a general account.

Note 2. Summary of Significant Accounting Policies

Basis of Accounting

The financial statements of the Plan are prepared using the accrual method of accounting.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the plan administrator to make estimates and assumptions that affect the reported amounts of net assets, changes in net assets, and the disclosure of contingent assets and liabilities at the date of the financial statements. Actual results could differ from those estimates.

Valuation of Investments and Income Recognition

The Plan's investments are stated at fair value as disclosed in Note 3.

Investments held in pooled separate accounts are valued at net asset value (NAV) of units held. The NAV is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund less its liability. There are no participant redemption restrictions for these investments, and participant redemptions are allowed daily. A redemption notice period is applicable only at the plan level. There are no unfunded commitments at December 31, 2024 and 2023.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Payment of Benefits

Benefits are recorded when paid.

Notes Receivable From Participants

Notes receivable from participants are reported at their unpaid principal balance plus any accrued but unpaid interest, with no allowance for credit losses, as repayments of principal and interest are received through payroll deductions.

Risks and Uncertainties

The Plan provides for investments that, in general, are exposed to various risks such as interest rate, credit and overall market volatility risks. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities will occur in the near term, and that such changes could materially affect the amounts reported in the statement of net assets available for benefits.

Administrative Expenses

The Company employs certain personnel who administer the Plan, and the Company pays these expenses without reimbursement from the Plan. Administrative expenses paid by the Plan are expensed as incurred. Additionally, certain investment management fees are netted in the net appreciation in fair value of investments.

Note 3. Fair Value Measurements

Fair value is the price that would be received to sell an asset in an orderly transaction between market participants at the measurement date. Fair value measurements must maximize the use of observable inputs and minimize the use of unobservable inputs. There is a hierarchy of three levels of inputs that may be used to measure fair value:

- Level 1** Quoted prices in active markets for identical assets
- Level 2** Observable inputs other than Level 1 prices, such as quoted prices for similar assets; quoted prices in markets that are not active; or other inputs that are observable or can be corroborated by observable market data for substantially the full term of the assets
- Level 3** Unobservable inputs supported by little or no market activity and are significant to the fair value of the assets

The asset's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. There have been no changes in the methodologies used at December 31, 2024 and 2023.

The fair value of the Plan's interest in the general account is based upon the net asset values of the general assets of Minnesota Life Insurance Company, reflecting all investments at fair value, and is classified as Level 3 in the fair value hierarchy. The inputs used in deriving the estimated fair values of the fund are based upon an effective annual interest rate that is established each month. Interest is credited, based upon the daily balance, at a rate that is the daily equivalent of the effective annual rate of interest applicable for each month. There is no stated minimum or maximum interest rate for the general account.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Note 4. Investment Contract With Insurance Company

The Plan entered into a General Account Group Contract (contract) with The Standard Insurance Company (The Standard). The Standard maintains the contributions in an unallocated fund. The contract is increased with earnings on the underlying investments and decreased for plan withdrawals and administrative expenses charged by Minnesota Life. The contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan.

The contract is benefit-responsive, in that the full contract value is accessible, but not all at once in the case of certain transfers. Benefit-responsive does not equate to fully benefit-responsive. General account transfer provisions in the contract prevent the contract from meeting the definition of fully benefit-responsive, since the participant is not allowed immediate full access to the general account balance at contract value in all situations. The contract is reported on the statements of net assets available for benefits at fair value.

The crediting interest rate is based on an agreed-upon formula with the issuer but cannot be less than zero. Such interest rates are reviewed quarterly for resetting.

Note 5. Information Certified by the Plan Trustee

The plan administrator has elected the method of annual reporting compliance permitted by ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Minnesota Life Insurance Company, a qualified institution, has certified the following investment information included in the accompanying financial statements and ERISA-required supplemental schedule is complete and accurate:

- Investments, at fair value, and notes receivable from participants as shown in the statements of net assets available for benefits as of December 31, 2024 and 2023
- Investment income components and interest income from notes receivable from participants as shown in the statement of changes in net assets available for benefits for the year ended December 31, 2024
- Investment information and notes receivable from participants included in the accompanying schedule of assets (held at end of year) as of December 31, 2024

The Plan's independent auditors did not perform auditing procedures with respect to this certified information, except for comparing such certified information to the related information included in the financial statements and ERISA-required supplemental schedule.

Note 6. Party-in-Interest Transactions

The Plan's investment funds are managed by The Standard Insurance Company, the trustee for the Plan. Accordingly, these transactions qualify as party-in-interest transactions. Fees paid by the Plan during the year for investment management, recordkeeping, auditing, and other professional services were rendered primarily by parties-in-interest. Fees paid by the Plan totaled \$2,809 during 2024.

Note 7. Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA as amended by subsequent legislation. In the event of plan termination, full-time employees will become 100% vested in their account balances.

Note 8. Tax Status

The Plan operates under an adoption agreement in connection with a volume submitter profit sharing plan sponsored by Minnesota Life Insurance Company. This volume submitter profit sharing plan has been filed with the appropriate agency and has obtained an opinion letter from the Internal Revenue Service stating that the volume submitter profit sharing plan constitutes a qualified plan under Section 401 of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the opinion letter, the plan administrator believes that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believes that the Plan is qualified, and the related trust is tax exempt as of the financial statement date.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Note 9. Subsequent Events

Subsequent events have been evaluated through October 13, 2025, which is the date these financial statements were available to be issued.
