Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Jabian, LLC 401(k) Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year then ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of Jabian, LLC 401(k) Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan ("investment information") by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA ("qualified institution").

1. DESCRIPTION OF PLAN

The following is a brief description of the Jabian, LLC 401(k) Plan (the "Plan"). Participants or other interested parties should refer to the Plan Agreement for a more complete description of the Plan's provisions.

A. General

The Plan is a defined contribution plan covering all eligible employees of Jabian, LLC (the "Company") who have reached the age of 21. Excluded employees include Union employees, nonresident aliens, Co-ops and interns. The Plan was effective January 1, 2007, and restated on January 1, 2022, and is subject to certain provisions of the Employee Retirement Income Security Act of 1974 ("ERISA"). The Plan has been amended over the years to comply with tax regulations.

The Company is the Plan administrator, and the sole partners of the Company are the trustees of the Plan. Empower Trust Company, LLC and Empower Annuity Insurance Company of America (collectively "Empower"), the qualified institutions, are the custodians of the Plan's assets. The 401(k) Committee of the Company is responsible for oversight of the Plan, monitoring investment performance and determining the appropriateness of the Plan investment offerings.

B. Eligibility

Eligible employees can participate in the Plan for purposes of salary deferrals after the completion of one hour of service. Eligible employees can participate in the Plan for purposes of discretionary matching or profit-sharing contributions after the completion of one year of service. Participants who are eligible to make salary deferrals to the Plan are generally eligible for any safe harbor contributions. The entry date into the Plan is the first day of the Plan Year quarter (January 1, April 1, July 1, or October 1) coinciding with or following the date on which the employee met the eligibility requirements.

C. Contributions

Contributions to the Plan include employee elective deferrals, rollover contributions, employer 401(k) safe harbor contributions and employer discretionary matching and profit-sharing contributions. Participants may elect to contribute a specific percent or dollar amount of annual compensation on either a pre-tax or after-tax (Roth) basis up to the maximum allowed by the Internal Revenue Service. Participants who have attained age 50 before the end of the Plan year may make additional catch-up contributions. The Company may contribute additional discretionary matching contributions to the Plan.

The Company may elect to make a nonelective safe harbor contribution for the Plan Year in accordance with the Plan document after the Plan year has commenced. The safe harbor contribution will only be required for a Plan Year that the Plan elects to provide for such

contribution and appropriate supplemental notice is provided to participants. There were no safe harbor contributions for the year ended December 31, 2024.

The Company may also elect to make a discretionary profit-sharing contribution to the Plan as determined by the Company. The profit-sharing contributions totaled \$617,364 for the year ended December 31, 2024. The Company has until the extended due date of its income tax return to remit this contribution. At December 31, 2024 and 2023, employer contribution receivables totaled \$577,225 and \$639,241, respectively (See Note 1. H.).

D. Participant Accounts

Participants' accounts are maintained by the custodian and are credited with the participant's contribution, the Company's contributions, and an allocation of the investment income (loss). Each participant is charged with fees upon receiving loans or distributions, as well as an allocated portion of plan administrative expenses. Allocations are based on participant earnings or account balances, as defined. The vested benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

E. Vesting

Participants are immediately vested in their elective contributions, rollover contributions and Company safe harbor contributions plus earnings or losses thereon. Vesting in the Company's matching and profit-sharing contributions plus actual earnings or losses thereon, is based on years of credited service. A participant is fully vested in the portion of his/her account attributable to Company discretionary matching and profit-sharing contributions after five years of credited service as follows:

<u>Years of Credited Service</u>	<u>Vested Percentage</u>
Less than 1 year	0%
1 year but less than 2 years	20%
2 years but less than 3 years	40%
3 years but less than 4 years	60%
4 years but less than 5 years	80%
5 years or more	100%

However, participants will automatically be 100% vested in the event of death, normal retirement age or permanent disability.

F. Notes Receivable from Participants

Participants may borrow from their fund accounts up to a maximum of 50% of the present value of their vested account balance. The loans, which are collateralized by the balance in the participant's account, bear interest at 9.00% - 9.50%, which is commensurate with local

prevailing rates as determined by the Plan Administrator. Principal and interest are paid ratably through monthly payroll deductions.

G. Payments of Benefits

Upon termination of service due to retirement, termination, death or disability, a participant or representative may elect to receive the value of the vested interest in his or her account as a lump-sum distribution. The Plan has an automatic lump sum distribution of all accounts below \$5,000 upon separation. In addition, upon written request and approval, participants may withdraw a portion or all of the balance in their employee contribution account.

H. Forfeited Accounts

Amounts forfeited by participants who are terminated from the Plan prior to being fully vested are used to reduce employer contributions or administrative expenses. Employer contributions were reduced by \$119,637 and \$0 from forfeitures from non-vested accounts for the years ended December 31, 2024 and 2023, respectively. Total unused forfeited cash balances as of December 31, 2024 and 2023 were \$86,757 and \$127,382, respectively. Of this amount, \$40,139 will be used to pay the 2024 employer profit sharing contribution.

2. SUMMARY OF ACCOUNTING POLICIES

A. Basis of Accounting

The financial statements of the Plan have been prepared on the accrual method of accounting in accordance with accounting principles generally accepted in the United States of America ("U.S. GAAP").

B. Use of Estimates

The preparation of financial statements in conformity with U.S. GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

C. Investment Valuation and Income Recognition

The Plan's investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 for discussion of fair value measurements.

Purchases and sales are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as those held during the year.

D. Contributions

Contributions from Plan participants and the matching contributions/profit sharing contributions from the Employer are recorded in the year in which the employee contributions are withheld from compensation.

E. Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balances plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses when incurred. If a participant ceases making loan repayments and the plan administrator deems the participant loan to be in default, the participant loan balance is reduced and a benefit payment is recorded.

F. Payments of Benefits

Benefits are recorded when paid.

G. Administrative Expenses

Certain expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements. Fees related to the administration of notes receivable from participants and benefits paid to participants or beneficiaries are charged directly to the participant account and are included in administrative expenses. Investment related expenses are included in net appreciation (depreciation) of fair value of investments.

H. Subsequent events

Subsequent events have been evaluated by management through October 13, 2025, the date these financial statements were issued.

3. FAIR VALUE MEASUREMENTS

U.S. generally accepted accounting principles establish a hierarchy for inputs used in measuring fair value of investments that maximizes the use of observable inputs and minimizes the use of unobservable inputs by requiring that the most observable inputs be used when available. The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1 within the hierarchy states that valuations are based on unadjusted quoted market prices for identical assets or liabilities in active markets. Level 2 within the hierarchy states that valuations are based on quoted prices for similar assets in active markets, quoted prices for identical assets in inactive markets or other observable inputs other than quoted market prices. Level 3 within the hierarchy states that valuations are based on significant unobservable inputs.

At December 31, 2024 and 2023, investments are the only assets that are measured at fair value on a recurring basis in periods subsequent to initial recognition. The following is a description of the valuation methodology used for the assets measured at fair value. There have been no changes in the methodologies used on December 31, 2024 and 2023:

Unallocated contract: The Plan has a guaranteed interest account contract with Empower Annuity Insurance Company of America. The guaranteed interest account is reported at contract value. Contract value is the relevant measurement attributed to fully benefit-responsive investment contracts because contract value is the amount Participants would receive if they were to initiate permitted transactions under the terms of the Plan. See Note 4 for information on the guaranteed interest account.

Mutual funds: Valued at the closing price reported on the active market on which the individual securities are traded.

Common collective trust funds: Valued based on the NAV of the shares/units held by the Plan based on the market value of its underlying investments as determined by the custodian. The NAV, as provided by the custodian, is used as a practical expedient to estimate fair value. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV. There is no redemption notice period or unfunded commitments.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

4. KEY GUARANTEED PORTFOLIO FUND

The Plan entered into the Key Guaranteed Portfolio Fund, a fully benefit-responsive fixed annuity investment contract with Empower Annuity Insurance Company of America ("EAICA"). At December 31, 2024 and 2023, the Plan's balance in the Key Guaranteed Portfolio Fund is \$653,784 and \$599,013, respectively. EAICA maintains contributions in a general account. The participant principal and interest are fully guaranteed by the entire general account assets of EAICA.

Because the guaranteed investment contract is fully benefit-responsive, contract value is the relevant measurement attribute for that portion of the net assets available for benefits attributable to the guaranteed investment contract. The guaranteed investment contract is presented on the face of the statement of net assets available for benefits at contract value. Contract value, as reported by EAICA, represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

The methodology for calculating the interest crediting rate is based on the earnings of the underlying assets in the entire medium-long term new portfolio compared to the minimum interest crediting rate, as stated in the contract, and prevailing market conditions. The interest crediting rate is reset quarterly. The average yield earned by the Plan for the benefit-responsive fund can be derived by averaging the quarterly gross interest rates for the fund over the year. The average for 2024 and 2023 was 1.41% and 1.23%, respectively.

Certain events limit the ability of the Plan to transact at contract value with the issuer. Such events include (1) amendments to the Plan documents (including complete or partial Plan termination or merger with another plan), (2) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the Plan sponsor or other Plan sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan, or (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA. The Plan administrator believes that any events that would limit the Plan's ability to transact at contract value with participants are not probable of occurring.

The guaranteed investment contract does not permit the insurance company to terminate the agreement prior to the scheduled maturity date. This contract does have a surrender charge of 5% that may be charged based on cumulative transfer percentages and advance notice of intent to terminate if a Plan terminates its interest in the contract.

The guaranteed investment contract is a single group annuity contract with a fixed rate of interest. It is not a portfolio of contracts whose yields are based on changes in the fair value of the underlying assets as would be found in a stable value fund. As a result, the average yield earned by the Plan is the yield earned (i.e., interest credited) on the group annuity contract.

5. INFORMATION PREPARED AND CERTIFIED BY CUSTODIANS

The Plan administrator has elected the method of annual reporting compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Empower Trust Company, LLC and Empower Annuity Insurance Company of America, the Custodians, have certified that the following data included in the accompanying financial statements and supplemental schedule is complete and accurate:

- Investments, at fair value investments at contract value and notes receivable from participants, as shown in the statements of net assets available for benefits as of December 31, 2024 and 2023.
- Investment income as shown in the statement of changes in net assets available for benefits for the year ended December 31, 2024.
- Schedule H, line 4i - schedule of assets (held at end of year) as of December 31, 2024.

The Plan's independent accountants did not perform auditing procedures with respect to this information except for comparing such information to the related information included in the financial statements and supplemental schedule.

6. RELATED PARTY TRANSACTIONS AND PARTY-IN-INTEREST TRANSACTIONS

Under ERISA, a party in interest has a defined relationship with the Plan and includes fiduciaries, service providers, employers, and others that have a relationship with the Plan or the Company. ERISA prohibits certain transactions between a retirement plan and a party-in-interest that creates a potential conflict of interest. Certain Plan investments are managed by Empower or affiliates; therefore, these investments and investment transactions qualify as exempt party-in-interest transactions. Fees paid to the Custodians for asset management, recordkeeping and other processing fees totaled \$100,877 and fees paid to an unrelated party for investment advisory fees totaled \$45,777. These transactions qualify as exempt party-in-interest transactions as the services are essential to the on-going operation of the Plan.

Notes receivable from participants are also defined by ERISA as exempt party in interest transactions.

7. PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants will become fully vested in their employer contributions.

8. TAX STATUS

The Plan adopted a non-standardized pre-approved profit sharing/money purchase plan designed by Ascensus, LLC with the most recent opinion from the Internal Revenue Service dated June 30, 2020, stating that the form of the Plan is qualified under Section 401 of the Internal Revenue Code (the "Code"), and, therefore, the related trust is tax-exempt. The Plan Sponsor has determined that it is eligible to and has chosen to rely on the IRS opinion letter for the Plan. Once qualified, the Plan is required to operate in conformity with the Code to maintain its qualification. Although the Plan has been amended since receiving the opinion letter, the Plan administrator believes that the Plan is being operated in compliance with the applicable requirements of the Code and, therefore, believes that the Plan is qualified and the related trust is tax exempt.

9. RISK AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the accompanying Statements of Net Assets Available for Benefits.
