Independent Auditor's Report

To the Plan Administrator

*Scope and Nature of the ERISA Section 103(a)(3)(C) Audit*

We have performed audits of the financial statements of the Christie's Inc. Pension Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C)"). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan ("investment information") by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA ("qualified institution").

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the years then ended, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

*Opinion*

In our opinion, based on our audits and on the procedures performed as described in the *Auditor's Responsibilities for the Audit of the Financial Statements* section:

- The amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- The information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

### *Basis for Opinion*

### Notes to Financial Statements December 31, 2024 and 2023

#### Note 1 - Description of Plan

The following description of the Christie's Inc. Pension Plan (the "Plan") is provided for general information purposes only. Participants should refer to the Plan agreement for a more comprehensive description of the Plan's provisions.

##### **General**

The Plan is a defined benefit pension plan established effective January 1, 1978, and most recently amended January 1, 2024 under the restatement made effective as of January 20, 2020. Prior to the Plan freeze effective June 1, 2007, the Plan covered substantially all employees of Christie's Inc. and its U.S. affiliates (the "Plan Sponsor" or the "Company"). The Plan Sponsor is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA"). The Pension Committee is responsible for oversight of the Plan and has overall responsibility for the operation and administration of the Plan. The Pension Committee determines the appropriateness of the Plan's investment offerings and monitors investment performance.

Effective June 1, 2007, Plan management froze the Plan; therefore, no new participants are allowed to enter the Plan and effective on December 31, 2009, benefit accruals were ceased for all participants by computing their accrued benefit as of December 31, 2009, as if they had terminated from service on such date.

Effective January 1, 2024, Section 11.6 of the Plan was amended to provide benefits with a present value greater than \$1,000 will not be paid in a lump-sum before the later of age 62 or the Participant's Normal Retirement Date unless the Participant consents, and that benefits greater than \$1,000 but not more than \$7,000 will be automatically rolled over to an individual retirement plan designated by the Plan administrator if the Participant does not elect another form of payment. These provisions do not apply to distributions to beneficiaries, surviving spouses, or alternate payees under a qualified domestic relations order.

##### **Pension benefits**

Under the terms of the Plan, employees who were employed as of May 31, 2007 are eligible for normal retirement benefits at the latter of the attainment of age 65 or the fifth anniversary of Plan participation. Participants become 100% vested in Plan benefits after five years of service.

At the participant's normal retirement date, as defined, the participant shall have a 100% vested and nonforfeitable interest in the participant's accrued annual benefit. A participant's accrued annual benefit is equal to 0.95% of the participant's highest average compensation over five consecutive years during the 10 years ending on the date in which the Plan was frozen (or the participant's date of termination, if earlier ("Average Annual Earnings"), plus 1.6% of the excess of the Average Annual Earnings over covered compensation (the 35-year average compensation covered by Social Security), all multiplied by the number of years of service (not to exceed 35 years). The Plan permits early retirement after age 55 and completion of 15 years of service; however, benefit payments are reduced based on actuarially determined values. Benefits are payable monthly from the date of retirement as a single-life annuity to unmarried participants and as a reduced joint and 50% survivor annuity to married participants. Certain other optional forms of benefit payment are available.

Effective May 1, 2015, the Plan was amended to allow participants who continue employment with the Plan Sponsor or are reemployed by the Plan Sponsor after reaching the normal retirement date the option to elect to receive normal retirement benefits while employment or reemployment continues.

#### Death benefits

If an active employee dies after meeting the requirements for early retirement, the surviving spouse or domestic partner shall receive a pension for life equal to one-half of the joint and 50% survivor benefit determined under the assumption that the participant had elected early retirement commencing on the first day of the month in which death occurred. Payment of the spouse or domestic partner survivor annuity must begin within one year of the participant's date of death.

#### Lump-sum window

Effective in 2024, the Plan was amended to provide a one-time Lump-Sum Window from August 15, 2024 through October 4, 2024 (extendable to no later than October 31, 2024) during which eligible participants could elect a lump-sum payment of their vested accrued benefit. Eligible participants include those with a vested benefit who either terminated employment before July 1, 2024 and were not in pay status, or who attained age 59½ prior to November 1, 2024, with an accrued benefit exceeding \$7,000 as of that date. Payments are calculated in accordance with Code Section 417(e) interest rates and mortality tables, and once made, fully discharge the Plan's obligations with respect to the participant's accrued benefit. The total lump-sum distributions taken during the lump-sum window period were \$16,604,203.

#### Note 2 - Summary of accounting policies

##### Basis of accounting

The Plan's financial statements have been prepared on the accrual basis of accounting.

##### Use of estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities and changes therein; disclosure of contingent assets and liabilities; and the actuarial present value of accumulated plan benefits at the date of the financial statements and changes therein. Actual results could differ from those estimates.

##### Investment valuation and income recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Pension Committee determines the Plan's valuation policies utilizing information provided by its investment advisers and the trustee. See Note 4 for a discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

##### Payment of benefits

Benefit payments to participants are recorded upon distribution.

##### Actuarial present value of accumulated plan benefits

Accumulated plan benefits are those future periodic payments, including lump-sum distributions that are attributable under the Plan's provisions to the service employees have rendered to date. Accumulated plan benefits include benefits expected to be paid to (a) retired or terminated employees or their beneficiaries, (b) beneficiaries of employees who have died and (c) present employees or their beneficiaries. Benefits under the Plan, up to the date in which the Plan was frozen, were accumulated based on employees' compensation during each year of credited service.

The accumulated plan benefits for active employees are based on their Average Annual Earnings. Benefits payable under all circumstances (retirement, death, disability or termination of employment) are included, to the extent they are deemed attributable to employee service rendered to the valuation date. Benefits to be provided via allocated annuity contracts excluded from Plan assets are excluded from accumulated plan benefits.

The actuarial present value of accumulated plan benefits is determined by an independent actuary, and is that amount that results from applying actuarial assumptions to adjust the accumulated plan benefits to reflect the time value of money (through discounts for interest) and the probability of payment (by means of decrements such as for death, disability, withdrawal or retirement) between the valuation date and the expected date of payment. The significant actuarial assumptions used in the valuations as of December 31, 2024 and 2023 were (a) life expectancy of participants under the PRI-2012 Total Mortality Table with Scale MP-2021 for December 31, 2024 and 2023, (b) retirement age assumptions (the assumed average retirement age was 65 during 2024 and 2023) and (c) investment return (assumed average rate of return compounded annually at 7.00% for 2024 and 2023). The foregoing actuarial assumptions are based on the presumption that the Plan will continue. Were the Plan to terminate, different actuarial assumptions and other factors might be applicable in determining the actuarial present value of accumulated plan benefits. The computations of the actuarial present value of accumulated plan benefits were made as of January 1, 2024 (see Note 8). Had the valuations been performed as of December 31, there would be no material differences.

#### **Administrative expenses**

The Plan is responsible for payment of the trustee expenses and fees including actuarial services, Pension Benefit Guaranty Corporation ("PBGC") premiums and recordkeeping services; however, the Company may pay the Plan expenses directly. Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Certain expenses incurred in connection with the general administration of the Plan that are paid by the Plan are recorded as deductions in the accompanying statements of changes in net assets available for benefits. In addition, certain investment related expenses from mutual funds are included in net appreciation in fair value of investments presented in the accompanying statements of changes in net assets available for benefits. Investment related expenses are deducted from investment income in the accompanying statements of changes in net assets available for benefits.

#### **Subsequent events**

Subsequent events were evaluated through October 10, 2025, which is the date the financial statements were available to be issued.

#### **Note 3 - Certified investments**

The Plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Investments held at December 31, 2024 and 2023, and investment income for the years then ended, that are disclosed in the accompanying financial statements and supplemental schedules, were obtained or derived from information supplied to the Plan administrator and certified as complete and accurate by Fidelity Management Trust Company, the trustee of the Plan.

#### Note 4 - Fair value measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities ("Level 1") and the lowest priority to unobservable inputs ("Level 3"). The three levels of the fair value hierarchy under Financial Accounting Standards Board ("FASB") issued Accounting Standards Codification ("ASC") 820 are described as follows:

- Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.
- Level 2: Inputs to the valuation methodology include:
  - Quoted prices for similar assets or liabilities in active markets;
  - Quoted prices for identical or similar assets or liabilities in inactive markets;
  - Inputs other than quoted prices that are observable for the asset or liability; and
  - Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

- Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023:

*Mutual funds:* Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value ("NAV") and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

*Money market fund:* Valued at the daily closing price as reported by the fund. The money market fund is an open-end mutual fund that is registered with the Securities and Exchange Commission. This fund is required to publish its daily NAV and to transact at that price. The money market fund is deemed to be actively traded.

*Collective trust funds:* Valued at the last reported NAV of shares held by the Plan at year end. The NAV, as provided by the trustee, is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund less its liabilities. The practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV. Participant transactions (purchases and sales) may occur daily. Were the Plan to initiate a full redemption of the collective trust, the investment advisor reserves the right to temporarily delay withdrawal from the trust in order to ensure that securities liquidations will be carried out in an orderly business manner.

#### Note 5 - Related party and party-in-interest transactions

Plan assets include investments in funds managed by Fidelity Management Trust Company. Fidelity Management Trust Company is the Plan's trustee and actuary and, as such, transactions with the trustee and actuary qualify as party-in-interest transactions. Fees incurred by the Plan for the investment related expenses are included in net appreciation in fair value of the investment, as they are paid through revenue sharing, rather than a direct payment. As described in Note 2, the Plan paid certain expenses related to investment activity to the trustee. Personnel and facilities of the Company have been used to perform administrative functions for the Plan at no charge to the Plan.

#### Note 6 - Funding policy

The Company has voluntarily agreed to make contributions to the Plan in amounts not less than the minimum funding requirement of ERISA and not more than that permitted by the Internal Revenue Code ("IRC"). During 2024, the minimum required contribution was \$1,460,771. To satisfy the minimum contribution, the Company made contributions of \$1,508,709. During 2023, the minimum required contribution was \$1,466,465. To satisfy the minimum contribution, the Company made a cash contribution of \$435,000 in September 2024, which was discounted to \$397,785 as of the valuation date of January 1, 2023. The Company elected to apply prefunding balance of \$1,068,680 to satisfy the remaining obligation.

#### Note 7 - Plan termination

As discussed in Note 1, the Plan was frozen for new participants effective June 1, 2007, and subsequently, effective December 31, 2009, the Plan ceased all benefit accruals for participants. The Company has not expressed any intent to discontinue the Plan, at this time. However, in the event the Plan terminates, the net assets of the Plan will be allocated, as prescribed by ERISA and its related regulations, generally to provide the following benefits in the order indicated:

- a. Annuity benefits that former employees or their beneficiaries have been receiving for at least three years, or that employees eligible to retire for that three-year period would have been receiving if they had retired with benefits in the normal form of annuity under the Plan. The priority amount is limited to the lowest benefit that was payable (or would have been payable) during those three years. The amount is further limited to the lowest benefit that would be payable under Plan provisions in effect at any time during the five years preceding Plan termination.
- b. Other vested benefits insured by the PBGC up to the applicable limitations (discussed subsequently).
- c. All other vested benefits (that is, vested benefits not insured by the PBGC).
- d. All nonvested benefits.

Benefits to be provided via contracts under which the trustee is obligated to pay the benefits would be excluded for allocation purposes.

Certain benefits under the Plan are insured by the PBGC if the Plan terminates. Generally, the PBGC guarantees most vested normal age retirement benefits, early retirement benefits, and certain disability and survivor's pensions. However, the PBGC does not guarantee all types of benefits under the Plan, and the amount of benefit protection is subject to certain limitations. Vested benefits under the Plan are guaranteed at the level in effect on the date of the Plan's termination.

Whether all participants receive their benefits should the Plan terminate at some future time will depend on the sufficiency, at that time, of the Plan's net assets to provide for accumulated benefit obligations and may also depend on the financial condition of the Plan Sponsor and the level of benefits guaranteed by the PBGC.

#### Note 9 - Tax status

The Internal Revenue Service ("IRS") has determined and informed the Company by a letter dated April 28, 2004, that the Plan and related trust are designed in accordance with applicable sections of the IRC. The Plan has been amended since receiving the determination letter. However, the Plan administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC and, therefore, believes that the Plan is qualified and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

#### **Note 10 - Risks and uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near-term and that such changes could materially affect the amounts reported in the statements of net assets available for benefits.

Plan contributions are made, and the actuarial present value of accumulated plan benefits are reported based on certain assumptions pertaining to interest rates, inflation rates and employee demographics, all of which are subject to change. Due to uncertainties inherent in the estimations and assumptions process, it is at least reasonably possible that changes in these estimates and assumptions in the near-term would be material to the financial statements.

- a) the market value of assets, including discounted receivables, on the valuation date, less
- b) the following percentages of prior years' investment gains (losses):
  - i) 67% of the prior year, and
  - ii) 33% of the second prior year,

Investment gains and losses are defined as the excess or deficiency of the expected return on the market value (at an assumed rate of 7.00%, not to exceed the third segment rate for that year) over the actual return on the market value of assets, including discounted receivables, for any given year.

- c) The actuarial value of assets can be neither less than 90% nor greater than 110% of the market value of assets, including discounted receivables.

**Shortfall Amortization Charge for ERISA Funding Purposes:** Per IRC Section 430(c), the shortfall amortization charge for any plan year is the aggregate total (not less than zero) of the shortfall amortization installments for such plan year with respect to any shortfall amortization base which has not been fully amortized. The shortfall amortization installments are the amounts necessary to amortize the shortfall amortization base of the plan for any plan year in level annual installments over the 15-year period beginning with such plan year.

**Actuarial Cost Method:** The unit credit cost method is used for ERISA funding target (FT). Under this method, accrued pension benefits are determined for all eligible active participants. These benefits reflect service, salary and negotiated benefit increases to date. The liability is then equal to the present value of all benefits (PVAB) for inactive participants plus the PVAB for active participants.

The normal cost is determined on an individual basis for all active participants who have not attained the assumed retirement age and is equal to the present value of the difference between the current accrued benefit and the anticipated accrued benefit one year later, with the accrued benefit based upon earnings, or negotiated benefit increases, to date in both cases. The total normal cost is based upon the sum of the individual normal costs. The target normal cost for funding is equal to the total normal cost plus assumed administrative expenses expected to be paid from the trust.

### **Definitions:**

*Vesting service:* Participant accrues a year of service for each plan year in which he is credited with at least 1,000 hours of service.

*Credited Service (Benefit Service):* Participant accrues a year of service for each plan year in which he is credited with at least 1,000 hours of service. No further Credited Service is credited under the Plan after December 31, 2009.

*Normal retirement date (NRD):* The first day of the month coincident with or immediately following the Participant's 65<sup>th</sup> birthday or, if later, the fifth anniversary of the date the Participant commenced participation in the Plan.

*Average Annual Earnings:* Participant's highest average annual Earnings received for any 5 consecutive calendar years during the last 10 consecutive calendar years of the Participant's employment. If, however, the participant does not have earnings in the participating companies for at least 60 months, the average will be taken over the number of months the participant has been employed with the participating companies. No earnings after December 31, 2009 will be considered.

*Covered Compensation:* Average of the taxable wage bases in effect for each calendar year during a 35-year period that ends with the year of Social Security normal retirement age.

**Plan Provisions** (continued)

*Monthly Pension Benefit:* The monthly accrued benefit is equal to 1/12th of the sum of the following (all benefit accruals were frozen effective December 31, 2009):

- 0.95% of the Participant's Average Annual Earnings not exceeding Covered Compensation multiplied by number of years of Credited Service
- 1.6 percent of the Participant's Average Annual Earnings in excess of Covered Compensation multiplied by number of years of Credited Service

No more than 35 years of Credited Service shall be taken into account for purposes of determining this benefit.

**Eligibility for Benefits:**

*Normal Retirement:* Retirement on NRD.

*Early retirement:* Optional retirement starting at attainment of age 55 with at least 15 years of Vesting Service.

*Postponed retirement:* Retirement after NRD.

*Deferred vested:* All participants are 100% vested if employed at NRD.

*Monthly Pre-retirement spouse death benefit:* Death while eligible for Normal, Early, Postponed, or Deferred Vested Retirement benefits, with a surviving spouse or Domestic Partner (married for at least 1 year prior to death). The benefit is equal to the Survivor portion of a 50% joint & survivor annuity, calculated as if the Participant had separated from service on the earlier of his actual separation from service or his date of death and assuming he survived until his earliest commencement date and elected a 50% joint & survivor annuity.

**Plan Provisions** (continued)

*Disability:* Not applicable.

**Monthly Benefits Paid Upon the Following Events:**

*Normal retirement:* Frozen monthly pension benefit at NRD.

*Early retirement:* The Monthly Pension Benefit payable at age 65, reduced by 5/9 of 1% for each of the first 60 full months and 5/18 of 1% for each additional full calendar month by which commencement precedes the Participant's NRD.

*Postponed retirement:* The greater of the Participant's accrued benefit at actual retirement date and the actuarially equivalent value of the adjusted normal retirement benefit determined as of that date, taking into account the months of deferred retirement from the later of the participant's NRD and 5/1/2015.

*Deferred vested:* The Monthly Pension Benefit payable at age 65, reduced by 5/9 of 1% for each of the first 60 full months and 5/18 of 1% for each additional full calendar month by which commencement precedes the Participant's NRD.

*Death with pre-retirement spouse benefit:* Monthly pre-retirement spouse benefit is payable in the form of a single life annuity, as described above in the monthly pre-retirement spouse death benefit section. The benefit commences on the later of the participant's date of death and the date the participant would have been eligible for early retirement; however the surviving spouse may elect to defer commencement until as late as the participant's NRD.

*Disability:* Not applicable.

**Forms of Payment:**

*Normal form (single participants):* Single life annuity

*Normal form (married participants):* 50% joint and survivor annuity.

*Optional forms:* Participants may elect a five-year certain and life annuity, ten-year certain and life annuity, 50%, 75% or 100% joint and survivor annuity, or, if the present value of their benefit is \$10,000 or less, a lump sum distribution.

*Description of optional form conversion factors:* Benefit of equivalent value computed on the basis of 7.00% per year, compounded annually, and the UP-1984 mortality table, set back 1 year.
