## Note 1 - Plan Description

The following description of Wiland, Inc. 401(k) Plan (the "Plan") provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan's provisions.

### **General**

The Plan is a defined contribution plan established on January 31, 2005 and subsequently amended and restated on March 24, 2022, covering all employees of Wiland, Inc. (the "Company") who are age 21 or older. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

### **Administration**

The Company is the sponsor of the Plan. The administrative committee, as provided in the plan agreement, is the plan administrator and has responsibility for the administration of the Plan. Fidelity Management Trust Company (Fidelity) functions as trustee and investment manager. Investment management fees and trustee fees are paid by the Plan in accordance with the plan agreement.

### **Contributions**

The Plan provides for employee salary deferral contributions up to a maximum of 60 percent of annual compensation subject to maximum tax-deferred limitations established by the Internal Revenue Code. This maximum percentage may be reduced by the plan administrator in certain circumstances. The Plan allows participants to contribute up to 60 percent of their compensation on an after-tax basis. Eligible employees who have reached age 50 during the plan year may elect to make catch-up contributions, as limited by the Internal Revenue Service (IRS). Participants may also make contributions to the Plan in the form of a rollover of funds from another qualified plan. Employees are automatically enrolled in the Plan upon meeting eligibility requirements at a deferral rate of 6 percent of eligible compensation unless the employee opts out of participation or elects a different deferral percentage.

The Company may make matching contributions of 50 percent of elective deferrals up to 8 percent of eligible compensation. The employer match is trued up annually. The Company has the right to designate all or a portion of the matching contributions as qualified. To the extent matching contributions are so designated, they are nonforfeitable and may not be withdrawn from the Plan prior to separation from service or attainment of age 65.

### **Forfeitures**

If a participant is not fully vested on his or her termination date, the non-vested amount of the account is forfeited. Forfeitures are used to reduce future company contributions or to pay administrative expenses of the Plan. At December 31, 2024 and 2023, forfeited account balances totaled \$36,796 and \$28,410, respectively.

The Plan used approximately \$57,407 of the forfeited balance for the year ended December 31, 2024 to reduce employer contributions.

### **Vesting**

Participants are immediately 100 percent vested in employee salary and rollover contributions and any income or loss thereon.

A participant's account balance becomes 100 percent vested upon death, attaining normal retirement age (the age of 65) while an employee, retirement due to disability, or termination of the Plan.

**Participant Accounts**

Each participant's account is credited with the participant's contributions and allocations of the Company's contributions and plan earnings and charged with an allocation of administrative expenses. Allocations are based on participants' compensation or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. Participants may direct the investments of their account balances into various investment options offered by the Plan.

**Participant Notes Receivable**

Participants may borrow from their accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50 percent of their account balances. The notes receivable is secured by the balance in the participant's account and bear interest at rates that range from 5.25 percent to 10.5 percent, which are commensurate with local prevailing rates determined periodically by the plan administrator and mature at various dates through December 2029. Principal and interest are paid ratably through monthly payroll deductions. During 2024, there was approximately \$35,702 in loans considered a distribution.

**Benefit Payments**

Distributions are payable upon retirement, death, disability, termination of employment, or attainment of 59½ years of age in the form of a lump-sum amount equal to the vested balance of a participant's account. Participants may also elect distribution under an installment plan. If a participant's vested account balance is equal to or less than \$1,000, the total vested account balance will be distributed in a lump sum within an administratively reasonable period of time after termination of employment if the participant does not elect a distribution or a rollover. The Plan also allows for terminated participant balances of \$1,000 to \$5,000 to be automatically rolled out of the Plan into an individual retirement account.

Participants may request that all or a portion of their accounts, but not the earnings thereon, be distributed in the case of financial hardship, as defined in the plan document. The plan administrator must approve any such hardship withdrawals.

**Party-in-interest Transactions**

Certain plan assets are in investment funds managed by Fidelity or its affiliates. Fidelity is the trustee of the Plan; therefore, these transactions qualify as party-in-interest transactions, as defined under ERISA guidelines. In addition, the Plan provides for loans to participants, which are also party-in-interest transactions that are exempt from the prohibited transaction rules.

**Termination**

While it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions set forth in the plan agreement and ERISA.

### ***Investment Valuation***

The Plan's investments are stated at fair value.

The common collective trust fund is valued at net asset value per share (NAV) (or its equivalent) of the fund, which is based on the fair value of the fund's underlying assets. All other investments are valued based on quoted market prices reported in active markets. See Note 4 for additional information.

### ***Participant Notes Receivable***

Participant notes receivable are recorded at their unpaid principal balances plus any accrued interest. Participant notes receivable are written off when deemed uncollectible.

### ***Benefit Payments***

Benefits are recorded when paid.

### ***Administrative Expenses***

Various administrative costs are paid by the Company.

### ***Use of Estimates***

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect certain amounts and disclosures at the date of the financial statements and during the reporting period. Accordingly, actual results may differ from those estimates.

### ***Risks and Uncertainties***

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the financial statements.

### ***Subsequent Events***

The financial statements and related disclosures include evaluation of events up through and including September 26, 2025, which is the date the financial statements were available to be issued.

## Note 2 – Certified Information

Fidelity holds the Plan's investments and participant notes receivable and executes all related transactions. The investment and participant note receivable balances and related income and losses included in the accompanying financial statements and supplemental schedule of assets held at end of year are based solely on information certified by Fidelity.

### Note 3 - Fair Value Measurements

Accounting standards require certain assets and liabilities be reported at fair value in the financial statements and provide a framework for establishing that fair value. The framework for determining fair value is based on a hierarchy that prioritizes the valuation techniques and inputs used to measure fair value.

#### **Level 1**

Fair values determined by Level 1 inputs use quoted prices in active markets for identical assets that the Plan has the ability to access.

#### **Level 2**

## Note 1 - Plan Description

The following description of Wiland, Inc. 401(k) Plan (the "Plan") provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan's provisions.

### **General**

The Plan is a defined contribution plan established on January 31, 2005 and subsequently amended and restated on March 24, 2022, covering all employees of Wiland, Inc. (the "Company") who are age 21 or older. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

### **Administration**

The Company is the sponsor of the Plan. The administrative committee, as provided in the plan agreement, is the plan administrator and has responsibility for the administration of the Plan. Fidelity Management Trust Company (Fidelity) functions as trustee and investment manager. Investment management fees and trustee fees are paid by the Plan in accordance with the plan agreement.

### **Contributions**

The Plan provides for employee salary deferral contributions up to a maximum of 60 percent of annual compensation subject to maximum tax-deferred limitations established by the Internal Revenue Code. This maximum percentage may be reduced by the plan administrator in certain circumstances. The Plan allows participants to contribute up to 60 percent of their compensation on an after-tax basis. Eligible employees who have reached age 50 during the plan year may elect to make catch-up contributions, as limited by the Internal Revenue Service (IRS). Participants may also make contributions to the Plan in the form of a rollover of funds from another qualified plan. Employees are automatically enrolled in the Plan upon meeting eligibility requirements at a deferral rate of 6 percent of eligible compensation unless the employee opts out of participation or elects a different deferral percentage.

The Company may make matching contributions of 50 percent of elective deferrals up to 8 percent of eligible compensation. The employer match is trued up annually. The Company has the right to designate all or a portion of the matching contributions as qualified. To the extent matching contributions are so designated, they are nonforfeitable and may not be withdrawn from the Plan prior to separation from service or attainment of age 65.

### **Forfeitures**

If a participant is not fully vested on his or her termination date, the non-vested amount of the account is forfeited. Forfeitures are used to reduce future company contributions or to pay administrative expenses of the Plan. At December 31, 2024 and 2023, forfeited account balances totaled \$36,796 and \$28,410, respectively.

The Plan used approximately \$57,407 of the forfeited balance for the year ended December 31, 2024 to reduce employer contributions.

### **Vesting**

Participants are immediately 100 percent vested in employee salary and rollover contributions and any income or loss thereon.

A participant's account balance becomes 100 percent vested upon death, attaining normal retirement age (the age of 65) while an employee, retirement due to disability, or termination of the Plan.

**Participant Accounts**

Each participant's account is credited with the participant's contributions and allocations of the Company's contributions and plan earnings and charged with an allocation of administrative expenses. Allocations are based on participants' compensation or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. Participants may direct the investments of their account balances into various investment options offered by the Plan.

**Participant Notes Receivable**

Participants may borrow from their accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50 percent of their account balances. The notes receivable is secured by the balance in the participant's account and bear interest at rates that range from 5.25 percent to 10.5 percent, which are commensurate with local prevailing rates determined periodically by the plan administrator and mature at various dates through December 2029. Principal and interest are paid ratably through monthly payroll deductions. During 2024, there was approximately \$35,702 in loans considered a distribution.

**Benefit Payments**

Distributions are payable upon retirement, death, disability, termination of employment, or attainment of 59½ years of age in the form of a lump-sum amount equal to the vested balance of a participant's account. Participants may also elect distribution under an installment plan. If a participant's vested account balance is equal to or less than \$1,000, the total vested account balance will be distributed in a lump sum within an administratively reasonable period of time after termination of employment if the participant does not elect a distribution or a rollover. The Plan also allows for terminated participant balances of \$1,000 to \$5,000 to be automatically rolled out of the Plan into an individual retirement account.

Participants may request that all or a portion of their accounts, but not the earnings thereon, be distributed in the case of financial hardship, as defined in the plan document. The plan administrator must approve any such hardship withdrawals.

**Party-in-interest Transactions**

Certain plan assets are in investment funds managed by Fidelity or its affiliates. Fidelity is the trustee of the Plan; therefore, these transactions qualify as party-in-interest transactions, as defined under ERISA guidelines. In addition, the Plan provides for loans to participants, which are also party-in-interest transactions that are exempt from the prohibited transaction rules.

**Termination**

While it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions set forth in the plan agreement and ERISA.

### ***Investment Valuation***

The Plan's investments are stated at fair value.

The common collective trust fund is valued at net asset value per share (NAV) (or its equivalent) of the fund, which is based on the fair value of the fund's underlying assets. All other investments are valued based on quoted market prices reported in active markets. See Note 4 for additional information.

### ***Participant Notes Receivable***

Participant notes receivable are recorded at their unpaid principal balances plus any accrued interest. Participant notes receivable are written off when deemed uncollectible.

### ***Benefit Payments***

Benefits are recorded when paid.

### ***Administrative Expenses***

Various administrative costs are paid by the Company.

### ***Use of Estimates***

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect certain amounts and disclosures at the date of the financial statements and during the reporting period. Accordingly, actual results may differ from those estimates.

### ***Risks and Uncertainties***

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the financial statements.

### ***Subsequent Events***

The financial statements and related disclosures include evaluation of events up through and including September 26, 2025, which is the date the financial statements were available to be issued.

## Note 2 – Certified Information

Fidelity holds the Plan's investments and participant notes receivable and executes all related transactions. The investment and participant note receivable balances and related income and losses included in the accompanying financial statements and supplemental schedule of assets held at end of year are based solely on information certified by Fidelity.

Under the terms of the Declaration of Separate Fund, retirement plans invested in the trust are required to provide 12 months' advance written notice to the trustee prior to redemption of trust units for any plan sponsor or plan fiduciary withdrawal. There were no unfunded commitments as of December 31, 2024 and 2023.

**Note 4 - Tax Status**

The Plan adopted is a preapproved plan. The preapproved plan has received a favorable opinion letter from the Internal Revenue Service indicating that the Plan, as designed, is qualified for federal income tax-exempt status. The Plan has not individually sought its own determination letter.
