Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of Ave Maria 403(b) Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the years then ended and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the years then ended stating that the certified investment information, as described in Note 5 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section:

- the amounts and disclosures in the financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- the information in the financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America. Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan's Employee Benefit Plan and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for one year after the date the financial statements are available to be issued.

For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, other than the information agreed to or derived from the certified investment information, including its form and content, is presented in conformity with the DOL's Rules and Regulations for Reporting and Disclosure under ERISA.

1. DESCRIPTION OF PLAN

The following is a description of Ave Maria 403(b) Retirement Plan (the 'Plan') which provides only general information. Participants should refer to the Summary Plan Description for a more complete description of the Plan's provisions.

GENERAL

The Plan is a defined contribution plan covering employees of Ave Maria University, Inc. Any employee who has attained age twenty-one or older and have completed one hour of service shall be eligible to participate in the Plan. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA) and qualifies under Internal Revenue Code Section 403(b). The Plan is sponsored by the Ave Maria University, Inc. The following is a description of terms used throughout the report.

Company: Ave Maria University, Inc.

Employer: Ave Maria University, Inc.

Custodians: Nationwide Financial Services, Inc. and TIAA

CONTRIBUTIONS

Contributions to the Plan were invested as directed by the participants in one or more investment alternatives held through Nationwide Financial Services, Inc. or TIAA. Effective January 1, 2023, the Plan was amended to freeze all new participation and contributions. As a result, no contributions were made to the Plan for the years ended December 31, 2024 and 2023. The Plan previously permitted participants to contribute from one-half percent to 100 percent of their gross compensation pursuant to Internal Revenue Code Section 403(b).

Prior to the freeze, the Plan sponsor was required to provide a matching contribution in an amount equal to 100 percent of participants' contributions, not to exceed 5 percent of the participants' gross compensation for the payroll period. Employer matching contributions were suspended effective July 1, 2020, and remained suspended until February 2022, when they were reinstated. However, due to the freeze on contributions as of January 1, 2023, the Plan sponsor made no matching contributions in 2023 and 2024.

NOTES TO FINANCIAL STATEMENTS

1. DESCRIPTION OF PLAN (CONTINUED)

VESTING

Participants are immediately vested in their elective contributions, as well as in the Company's matching and discretionary contributions, and any actual earnings thereon. However, effective January 1, 2023, all new contributions to the Plan were frozen. Therefore, while participants retain their vested interests in existing contributions, no new matching or discretionary contributions will be made following the freeze.

PARTICIPANT ACCOUNT

Each participant's account is credited with the participant's elective contributions, the participant's share of the Company's matching and discretionary contributions, and an allocation of the Plan's earnings (losses). Allocations are based on the participant's proportionate share of funds in each of their investment accounts. The participant is entitled to the benefit that can be provided from the participant's vested account.

PAYMENT OF BENEFITS

On termination of service due to death, disability, or retirement, a participant may elect to either receive a lump-sum amount equal to the value of the participant's vested interest in his or her account, or have it rolled over into an individual retirement account or another qualified retirement plan.

NOTES RECEIVABLE FROM PARTICIPANTS

The Plan allows participants to borrow money from the Plan up to the lesser of \$50,000 (reduced by the amount of the highest outstanding balance of loans during the one-year period ending on the day before the loan is made, over the outstanding balance of loans from the Plan on the date the loan is made), or one-half of the participant's account balance. Loans must be at least \$1,000 and have a term of no longer than five years, unless the loan is for the purchase of a primary residence. Loans must bear a reasonable interest rate. The loan is secured up to 50% of the participants interest in the Plan and such other collateral that is deemed necessary.

PLAN TERMINATION

The Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, the net assets would be distributed to the participants according to participant account balances.

1. DESCRIPTION OF PLAN (CONTINUED)

FORFEITURES

Forfeitures refer to the non-vested portion of a former employee's account balance in the plan. There were no forfeitures in 2024 and 2023.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

BASIS OF ACCOUNTING

The financial statements of the Plan are prepared on the accrual basis of accounting in accordance with U.S. Generally Accepted Accounting Principles.

ADMINISTRATIVE EXPENSES

Most administrative expenses incurred to maintain the Plan are paid by the employer and therefore excluded from these financial statements. Investment-related expenses are included in net appreciation or depreciation in fair value of investments. Fees for the participant loans are included and are charged directly to the participant.

USE OF ESTIMATES

The preparation of financial statements in accordance with accounting principles generally accepted in United States of America requires the plan administrator to make estimates and assumptions that affect certain reported amounts of assets and liabilities and charges there in, and disclosures of contingent assets and liabilities. Accordingly actual results may differ from those estimates.

INVESTMENT VALUATIONS

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Purchases and sales of securities are recorded on a trade-date basis. Interest income is reported on an accrual basis. Dividends are recorded on ex-dividend date. The participant loans are valued at their outstanding balances, which approximate fair value. The net appreciation includes gains and losses on investments bought and sold, as well as held during the year. See Note 6 for discussion of fair value measurements.

DATE OF MANagements REVIEW

Subsequent events were evaluated through October 8, 2025, which is the date the financial statements were available to be issued.

3. INCOME TAX STATUS

The Internal Revenue Service (IRS) has determined the Company by a letter dated July 13, 2009, that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code (IRC). Although the plan has been amended since receiving the determination letter, the Plan administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC and therefore believes that the Plan is qualified and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require plan administrator to evaluate tax positions taken by the Plan and recognize a tax liability for any uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by tax authorities; however, there are currently no audits for any tax periods in progress.

4. RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the value of investment securities will occur in the near term and that such changes materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

5. INFORMATION PREPARED AND CERTIFIED BY CUSTODIANS (UNAUDITED)

At December 31, 2024 and 2023, the plan's investments were held by the Custodians. The following is a summary of the Plan's financial information that is included in the financial statements based on information that is certified by the Custodians as complete and accurate in accordance with section 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under the Employment Retirement Income Security Act of 1974.

6. FAIR VALUE MEASUREMENTS

The fair value measurement accounting literature establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority. Level 2 inputs consist of observable inputs other than quoted prices for identical assets. Level 3 inputs are unobservable and have the lowest priority. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value. There are no Plan assets requiring the use of Level 2 inputs for the periods presented.

Level 1 Fair Value Measurements

The fair value of money market accounts are valued at the account balance. The fair value of mutual funds is based on quoted net assets values of the shares as reported by the fund. The mutual funds held by the Plan are considered to be actively traded.

Level 2 Fair Value Measurements

Fair values determined by Level 2 inputs use other inputs that are observable, either directly or indirectly. These Level 2 inputs include quoted prices for similar assets in active markets, quoted prices of identical or similar assets in markets that are not active, and inputs other than quoted prices that are observable for the asset. As of the current year, the Plan did not hold Level 2 assets.

Level 3 Fair Value Measurements

The fair value of real estate is determined using external appraisals, which are estimates of property values based on a professional's opinion. The fair value of annuity contracts are valued using the accumulated cash contributions, interest, credited to the Plan's contract, and transfers, if any, less any withdrawals, if any.
