**NOTE 1 – DESCRIPTION OF PLAN**

The following brief description of the Bank Independent (Employer, Company) Pension Plan (Plan) is provided for general information purposes only. Participants should refer to the Plan agreement for more complete information.

General: The Plan is a defined benefit pension plan covering employees of the Company who have completed one year of service, attained 21 years of age, and completed 1,000 service hours. It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

Pension Benefits: Employees with 5 or more years of service are entitled to monthly pension benefits beginning at normal retirement age (65) equal to 0.65% of their final average monthly compensation times credited service up to 35 years plus 0.65% of final monthly average compensation in excess of covered compensation times credited service, up to 35 years. The Plan permits early retirement after completing 5 years of service and attainment of age 55. Employees may elect to receive their pension benefits in the form of a joint and survivor annuity. If employees terminate before rendering 5 years of service, they forfeit the right to receive a portion of their accumulated plan benefits attributable to the Company's contributions. Employees may elect to receive the value of their accumulated plan benefits as a lump-sum distribution upon retirement or termination, or they may elect to receive their benefits as a life annuity payable monthly from retirement. For each employee electing a life annuity, payments will not be less than the greater of (a) the accumulated contributions plus interest or (b) an annuity for five years.

Death and Disability Benefits: If an active employee dies at age 55 or older, a death benefit equal to the value of the employee's accumulated pension benefits is paid to the employee's beneficiary. Active employees who become totally disabled receive annual disability benefits that are equal to the normal retirement benefits they have accumulated as of the time they become disabled. Disability benefits are paid until normal retirement age at which time disabled participants begin receiving normal retirement benefits computed as though they had been employed to normal retirement age with their annual compensation remaining the same as at the time they became disabled.

Administrative Expenses: Certain costs incurred in the administration of the Plan have been paid by the Company.

**NOTE 2 – SUMMARY OF ACCOUNTING POLICIES**

The following are the significant accounting policies followed by the Plan:

Basis of Accounting: The accompanying financial statements are prepared on the accrual basis of accounting.

Estimates: The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures, and actual results may differ from those estimates. It is reasonably possible that a significant change may occur in the near term for the estimates of actuarial present value of accumulated plan benefits.

Investment Valuation and Income Recognition: The Plan's investments are reported at fair value. Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis.

Risks and Uncertainties: Investments are exposed to various risks such as interest rate, market, liquidity and credit risks. Due to the level of risk associated with certain investments, it is at least reasonably possible that changes in the values of investments will occur in the near term and that such change could materially affect the amounts reported in the statement of net assets available for benefits.

Plan contributions are made and the actuarial present value of accumulated plan benefits are reported based on certain assumptions pertaining to interest rates, inflation rates and employee demographics, all of which are subject to change. Due to uncertainties inherent in the estimations and assumptions process, it is at least reasonably possible that changes in these estimates and assumptions in the near term would be material to the financial statements.

Benefit Payments: Benefits are recorded when paid.

Concentration of Credit Risk: All of the Plan's investments are in interest bearing deposit accounts by the Company. Therefore, the Plan's exposure to credit risk is significantly affected by the financial condition of the Company.

**NOTE 3 – FUNDING POLICY**

The Company's funding policy is to make annual contributions to the Plan in amounts that are estimated to provide sufficient Plan assets to pay pension benefits to participants by the time they retire. There was no Company contribution for 2024. Participant contributions are not permitted under the Plan.

**NOTE 4 – PLAN TERMINATION**

Although it has not expressed any intention to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA and its related regulations. In the event the Plan terminates, the net assets of the Plan will be allocated among the participants and beneficiaries of the Plan in the order provided by ERISA.

Certain benefits under the Plan are insured by the Pension Benefit Guaranty Corporation (PBGC) if the Plan terminates. Generally, the PBGC guarantees most vested normal age retirement benefits, early retirement benefits, and certain disability and survivor's pensions. However, the PBGC does not guarantee all types of benefits under the Plan, and the amount of benefit protection is subject to certain limitations.

Whether all participants receive their benefits should the Plan terminate at some future time will depend on the sufficiency, at that time, of the Plan's net assets to provide for accumulated benefit obligations and may also depend on the level of benefits guaranteed by the PBGC.

**NOTE 5 – FAIR VALUE MEASUREMENTS**

Fair value is the price that would be received by the Plan for an asset or paid by the Plan to transfer a liability (an exit price) in an orderly transaction between market participants on the measurement date in the Plan's principal or most advantageous market for the asset or liability. Fair value measurements are determined by maximizing the use of observable inputs and minimizing the use of unobservable inputs when measuring fair value. The hierarchy places the highest priority on unadjusted quoted market prices in active markets for identical assets or liabilities (level 1 measurements) and gives the lowest priority to unobservable inputs (level 3 measurements). The three levels of inputs within the fair value hierarchy are defined as follows:

Level 1: Quoted prices (unadjusted) for identical assets or liabilities in active markets that the Plan has the ability to access as of the measurement date.

Level 2: Significant other observable inputs other than level 1 prices such as quoted prices for similar assets or liabilities; quoted prices in markets that are not active; or other inputs that are observable or can be corroborated by observable market data.

Level 3: Significant unobservable inputs that reflect the Plan's own assumptions about the assumptions that market participants would use in pricing an asset or liability.

In some cases, a valuation technique used to measure fair value includes inputs from multiple levels of the fair value hierarchy. The lowest level of significant input determines the placement of the entire fair value measurement in the hierarchy.

The following descriptions of the valuation methods and assumptions used by the Plan to estimate the fair values of investments apply to investments held directly by the Plan.

*Interest-bearing deposit accounts:* Fair values of interest-bearing deposit accounts have been determined to approximate their deposit account balances (level 2 inputs), with no discounts for credit quality or liquidity restrictions. The Plan's investments in money market deposit accounts exceed federally insured balances.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

**NOTE 6 – ACTUARIAL PRESENT VALUE OF ACCUMULATED PLAN BENEFITS**

Actuarial Present Value of Accumulated Plan Benefits: Accumulated plan benefits are those future periodic payments, including lump-sum distributions that are attributable under the Plan's provisions to the service employees have rendered. Accumulated plan benefits include benefits expected to be paid to (a) retired or terminated employees or their beneficiaries, (b) beneficiaries of employees who have died, and (c) present employees or their beneficiaries. Benefits under the Plan are based on employees' compensation during their last five years of credited service. The accumulated plan benefits for active employees are based on their years of service ending on the date as of which the benefit information is presented (valuation date). Benefits payable under all circumstances – retirement, death, disability, and termination of employment – are included, to the extent they are deemed attributable to employee service rendered to the valuation date.

The actuarial present value of accumulated plan benefits is determined by an actuary, and is that amount that results from applying actuarial assumptions to adjust the accumulated plan benefits to reflect the time value of money (through discounts for interest) and the probability of payment (by means of decrements such as for death, disability withdrawal, or retirement) between the valuation date and the expected date of payment. The significant actuarial assumptions used in the valuations as of December 31, 2024 and 2023 were, respectively, as follows:

Mortality: 2024 - PRI-2012 mortality tables projected with scale MP-2021; 2023 - PRI-2012 mortality tables projected with scale MP-2021

Retirement age assumption: Graded from age 55 to 75

Investment return: The 2024 and 2023 valuations included assumed average rates of return of 3% and 3%, respectively.

The foregoing actuarial assumptions are based on the presumption that the Plan will continue. Were the Plan to terminate, different actuarial assumptions and other factors might be applicable in determining the actuarial present value of accumulated plan benefits.

**NOTE 7 - PARTY-IN-INTEREST TRANSACTIONS**

Parties-in-interest are defined under Department of Labor (DOL) regulations as any fiduciary of the Plan, any party rendering service to the Plan, the employer, and certain others. Certain professional fees for the administration and audit of the Plan were paid by the Company. Certain administrative functions are performed by officers or employees of the Company. No such officer or employee receives compensation from the Plan. Administrative expenses are paid by the Company.

**NOTE 8 – TAX STATUS**

The Internal Revenue Service has determined and informed the Company by a letter dated November 30, 2017, that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the determination letter, Plan management believes that the Plan is designed and being operated in compliance with the applicable requirements of the IRC.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan. The plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The plan administrator believes it is no longer subject to income tax examinations for years prior to 2021.

**NOTE 9 – SUBSEQUENT EVENTS**

Plan management has evaluated subsequent events for recognition and disclosure through October 14, 2025, the date the financial statements were available to be issued. No subsequent events requiring adjustment or disclosure were identified.

### Plan Effective Date

The plan was originally effective July 1, 1989. Amended and restated effective January 1, 2008. The plan year is the twelve month period ending December 31.

### Eligibility

All employees are eligible to participate under the plan on the first day of the month coincident with or next following the later of attaining age 21 and first anniversary of hire. "Employee" means any person on the payroll whose wages are subject to withholding for the purpose of federal income tax.

### Credited Service

The number of years and completed months of service from date of hire to date of termination, adjusted for certain periods of unpaid absence.

### Vesting Service

Total service from date of hire to date of termination, less any absence in excess of 12 months that is excluded from credited service, using elapsed time.

### Covered Compensation

A 35- year average of the Taxable Wage Base (TWB) under social security. The TWB is the annual limit on wages subject to the FICA tax for social security. The 35-year period ends with the year the employee reaches eligibility for an unreduced social security benefit (age 65, 66, or 67 depending on the year the employee was born). For years after the year of termination and prior to the end of the 35-year period, the TWB from the year of termination is used.

### Final Average Monthly Compensation

The monthly average of the 5 consecutive years' compensation out of the last 10 years that gives the highest average. Compensation includes W-2 earnings plus any compensation deferred under a Section 125 or Section 401 (k) plan. Compensation is limited to \$200,000 (indexed beginning 2003) as required.

### Normal Retirement

Participants are eligible for normal retirement after the attainment of age 65.

### Normal Form of Payment

Life only annuity is the normal form of payment.

---

### Normal Retirement Benefit

The normal retirement benefit is the sum of (a) and (b) where (a) is 65% of final average monthly compensation times credited service up to 35 years and (b) is .65% of the excess, if any, of final average monthly compensation over covered compensation times credited service up to 35 years.

### Optional Forms of Payment

Monthly pension benefits are paid as described above as a single life annuity, if the participant has no spouse as of the date payments begin, or if the participant so elects. Otherwise, benefits are paid in the form of the 50% joint and survivor annuity option or, if the participant elects and the spouse consents, another actuarially equivalent optional form offered by the Plan. Optional annuity forms are 50% or 75% joint and survivor, 66 $\frac{2}{3}$ % joint and last survivor, and ten-years certain and life.

### Accrued Benefit

The participant's accrued benefit at any given date is determined under the normal retirement formula, but is based on current credited service, final average monthly compensation and covered compensation.

### Actuarial Equivalent

UP-1984 Mortality Table and 8% interest.

### Early Retirement

Participants are eligible for early retirement after the attainment of age fiftyfive (55) and five (5) Years of Vesting Service. The accrued benefit at the early retirement date is reduced to reflect early payment. The early retirement reduction is 1/15 for each of the first five (5) years preceding normal retirement and 1/30 for each of the next five (5) years preceding normal retirement. Enhanced early retirement benefits are provided if the participant retires after age 62 with at least 25 years of service.

### Deferred Retirement Benefit

If retirement occurs after the normal retirement date, the late retirement income will be based on the greater of (a) the normal retirement benefit calculated using credited service and final average monthly compensation as of the late retirement date or (b) the income provided by the single-sum value of the retirement income payable as of normal retirement date if employment had then terminated, accumulated with interest to actual retirement.

### Vesting

A participant is 100% vested upon completion of 5 years of vesting service. However, all participants become 100% vested upon reaching age 65.

---

### Termination Benefit

The termination benefit is equal to the vested accrued benefit, payable in the normal form, commencing at normal retirement date. Optionally, the participant may elect to receive an actuarially reduced benefit commencing prior to normal retirement date.

### Disability

A participant is eligible for disability benefits if there is total and permanent disability of participant prior to normal retirement date and the participant is receiving benefits under Social Security disability or the company's long-term disability program.

### Disability Benefit

The benefit which is deferred to age 65 is equal to the anticipated retirement benefit based on final average earnings assuming the participant continued to earn the same rate of pay at disability until normal retirement date, and on service to normal retirement date.

### Death Benefit for Participants in Active Service

To receive death benefits a participant must have attained age 21 and 1 year of credited service. The participant's beneficiary will receive an income payable for ten years certain and life that can be provided by the present value of the accrued benefit.
