### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of Lee Construction Group 401(k) Retirement Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [(ERISA Section 103(a)(3)(C) audit)]. The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023 and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of Lee Construction Group 401(k) Retirement Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from qualified institutions as of December 31, 2024 and 2023 and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 8 to the financial statements, is complete and accurate.

### Opinion

**Note 1 – Description of Plan**

---

The following brief description of the Lee Construction Group 401(k) Retirement Plan (the “Plan”) is provided for general information purposes only. Participants should refer to the Plan agreement for more complete information.

*General*

The Plan is a defined contribution plan covering all eligible employees of Lee Construction Group, Inc.; Piedmont Development Group, Inc.; Lee Building Company, Inc.; Piedmont Facilities Management, Inc.; Piedmont Plaster & Drywall, Inc.; and Piedmont Concrete Contractors, Inc. (collectively the “Company”). Employees become eligible to participate after completing two months of service and attaining age 21. Employees are eligible for entry to the Plan on the first day of the month following completion of two months of service. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

*Contributions*

Participants may contribute a percentage of their compensation as pre-tax or Roth deferrals to the Plan and may also contribute amounts representing distributions from other qualified plans. Participants of qualifying age may make additional “catch-up” contributions. Participants direct the investment of their contributions into various investment options offered by the Plan. The Company may make matching contributions as determined annually by the Company’s Board of Directors. The Board of Directors elected to make a 10% matching contribution for 2024. Contributions are subject to certain limitations.

*Participant Accounts*

Each participant’s account is credited with the participant’s contribution and allocations of (a) the Company’s contribution and (b) Plan earnings and administrative expenses. Allocations are based on participant compensation or account balances, as defined by the Plan. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

*Forfeitures*

At December 31, 2024 and 2023, forfeited non-vested accounts totaled \$6,311 and \$3,084, respectively. Forfeitures may be used to reduce employer contributions or pay Plan expenses. During 2024, \$6,652 of forfeitures were used to reduce employer contributions which are remitted annually after Plan year end.

*Vesting*

Participants are immediately vested in their contributions, plus actual earnings thereon. Vesting in the Company’s contributions is based on years of continuous service. Participants are fully vested in Company contributions after attaining six years of credited service.

*Payment of Benefits*

Upon attainment of normal retirement age of 65, termination of employment, or in the case of death, a participant or their beneficiary will receive the vested portion of the amount credited to the participant’s account. The participant may

elect to receive a lump-sum distribution, or periodic payments as defined in the Plan provisions. Participants age 59 1/2 or older are eligible for in-service withdrawals from their deferral and employer funded accounts. Hardship withdrawals are also permitted, subject to the provisions described in the Plan document. Effective January 1, 2024, the automatic distribution threshold increased from \$5,000 to \$7,000 in accordance with Secure Act 2.0.

*Administrative Expenses*

Plan fees and administrative expenses are paid by the Company or the Plan on a discretionary basis. A portion of these fees and expenses were paid by the Plan for the year ended December 31, 2024.

**Note 2 – Summary of Significant Accounting Policies**

---

*Basis of Accounting*

The accompanying financial statements have been prepared on the accrual basis of accounting.

Investment contracts held by a defined contribution plan are required to be reported at fair value, except for fully benefit-responsive investment contracts. Contract value is the relevant measurement attribute for fully benefit-responsive investment contracts because contract value is the amount participants would receive if they were to initiate permitted transactions under the terms of the plan.

*Estimates*

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan Administrator to make estimates and assumptions that affect reported amounts of assets and liabilities and changes therein and disclosures of contingent assets and liabilities. Actual results may differ from those estimates.

*Investment Valuation and Income Recognition*

The Plan's investments are stated at fair value except for fully benefit-responsive investment contracts, which are reported at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 for a discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation or depreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

*Payment of Benefits*

Benefits are recorded when paid.

*Subsequent Events*

Subsequent events have been evaluated through October 10, 2025, the date the financial statements were available to be issued.

**Note 3 – Fair Value Measurements**

The Plan’s mutual funds are reported at fair value in the accompanying statements of net assets available for benefits. The methods used to measure fair value may produce an amount that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

The fair value measurement accounting literature establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority; Level 2 inputs consist of observable inputs other than quoted prices for identical assets; and Level 3 inputs consist of unobservable inputs and have the lowest priority. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value. Level 3 inputs were used only when Level 1 or Level 2 inputs were not available.

*Level 1 Fair Value Measurements*

The fair values of mutual funds are based on quoted net asset values of the shares held by the Plan at year end.

**Note 4 – Fully Benefit-Responsive Investment Contract with Insurance Company**

Participants may also invest in a Key Guaranteed Portfolio Fund that is a traditional investment contract. This contract meets the fully benefit-responsive investment contract criteria and therefore is reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value represents contributions made under each contract, plus earnings, less participant withdrawals, and administrative expenses. The average yield earned by the Plan is the yield earned on the group annuity contract. The crediting rate for the fund to

participants was 1.41% and 1.23% for the periods ended December 31, 2024 and 2023, respectively. The following represents the total contract value of this investment contract held by the Plan.

With traditional investment contracts, the Plan owns only the contract itself. Traditional investment contracts are designed to accrue interest based on crediting rates established by the contract issuers.

The traditional investment contract held by the Plan is a guaranteed investment contract. The contract issuer is contractually obligated to repay the principal and interest at a specified interest rate that is guaranteed to the Plan. The crediting rate is based on a formula established by the contract issuer but will not fall below zero percent. The crediting rate is reviewed on a quarterly basis for resetting. The contract cannot be terminated before the scheduled maturity date.

Certain events might limit the ability of the Plan to transact at contract value with the contract issuer. These events may be different under each contract. Examples of such events include the following:

- The Plan’s failure to qualify under Section 401(a) of the *Internal Revenue Code (IRC)* or the failure of the trust to be tax-exempt under Section 501(a) of the *IRC*
- Premature termination of the contracts
- Plan termination or merger
- Changes to the Plan’s prohibition on competing investment options
- Other Plan Sponsor events that significantly affect the Plan’s normal operations

No events are probable of occurring that might limit the ability of the Plan to transact at contract value with the contract issuers and that also would limit the ability of the Plan to transact at contract value with the participants.

In addition, certain events allow the issuer to terminate the contracts with the Plan and settle at an amount different from contract value. Those events may be different under each contract. Examples of such events include the following:

- An uncured violation of the Plan’s investment guidelines
- A breach of material obligation under the contract
- A material misrepresentation
- A material amendment to the agreements without the consent of the issuer

**Note 5 – Related Party and Parties-in-Interest Transactions**

Certain employees of the Plan’s Sponsor provide administrative and accounting services to the Plan at no additional cost to the Plan. These employees are also participants of the Plan.

Plan participants may choose to invest in funds held by the Plan’s Custodians. Therefore, these transactions qualify as related party transactions. Fees paid to the Custodians by the Plan for investment management and trust services amounted to \$23,015 for the year ended December 31, 2024.

**Note 6 – Plan Termination**

Although it has not expressed any intent to do so, the Company has the right to amend or terminate the Plan at any time subject to the provisions of ERISA. In the event of termination of the Plan, participants will become 100% vested in their accounts.

**Note 7 – Tax Status**

---

The Plan adopted a non-standardized, pre-approved plan sponsored by CCH Incorporated effective August 1, 2021 which received a favorable opinion letter from the Internal Revenue Service dated June 30, 2020, stating that the Plan is designed in accordance with applicable sections of the *IRC*. The Plan Administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the *IRC*.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the plan and recognize a tax liability (or asset) if the plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan Administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements.
