### ***Scope and Nature of the ERISA Section 103(a)(3)(C) Audit***

We have performed audits of the financial statements of the Wayne UNC 403(b) Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's ("DOL") Rules and Regulations for Reporting and Disclosure under ERISA ("ERISA Section 103(a)(3)(C) audit"). As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan ("investment information") by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency ("qualified institution"), provided that the investment information is prepared and certified to by the qualified institution in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA.

Management has obtained certifications from qualified institutions as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

### ***Opinion***

In our opinion, based on our audits and the procedures performed as described in the *Auditor's Responsibilities for the Audit of the Financial Statements* section of our report

- the amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America ("GAAP"); and
- the certified investment information in the accompanying financial statements agrees to, or is derived from, in all material respects, the information prepared and certified by qualified institutions that management determined meet the requirements of ERISA Section 103(a)(3)(C).



### ***Basis for Opinion***

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (“GAAS”). Our responsibilities under those standards are further described in the *Auditor’s Responsibilities for the Audit of the Financial Statements* section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

### ***Responsibilities of Management for the Financial Statements***

Management is responsible for the preparation and fair presentation of the financial statements in accordance with GAAP, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management’s election of the ERISA Section 103(a)(3)(C) audit does not affect management’s responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern within one year after the date that the financial statements are available to be issued.

- the certified investment information in the supplemental schedule agrees to, or is derived from, in all material respects, the information prepared and certified by qualified institutions that management determined meet the requirements of ERISA Section 103(a)(3)(C).

### 1. Description of Plan

The following description of the Wayne UNC 403(b) Plan (the “Plan”) is provided for general information purposes only. Participants should refer to the comprehensive Plan Document for a more complete description of the Plan’s provisions.

#### *General*

The Plan is a defined contribution plan established January 1, 2001 covering all employees of Wayne Memorial Hospital, Inc. and affiliates (the “Hospital” or “Employer”). Employees are eligible to participate upon hire. The Retirement Committee is responsible for oversight of the Plan. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (“ERISA”).

#### *Contributions*

Participants may elect to contribute up to 100% of their annual compensation, as defined by the Plan, subject to Internal Revenue Code (“IRC”) limitations. Eligible employees are automatically enrolled at 3% of pre-tax compensation as a deferral contribution to the Plan, increasing by 1% each January 1<sup>st</sup> until reaching 6%, unless such employee affirmatively declines to enroll in the Plan or affirmatively elects to defer a percentage other than 3%. Participants may elect to make pre-tax and/or Roth contributions to the Plan. Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. Additionally, participants may contribute amounts representing distributions from other qualified defined benefit or contribution plans (rollovers). The Plan does not provide for Employer contributions.

#### *Plan Loans*

Up until 2014, participants could borrow directly from Variable Annuity Life Insurance Company (“VALIC”) a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of the vested accrued benefit of the VALIC Fixed Account. The participant must pledge sufficient collateral. The collateral of the loans must be maintained in their investment accounts to the VALIC Fixed Accounts.

The loans are not shown in the Plan’s statements of net assets available for benefits, as the loans are not made from plan assets and are, therefore, not considered assets of the Plan. Loan interest rates are variable at prevailing interest rates and can be increased or decreased by VALIC. Principal and interest is paid ratably by the participant directly to VALIC. A default charge will be assessed against the portion of the loan collateral used to foreclose on all or part of any loan.

Loan balances outstanding to VALIC from the Plan’s participants were \$35,981 and \$50,387 as of December 31, 2024 and 2023, respectively. There were \$35,981 and \$50,387 in loans to participants in default, and subject to repayment from participants’ accounts at the time of distribution, as of December 31, 2024 and 2023, respectively. There was \$16,290 in loan collateral foreclosed upon by VALIC and distributed from participant accounts to repay a defaulted loan during 2024.

### ***Participant Accounts***

Each participant's account is credited with the participant's contributions, employer contributions, and an allocation of net Plan earnings or losses. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which participants are entitled is the vested portion of their accounts.

### ***Vesting***

Participants are immediately vested in their contributions plus actual earnings thereon.

### ***Payment of Benefits***

On termination of service due to death, disability or retirement, a participant may elect to receive an amount equal to the value of the participant's vested interest in his or her account in either a lump-sum amount or various installment options as provided by the Plan. The Plan allows in-service distributions upon demonstration of financial hardship, disability, or after the participant reaches the age of 59 ½ years. Vested account balances below \$1,000 may be automatically paid to participants at the discretion of the Hospital.

### ***Notes Receivable from Participants***

Participants are permitted to borrow a minimum of \$1,000 of their vested benefits under the Plan. Participants may borrow up to a maximum equal to the lesser of 50% of their vested account balance or \$50,000, reduced by the highest outstanding loan balance in their account during the prior 12-month period. Loans are secured by the participant's account and bear an interest rate at the prime rate plus 1% or at local prevailing rates as determined by the Plan Administrator, which would be made under similar circumstances and is fixed for the term of the loan. The notes are repaid ratably through payroll deductions over a period of five years or less. These loans are subject to certain restrictions as defined by the Plan Document and applicable restrictions under the IRC.

Also, each participant may not have more than one loan outstanding at any time.

## **2. Summary of Accounting Policies**

### ***Basis of Accounting***

The accompanying financial statements of the Plan are prepared on the accrual basis of accounting.

### ***Use of Estimates***

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America ("GAAP") requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities, and changes therein and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

### *Investment Valuation and Income Recognition*

The Plan's investments are stated at fair value with the exception of fully benefit-responsive investment contracts. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Retirement Committee determines the Plan's valuation policies utilizing information provided by its investment adviser and custodian. See Note 4 for discussion of fair value measurements.

The Plan's fully benefit-responsive investment contracts (see Note 5) are valued at contract value.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) in the fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

### *Contributions Receivable*

Participant contributions are recognized in the period during which the Company makes the respective payroll deduction from the participant's compensation.

### *Notes Receivable from Participants*

Notes receivable from participants are measured at their unpaid principal balance plus accrued unpaid interest. If a participant ceases to make loan repayments and the Plan Administrator deems the participant loan to be in default, the participant loan balance is reduced, and a benefit payment is recorded.

### *Payment of Benefits*

Benefit payments are recorded when paid.

### *Administrative Expenses*

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Hospital. Expenses that are paid by the Hospital are excluded from these financial statements. Fees related to participant-initiated transactions are charged directly to the participant's account and are included in administrative expenses. Investment-related expenses are included in net appreciation (depreciation) in fair value of investments.

## **3. Certified Investment Information**

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including investments and notes receivable from participants held at December 31, 2024 and 2023, and net appreciation in fair value of investments, interest and dividends, and interest income on notes receivable from participants for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Delaware Charter Guarantee and Trust Company d/b/a Principal Trust Company ("Principal") and Variable Annuity Life Insurance Company ("VALIC"), qualified institutions.

### 4. Fair Value Measurements

Accounting Standards Codification (“ASC”) 820, *Fair Value Measurement*, provides for a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under ASC 820 are described as follows:

*Level 1* - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

*Level 2* - Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets.
- Quoted prices for identical or similar assets or liabilities in inactive markets.
- Inputs other than quoted prices that are observable for the asset or liability.
- Inputs that are derived principally from, or corroborated by, observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

*Level 3* - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

A financial instrument’s level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

There have been no changes in the methodologies used at December 31, 2024 or 2023. The following is a description of the valuation methodologies used for assets measured at fair value:

**Fixed Annuity Contracts:** The non-fully benefit responsive (“NFBR”) fixed annuity contracts, composed of the VALIC Fixed Account Plus, are reported at fair value. Fair value is determined using a discounted cash flow model. The fixed annuity contracts are not available for sale or transfer on any securities exchange. The fixed annuity accounts are subject to various restrictions. See Note 5.

**Mutual Funds:** Mutual funds represent investments with various investment managers. The funds are valued at the daily closing price as reported by the fund. Funds held by the Plan are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value and to transact at that price. The mutual funds held in the Plan are deemed to be actively traded.

The preceding methods described may produce a fair value calculation which may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

During 2024, total purchases and sales of the fixed annuity contracts (NFBR) were \$0 and \$161,698, respectively.

## **5. Annuity Contracts**

### ***Principal Fixed Income Guaranteed Option***

The Plan holds group annuity accounts with Principal Life Insurance Company, an insurance company registered in the state of Iowa.

Principal Fixed Income Guaranteed Option annuity accounts are credited with a guaranteed minimum rate of interest. The guaranteed minimum interest rate will be first established at the contract date. Subsequently, the guaranteed minimum interest rate will be determined each time composite crediting rates are announced. The guaranteed minimum interest rate will be determined by taking the average of five-year constant maturity treasury rates twelve months prior to Principal Life Insurance Company announcing the composite crediting rate, reducing this average by 1.25%, and rounding this amount to the nearest 0.05%. Constant maturity treasury rates means those rates posted by the board of governors of the Federal Reserve System or by an agency that provides similar information. The guaranteed minimum interest rate will never be less than 1% or greater than 3%.

Contributions to the annuity accounts are grouped into “vintages” comprised of deposits received over defined time periods. The interest crediting rate for each vintage is determined, in part, by the net investment earnings rate of the assets supporting that vintage.

These group annuity contracts are considered fully benefit-responsive investment contracts as defined by ASC 962, because they are fully liquid and immediately cashable once a participant terminates employment with the Employer.

### ***VALIC Fixed Account Plus***

The Plan also holds VALIC fixed annuity accounts with Variable Annuity Life Insurance Company (“VALIC”), an insurance company registered in the state of Texas. VALIC fixed annuity accounts are credited with a guaranteed minimum rate of interest that is determined monthly. The minimum guaranteed rate depends on the year the account was established.

The VALIC Fixed Account Plus employs a modified new money crediting policy. VALIC declares a “current” interest rate at the beginning of each month applicable to contributions received during that month. The current rate declared is guaranteed until the end of that calendar year for contributions received that month. At the beginning of the third calendar year, such contributions will earn interest at a new declared pool rate. This rate is established January 1 of each calendar year and guaranteed for that entire calendar year. The contractually guaranteed minimum interest rate is applicable for the lifetime of the contract.

The VALIC Fixed Account Plus may be withdrawn at a rate of 20% annually. Any transfers back to the VALIC Fixed Account Plus may be subject to new crediting interest rates. The VALIC Short-Term Fixed account may be withdrawn up to 100% at any time. After a transfer into the VALIC Short-Term Fixed account, as participant may not make a transfer out of the account within 90 days. Withdrawals are subject to a surrender charge if more than 10% of the balance is withdrawn. Surrender charges are equal to the lesser of 5% of all deposits into the account in the last 60 months or 5% of the amount withdrawn. The VALIC Fixed Interest Option interest rate is declared monthly with a minimum crediting rate set at the beginning of the year. There are no surrender charges. Transfers out to a competing fund are limited for 90 days. Plan directed transfers are limited to 20% per year. The VALIC fixed annuity contracts are not considered to be fully benefit-responsive investment contracts as defined by ASC 962.

## **6. Related Party and Party-In-Interest Transactions**

Certain investments are managed by Principal and VALIC. As described in Note 2, the Plan paid certain expenses related to plan operations and investment activity to various service providers. Notes receivable from participants also qualify as party-interest transactions. These transactions are party-in-interest transactions, which are exempt from prohibited transaction rules.

## **7. Plan Termination**

Although it has not expressed any intention to do so, the Hospital has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions set forth in ERISA. In the event that the Plan is terminated, participants would remain 100% vested in their accounts.

### 8. Tax Status

The Plan uses a volume submitter plan document sponsored by Principal Life Insurance Company. Principal Life Insurance Company received an opinion letter from the Internal Revenue Service (“IRS”), dated March 31, 2017, which states that the volume submitter document, as then designed, satisfies the applicable provisions of the IRC. Although the Plan has been amended since the date of the opinion letter, Plan management believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC.

GAAP requires plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no IRS examinations for any tax periods in progress.

### 9. Risks and Uncertainties

The Plan holds various investment securities. Investment securities, in general, are exposed to various risks, such as interest rate risk, credit risk and overall market volatility. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the amounts reported in the financial statements and participant account balances.

### 10. Subsequent Events

The Plan has evaluated subsequent events through October 13, 2025, the date the financial statements were available to be issued.
