Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of City of Hope Medical Group 401(k) Retirement Savings Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan ("investment information") by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA ("qualified institution").

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 4 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section –

- The amounts and disclosures in the financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- The information in the financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America. Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

NOTE 1 - DESCRIPTION OF THE PLAN AND SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

A. Plan Description

The City of Hope Medical Group 401(k) Retirement Savings Plan (the “Plan”) is a defined contribution plan established June 1, 2011 to provide voluntary retirement benefits and tax-deferred savings opportunities to eligible employees of the Plan’s sponsor, City of Hope Medical Group, Inc. (the “Company”). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). Officers and employees of the Company serve as the Plan’s administrator. The specific provisions of the Plan are contained in the Plan document, which governs the legal operations of the Plan. The following provides only general information; participants and others should refer to the Plan document for further details.

B. Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America (GAAP).

C. Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the plan administrator to make estimates and assumptions that affect reported amounts and disclosures. Actual results may differ from those estimates.

D. Investment Valuation and Income Recognition

Plan investments are participant-directed.

GAAP establishes a hierarchy that prioritizes valuation inputs into three levels based on the extent to which inputs used in measuring fair value are observable in the market. Level 1 inputs are quoted prices in an active market. Level 2 inputs are quoted prices for similar instruments and model-based valuation techniques for which all significant assumptions are observable in the market or can be corroborated by observable market data. Level 3 inputs are generally unobservable and typically reflect management’s estimates of assumptions that market participants would use in pricing the asset or liability.

^A In accordance with ASC 820, the investment measured at net asset value per share (or its equivalent) has not been classified in the fair value hierarchy. The fair value amounts presented in this table are intended to permit reconciliation of the fair value hierarchy to the line items presented in the statements of net assets available for benefits.

Level 1 investments are mutual funds, common and preferred stock, and government bonds consisting of US Treasury securities valued at their quoted market prices. Level 2 investments are corporate bonds recorded at fair value based on valuations by third party pricing services. The pooled separate account is valued based on net asset value per unit of the fund as reported for each valuation date and is estimated based on the valuation of the underlying investments. Redemptions may be made on a daily basis with no restrictions. The net asset value is used as a practical expedient to estimate fair value. The investment is a direct filing entity with the Department of Labor. There are no unfunded commitments as of December 31, 2024. Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividend income is recognized on the ex-dividend date.

E. Eligibility

Company employees are eligible to participate in the Plan upon employment, except for union employees and leased employees, as defined by the Plan.

F. Contributions and Vesting

Participants may contribute to the Plan through salary deductions up to 70% of compensation, as defined by the Plan, up to the statutory maximum as determined by the Internal Revenue Code ("IRC"). Participants' rights to their voluntary contributions are 100% vested immediately upon contribution. The Company is required to contribute an amount equivalent to 20% of each participant's qualified pre-tax annual compensation, as defined by the Plan.

G. Notes Receivable from Participants

The Plan allows participants to borrow not less than \$1,000 up to the lesser of \$50,000 or 50% of their vested account balances. A loan is secured by a participant's vested account balance, bears interest at available market financing rates and must be repaid to the Plan in five years. Principal and interest are paid ratably through payroll deductions. Notes receivable from participants are measured at their unpaid principal balance plus accrued interest.

H. Distributions and Withdrawals

Each participant's share of the net assets of the Plan is allocated to an individual account. Vested benefits are payable upon termination of service due to death, disability or retirement. Participants may elect to receive either a lump-sum or installments over a specified period of time. For terminations due to other reasons, a participant may receive the value of the vested interest in his or her account as a lump-sum distribution or leave the vested account balance in the Plan until required minimum distributions begin. In-service withdrawals are allowed for participants who reach age 59½.

I. Retirement Age

Normal retirement age is 65.

J. Administrative Expenses

The Plan pays most administrative expenses. In 2024, the Plan paid the following fees:

K. Forfeitures

Forfeitures of participants' non-vested account balances are applied to offset Plan expenses or reduce Company contributions. As of December 31, 2024 and 2023, forfeited non-vested accounts totaled \$439,284 and \$1,224,189, respectively; \$218,979 was used to pay Plan expenses in 2024.

L. Risks and Uncertainties

Plan investments are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with investments, it is at least reasonably possible that changes in the value of investments in the near term could materially affect the amounts reported in the financial statements.

NOTE 2 - INCOME TAX STATUS

The Plan adopted Charles Schwab Trust Company's Prototype Non-Standardized Profit Sharing plan, which has received a favorable opinion letter from the Internal Revenue Service stating that the Plan constitutes a qualified plan under Section 401(a) of the IRC and that it is exempt from federal income taxes. Although the Plan has since been amended, the plan administrator and the Plan's tax counsel believe that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC.

GAAP requires management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken a tax position that more likely than not would not be sustained upon examination by a tax authority. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

NOTE 3 - PLAN TERMINATION

The Company has the right under the Plan to discontinue contributions at any time and to terminate the Plan subject to the provisions of ERISA. If the Plan were to terminate, participants would become 100% vested in their accounts.

NOTE 4 - FINANCIAL INFORMATION CERTIFIED BY THE TRUSTEE

The plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Information regarding investments held at December 31, 2024 and 2023 and investment income for the year ended December 31, 2024 that is disclosed in the accompanying financial statements and supplemental schedule was obtained or derived from information supplied to the plan administrator and certified as complete and accurate by Charles Schwab Trust Bank, the trustee of the Plan.

NOTE 5 - RELATED PARTY TRANSACTIONS

Certain investments of the Plan are managed by Charles Schwab Trust Bank (Schwab), or its affiliates. Schwab is the trustee as defined by the Plan, and therefore, these transactions qualify as party in interest transactions; however, they are exempt from the prohibitions under ERISA.
