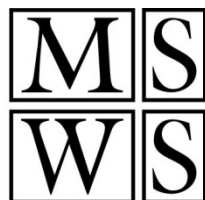

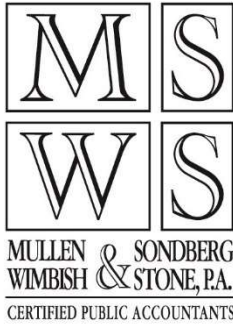

December 31, 2024 and 2023

Note 1 - Description of Plan

The following description of the Urban Engineering & Associates, Inc. 401(k) Plan (the “Plan”) provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan’s provisions.

General: Urban Engineering & Associates, Inc. 401(k) Plan, established January 1, 1988 and restated effective December 1, 2017, is a defined contribution plan covering substantially all employees of Urban Engineering & Associates, Inc. (the “Employer”). An employee becomes eligible to participate in the salary deferral feature of the Plan on the first day of the month, coincident with or next following the date he or she completes three consecutive months of service and is age twenty-one or older. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”).

Urban Engineering & Associates, Inc. is the plan administrator, Ascensus Trust Company (“Ascensus Trust”) is the asset trustee and Ascensus, Inc. (“Ascensus”) is the record keeper of the Plan.

Contributions: Eligible employees may elect to defer up to 100% of his or her compensation and have such deferrals contributed by the Employer to his or her account under the Plan. Participant contributions are subject to the annual Internal Revenue Code limits as adjusted each year. This may be further limited so that the Plan complies with the 401(k) and 401(m) nondiscrimination tests. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans. Participants direct the investment of their contributions into various investment options offered by the Plan. On December 1, 2017 the Plan was amended to incorporate an automatic enrollment and salary deferral feature. For newly eligible participants, salary deferrals equal to 3% of eligible compensation will be contributed as pre-tax deferrals. Participants may elect a different deferral amount or elect not to defer. Participants direct the investment of their contributions into various investment options offered by the Plan. Contributions made by the Employer for the years ended December 31, 2024 and 2023 total \$217,047 and \$184,905, respectively.

The Employer contributions are determined at the discretion of the Employer’s management. For the plan years ended December 31, 2024 and 2023, the Employer matched 30% of each qualifying contributing participant’s elective deferral. The discretionary matching Employer contributions are invested in a portfolio of investments as directed by the participant.

Participant Accounts: Each participant’s account is credited with the participant’s contribution and allocations of (a) the Employer’s contribution and, (b) Plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account. Contributions are invested, at the discretion of the participants, in one, several, or all of the investment alternatives selected by the plan administrator.

Vesting: Participants are immediately vested in their contributions plus actual earnings thereon. Vesting of the Employer's matching contribution portion of their accounts plus actual earnings thereon is based on years of continuous service. A participant becomes 20 percent vested after two years of credited service, and then 20 percent of each year thereafter. Therefore, a participant will become 100 percent vested after 6 years of credited service. A participant will also become fully vested upon attainment of normal retirement age, early retirement age, retirement due to disability, death, or upon termination of the Plan.

Payment of Benefits: On termination of service due to death, disability or retirement, a participant may elect to receive an amount equal to the value of the participant's vested interest in his or her account in either a lump-sum amount, or in nonrecurring partial payments from the vested portion of their individual account. For termination of service due to other reasons, a participant may receive the value of the vested interest in his or her account as a lump-sum distribution. Eligible distributions may also be rolled over to another qualifying plan or IRA. Hardship withdrawals are permitted in accordance with Internal Revenue Service regulations.

Administrative Expenses: The administrative expenses related to the Plan's Trustee are paid by the Plan. The Employer pays all other administrative expenses of the Plan. For the years ended December 31, 2024 and 2023, the amount paid by the Plan was \$49,796 and \$46,103, respectively.

Notes Receivable from Participants: Loans are not permitted under the Plan.

Forfeitures: During the years ending December 31, 2024 and 2023, forfeited non-vested accounts totaled \$11,464 and \$3,375, respectively. During the years ended December 31, 2024 and 2023, \$5,507 and \$3,390 was used from forfeited accounts to pay for plan expenses, respectively. Total amounts available to reduce future employer contributions or pay for Plan expenses are \$6,251 and \$16 as of December 31, 2024 and 2023, respectively.

Note 2 - Summary of Accounting Policies

Basis of Accounting

The financial statements of the Plan are prepared in accordance with accounting principles generally accepted in the United States of America. This basis of accounting involves the application of accrual accounting; consequently, revenues and gains are recognized when earned, and expenses and losses are recognized when incurred.

Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

Note 2 - Summary of Accounting Policies (Cont.)

Investment Valuation and Income Recognition

The Plan's investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation or depreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Contributions and Related Receivables

Contributions from the Employer and the participants of the Plan are accrued in the period in which they come obligations under provisions of the Plan agreement. The Employer matching contributions are recorded in the year in which the associated participant contributions are withheld from the amounts paid. Plan management has determined that all contribution receivables are fully collectible and therefore no allowance for credit losses has been established.

The Plan reported employer's contributions receivable as a contributions due which relates to work performed on or before December 31. Management of the Plan evaluates participating employer's contributions receivable periodically for potential uncollectible amounts based on the likelihood of collection. As of December 31, 2024 and 2023, there were no allowances for credit losses established.

Payment of Benefits

Benefits are recorded when paid. Benefits paid to participants amounts to \$1,118,460 and \$1,091,663 for the years ended December 31, 2024 and 2023, respectively.

Note 3 - Information Prepared and Certified by Trustee

Investment Data

All data contained in the statements of net assets available for benefits, statements of changes in net assets available for benefits for the years ended December 31, 2024 and 2023, and the Schedule H, Line 4i – Schedule of assets (held at end of year) for the year ended December 31, 2024 was summarized from information supplied and certified as complete and accurate by the Ascensus LLC, the Trustee of the Plan.

Schedule of Assets Held for Investment Purposes

The accompanying Schedule H, Line 4i – Schedule of assets (held at end of year) represents a detailed listing of all investments held by the Plan as of December 31, 2024.

Note 4 - Fair Value Measurements

The Plan's investments are reported at fair value in the accompanying statement of net assets available for benefits. The methods used to measure fair value may produce an amount that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

ASC 820-10 Fair Value Measurements establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under *FASB ASC820* are as described as follows:

- Level 1: Inputs that reflect unadjusted quoted prices in active markets for identical assets or liabilities that the Plan has the ability to access at the measurement date.
- Level 2: Inputs to the valuation methodology include:
 - quoted prices for similar assets or liabilities in active markets;
 - quoted prices for identical or similar assets or liabilities in inactive markets;
 - inputs other than quoted prices that are observable for the asset or liability;
 - inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

- Level 3: Inputs that are unobservable and supported by little or no market activity and that are significant to the fair value of the assets or liabilities.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

The Plan has no Level 2 or Level 3 investments. The Plan's Level 1 investments comprise of money market and registered investment companies valued at \$13,016,316 and \$11,583,425 as of December 31, 2024 and 2023, respectively. Registered investment companies and money market funds are valued at the daily closing prices as reported by the funds in active markets. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The registered investment companies and money market funds held by the Plan are deemed to be actively traded.

Note 4 - Fair Value Measurements (Cont.)

Money market funds: A money market fund is a type of fixed income mutual fund that invests in debt securities characterized by their short maturities and minimal credit risk. Money market mutual funds are among the lowest-volatility types of investments.

Registered investment companies: Registered investment companies are valued at the daily closing prices as reported by the funds. Registered investment companies held by the Plan are open-end mutual funds that are registered with the SEC. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The registered investment companies held by the Plan are deemed to be actively traded.

Note 5 - Party-in-interest Transactions (Cont.)

Certain Plan investments are shares of mutual funds managed by Ascensus, LLC. Ascensus, LLC is the Trustee as defined by the Plan, and therefore, these transactions qualify as party-in-interest transactions. For the years ended December 31, 2024 and 2023, fees paid by the Plan for the investment management services amounted to \$17,232 and \$16,130, respectively. Potomac Wealth Management is the investment fiduciary and provides investment advisory services to the Plan, and therefore, these transactions qualify as party-in-interest transactions. For the years ended December 31, 2024 and 2023, fees paid by the Plan for the investment management services amounted to \$32,564 and \$29,973, respectively.

Note 6 - Reportable Transactions

A reportable transaction is a transaction, or series of transactions, exceeding five percent of the current value of the Plan's assets at the end of the year. During the Plan year ended December 31, 2024 and 2023, there were no reportable transactions.

Note 7 - Plan Termination

Although it has not expressed any intent to do so, the Employer has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, the net value of each participant's account shall become fully vested and no portion of the Plan's assets may be used for any purpose other than the exclusive benefit of the participants and their beneficiaries.

Note 8 - Tax Status

The plan was amended and restated December 1, 2017 to incorporate an automatic contribution arrangement. The Plan utilizes the Non-standardized Profit Sharing Plan with CODA as provided by Ascensus, Inc., which obtained its latest advisory letter on June 30, 2020, whereby the IRS stated that the Non-standardized Profit Sharing Plan with CODA, as then designed, was in compliance with the applicable requirement of the Internal Revenue Code (IRC). Therefore, no provision for income taxes has been included in the Plan's financial statements.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024 and 2023, there are no uncertain tax positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are no current audits for any tax periods in progress.

Note 9 - Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

Note 10 - Subsequent Events

The Plan has evaluated the impact of subsequent events. There have been no subsequent events through October 6, 2025, the day the Plan's financial statements were available to be issued, that require recognition or disclosure.
