Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of 401(k) Plan for the Employees of The Decurion Corporation (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). NOTE 1 - DESCRIPTION OF THE PLAN

The 401(k) Plan for the Employees of The Decurion Corporation (the “Plan”) is a defined contribution plan covering substantially all employees of Decurion Corporation (the “Company”). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”). The assets of the Plan were held in a trust by John Hancock Trust Company LLC before being transferred to Fidelity Plan Sponsor WebStation on January 1, 2024.

THE PLAN DOCUMENT INCLUDES DETAILED RULES FOR EACH SITUATION. PARTICIPANTS AND OTHER INTERESTED PARTIES SHOULD REFER TO THE PLAN AGREEMENT AND ANY AMENDMENTS REGARDING SPECIFIC PROVISIONS OF THE PLAN.

A. Eligibility

Company employees, except for those covered by a collective bargaining agreement, residents of Puerto Rico and independent contractors, are eligible to participate in the Plan after having completed 1,000 hours of service and attaining age 21. Company employees who are considered temporary employees, except for those covered by a collective bargaining agreement, residents of Puerto Rico and independent contractors, are eligible to participate in the Plan after having completed 1,000 hours of service and attaining age 21. Prior to January 1, 2019, the service requirement for temporary employees was 90 days.

B. Benefits

Distributions of a participant’s account are made upon termination of service, death, disability or retirement. A participant or beneficiary may elect to receive a single lump-sum payment equal to the value of his or her vested interest in their account. Terminated participants with account balances of \$7,000 or less can be distributed whether or not requested. Additionally, an in-service distribution can also be made to participants who have attained the age of 59½, upon disability or when experiencing financial hardship.

Benefits are recorded when paid.

C. Vesting

Participants are 100% vested in their salary deferral contribution, Company safe harbor matching contributions and rollover contributions, plus actual earnings thereon. Participants actively employed by the Company after December 31, 2007 are 100% vested in any Company matching contributions. Other Company contributions, or if employment terminated prior to January 1, 2008, any Company matching contributions, plus actual earnings thereon is based on years of vested service as follows:

D. Contributions

Participants may contribute up to 60% of eligible compensation, as defined in the Plan, subject to Internal Revenue Code ("IRC") limitations.

The Plan provides participants the option to elect pre-tax and/or Roth contributions.

The Plan calls for a Company safe harbor matching contribution equal to 100% of the first 6% of deferred amount by employees. Safe harbor Company matching contributions for the year ended December 31, 2024 were \$402,166.

E. Notes Receivable from Participants

The Plan allows participants to borrow not less than \$1,000 up to the lesser of \$50,000 or 50% of their vested account balance. A loan is secured by a participant's vested account balance, bears interest at available market financing rates and must be repaid to the Plan in five years unless the loan is used for the purchase of a principal residence, in which case the maximum repayment period is 10 years. The plan administrator establishes the specific terms and conditions of loans to participants. Notes receivable from participants at December 31, 2024 carry interest rates ranging from 4.25% to 9.50%. A loan set up fee of \$100 will be deducted from the participant's account for each loan.

F. Forfeitures

Forfeitures, which arise as a result of a participant's termination prior to full vesting are used to reduce future contributions by the Company or to pay Plan expenses. There were no forfeitures for the years ended December 31, 2024 and 2023. As of December 31, 2024 and 2023, no forfeitures were available for future use.

G. Administrative Expenses

Most administrative expenses are paid by the Company.

NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

A. Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting.

B. Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America ("GAAP") requires management to make estimates and assumptions that affect certain reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from these estimates.

C. Investment Valuation and Income Recognition

The participants select how their share of plan assets will be invested among those investment vehicles made available.

Level 1 investments consist of a money market fund and mutual funds reported at fair value based on quoted market prices. The pooled separate account is valued and reported at net asset value based on market prices for the underlying securities as determined by trades for identical or similar securities.

The investment objective of the pooled separate account is to provide a low risk, stable investment offering competitive yields. Pooled separate account investments may be redeemed any time at net asset value. There are no restrictions on redemptions and no unfunded commitments to purchase additional shares for the pooled separate account.

Purchases and sales of securities are recorded on the trade-date basis. Interest income is recorded on the accrual basis. Net appreciation includes gains and losses on investments bought and sold as well as held during the year.

D. Risks and Uncertainties

The Plan provides for various investment options in any combination of investments offered by the Plan. Investments are exposed to various risks, such as interest rate, market fluctuations and credit risks. Due to the risk associated with investments, it is at least reasonably possible that changes in market values, interest rates or other factors in the near term would materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits and statement of changes in net assets available for benefits.

NOTE 3 - INCOME TAX STATUS

The Plan has received an opinion letter dated November 7, 2016 from the Internal Revenue Service which stated that the Plan, as then designed, was in compliance with the applicable requirements of the IRC. The plan administrator believes that the Plan is currently being operated in compliance with the applicable provisions of the IRC. Therefore, no provision for income taxes has been included in the Plan's financial statements.

GAAP requires management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken a tax position that more likely than not would not be sustained upon examination by a tax authority. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

NOTE 4 - PLAN TERMINATION

Although it has not expressed an intent to do so, the Company has the right under the Plan to discontinue its contributions subject to the provisions of ERISA. In the event of Plan termination, participants will be 100% vested in their accounts and Plan assets will be distributed based upon the participants' account balances at the time.

NOTE 5 - FINANCIAL INFORMATION CERTIFIED BY THE TRUSTEES

The plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Information

NOTE 6 - RELATED PARTY TRANSACTIONS

Certain Plan investments are issued or managed by the trustee or its affiliates. Transactions in these investments, while considered party-in-interest transactions under ERISA regulations, are permitted under provisions of the Plan and are specifically exempt from the prohibitions of party-in-interest transactions under ERISA.

NOTE 7 - SUBSEQUENT EVENTS

Management has evaluated subsequent events through October 10, 2025, the date on which the financial statements were available to be issued. There were no material subsequent events that required recognition or additional disclosure in these financial statements.

NOTE 1 - DESCRIPTION OF THE PLAN

The 401(k) Plan for the Employees of The Decurion Corporation (the “Plan”) is a defined contribution plan covering substantially all employees of Decurion Corporation (the “Company”). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”). The assets of the Plan were held in a trust by John Hancock Trust Company LLC before being transferred to Fidelity Plan Sponsor WebStation on January 1, 2024.

THE PLAN DOCUMENT INCLUDES DETAILED RULES FOR EACH SITUATION. PARTICIPANTS AND OTHER INTERESTED PARTIES SHOULD REFER TO THE PLAN AGREEMENT AND ANY AMENDMENTS REGARDING SPECIFIC PROVISIONS OF THE PLAN.

A. Eligibility

Company employees, except for those covered by a collective bargaining agreement, residents of Puerto Rico and independent contractors, are eligible to participate in the Plan after having completed 1,000 hours of service and attaining age 21. Company employees who are considered temporary employees, except for those covered by a collective bargaining agreement, residents of Puerto Rico and independent contractors, are eligible to participate in the Plan after having completed 1,000 hours of service and attaining age 21. Prior to January 1, 2019, the service requirement for temporary employees was 90 days.

B. Benefits

Distributions of a participant’s account are made upon termination of service, death, disability or retirement. A participant or beneficiary may elect to receive a single lump-sum payment equal to the value of his or her vested interest in their account. Terminated participants with account balances of \$7,000 or less can be distributed whether or not requested. Additionally, an in-service distribution can also be made to participants who have attained the age of 59½, upon disability or when experiencing financial hardship.

Benefits are recorded when paid.

C. Vesting

Participants are 100% vested in their salary deferral contribution, Company safe harbor matching contributions and rollover contributions, plus actual earnings thereon. Participants actively employed by the Company after December 31, 2007 are 100% vested in any Company matching contributions. Other Company contributions, or if employment terminated prior to January 1, 2008, any Company matching contributions, plus actual earnings thereon is based on years of vested service as follows:

D. Contributions

Participants may contribute up to 60% of eligible compensation, as defined in the Plan, subject to Internal Revenue Code ("IRC") limitations.

The Plan provides participants the option to elect pre-tax and/or Roth contributions.

The Plan calls for a Company safe harbor matching contribution equal to 100% of the first 6% of deferred amount by employees. Safe harbor Company matching contributions for the year ended December 31, 2024 were \$402,166.

E. Notes Receivable from Participants

The Plan allows participants to borrow not less than \$1,000 up to the lesser of \$50,000 or 50% of their vested account balance. A loan is secured by a participant's vested account balance, bears interest at available market financing rates and must be repaid to the Plan in five years unless the loan is used for the purchase of a principal residence, in which case the maximum repayment period is 10 years. The plan administrator establishes the specific terms and conditions of loans to participants. Notes receivable from participants at December 31, 2024 carry interest rates ranging from 4.25% to 9.50%. A loan set up fee of \$100 will be deducted from the participant's account for each loan.

F. Forfeitures

Forfeitures, which arise as a result of a participant's termination prior to full vesting are used to reduce future contributions by the Company or to pay Plan expenses. There were no forfeitures for the years ended December 31, 2024 and 2023. As of December 31, 2024 and 2023, no forfeitures were available for future use.

G. Administrative Expenses

Most administrative expenses are paid by the Company.

NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

A. Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting.

B. Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America ("GAAP") requires management to make estimates and assumptions that affect certain reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from these estimates.

The pooled separate account is valued and reported at net asset value based on market prices for the underlying securities as determined by trades for identical or similar securities.

The investment objective of the pooled separate account is to provide a low risk, stable investment offering competitive yields. Pooled separate account investments may be redeemed any time at net asset value. There are no restrictions on redemptions and no unfunded commitments to purchase additional shares for the pooled separate account.

Purchases and sales of securities are recorded on the trade-date basis. Interest income is recorded on the accrual basis. Net appreciation includes gains and losses on investments bought and sold as well as held during the year.

D. Risks and Uncertainties

The Plan provides for various investment options in any combination of investments offered by the Plan. Investments are exposed to various risks, such as interest rate, market fluctuations and credit risks. Due to the risk associated with investments, it is at least reasonably possible that changes in market values, interest rates or other factors in the near term would materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits and statement of changes in net assets available for benefits.

NOTE 3 - INCOME TAX STATUS

The Plan has received an opinion letter dated November 7, 2016 from the Internal Revenue Service which stated that the Plan, as then designed, was in compliance with the applicable requirements of the IRC. The plan administrator believes that the Plan is currently being operated in compliance with the applicable provisions of the IRC. Therefore, no provision for income taxes has been included in the Plan's financial statements.

GAAP requires management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken a tax position that more likely than not would not be sustained upon examination by a tax authority. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

NOTE 4 - PLAN TERMINATION

Although it has not expressed an intent to do so, the Company has the right under the Plan to discontinue its contributions subject to the provisions of ERISA. In the event of Plan termination, participants will be 100% vested in their accounts and Plan assets will be distributed based upon the participants' account balances at the time.

NOTE 5 - FINANCIAL INFORMATION CERTIFIED BY THE TRUSTEES

The plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Information

regarding investments held at December 31, 2024 and 2023, and investment income for the year ended December 31, 2024 that is disclosed in the accompanying financial statements and supplemental schedule were obtained or derived from information supplied to the plan administrator and certified as complete and accurate by Fidelity Management Trust Company and John Hancock Trust Company LLC, trustees of the Plan.

NOTE 6 - RELATED PARTY TRANSACTIONS

Certain Plan investments are issued or managed by the trustee or its affiliates. Transactions in these investments, while considered party-in-interest transactions under ERISA regulations, are permitted under provisions of the Plan and are specifically exempt from the prohibitions of party-in-interest transactions under ERISA.

NOTE 7 - SUBSEQUENT EVENTS

Management has evaluated subsequent events through October 10, 2025, the date on which the financial statements were available to be issued. There were no material subsequent events that required recognition or additional disclosure in these financial statements.
