Note 1 – Description of the Plan

S&H Farm Supply (the “Company”) sponsors an employee savings and retirement plan. The following description of the S&H Farm Supply Employee Savings and Retirement Plan (the “Plan”) provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan's provisions.

A. General

The Plan is a defined contribution plan covering substantially all full-time and part-time employees of the Company age 18 and older effective the first day of the Plan year quarter following three (3) months of employment. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”).

B. Contributions

Elective Contributions - Each year, participants may contribute, pretax, up to a specified dollar amount determined by the Internal Revenue Service, as defined in the Plan. The participants can elect a percentage or specified amount in addition to excess employer benefits.

Employer Matching Contributions – The Company matching contribution is a fixed amount equal to 25% of the participant salary deferrals that do not exceed 3% of compensation. The Company contributed a match amount of \$327,214 for 2024.

C. Participant Accounts

Each participant's account is credited with the participant's contributions and Company matching contributions, as well as Plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

D. Vesting of Benefits

Participants are vested immediately in their contributions plus actual earnings thereon. Vesting in the Company's contribution of their portion of their accounts is based upon a graduated scale where the Company contributions become fully vested in five years. Upon termination of employment and participation in the Plan, participants are entitled to receive the amounts they contributed and any vested contributions plus the interest that has been credited to their account.

E. Payment of Benefits

On termination of service due to death, disability, retirement or other reasons, a participant may receive a lump sum amount equal to the value of the participant's vested interest in his or her account.

F. Forfeitures

At December 31, 2024 and 2023, forfeited non-vested accounts totaled \$37,052 and \$294, respectively. These amounts will be used to pay administrative fees or reduce future employer contributions.

Note 2 – Summary of Significant Accounting Policies

A. *Basis of Presentation*

The financial statements of the Plan are prepared on the accrual basis of accounting.

Investment contracts held by a defined contribution plan that are fully benefit responsive are required to be reported at contract value because contract value is the amount participants would receive if they were to initiate permitted transactions under the terms of the plan. The statement of changes in net assets available for benefits is prepared using the contract value basis for fully benefit-responsive investment contracts.

B. *Use of Estimates*

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

C. *Investment Valuation and Income Recognition*

Investments are reported at fair value (except for fully benefit-responsive investment contracts, which are reported at contract value). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Investment Committee determines the Plan's valuation policies utilizing information provided by the investment advisors, custodians and insurance company. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends, if applicable, are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

D. *Excess Contributions Payable*

Amounts payable to participants for contributions in excess of amounts allowed by the IRS are recorded as a liability with a corresponding reduction to contributions.

E. *Payment of Benefits*

Benefits are recorded when paid.

F. *Expenses*

Certain expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements.

G. *Subsequent Events*

The Plan has evaluated subsequent events through October 14, 2025, the date the financial statements were available to be issued.

Note 4 – Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted price in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical liabilities in active markets that the Plan has the ability to access.

Level 2 Inputs to the valuation methodology include:

- quoted prices for similar assets or liabilities in active markets
- quoted prices for identical or similar assets or liabilities in inactive markets
- inputs other than quoted prices that are observable for the asset or liability
- inputs that are derived principally from or corroborated by observable market data by correlation or other means

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Pooled separate accounts: Valued at the Net Asset Value (NAV), as provided by the insurance company who holds the pooled separate account. These funds are considered open-ended mutual funds, meaning that the fund is ready to redeem its shares at any time and offers its shares for sale to the public. These funds are required to publish their daily NAV and transact at that price. The NAV is based on the fair value of the underlying investments held by the fund less its liabilities.

Changes in Fair Value of Level 3 Assets

Amounts are held in Nationwide Life Insurance Company's general account and are credited on a net daily basis at annual effective rates. This contract is not fully benefit responsive and contract value approximates fair value. The fair market value is equal to the contract value less any Contingent Deferred Sales Charge (CDSC), if applicable, and Market Value Adjustment.

The availability of observable market data is monitored to assess the appropriate classification of financial instruments within the fair value hierarchy. Changes in economic conditions or model-based valuation techniques may require the transfer of financial instruments from one fair value level to another. The Plan evaluates the significance of transfers between levels based upon the nature of the financial instrument and the size of the transfer relative to total net assets available for benefits.

Note 5 – Related-Party Transactions and Party in Interest Transactions

The Plan invests in certain pooled separate accounts and a guaranteed investment contract managed by Nationwide, the Plan's trustee and, therefore, these transactions qualify as exempt party in interest transactions. Fees incurred by the plan for the investment management, recordkeeping and audit services are charged to the plan participants on a pro rata basis. The Plan Sponsor pays directly any other fees related to the plan's operations. Certain fees of administering the Plan are paid to the Trustee by the Plan. These transactions qualify as exempt party-in-interest transactions.

Note 6 - Termination of the Plan

Although the Company has not expressed any intention to do so, it has the right to discontinue its contributions at any time and to terminate the Plan subject to the provisions set forth in the Plan and under ERISA. In the event that the Plan should be terminated, all remaining Plan assets shall be allocated to the participants as described in the full text of the Plan.

Note 7 - Tax Status

The Plan is using a prototype plan dated May 1, 2002 and filed certification of Intent to Adopt a Pre-Approved Plan on January 31, 2007. The prototype plan most recently received an opinion letter on June 30, 2020 in which the Internal Revenue Service stated that the form of the Plan document was acceptable under the applicable requirements of the Internal Revenue Code. The Plan has been amended since that letter. However, the Plan administrator and the Plan's tax counsel believe that the prototype plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code. Therefore, no provision for income tax has been included in the Plan's financial statements.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the plan and recognize a tax liability if the plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan administrator believes it is no longer subject to income tax examinations for years prior to 2021.

Note 8 – Risks and Uncertainties
