Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of Kent Security Services, Inc. and Kent Security of Palm Beach, Inc. 401(k) Retirement Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section—

NOTE 1 – DESCRIPTION OF PLAN

The following description of the Kent Security Services, Inc. and Kent Security of Palm Beach, Inc. 401(k) Retirement Plan (the Plan) provides only general information. Participants should refer to the plan document for a more complete description of the Plan's provisions.

General and Eligibility

The Plan was established on January 1, 1998 as a defined contribution plan available to eligible employees of Kent Security Services, Inc., Kent Security of Palm Beach, Inc. and their affiliated companies (collectively, the "Company", "Plan Sponsor" or "Employer"). The Plan has been amended and restated over the years to comply with certain tax legislation. Eligible employees may enter the plan semi-annually after completing six months of credited service and reaching the age of 21 years old, as defined in the Plan document.

John Hancock Life Insurance Company (USA) (the Custodian) serves as the custodian of the Plan, holds the Plan's investment assets, and executes investment transactions. The Company is the plan administrator and is responsible for the operation of the Plans investment offerings and monitors investment performance.

The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Contributions

Each year, participants may voluntarily contribute up to 100% of their eligible annual compensation, as defined in the Plan, within the limits prescribed by the Internal Revenue Service (IRS). For the year ended December 31, 2024, individual participant contributions were limited to \$23,000. Participants who have attained age 50 before the end of the Plan year are eligible to make catch up contributions up to \$7,500 for the year ended December 31, 2024. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans (roll over).

The Company makes a safe harbor matching contribution which is equal to 100% of a participant's contributions up to 4% of the participants eligible compensation, as defined. For the year ended December 31, 2024, the Company's safe harbor matching contributions totaled \$214,530. The Company may make additional discretionary and profit-sharing contributions to the Plan. No such discretionary or profit-sharing contributions were made during the year ended December 31, 2024. Participants are eligible for the company's safe harbor, discretionary or profit-sharing contributions after meeting the eligibility requirements to participate in the plan. All employer contributions are invested in funds in accordance with the participants discretion and the plans provisions. Contributions are subject to certain IRS limitations.

Participant Accounts

Each participant account is credited with the participants' contributions plus actual earnings thereon and (a) the Employer's contributions and, (b) Plan earnings or losses thereon. Participants are charged with his or her withdrawals and all allocation of administrative expenses. Allocations are based on the participant earnings or losses, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. All participant contributions are participant directed and may be invested into various investment options offered by the Plan.

Vesting

Participants are immediately vested in their contributions and the Employer's safe harbor contributions, plus actual earning or losses thereon. Vesting in the Employer's discretionary and profit-sharing contributions, plus earnings or losses thereon, is based upon the number of years of credited services.

A participant is 100% vested after six years of credited service over a six-year graded vesting schedule. Regardless of years of service, participants are 100% vested upon reaching normal retirement age (65), becoming disabled, or upon death or termination of the Plan.

Forfeitures

Forfeited nonvested accounts may be used to reduce future Employer contributions or to offset Plan expenses. For the year ended December 31, 2024, there were no forfeitures used to reduce Employer contributions or to offset Plan administrative expenses. As of both December 31, 2024 and 2023, available forfeited non-vested accounts totaled \$0 and \$151, respectively.

NOTE 1 – DESCRIPTION OF PLAN (Continued)

Participant Notes Receivable

Plan participants may borrow from their accounts a minimum of \$1,000 and up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. Loans are secured by the vested account balance in the participant's account, and bear interest at the prime rate plus 2%, determined as of the date of the loan request. A participant may only have one (1) loan outstanding at any time. Principal and interest are paid ratably through regular payroll deductions. All loans are required to be repaid within a period of five years, except loans to acquire the participant's principal residence which must be repaid in a reasonable period of time, not to exceed thirty years.

Payment of Benefits

Upon termination of service due to death, disability, or normal retirement age (65), a participant may elect to receive an amount equal to the value of the participants vested interest in his or her account in a lump sum distribution, or monthly installments. For termination of service due to other reasons, a participant may choose to leave the vested interest in the plan if such amounts exceed \$5,000 or elect a lump sum distribution. Participants vested amounts less than \$5,000 must elect a lump sum distribution. Participants may take in-service withdrawals upon attainment of age 59 1/2 or the immediate and heavy financial hardship needs, as defined in the Plan document.

Administrative Expenses

The Plan allows certain administrative expenses to be paid from Plan assets. Certain administrative expenses are paid by the Plan Sponsor and not reflected in these financial statements.

NOTE 2 – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The financial statements of the Plan are prepared using the accrual basis of accounting in conformity with accounting principles generally accepted in the United States of America (U.S. GAAP).

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Plan management determines the Plan's valuation policies utilizing information provided by the investment advisor and the Custodian.

Interest income is recognized when earned. Dividends are recorded on the ex-dividend date. Purchases and sales of securities are recorded on a trade-date basis. Net appreciation includes the Plan's gains and losses on the investments bought and sold, as well as held during the year.

Use of Estimates

The preparation of financial statements in conformity with U.S. GAAP requires Plan management to make estimates and assumptions that affect certain reported amounts of assets and liabilities and changes in net assets and disclosure of contingent assets and liabilities. Actual results could differ from those estimates and those differences could be material.

Risks and Uncertainties

The Plan provides for various investment options. Investment securities are exposed to various risks, such as interest rate risk, market risk, liquidity risk, and credit risk. Due to the level of risk associated with certain investment securities and the level of uncertainty related to changes in the value of investment securities, it is at least reasonably possible that changes in risks in the near term would materially affect participants account balances and the amounts reported in the financial statements.

Payment of Benefits

The Plan records benefits when paid.

Plan Administration

The Company is the Plan Administrator, and as such, controls and manages the operations of the Plan. The Plan's investment assets are maintained by the Custodian as of and for the year ended December 31, 2024. The Custodian invests cash received, interest and dividend income, and makes distributions to participants (subject to the direction of the participants). Aimpoint Pension, LLC provides third-party administrative services the Plan. The Plan allows certain administrative expenses to be paid from Plan investment assets.

Uncertain Tax Positions

U.S. GAAP requires the Plan to assess its uncertain tax positions for the likelihood they would be overturned upon examination by the IRS. In accordance with this guidance, the Plan's management has determined it does not have any positions at December 31, 2024 that it would be unable to substantiate.

Subsequent Events

The Plan has evaluated subsequent events through October 7, 2025, the date the financial statements were available to be issued.

NOTE 3 – INVESTMENT INFORMATION CERTIFIED BY THE CUSTODIAN

The Plan Administrator has elected the method of annual reporting compliance permitted by ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520 103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, the Custodian has certified that the following investment information included in the accompanying financial statements and ERISA-required supplemental schedule is complete and accurate:

- Investments and participant notes receivable as shown on the statements of net assets available for benefits as of December 31, 2024 and 2023.
- Net investment activity and interest income on participant notes receivable as shown in the statement of changes in net assets available for benefits for the year ended December 31, 2024; and
- Investment information included in the schedule of assets (held at end of year) as of December 31, 2024, as shown on the ERISA-required supplemental schedule.

The Plan's independent auditors did not perform auditing procedures with respect to this certified information, except for comparing such certifies information to the related investment information included in the financial statements and ERISA-required supplemental schedule.

NOTE 4 – FAIR VALUE MEASUREMENTS

Accounting guidance provides a framework for measuring fair value and provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements).

The three levels of the fair value hierarchy are described as follows:

Level 1 – Unqualified quoted prices for identical, unrestricted assets or liabilities in active markets that a plan has the ability to access.

Level 2 – Quoted prices for similar assets or liabilities in active markets; quoted prices for identical or similar assets or liabilities in inactive markets; inputs other than quoted prices that are observable for the assets or liability; and inputs that are derived principally from or corroborated by observable market data by correlation or other means for sustainability the full term of the assets or liabilities.

Level 3 – Significant unobservable inputs.

A financial instruments level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Evaluation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs. There have been no changes in the methodology used at December 31, 2024 and 2023. During the year ended December 31, 2024, there were no transfers of financial instruments into or out of Level 3.

The following is a description of the valuation methodology used for assets measured at fair value:

Pooled separate accounts - valued based upon the units of such pooled separate accounts held by the Plan at year end multiplied by their respective value. The unit values of the pooled separate accounts are based upon significant observable inputs, but are not based upon quoted market prices in an inactive market and are therefore considered Level 2 investments within the fair value hierarchy.

The preceding method described may produce a fair value calculation that may not be indicative of the net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

NOTE 5 – PARTY-IN-INTEREST TRANSACTIONS

Parties-in-interest are defined under the DOL Regulations as any fiduciary of the Plan, any party rendering service to the Plan, the Employer and certain others. The Plan's investments consist of pooled separate accounts that are maintained, and managed, and/or issued by the Custodian. John Hancock Retirement Services (JHRS), an affiliate of the Custodian is the Plan's recordkeeper. Therefore, transactions with the Custodian and JHRS qualify as party-in-interest transactions.

Certain administrative functions are performed by officers and employees of the Plan Sponsor. No officer or employee received compensation from the Plan for these services.

The Plan contracted with Aimpoint Pension, LLC for third-party administrative services. The Plan compensates Aimpoint Pension, LLC directly for such services which is included in administrative expenses for the year ended December 31, 2024 in the accompanying statement of changes in net assets available for benefits.

NOTE 6 – FIDELITY BOND

The Plan has complied with the fidelity bonding requirement of ERISA.

NOTE 7 – PLAN TERMINATION

Although it has not expressed an intent to do so, the Plan Sponsor has the right under the Plan to discontinue its contribution to anytime and to determine the Plan subject to the provisions of the visa. In the event of plan termination, participants will become 100% vest in the employer contribution portion of their accounts.

NOTE 8 – TAX STATUS

On March 31, 2014, the IRS stated that the volume submitter profit-sharing plan with CODA adopted by the Plan, as the designed, qualifies under the Section 401(a) of the Internal Revenue Code (IRC) and therefore, the Plan and its related trust are tax-exempt. Accordingly, the Plan is required to operate in accordance with the IRC to maintain its qualification. The Plan has not received a determination letter, however, the Plan Administrator and the Plan's tax counsel believe that the Plan is being operated in compliance with the applicable requirements of the IRC. Further, as of the date of this report the Plan has not completed required testing of its employees' compensation on an annual basis in accordance with the IRC in order to maintain its qualified status. The Plan Administrator has indicated that it will take the necessary steps to bring the Plan's operations into compliance with the IRC. Therefore, no provision for income taxes has been included in the Plan's financial statements.

The Plan is subject to routing audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan Administrators believe it is no longer subject to income tax examinations for years prior to 2021.
