Independent Auditors' Report

To the Participants and Plan Administrator of
PPL Employee Group Health and Insurance Plan

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of PPL Employee Group Health and Insurance Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits (modified cash basis) as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits (modified cash basis) for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 4 to the financial statements, is complete and accurate.

Opinion

Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations or the override of internal control. Such procedures include examining, on a test basis, evidence regarding the amounts and disclosures in the financial statements.
- Obtain an understanding of internal control relevant to the audit in order to design audit procedures that are appropriate in the circumstances, but not for the purpose of expressing an opinion on the effectiveness of the Plan's internal control. Accordingly, no such opinion is expressed.
- Evaluate the appropriateness of accounting policies used and the reasonableness of significant accounting estimates made by management, as well as evaluate the overall presentation of the financial statements.
- Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for a reasonable period of time.

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of modified cash basis of accounting.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with the modified cash basis described in Note 2.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings and certain internal control-related matters that we identified during the audit.

Other Matter - Supplemental Schedules Required by ERISA

The supplemental schedules, Schedule H, Line 4(i) - Schedule of Assets (Held at End of Year) as of December 31, 2024, and Schedule H, Line 4(j) - Schedule of Reportable Transactions for the year ended December 31, 2024, are presented for purposes of additional analysis and are not a required part of the financial statements but are supplementary information required by the DOL's Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedules, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audits of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS. For information included in the supplemental schedules that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedules, we evaluated whether the supplemental schedules, other than the information agreed to or derived from the certified investment information, including their form and content, are presented in conformity with the DOL's Rules and Regulations for Reporting and Disclosure under ERISA.

In our opinion:

- The form and content of the supplemental schedules, other than the information in the supplemental schedules that agreed to or is derived from the certified investment information, are presented, in all material respects, in conformity with the DOL's Rules and Regulations for Reporting and Disclosure under ERISA.
- The information in the supplemental schedules related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

1. PLAN DESCRIPTION

The PPL Employee Group Health and Insurance Plan ("Plan") is a health and welfare plan sponsored and administered by PPL Services Corporation (the "Company"), an unregulated subsidiary of PPL Corporation. The Plan provides benefits to active employees of the Company, PPL Electric Utilities Corporation, PPL Strategic Development LLC (collectively, "PPL") and beginning January 1, 2024, Kentucky Utilities Company, Louisville Gas and Electric Company, and LG&E and KU Services Company (collectively, "LKE"), (all, collectively, the "Participating Companies"). Full-time salaried employees of the Participating Companies are eligible to participate in the Plan on their date of hire. Part-time employees of PPL and employees of PPL who are represented by the International Brotherhood of Electric Workers Local 1600 are eligible to participate in the Plan 30 days after their date of hire, subject to meeting eligibility requirements. Part-time employees of LKE and employees of LKE who are represented by the International Brotherhood of Electric Workers Local 2100 or by the United Steel, Paper and Forestry, Rubber, Manufacturing, Energy, Allied Industrial and Service Workers International Union are eligible to participate in the Plan on their date of hire.

In addition, the Company assumed the obligation to provide health care and life insurance coverage to retirees that had been covered under the PPL Montana Retiree Health Plan as of June 1, 2015 as part of the agreement related to the 2015 corporate realignment to spin off PPL's Energy Supply business. These benefits have been and will continue to be paid from the general assets of the Company, and are reflected as employer contributions in these financial statements. The benefit obligation of \$1.0 million at December 31, 2024 was based on a discount rate of 5.92% and the benefit obligation of \$1.1 million at December 31, 2023 was based on a discount rate of 5.57%.

The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended ("ERISA"). The following description of the Plan provides only general information. Although the Company intends to sponsor the Plan for an indefinite period, the Company has the right to amend or terminate the Plan at any time. Participants should refer to the Summary Plan Description and/or the Plan document for a more complete description of the Plan provisions.

Benefits

The Plan provides the following benefits to participants and their eligible dependents:

Health benefits: Medical and prescription drug benefits are self-insured and provided through contracts between Participating Companies and third party administrators. Plan participants can choose between various levels of coverage to manage their health care costs, including a PPO and a High Deductible Health Plan with an employer contribution into an employee Health Savings Account. Employee contributions are a percentage of the total cost set by the Company based on the medical plan selected and the level of coverage chosen. Eligible plan participants are also able to receive services at on-site health clinics, which provide primary care services.

Dental benefits: Dental benefits are self-insured and provided through contracts between Participating Companies and third-party administrators. Plan participants can choose between various levels of coverage to manage their dental care costs. Employee contributions are a

percentage of the total cost set by the Company based on the dental plan selected and the level of coverage chosen.

Vision benefits: Vision benefits are provided through an insurance contract between Participating Companies and insurers. Plan participants can choose between various levels of coverage. Employee contributions are the total cost of the plan based on the level of coverage chosen.

Life insurance benefits: Basic life insurance benefits are provided to participants through an insurance contract with Metropolitan Life Insurance Company. The amount of a participant's coverage depends, in part, on their employment status. Eligible employees may also elect to purchase supplemental coverage on themselves and their eligible dependents under the Plan.

Long-term disability: Participants eligible for long-term disability receive benefits through an insurance contract with Lincoln. The Participating Companies pay for the full cost of coverage. For a certain period of time, participants may also be eligible to receive continued medical, dental and life insurance coverage under the Plan.

Supplemental individual disability insurance: Eligible non-union employees, generally those classified in job categories of manager and above, may elect supplemental individual disability insurance coverage to supplement the long-term disability benefits offered under the Plan. Employees electing this benefit pay the full cost of coverage

Accidental death & dismemberment: Accidental death & dismemberment benefits are provided to eligible participants through an insurance contract with Metropolitan Life Insurance Company. The Participating Companies pay for the full cost of coverage.

Severance benefits: Participating Companies may provide benefits to eligible non-union employees who are separated from service for a specified reason.

Voluntary benefits: Voluntary Legal, Accidental, Hospital Indemnity, and Critical Illness Insurance are available to participants under the Plan. Employees electing any of these benefits pay the full cost of coverage.

Contributions

Employee contributions for elected benefits are deducted from the employee's bi-weekly payroll. Employees on leave of absence are billed directly for their coverage under the Plan. Employee contributions are retained by the appropriate Participating Company and offset the Plan costs paid by that company.

Employer contributions represent the claims payments, administrative fees, insurance premiums and severance payments that are paid directly by the Participating Companies, after offset by any employee contributions.

Plan Funding

In October of 2017, the Company submitted a request for a private letter ruling from the Internal Revenue Service (“IRS”) to move excess funds from a PPL Bargaining Unit Retiree Health Plan Voluntary Employee Benefit Association (“VEBA”) trust held by The Bank of New York Mellon Corporation (the “Trustee”), to a new VEBA subaccount to pay for covered health care claims of active bargaining unit employees (“Subaccount”). The Subaccount is intended to qualify as a tax-exempt trust under Section 501(c)(9) of the Internal Revenue Code (“Code”). A favorable ruling was received from the IRS in May of 2018. In June of 2018, \$65 million was transferred from the VEBA to the Subaccount. Additionally, in October 2024, an additional \$13 million was transferred from the VEBA to the Subaccount. The Subaccount is restricted to the payment of health care benefits provided under the Plan to active employees who are members of the International Brotherhood of Electric Workers Local 1600.

The transfers of assets to the Subaccount resulted in the funded status of the Plan and the requirement to prepare these audited financial statements for all Plan activity, until those funds are exhausted.

Employee contributions made by members of the International Brotherhood of Electric Workers Local 1600 for health care are deducted from their gross claims cost to determine the net amount to be reimbursed from the Subaccount.

Administrative Expenses

The Plan pays certain administrative expenses that consist primarily of administrative fees paid to third-party claims administrators, consultants, the plan auditor, trustee and actuary. Those expenses paid by the Plan are reported on the Statement of Changes in Net Assets Available for Benefits - Modified Cash Basis as administrative expenses. Other administrative expenses not paid by the Plan are paid by the Participating Companies on behalf of the Plan. Certain administrative functions are performed by employees of the Participating Companies. No such employee receives compensation from the Plan.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

The accompanying financial statements have been prepared on the modified cash basis of accounting. Claims incurred, but not reported are not included in the financial statements. All activity of the Plan, including employee contributions, vendor payments and investment activity is recorded as received or paid from the Subaccount for Bargaining Unit employees, or from the general assets of the Participating Companies in regard to salaried employees and for former PPL Montana Retirees from general assets of the Company.

Postretirement benefits include future benefits expected to be paid to or for currently retired participants and their dependents. Postretirement benefit obligations represent the actuarial present value of those estimated future benefits that are attributable to employee service rendered to the valuation date. See Note 1 for additional information on benefits offered by the Plan.

The actuarial present value of the expected postretirement benefit obligations for the PPL Montana Retirees is determined by an actuary and is the amount that results from applying actuarial assumptions to historical claims-cost data to estimate future annual incurred claims costs per participant and to adjust such estimates for the time value of money (through discounts for interest) and the probability of payment (by means of decrements such as those for death, disability, withdrawal, or retirement) between the valuation date and the expected date of payment, and to reflect the portion of those costs expected to be paid by Medicare, the retired participants, and providers.

The foregoing assumptions are based on the presumption that the Plan will continue. Were the Plan to terminate, different actuarial assumptions and other factors might be applicable in determining the actuarial present value of the postretirement benefit obligation.

For the following disclosures, dollar amounts are presented in thousands.

The preparation of financial statements requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities, benefit obligations and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

The Plan's investments are reported at fair value as discussed in Note 3. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date.

Purchases and sales of securities are recorded on a trade-date basis. Investment income is recorded on the accrual basis. Investment income (loss) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Pharmacy rebates totaling \$6,484 have been netted with Health care benefit payments, net in the accompanying Statements of Changes in Net Assets Available for Benefits for the year ended December 31, 2024.

The SECURE 2.0 Act of 2022 was signed into law on December 29, 2022. This legislation includes a vast array of provisional changes to retirement plans, becoming effective in 2023 and beyond. Plan management adopted mandatory provisions effective for the year ended December 31, 2024, and continues to evaluate the impact of the adoption and implementation of this legislation on the Plan. The application of SECURE 2.0 Act did not have a material effect on the Plan's financial statements.

Subsequent Events

The Plan has evaluated subsequent events through October 14, 2025, the date the financial statements were available to be issued.

3. FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy are described as follows:

Level 1 - Inputs to the valuation methodology are unadjusted quoted market prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs other than quoted prices included within Level 1 that are observable for the asset or liability, either directly or indirectly, such as:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement. Management believes such inputs are predicated on the assumptions market participants would use to measure the asset or liability at fair value.

(a) In accordance with accounting guidance certain investments that are measured at fair value using the Net Asset Value per share ("NAV") or its equivalent, practical expedient have not been classified in the fair value hierarchy. The fair value amounts presented in the table are intended to permit reconciliation of the fair value hierarchy to the amounts presented in the Statements of Net Assets Available for Benefits - Modified Cash Basis.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

The commingled equity index and debt index funds are valued at the NAV of units of a bank collective trust. The NAV, as provided by the Trustee, is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund less its liabilities. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV. Transactions (purchases and sales) may occur daily. There are no redemption restrictions for these commingled funds.

Investments in money market funds represent investments in funds that invest primarily in a diversified portfolio of investment grade money market instruments, including, but not limited to, commercial paper, repurchase agreements and other evidences of indebtedness with a maturity not exceeding 13 months from the date of purchase. The primary objective of the funds is a high level of current income consistent with stability of principal and liquidity. Valuation is based on quoted prices in an active market. Redemptions can be made daily on this fund.

4. INFORMATION CERTIFIED BY TRUSTEE

The Company has elected the method of compliance as permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA for 2024 and 2023. Accordingly, the Trustee of the Plan has certified to the completeness and accuracy of all investments reported in the accompanying Statements of Net Assets Available for Benefits - Modified Cash Basis as of December 31, 2024 and 2023 and the supplemental Schedule H, Line 4(i) - Schedule of Assets (Held at End of Year) as of December 31, 2024, and the related investment activity reported in the Statement of Changes in Net Assets Available for Benefits - Modified Cash Basis and Schedule H Line 4(j) - Schedule of Reportable Transactions for the year ended December 31, 2024. Such information was obtained by management and agreed to or derived from information certified as complete and accurate by a qualified institution.

5. TAX STATUS

The trust established under the Plan to hold the Plan's assets is qualified pursuant to Section 501(c)(9) of the Code, and accordingly, the trust's net investment income is exempt from income taxes. The Plan has obtained a favorable tax ruling from the IRS, and the Plan's internal legal counsel and the Company believe that the Plan, as amended, continues to comply with the applicable requirements of the Code, and the Company believes the Plan is currently operated in accordance with applicable provisions of the Code.

Accounting principles generally accepted in the United States of America require management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

6. PARTY-IN-INTEREST TRANSACTIONS

Certain Plan investments are shares of commingled funds managed by Mellon Capital Management, which is an affiliate of the Trustee. Transactions in these investments qualify as party-in-interest transactions which are exempt from the prohibited transactions rule.

7. RISK AND UNCERTAINTIES

Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Market risks include global events, such as a pandemic, or international conflict, which could impact the value of investment securities. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and such changes could materially affect the amounts reported in the Statements of Net Assets Available for Benefits - Modified Cash Basis.

At December 31, 2024 and 2023, the Plan had investments of \$17,918 and \$16,712, that were concentrated in two Mellon Capital Management commingled funds.
