Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of Whitehouse Post Productions, LLC 401(k) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for plan benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for plan benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Note 1- Description of Plan:

The following description of the Whitehouse Post Productions, LLC 401(k) Plan (“Plan”) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan’s provisions.

General

The Plan is a defined contribution plan covering all employees of the Company (except those who are members of a collective bargaining unit, a leased employee, or a nonresident alien) who are at least twenty-one years of age and participate in the month after the date of employment. If you are a Special Employee of the employer, you must have reached twenty-one years of age, and completed 1,000 hours of service in your first year of service to be eligible to participate in the Plan. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Board of Trustees is responsible for the oversight of the Plan, and determines the appropriateness of the Plan’s investment offerings, monitors investment performance, and reports to the Plan’s Board of Trustees.

The Company includes all companies under common control or part of an affiliated service group with Whitehouse Post Productions, LLC.

Contributions

The annual additions paid to a participant’s account cannot exceed the lesser of 100% of the participant’s compensation or \$69,000 for the year 2024. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans. Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan currently offers twenty-eight investment funds as investment options for participants. The Company may provide an annual discretionary contribution to the Plan at the option of the board of directors. Discretionary contributions are invested as directed by the individual participant.

For discretionary matching contributions there is not a minimum requirement for this contribution to be made. For profit sharing contributions, an employee must be employed on the last day of the Plan year and complete more than 500 hours of service during the Plan year. An annual matching and profit sharing contribution may be contributed at the discretion of the Company. For the year ended December 31, 2024, no matching or discretionary profit sharing contributions were made.

Participant accounts

Each participant’s account is credited with the participant’s contribution and allocations of (a) the Company’s contribution and, (b) Plan earnings. Participant accounts are charged with allocations of administrative expenses that are paid by the Plan. Allocations are based on participant earnings or account balances, as defined. All amounts in a participant’s account are participant directed. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

Note 1- Description of Plan (continued):

Vesting

Participants are immediately vested in their contributions plus actual earnings thereon. Vesting in the Company's contribution portion of their accounts is based on years of continuous service. A participant is 100% vested after five years of credited service. Vesting in Company contributions plus earnings thereon is based on continuous years of service as follows:

Notes receivable from participants

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The notes are secured by the balance in the participant's account and bear interest at a reasonable rate of interest. Note terms may not exceed 5 years, except for notes for the purchase of a participant's primary residence. Principal and interest are paid ratably through monthly payroll deductions. There are no past due or non-accrual notes receivable at December 31, 2024. Interest income on the notes is accrued through year-end and listed at their amortized cost. Notes are measured at their unpaid principal balance plus any accrued but unpaid interest. No allowance for credit losses has been recorded as of December 31, 2024.

Payment of benefits

On termination of service due to death, disability, retirement or other reasons, a participant is entitled to a lump-sum distribution of their total vested interest. There were \$1,134,026 in termination of service benefits as of December 31, 2024. At December 31, 2024, there were no distributions requested by participants and not paid.

Note 2 - Summary of Significant Accounting Policies:

Basis of accounting

The financial statements of the Plan are prepared under the accrual method of accounting.

Plan administration

The Company is the Plan sponsor and the Manager of Human Resources of the Company is the Plan administrator. The Plan administrator is responsible for carrying out the duties imposed under ERISA.

Use of estimates

The preparation of financial statements in conformity with the United States of America generally accepted accounting principles requires the Plan administrator to make estimates and assumptions that affect certain reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Accordingly, actual results may differ from those estimates.

Note 2 - Summary of Significant Accounting Policies (continued):

Parties-In-Interest Expenses

The Plan sponsor incurs the majority of the Plan expenses on behalf of the Plan that include party-in-interest transactions that are not reimbursed by the Plan. Expenses that are paid by the Plan sponsor are excluded from these financial statements. Fees related to the administration of distributions and notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation of fair value of investments. The Plan also pays indirect compensation to service providers that is deducted from investment income.

Investment valuation and income recognition

The Plan's investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's management determines the Plan's valuation policies utilizing information provided by investment advisors, custodians, and insurance company. See Note 7 for a discussion of fair value measurement.

Purchases and sales of securities are recorded on a trade date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date.

Payment of benefits

Benefits are recorded when paid.

Forfeited accounts

Forfeited nonvested accounts totaled \$0 at December 31, 2024, and 2023.

Note 3 - Information Prepared and Certified By Trustee:

The Plan obtained certification on the information in this footnote from Fidelity Management Trust Company that was utilized in these financial statements.

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including investments and notes receivable from participants held at December 31, 2024 and 2023, and net appreciation in fair value of investments, interest and dividends, and interest income on notes receivable from participants for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Fidelity Management Trust Company (the trustee of the Plan).

Note 4 - Plan Termination:

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their employer contributions.

Note 5 - Tax Status:

The Internal Revenue Service has determined and informed the Company by a letter dated June 30, 2020 that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code (IRC). The Plan has been amended since receiving the determination letter. However, the Plan administrator and the Plan's tax counsel believe that the Plan is currently designed and operated in compliance with the applicable requirements of the Internal Revenue Code, and therefore, believe that the Plan is qualified, and the related Trust is tax-exempt.

Note 6 - Subsequent Events:

Management has evaluated subsequent events through October 10, 2025, the date which the financial statements were available to be issued.

Note 7 - Investments and Fair Value Measurements:

The United States of America generally accepted accounting principles establish a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in an active market for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy are described below:

Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 – Inputs to the valuation methodology include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or by other means.

Note 7 - Investments and Fair Value Measurements (continued):

If the asset or liability has a specified contractual term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability’s fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodology used for assets measured at fair value. There have been no changes in methodologies used at December 31, 2024 and 2023:

Mutual Funds: Valued at the fair value of the shares in the mutual funds at net asset value per share at December 31, 2024. These funds are deemed to be actively traded.

The preceding method described may produce a fair value calculation that may not be indicative of the net realizable value or reflective of fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

The Plan intends to provide an appropriate range of asset classes that will reasonably span the risk-and-return spectrum that satisfies the broad range of criteria as established by the U.S. Department of Labor, and that is consistent with the investment needs and abilities of the participants. Investments may be redeemed at the discretion of the participants and have no restrictions on redemption.

Note 10 - Indirect Compensation:

For the year ended December 31, 2024, the Plan paid indirect compensation to third parties other than the custodian. These fees were not more than \$5,000 per provider. Indirect compensation is compensation that a service provider receives from sources other than the Plan directly or from the Plan sponsor in connection with services rendered to the Plan during the Plan year. The Plan also pays recordkeeping and account maintenance fees to the custodian of the Plan.

Note 11 - Uncertain Tax Positions:

Accounting principles generally accepted in the United States of America require the Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the organization has taken an uncertain tax position that more likely than not would be sustained upon examination by federal and state taxing authorities. The Plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of October 10, 2025 there are no uncertain tax positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan has never had unrelated business income tax (UBIT) nor has it had to file the Form 990-T. Therefore, all tax years are open for examination by federal and state taxing authorities related to UBIT.
