Independent Auditor's Report

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Valmark, Inc. Retirement Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the Statements of Net Assets Available for Benefits as of December 31, 2024 and 2023, and the related Statement of Changes in Net Assets Available for Benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in note 3 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audits of the Financial Statements section:

- the amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

- the information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audits of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of these financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for one year after the date the financial statements are available to be issued.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

1. DESCRIPTION OF PLAN

The following description of the Valmark, Inc. Retirement Plan (the Plan) provides only general information. Participants should refer to the Plan Agreement for a more complete description of the Plan's provisions.

a. General

The Plan is a qualified defined contribution plan, established on April 1, 1993. The Plan covers all employees of Valmark, Inc. (the Company).

The Company is also the plan sponsor and the plan administrator.

The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

b. Eligibility

Employees are eligible to participate after reaching the age of 21 and completing one year of service (1,000 hours). Participants may enter the Plan on the first January 1st or July 1st occurring immediately after satisfaction of the eligibility requirements.

c. Contributions

Each year, participants may contribute up to 15% of eligible compensation, as defined in the Plan document. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions.

The Plan has a safe harbor nonelective contribution feature. Under the terms of the safe harbor provisions, the Company contributes 3% of each eligible participant's compensation. During the year ended December 31, 2024, the Company paid or accrued a total of \$250,347 of safe harbor contributions.

At its discretion, the Company may elect to make a discretionary profit sharing contribution. There were no such contributions made for the year ended December 31, 2024.

Participants may also contribute amounts representing distributions from other qualified defined benefit and defined contribution plans (rollover).

Participants direct the investment of their contributions, Company contributions and any related earnings into various investment options offered by the Plan. Participants may change their investment elections and make transfers between investment options on a daily basis.

Contributions are subject to certain Internal Revenue Service (IRS) limitations.

d. Participant accounts

Each participant's account is credited with the participant's contributions, Company contributions, as well as an allocation of the Plan's earnings (losses) and expenses. The allocation of the Plan's earnings or losses is based on each participant's share/unit values. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

e. Vesting

Participants are immediately vested in their salary deferral contributions and safe harbor nonelective contributions plus actual earnings or losses thereon.

Vesting in any Company discretionary profit sharing contributions plus actual earnings or losses thereon is in accordance with the following schedule:

Participant interests in all Company discretionary contributions will become 100% vested upon death, disability, or reaching normal retirement age (65).

f. Notes receivable from participants

Participants may borrow from their account balance a minimum of \$1,000 up to a maximum amount equal to the lesser of \$50,000 or 50% of their vested balance. Loan terms can be up to five years, except loans used to purchase a primary residence can be for extended loan terms. The loans are secured by the balance in the participant's account and bear interest at the prime rate as specified in the Wall Street Journal plus 2%. At December 31, 2024, the range of interest rates on all outstanding loans was 5.25%-10.50%. The Plan requires repayment of the loan obligation through payroll deductions; however, the participant may repay the loan at any time.

g. Payment of benefits

Benefits will be paid to the participants or the participant's beneficiary upon termination of service, death, disability, or retirement.

If the participant's vested account balance is over \$7,000, then the distribution will be paid either as a lump sum cash payment, a direct rollover or in installment payments for required minimum distributions, at the participant's discretion.

g. Payment of benefits, (Continued)

If the participant's vested account balance is under \$7,000 but over \$1,000, then the distribution may be made, either as a lump sum cash payment, or as a direct rollover, as soon as administratively practicable after the participant leaves the Company. If the participant does not respond regarding method of distribution, then the distribution may be rolled into an Individual Retirement Account in the name of the participant regardless of whether the participant consents to receive it.

If the participant's vested account balance is under \$1,000, then the distribution may be made in a lump sum cash payment regardless of whether the participant consents to receive it.

In-service lump sum distributions are available to any participant who has reached age 59 ½.

Participants may also withdraw funds from their account in the event of financial hardship as defined in the Plan document.

h. Forfeited accounts

Forfeitures of terminated participants' nonvested accounts are maintained in a separate account under the Plan. Under the terms of the Plan, forfeitures may be used to pay the Plan's expenses or reduce future employer contributions at the discretion of the Company. Unallocated forfeitures of terminated participants' nonvested accounts totaled \$3,893 and \$3,821 at December 31, 2024 and 2023, respectively. No forfeitures were used during 2024.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

a. Basis of accounting

The financial statements of the Plan are prepared under the accrual basis of accounting.

b. Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

c. Investment valuation and income recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The plan administrator determines the Plan's valuation policies utilizing information provided by the investment adviser and trustee. See note 4 for discussion of fair value measurements.

c. Investment valuation and income recognition, (Continued)

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

d. Notes receivable from participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when incurred. No allowance for credit losses has been recorded as of December 31, 2024 or 2023. If a participant ceases to make loan repayments and the plan administrator deems the participant loan to be in default, the participant loan balance is reduced, and a benefit payment is recorded.

e. Payment of benefits

Benefits are recorded when paid.

f. Administrative expenses

Certain expenses incurred by the Plan are paid by the Company and are excluded from these financial statements. Administrative fees not paid by the Company are charged to participants' accounts and apportioned based upon their relative account values. Transaction based fees are charged directly to participant's accounts.

g. Date of the Plan's review

The Plan has evaluated subsequent events through October 13, 2025, the date the financial statements were available to be issued.

3. TRUSTEE CERTIFICATIONS UNDER ERISA SECTION 103(a)(3)(C)

The plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted under such election, the auditors' examination did not extend to the following information certified by Ascensus Trust Company, the trustee, as complete and accurate:

4. FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3).

The three levels of the fair value hierarchy under Financial Accounting Standards Board Accounting Standards Codification 820 are described as follows:

Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access at the measurement date.

Level 2 Inputs other than quoted prices included within Level 1 that are observable for the asset or liability, either directly or indirectly, such as:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from, or corroborated by, observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs that are unobservable inputs for the asset or liability.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Mutual funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Money market fund: Valued at cost plus accrued interest which approximates fair value.

5. PARTY-IN-INTEREST TRANSACTIONS

Plan investments are held by Ascensus Trust Company, the Plan trustee. Transactions with the trustee are recognized as exempt party-in-interest transactions under ERISA.

For the year ended December 31, 2024, the Plan paid \$21,151 for certain expenses related to plan operations to various service providers. These expenses are recognized as exempt party-in-interest transactions under ERISA.

6. PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants would become 100% vested in any employer discretionary contributions.

7. TAX STATUS

The Plan uses a prototype non-standardized profit-sharing plan that received a favorable opinion letter from the IRS dated June 30, 2020, which stated that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code (IRC). The plan administrator and the Plan's tax counsel believe that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believe that the Plan is qualified, and the related trust is tax-exempt.

7. TAX STATUS, (Continued)

Accounting principles generally accepted in the United States of America require the plan administrator to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any taxing periods in progress.

8. RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances, and the amounts reported in the Statements of Net Assets Available for Benefits.
