## INDEPENDENT AUDITOR'S REPORT

To the Plan Administrator of the  
Mediko P.C. 401(k) Profit Sharing Plan and Trust

### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of Mediko P.C. 401(k) Profit Sharing Plan and Trust (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's ("DOL") Rules and Regulations for Reporting and Disclosure under ERISA. Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the years then ended, stating that the certified investment information, as described in Note 9 to the financial statements, is complete and accurate.

### Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section—

- the amounts and disclosures in the financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States.
- the information in the financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

## **Basis for Opinion**

We conducted our audits in accordance with auditing standards generally accepted in the United States. Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audits. ## **Responsibilities of Management for the Financial Statements**

### Notes to Financial Statements

#### 1. Description of Plan:

The following description of the Mediko P.C. 401(k) Profit Sharing Plan and Trust (the "Plan") provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

**General:** The Plan is a defined contribution plan covering all eligible employees of Mediko, Inc. (the "Company"). Employees become eligible to participate in the Plan immediately, assuming they are the age of 18 or older. Employees become eligible to receive profit sharing contributions on the first day of the month coinciding with or next following the date the employee completes one year of service with at least 500 hours of service. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA").

**Contributions:** The Plan provides for participant contributions of pre-tax and roth contributions of annual compensation, as defined in the Plan. Participants may contribute up to 100% of pre-tax annual compensation. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans, as well as certain individual retirement accounts. The Company may make matching contributions equal to a discretionary percentage of a participant's elective deferrals, to be determined by the Company. The Company may contribute additional amounts at the options of the Company. During 2024, the Company contributed up to 4% of the participant's compensation. The Company did not make matching contributions in 2023. No discretionary employer contributions were remitted to the Plan in 2024 or 2023. No correcting contributions were made by the Plan Sponsor during 2024. Correcting contributions of \$2,384 were made by the Plan Sponsor during 2023. Contributions are subject to certain limitations. Participants of qualifying age may make additional "catch-up" contributions, subject to certain limitations.

**Participant Accounts:** Each participant's account is credited with the participant's contributions and allocations of (a) the Company's contributions and (b) Plan earnings or losses and charged with an allocation of administrative expenses. Allocations are based on participant compensation or account balances, as defined by the Plan. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

**Investment Options:** Participants direct Empower Trust Company, LLC ("Empower"), the ("Trustee"), as to the investment of their account balances in accordance with guidelines established by the Plan. Participants may change their investment elections at any time. Investments which are invested in one of the Trustee's investment options are described herein as "Participant-Directed." Investments which are invested outside of the Trustee's investment options are described as "Self-Directed."

### Notes to Financial Statements, Continued

#### 1. Description of Plan, Continued:

**Vesting:** Participants are immediately vested in their contributions, plus actual earnings thereon. Vesting in the Company's contributions is based on years of continuous service. Participants are fully vested in employer matching contributions after attaining two years of credited service. Participants are fully vested in Company discretionary contributions after attaining six years of credited service.

**Notes Receivable from Participants:** Participants may borrow from their Plan accounts a minimum of \$1,000 up to a maximum amount equal to the lesser of \$50,000 or 50% of their vested account balance. Loan terms cannot exceed four and a half years, unless the proceeds are used to acquire a principal residence. The loans are secured by the vested balance in the participant's account and bear interest at rates commensurate with the bank prime rate plus 1% as determined by the U.S. Federal Reserve on the last business day of a calendar quarter. Principal and interest are paid ratably through payroll deductions. Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Only one outstanding loan is allowed per participant at any one time. Delinquent notes receivable from participants deemed to be in default by the Plan Administrator, are reclassified as distributions based upon the terms of the Plan document.

**Payment of Benefits:** Distribution of the vested portion of a participant's account will occur upon the participant's termination of service, retirement, death, or disability or hardship withdrawal, as defined in the Plan. A participant is entitled to receive a lump-sum payment in an amount equal to the vested value of his or her account.

**Plan Administration:** Overall responsibility for administering the Plan rests with the Company. Participant accounts are administered by Empower, which serves as the Trustee of the Plan.

**Forfeitures:** Forfeited balances of terminated participants' non-vested accounts are applied to pay administrative expenses or to reduce future Company contributions. Forfeited balances available were \$3,325 and \$1,641 at December 31, 2024 and 2023, respectively. Forfeitures applied to pay administrative expenses were \$1,658 during 2024. No forfeitures were applied to pay administrative expenses or to reduce future Company contributions during 2023. Additions to forfeited balances available were \$3,342 and \$26 during 2024 and 2023, respectively.

#### 2. Summary of Significant Accounting Policies:

**Basis of Accounting:** The financial statements of the Plan are prepared on the accrual basis of accounting.

#### 2. Summary of Significant Accounting Policies, Continued:

**Investment Valuation and Income Recognition:** Investments in cash and cash equivalents, money markets, mutual funds, common stocks, and pooled separate accounts are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 for discussion of fair value measurements. Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) in the fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

**Payment of Benefits:** Benefits are recorded when paid.

**Use of Estimates:** The preparation of financial statements in conformity with accounting principles generally accepted in the United States requires the plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Actual results could differ from those estimates.

**Subsequent Events:** Management has evaluated subsequent events through October 9, 2025, the date the financial statements were available to be issued and has determined that there are no subsequent events to be reported in the accompanying financial statements.

#### 3. Fair Value Measurements:

The Financial Accounting Standards Board ("FASB") has issued guidance for measurement and disclosure of fair value and established a three-tier fair value hierarchy, which prioritizes the inputs used in measuring fair value as follows:

- Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.
- Level 2 Inputs to the valuation methodology are quoted prices for similar instruments in active and inactive markets; and model driven valuations with significant inputs and drivers derived from observable active markets.
- Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

### Notes to Financial Statements, Continued

#### 3. Fair Value Measurements, Continued:

Valuation techniques used should maximize the use of observable inputs and minimize the use of unobservable inputs. The following is a description of the valuation methodologies used for investments carried or disclosed at fair value:

**Cash and cash equivalents:** Valued at cost, which approximates fair value.

**Money market fund:** Valued at cost, which approximates fair value.

**Mutual funds:** Valued at the daily closing price reported by the fund. Mutual funds held by the Plan are open-ended mutual funds that are registered with the Securities and Exchange Commission ("SEC"). These funds are required to publish their daily net assets value ("NAV") and to transact at that price.

**Corporate stocks:** Valued at the daily closing price reported on the active market on which the individual securities are traded.

**Fixed income:** Government and commercial bonds are valued using a market approach on yields currently available on comparable securities of issuers with similar credit ratings.

**Pooled separate accounts:** Unit value calculated based on the net assets or the observable Net Asset Value ("NAV") of the underlying pool of securities or investments. The NAV is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund less liabilities. This practical expedient is not used when it is determinable to be probable that the fund will sell the investment for an amount different than the reported NAV.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date. There were no Level 3 assets or liabilities in the Plan as of December 31, 2024 and 2023.

\*In accordance with FASB guidance Accounting Standard Update 2015-07, certain investments that were measured at NAV have not been classified in the fair value hierarchy. The fair value amounts presented in the table above are intended to permit reconciliation of the fair value hierarchy to the line items presented in the statements of net assets available for benefits.

#### 4. Administrative Expenses:

Expenses paid by the Plan include investment management and third party administrator fees. Although not required by the Plan, some of the costs of the Plan administration are absorbed by the Company.

#### 5. Related-Party Transactions:

The Plan paid administrative expenses to the trustee totaling \$36,165 during 2024 and \$24,146 during 2023.

Self-directed funds are administered by MSW Wealth Management Group who charge participants transaction fees for services provided with regards to these accounts. Fees paid by the Plan for the investment management services for the self-directed funds are included in administrative expenses. During 2024 and 2023, the Plan paid \$22,961 and \$20,052, respectively, of administrative expenses to MSW Wealth Management Group.

#### 6. Plan Termination:

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their accounts.

#### 7. Tax Status:

The Internal Revenue Service has determined and informed the Prototype Sponsor by a letter dated June 30, 2020 that the Plan and related trust are designed in accordance with the applicable sections of the Internal Revenue Code. The Plan has been amended since receiving the opinion letter; however, the plan administrator believes the Plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code. Management has evaluated the effects of accounting guidance related to uncertain income tax positions and concluded that the Plan had no significant financial statement exposure to uncertain income tax positions at December 31, 2024 and 2023. The Plan is not currently under audit by any tax authority.

#### 8. Risks and Uncertainties:

The Plan provides for investments in various securities. Investments are exposed to various risks, such as interest rate, market and credit. Due to the level of risk associated with certain investment securities and the level of uncertainty related to changes in the value of investment securities, it is at least reasonably possible that changes in risks in the near term could materially affect participants' account balances and the amounts reported in the financial statements.

#### 9. Financial Information Certified by a Qualified Institution:
