INDEPENDENT AUDITORS' REPORT

To the Plan Administrator of the

SCOPE AND NATURE OF THE ERISA SECTION 103(A)(3)(C) AUDIT

We performed audits of the accompanying financial statements of the Colliflower, Inc. 401(k) Profit Sharing Plan (Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the Statements of Net Assets Available for Benefits as of December 31, 2024 and 2023, the related Statement of Changes in Net Assets Available for Benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management obtained a certification from Transamerica Trust Company for the year ended December 31, 2024 stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

OPINION

- The information in the financial statements referred to above related to assets held and certified by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

BASIS FOR OPINION

We conducted our audits in accordance with auditing standards generally accepted in the United States of America. NOTE 1 DESCRIPTION OF PLAN

The following description of the Colliflower, Inc. 401(k) Profit Sharing Plan (Plan) provides only general information. Participants should refer to the Plan Agreement for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan covering all employees of Colliflower, Inc. (Company) provided the employee attains certain minimum levels of service with the Company. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

During 2023, Plan management selected a new custodian for the Plan. At December 31, 2023, all investments were converted to cash and subsequently transferred to the new custodian as of January 1, 2024.

Eligibility

Employees are eligible to contribute to the Plan upon the completion of two months of service. The employee's entry date will be the first day of the month after or coinciding with the date eligibility requirements are met. Effective May 1, 2025, the Plan contains an automatic enrollment feature with an initial contribution amount of 3%.

Contributions

Participants may elect to defer up to the maximum amount of pretax annual compensation, as defined by the Plan, not to exceed limitations set by the Internal Revenue Code (IRC). Participants who turn 50 years old before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollovers). Participants direct the investment of their contributions and any Company contributions into various investment options offered by the Plan.

The Company may make discretionary matching contributions on elective deferrals or discretionary profit-sharing contributions as it determines. Contributions are subject to certain limitations.

Participant Accounts

Each participant's account is credited with the participant's contributions, the Company's matching contributions, if any, and allocations of the Company's profit-sharing contributions, if any, investment earnings/losses, and charged with an allocation of administrative expenses. Allocations are based on participant earnings, account balances, or specific transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

(See Independent Auditors' Report)

Vesting

Participants are immediately vested in their voluntary contributions and Company contributions required by the Davis-Bacon Act plus earnings thereon. A participant is 20% vested after two years of service and fully vested in Company contributions after six years of credited service. Participants are automatically fully vested upon attainment of early retirement (age 55 and at least six years of service), disability, death, or termination of the Plan.

Investment Options

Upon enrollment in the Plan, participants may direct their contributions in various investment options. Specific information regarding these options may be obtained from the Plan Administrator. Participants may change their investment options at any time.

Participants may borrow from their accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The loan terms may not exceed five years unless the proceeds are used for the purchase of a primary residence. The notes receivable are collateralized by the balance in a participant's account and bear interest at a rate comparable to rates charged by commercial lending institutions for loans of similar terms. Notes receivable are repaid through payroll deductions and may be repaid in full at any time.

Payment of Benefits

Upon termination of service, a participant may elect to receive installments, a single lump-sum distribution of a portion of the participant's vested account balance, or a lump-sum amount equal to the value of the participant's entire vested interest in the participant's account. Hardship distributions are permitted if certain conditions are met. In-service withdrawals are also permitted for participants who have reached age 59½. If the total value of an inactive participant's vested account balance is \$1,000 or less, the Plan Administrator may require a distribution of the entire account balance in a lump sum. If the total value of an inactive participant's account is \$1,001 to \$5,000, the Plan Administrator may require the balance to be rolled over to an individual retirement plan designated by the Plan Administrator. These methods and options are described in the Plan Agreement.

Administrative Expenses

The Plan's administrative expenses are paid by either the Plan or the Company as provided by the Plan Agreement.

Forfeited Accounts

At December 31, 2024, forfeited non-vested accounts totaled \$1,540. These accounts will be used to reduce future administrative expenses and company contributions. In 2024, Plan expenses were reduced by \$7,875, and Company contributions were reduced by \$40,907 from forfeited non-vested accounts.

Plan Termination

Although the Company has not expressed any intent to do so, the Company has the right under the Plan to terminate the Plan at any time subject to the provisions of ERISA. Upon termination of the Plan, all interests of the participants not previously vested would become vested and non-forfeitable, and the net assets of the Plan would be distributed to participants based upon individual equities in the Plan.

NOTE 2 SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Presentation

The accompanying financial statements are prepared on the accrual basis of accounting.

Accounting Standards Codification

All references in the financial statements to the Codification refer to the Accounting Standards Codification and the Hierarchy of Generally Accepted Accounting Principles (GAAP) issued by the Financial Accounting Standards Board. The Codification is the single source of authoritative GAAP in the United States.

Use of Estimates

The preparation of financial statements in conformity with GAAP requires management to make estimates and assumptions that affect the amounts reported in the financial statements and accompanying notes. Actual results could differ from those estimates.

Valuation of Investments

Investments are stated at fair value. See Note 4 for a discussion of fair value measurements.

Benefit Payments

Benefits are recorded when paid.

Risk and Uncertainties

The Plan provides for investments in various investment securities, which are exposed to various risks, such as interest rate, credit, and overall volatility. Due to the level of risk

associated with certain investment securities, it is reasonably possible that changes in the values of investment securities will occur in the near term, and such changes could materially affect the amounts reported in the Statements of Net Assets Available for Benefits.

Notes Receivable From Participants

Notes receivable from participants are carried at their unpaid principal balance plus accrued interest. Delinquent participant loans are reclassified as distributions based upon the terms of the Plan Agreement.

NOTE 3 INFORMATION CERTIFIED BY THE TRUSTEES

Plan's investments were held by the Trustee, Transamerica Trust Company, at December 31, 2024. The Plan's investments were held by the Trustee, John Hancock Life Insurance Company, at December 31, 2023. Financial information related to those investments is included in the accompanying financial statements based on information certified by the Trustees. The information, which was not audited by independent auditors, is summarized below:

NOTE 4 VALUATION OF INVESTMENTS

Investments are recorded at fair value in accordance with the provisions of the Fair Value Measurements and Disclosures Topic of the Codification, which establishes a framework for measuring fair value. The framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1

measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy are described below:

Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 Inputs to the valuation methodology include:

Quoted prices for similar assets or liabilities in active markets;

Quoted prices for identical or similar assets or liabilities in inactive markets;

Inputs other than quoted prices that are observable for the asset or liability;

Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Below is a description of the valuation methodology used for assets measured at fair value. There were no changes in the methodology used at December 31, 2024 and 2023.

Mutual Funds: Valued at the net asset value (NAV) of shares held by the Plan at year end. NAV is based on the value of the underlying assets owned by the fund, minus its liabilities, and then divided by the number of shares outstanding. NAV is a quoted price in an active market.

Common and Collective Trusts: Valued using NAV. NAV is quoted on a private market that is not active; however, the unit price is based on underlying instruments which are traded on an active market.

The method described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation method is appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

NOTE 5 INVESTMENT IN STABLE VALUE CONTRACT

The Plan has an investment in the Transamerica Stable Value Ascend Option, which is a fully benefit responsive investment contract and, therefore, reported at contract value. Contract value, as reported by the Trustee of the Plan, represents contributions made under the fund, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

There are no reserves against contract value for credit risk of the contract issuer or otherwise. Certain events limit the Plan's ability to transact at contract value with the issuer. Such events include the following: (a) amendments to the Plan Agreement (including complete or partial Plan termination or merger with another plan), (b) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (c) bankruptcy of the Plan sponsor or other Plan sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan, or (d) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA. The Plan administrator does not believe any events that would limit the Plan's ability to transact at contract value with Plan participants or the issuer are probable of occurring.

NOTE 6 TAX STATUS

The Plan obtained its latest determination letter on June 30, 2020, wherein the Internal Revenue Service determined the Plan was designed and operating in accordance with the applicable sections of the IRC. Although the Plan was amended since receiving the

determination letter, the Plan Administrator believes the Plan is designed and currently operating in compliance with the applicable requirements of the IRC. Therefore, no provision for income taxes was included in the Plan's financial statements.

GAAP requires Plan management to evaluate uncertain tax positions for recognition in the financial statements. The Plan Administrator concluded that there were no uncertain tax positions as of December 31, 2024.

NOTE 7 RELATED-PARTY TRANSACTIONS

Certain Plan investments are managed by the Trustee of the Plan. These transactions qualify as party-in-interest transactions. Investment management and recordkeeping fees paid to parties in interest totaled approximately \$35,800 for the year ended December 31, 2024. These party-in-interest transactions are exempt from the prohibited transaction rules of ERISA.
