Notes to Financial Statements

December 31, 2024

1. Description of the Plan

General

The St. Joseph Corporate Services 401(k) Plan (Plan) is a defined contribution plan established June 1, 1993 and most recently restated effective January 1, 2022 covering certain employees of St. Joseph Corporate Services, Inc. and SJ Physician Services, Inc. (the “Employer”). There is no age requirement to participate in the employee deferral component of the Plan. Participants enter the Plan immediately upon date of hire. The matching contribution, if applicable, begins each January 1, April 1, July 1 and December 1 after an employee reaches age twenty-one or older and completes one year of service.

The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”). Participants should refer to the Plan agreement for a more complete description of the Plan’s provisions.

On December 23, 2018, a majority of the employees of St. Joseph Hospital Corporate Services, Inc. were transitioned to employees of St. Joseph Hospital (Hospital). As a result, those impacted employees who were participants in the Plan will become participants in the Hospital 403(b) Plan. The Plan has ten active participants on December 31, 2024.

Contributions

Participants can contribute up to 100 percent of their annual salary, subject to Internal Revenue Service (IRS) limitations. All contributions and earnings thereon are deferred for income tax purposes until withdrawal. Participants can make changes to their respective contribution percentages at any time. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit and defined contribution plans.

The Plan permits Roth elective deferrals. Roth elective deferrals shall be treated in the same manner as participant elective deferrals, except that Roth elective deferrals are not “pre-tax” deferrals as defined in the Code.

Employer matching contributions are allowed, equal to a percentage of each participant’s salary reduction, to be determined by the Employer. The Employer match of 100% of the first 2% of eligible compensation is only for non-highly compensated eligible participants for the years ended December 31, 2024 and 2023. The matching contribution is calculated and deposited annually, if applicable.

St. Joseph Corporate Services 401(k) Plan

Notes to Financial Statements (continued)

1. Description of the Plan (continued)

Participants' Accounts

Each participant's account is credited with the participant's contribution and allocations of (a) Company contributions, if any and (b) Plan earnings (losses). The benefit to which a participant is entitled is the benefit that can be provided from the participant's account.

Forfeitures/Unallocated Accounts

At December 31, 2024 and 2023, forfeited non-vested employer contributions totaled \$8,894 and \$15,283, respectively. These amounts will be used to reduce future employer contributions or pay plan expenses. Forfeiture amounts used to reduce employer contributions or pay plan expenses amounted to \$7,938 and \$-0- during the years ended December 31, 2024 and 2023, respectively.

At December 31, 2024 and 2023, funds available in the advanced employer account totaled \$-0- and \$7,540, respectively. These amounts can be used to pay plan expenses. Amounts used to reduce expenses amounted to \$7,610 and \$6,024 during the years ended December 31, 2024 and 2023, respectively.

Vesting

Participants are immediately vested in their contributions and any QNEC contributions plus actual earnings thereon. Vesting in matching and discretionary employer contributions, if any, plus actual earnings thereon is based on years of continuous service.

All employees hired on or after July 1, 2011, will be subject to a 3-year cliff schedule that provides 100% vesting after three years of service. (For each year of credited vesting, employees must have at least 1,000 or more eligible hours per plan year.)

Payment of Benefits

Participants may withdraw all or a portion of the balance of their contribution account to the extent necessary to meet financial hardship or for any reason after retirement, termination of employment, total or permanent disability, or death. All benefits are payable in the form of a lump sum cash payment or installments.

In-service distributions are available for employees age 59 1/2 and older.

Notes to Financial Statements (continued)

1. Description of the Plan (continued)

Plan Termination

Although they have not expressed any intent to do so, the Trustees have the right under the Plan to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts.

Notes Receivable from Participants

Participants may borrow from their accounts provided that the loan does not exceed the lesser of \$50,000 or 50% of their vested account balance. The Plan has established a minimum loan request of \$1,000, and participants are allowed two outstanding loans from the Plan. Loans bear interest at a rate of prime plus 1%. Repayment of principal and interest within five years is required by the Plan, except when the loan is for the purchase of a principal residence, in which case the repayment term may be longer than five years.

2. Accounting Policies

Basis of Presentation

The financial statements have been prepared on the accrual basis of accounting.

Investment Valuation and Income Recognition

Investments are stated at fair value. Fair value is defined as the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date (an exit price). See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Management fees and operating expenses charged to the Plan for the management of investments are deducted from income earned on a daily basis and are not separately reflected. Consequently, management fees and operating expenses are reflected as a reduction of investment return for such investments.

Notes to Financial Statements (continued)

2. Accounting Policies (continued)

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income on notes receivable from participants is recorded when it is earned. Delinquent participant loans are reclassified as distributions based upon the terms of the plan document.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the amounts reported in the financial statements and accompanying notes. Actual results could differ from those estimates.

Administrative Expenses

The Plan entered into a service agreement with the investment advisor firm and those fees related to advisor services are fixed at \$38 per participant. The Plan captures all revenue sharing amounts that are included in the net appreciation for the years ended December 31, 2024 and 2023 of \$7,081 and \$7,301, respectively. The amounts paid from this account are included below.

The amount available in the expense budget account at December 31, 2024 and 2023 is \$3,092 and \$2,604, respectively. The amounts used from the expense budget account to offset expenses during the years ended December 31, 2024 and 2023 amount to \$6,652 and \$23,696, respectively.

For the years ended December 31, 2024 and 2023, \$14,956 and \$15,508, respectively, was charged to participant accounts. These amounts include amounts paid from the expense budget account and certain expenses such as participant loan processing fees. Other fees are deducted directly from participant accounts.

Payment of Benefits

Benefits are recorded when paid.

3. Certified Investments

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including investments and notes receivable from participants held at December 31, 2023 and 2024, and net appreciation (depreciation) in fair value of investments, interest and dividend income, and interest income on notes receivable from participants for the years then ended, was obtained by management and agreed to or derived from information certified as complete and accurate by State Street Bank & Trust Company, the trustee of the Plan.

4. Fair Value Measurements

The fair value framework establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The fair value hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets and liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy are described below.

Level 1 – Unadjusted quoted prices in active markets that are accessible to the reporting entity at the measurement date for identical assets and liabilities.

Level 2 – Inputs other than quoted prices in active markets for identical assets and liabilities that are observable either directly or indirectly for substantially the full term of the asset or liability. Level 2 inputs include the following:

- Quoted prices for similar assets and liabilities in active markets
- Quoted prices for identical or similar assets or liabilities in markets that are not active
- Observable inputs other than quoted prices that are used in the valuation of the asset or liabilities (e.g., interest rate and yield curve quotes at commonly quoted intervals)
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Notes to Financial Statements (continued)

4. Fair Value Measurements (continued)

Level 3 – Unobservable inputs for the asset or liability (i.e., supported by little or no market activity). Level 3 inputs include management’s own assumption about the assumptions that market participants would use in pricing the asset or liability (including assumptions about risk).

The level in the fair value hierarchy within which the fair value measurement is classified is determined based on the lowest level input that is significant to the fair value measure in its entirety.

The following is a description of the valuation methodologies used by the Plan. There have been no changes in the valuation methodologies at December 31, 2024 and 2023.

Mutual funds are valued daily at the closing price per share, as reported by the fund. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Common stocks are valued at the closing price reported on the active market on which the individual securities are traded.

The Transamerica Retirement Solutions Collective Trust Institutional Stable Pooled Fund (Stable Value Fund) is a *common trust fund* and is valued based upon the net asset value of shares held by the Plan by Transamerica Retirement Solutions. The net asset value is used as a practical expedient to estimate fair value. Redemptions are processed daily. There are no unfunded commitments.

Withdrawals from the Stable Value Fund will be made at the prevailing declared unit value as determined by the net asset value. Withdrawals from the Stable Value Fund are subject to restrictions that apply to the underlying Stable Value Trust (Trust). Transfers may not be made by participants to fixed income funds (competing funds). Monies transferred to non-fixed income funds may not be transferred to fixed income funds for 90 days but may be transferred back to the Stable Value Fund at any time. In addition, the trustee of the Trust also has the right to delay for up to 12 months any other withdrawal, including the withdrawal of all or a portion of the assets of an investor in the Trust.

The valuation methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while plan management believes the valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

5. Parties-In-Interest

Section 3(14) of ERISA defines a party-in-interest to include, among others, fiduciaries or employees of the Plan, any person who provides services to the Plan or an employer whose employees are covered by the Plan. Accordingly, notes receivable from participants are considered party-in-interest transactions.

Certain plan investments are managed by Transamerica Partners and Transamerica Investment Advisors. Transamerica Retirement Solutions Corporation is the plan recordkeeper and, therefore, these transactions qualify as party-in-interest transactions. In addition, State Street Bank & Trust is the trustee of the Plans assets and certain investments are managed by State Street Bank & Trust and, therefore, these transactions qualify as party-in-interest transactions.

6. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Market risks include global events which could impact the value of investment securities, such as a pandemic or international conflict. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

7. Income Tax Status

The Plan has adopted the non-standardized pre-approved profit sharing plan of Transamerica Retirement Solutions LLC. The non-standardized pre-approved profit sharing plan sponsor received an advisory letter from the IRS dated June 30, 2020 in which the Internal Revenue Service stated that the form of the non-standardized pre-approved profit sharing plan was in compliance with the applicable requirements of the Internal Revenue Code (Code). Although the Plan has been amended since receiving the advisory letter, the plan administrator believes the Plan is being operated in compliance with the applicable requirements of the Code and, therefore, believes that the Plan is qualified, and the related trust is tax exempt.

Accounting standards require recording uncertain income tax positions that exist in the Plan's financial statements. Plan management has determined there are no uncertain tax positions and believes there is no adjustment or disclosure required in the Plan's financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.
